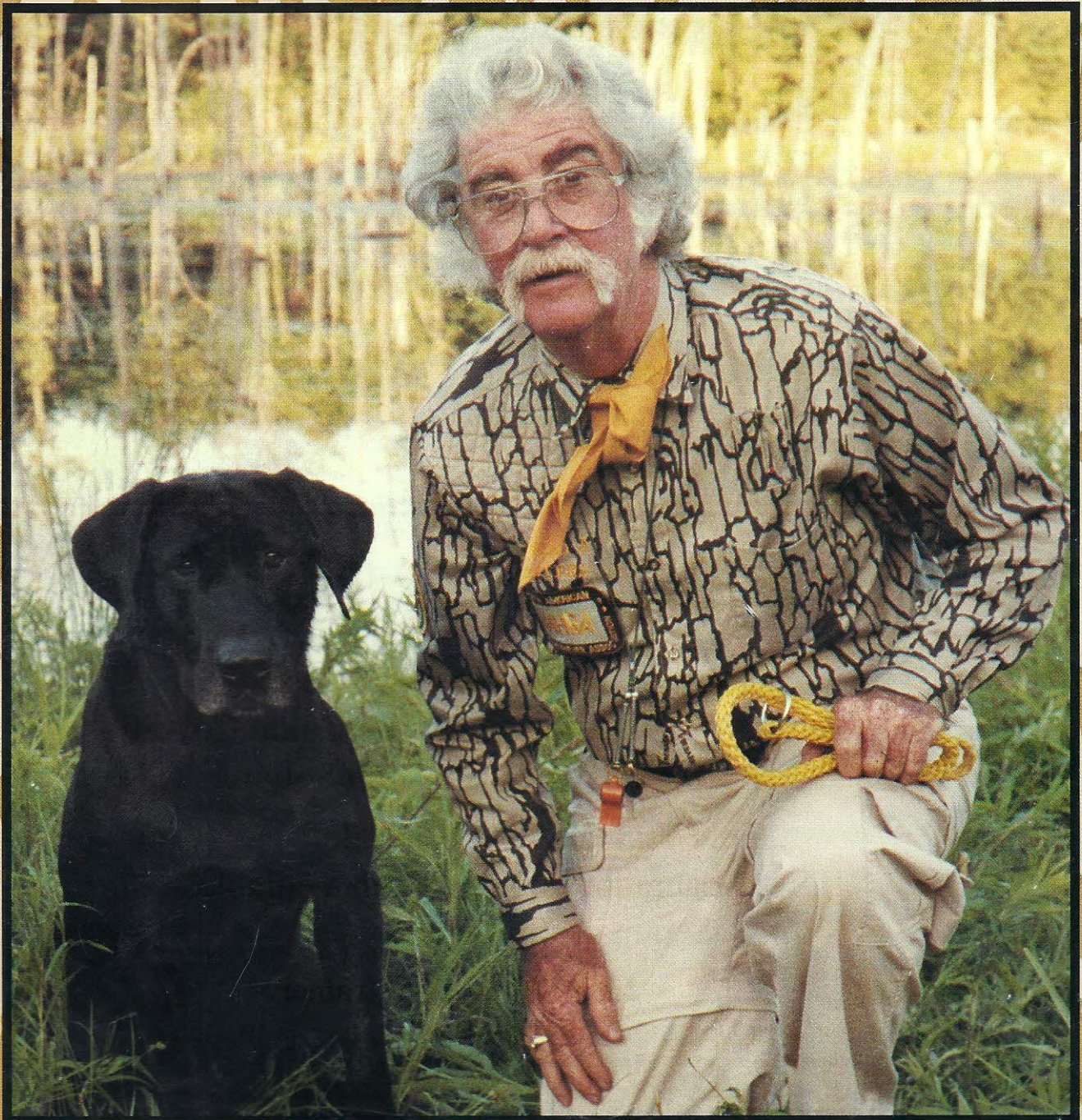

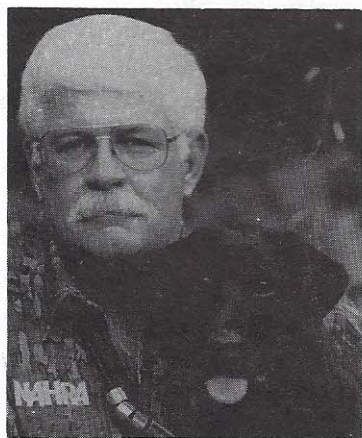

I thought long and hard about my current involvement with the dogs. I have continued through the years because dogs like "Peco" deserve our support. I'm a little gun shy going into the new year but determined to move forward. With each passing there is a new birth. Rosemary is expecting a new puppy in March, the two legged variety. Things will be a little hectic around here during that time so give us a little consideration.

The NAHRA Invitational will be held in Culpeper, Virginia May 9th through the 15th. The event will be hosted by the Richard A. Wolters Foundation and named the Richard A. Wolters Invitational in Richard's honor. The Foundation is a non profit charitable corporation. Its function is charitable, educational, literary and scientific objectives within the meaning of Section 501(c)(3) of the Internal Revenue Code. It is further projected that the Foundation will promote conservation, provide drug dogs to law enforcement agencies, make grants of funds and dogs for the assistance of the blind and other impaired people. It will educate the public about the history and development of retriever breeds

of dogs. The corporation has no capital stock and no part of its net earnings shall benefit or be distributed to its directors, trustees or officers. The immediate goal of the Foundation is to host an annual event and present an award in Richard's honor. A memorial and museum will follow.

Keith Stroyan, NAHRA International Liaison, has been busy. Keith is dedicated to the task and determined to harness the collective energy of the membership via regional support. Clubs within each of the ten regions will discuss potential rule changes, interpretation of rules, judging clinics and involvement with the Judges Newsletter. Another International Raffle is planned for 1994-1995. Clubs and regions will work together to generate quality hunting trips and discuss the advantages of widespread support and the benefits for each region and NAHRA. A copy of the Judges Newsletter addressing handling on marks will appear in this issue of the NAHRA NEWS. We urge members to phone 1- 800- 421- 4026 to request a judges application. A better understanding of running rules through education is a primary focus nationally. Most regions feel we need better informed judges and also urge handlers to participate at clinics to have a greater understanding of the requirements for running field tests through interpretation.

TBS will host a 2 hour program "Cats & Dogs" March 28, 1994 on cable TV. The show will air at 8:05 Pacific and Eastern and 7:05 Central. A segment of the show will deal with NAHRA Field Tests.

I plan to travel to as many regions as possible this year. Hopefully I'll have an opportunity to visit with you.

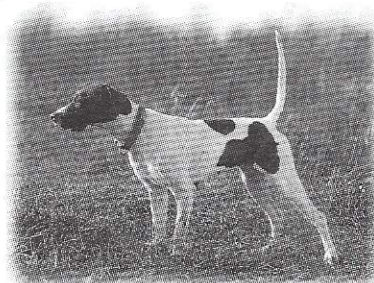

# Veterinary Corner

## Research Update

Retained deciduous teeth: don't wait for the fall.

Dog owners should not patiently wait for retained deciduous ("baby") teeth to fall or not fall on their own. These retained teeth can do a great deal of permanent damage to the mouth and jaw as well as prevent the normal eruption of permanent teeth. The resulting malocclusion when a permanent tooth is displaced is not just a cosmetic problem. The first step in preventing these consequences is to be aware that they can happen, especially in toy breeds, which appear to be particularly susceptible to the problem. Some experts say the retention of deciduous teeth is probably a hereditary problem, although developmental factors are also involved.

Dr. Ashley B. Oakes of Louisiana State University has outlined the options for treating retained deciduous teeth. Early detection and prompt extraction can prevent malocclusion as two teeth compete for the same small place. But most young dogs suffer from what could be called the "visit to the veterinarian time gap." As Dr. Oakes explains, many dogs do not return to the doctor until one

year after their initial rabies virus immunization. If the deciduous teeth have not fallen out by that time, a dental malocclusion that could have been prevented has already developed.

Owners should monitor the teeth daily or every other day during the growth stage, and the deciduous teeth should be reported.

Many veterinarians can give owners a chart showing retained and deciduous teeth to guide the owner's daily inspection.

### Approximate ages when teeth erupt in puppies (in weeks)

Temporary teeth	Permanent teeth
Incisors 4-6	12-16
Canines 3-5	12-16
Premolars 5-6	16-20
Molars	16-24

### Questions from Our Readers

Q: Some dog foods are being advertised as having "high digestibility"

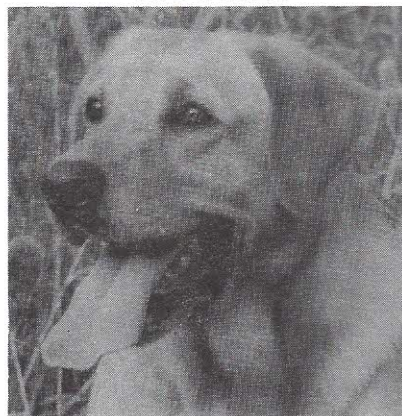
resulting in "low stool volume." Does that mean the food has reduced fiber content?

What should the fiber content of dog food be?

A: No, that does not mean the food has reduced fiber content. In fact, many dog foods have relatively low fiber content. Most dogs handle such foods very well and have no problems. Unlike the situation in humans, dogs have an extremely low incidence of colon cancer. It may be that some forms of colitis can be managed with a diet high in fiber. Several diets have been formulated with a higher fiber content in order to manage such problems. The fiber content of manufactured dog foods is perfectly adequate for the vast majority of our canine population. There is no ideal percentage for the fiber content of a dog food. If a dog develops a problem that is manageable by an elevated fiber content in its diet, it is important to raise the fiber content. As stated previously, an elevated fiber content is present in several manufactured pet foods such as Hill's r/d. It is also possible to formulate home-prepared diets that meet this criterion.

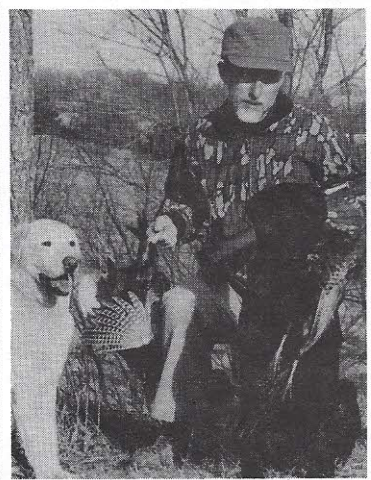

# The Dogs Make Me Do It, Dear!

My dogs re-introduced me to waterfowl hunting after a long pause. Years in college and new job pressure kept me from hunting of any kind. I bounced from Philadelphia to Pasadena to Madison with only an occasional glimpse of wildlife, no dog or shotgun. Something was missing until I discovered Iowa pheasant hunting. I tried the first year without a dog and soon realized that I could do better with one. Preparation for the second year involved extensive training of the family pet, a Standard Poodle named Ted. Ted lacked nothing in the enthusiasm department, but had a hard time with gun range and little in the hunting talent department. Poodles were originally bred as waterfowl retrievers, but that time has long since passed. Dog generations are short, so breeding for looks can take the hunt out in a hurry. Preparation for my third year of pheasant hunting began by looking up the Iowa DNR statistics on pheasant hunting success with dogs.

Now, if you're a pointer man, or poodle fan, please don't get upset, but the plain fact is that in Iowa pheasant hunting, RETRIEVERS put the most birds in the bag. Pointing breeds are second, spaniels third and hunting with no dog a distant fourth. Well-bred trained hunting dogs are amazing conservation tools. If a bird is knocked down in the marsh or field, trained retrievers will work

their tails off to find it. And they're darn good at finding pheasants before the gun goes off, too.

My old yellow lab Roxie was born the same year as the North American Hunting Retriever Association (NAHRA) and those two have conspired to make me a waterfowl hunter again. At least, I tell my wife, "I have to go duck hunting to keep the dogs well-rounded and be sure they live up to their potential." NAHRA was designed to test the all-around hunting retriever, both in upland and waterfowl work, including tracking a cripple. I have made friends with some real duck and goose hunting experts through the dog tests and they are teaching me how to do these things right. I do blame the duck hunting on NAHRA, because I don't think my wife is up to one of my friend's excuses for duck-hunting widowhood: "Darlin', duck hunting" 'swhat I AM." I figure it's safer to blame it on the dogs.

Pheasant hunting is simple. You get up at seven, have a coffee, drive over to a neighbor's farm and start hunting at eight. I always get my limit in exercise. Waterfowling is different. You plan for months, buy lots of calls and tapes to practice, fix up your blind (shown in the back of the photo) and so on. I now have dozens of decoys, a duck skiff, waders, a much better shotgun for a wider variety of loads, and, of course, retrievers. But I still don't like getting up at midnight and sitting all night in a cold boat just to claim a spot, so my wife and I returned two acres of soggy hay ground behind the house to marsh.

Our little marsh is a lot like NAHRA in one very important respect. My wife, the dogs and I enjoy it year around. There's ice skating in February, Bluebills in March, a succession of Mallards, Spoonbills, Teal and Geese in April, and Wood ducks all summer. September brings the Teal back and October begins the hunting season. Hunting season is the best part of the year, but a moonlit April night with newly returned geese honking all night outside our bedroom window comes close. A clutch of wood ducklings jumping out of their nest in June, does too. Last summer my wife was down on the marsh helping me train dogs when one brood left the nest. Hunting Retriever tests keep me and my dogs busy in the off season; like the activity on the marsh, they're a good off-season substitute for hunting.

Training for NAHRA tests is preparation that ensures an enjoyable hunting season, just like the nesting on our marsh. A talent-

ed, trained retriever puts nearly every downed bird in the bag and sits quietly on the bow of the boat or outside the blind until the shooting stops. NAHRA tests are designed to stimulate hunting and specifically prepare your dog for hunting. I'll give you some examples from tests I have judged in the past year.

The Senior water test we set up at the May NAHRA Invitational at Masomack in upstate New York began with the handler blocked inside a blind and the dog out front. After lots of duck calling, three dry shots were fired, one from our blind and two from a blind across the marsh. This was to stimulate a missed bird being hit by our partners and knocked down without the dog seeing it. All that excitement makes for a tough blind retrieve, just like real hunting. Our bird 'landed' well outside the other parties' decoys and the line to the bird was over a small island. There was a strong temptation for the dogs to cheat on the island, go toward the other shots and into their decoys. The work of these national caliber dogs was spectacular, but a few succumbed to the temptations.

Our Senior water test at the Midnight Sun Gun Dog Association in Alaska last July was run from deep water out of Jim Anibas' big freighter canoe. We heard a lot of excuses about how various handler's dogs don't usually hunt out of a boat, but actually most did fine work. Alaska has more good retrievers per capita than anyplace I've been. The boat test took a long time and the club got to live up to its name - I was placing decoys for the next morning's Intermediate water test in the dusk of midnight.

The Intermediate land test I set up with Frank O'Brian had the handler lay down in a spread of Emperor Goose decoys, cover up with camo, hold a gun and call while the dog sat nearby. We called for a while and two sets of hidden bird throwers 60 or so yards out behind some brush also called. Then there was a silent pause. I had the most awful reject goose call, so I asked each handler in an earnest tone if that's what Emperor geese really sound like. They were all so polite to the outside judge laying in the decoys with them, but Frank almost peed in his judges' chair from his position behind the line listening to the nervous handlers. They really were more concerned that their dog might break than answering my dumb questions. The test continued with more calling, but this time the answer calls

from the bushes produced two birds, one of which I "shot" from our decoy spread with a 12 ga. blank. The handler had to shoulder his gun and the dog had to sit until released after the shooting and then retrieve our double.

The Started tests we set up last August in Wisconsin were more basic, five single marked retrieves. We began with three progressively more difficult land marks, the last being a walk up. Then we went to water. Handlers could steady their dog with a slip lead in one hand, but we had handler's holding a gun in one water series and blowing a duck call in another. The dogs had to swim by decoys and show that they weren't gun shy, as we fired a shot from our "blind."

NAHRA and the other hunting retriever test programs have from beginner through real working retrievers on to advanced polished dogs. The first main goal of our local retriever club is to help every member get the best from their dog, whatever the level. I

have two dozen decoys that my wife calls the "Chernobyl ducks" because of all their service in Beginner tests with pups that aren't used to decoys. We know that many of our members won't go very far with their dogs' training, but a talented Started dog that knows his master's special kind of hunting is still a great asset. There's no law that says you can't tie your pooch outside the blind to steady him. If he's trained enough to watch for the ducks, not be bothered by the shots, ignore the decoys and bring the birds gently back, you may have all the dog your kind of hunting requires.

Folks who have the time and desire to train more move into Intermediate tests that lead to the NAHRA title WR, for Working Retriever. These tests include all the things you would want in a working hunting dog: double marks on land and water, tracking, quartering, and a blind water retrieve. Dogs that can do these tests are a joy to hunt with anywhere from upstate New York to Alaska. For those of us that really enjoy this kind of substitute hunting, there are also Senior tests leading to the titles Master Hunting Retriever (MHR) and Grand Master Hunting Retriever (GMHR), as well as the annual Invitational Field test. Whatever the level, the off-season activity

makes our dogs more enjoyable to hunt with the following fall.

We don't want to see our hunting retrievers suffer the fate of my fine companion, the house pet Standard Poodle, Ted. While Standard Poodles are smart, easy to train, and people oriented, it is all but impossible to find one that is a competent waterfowl dog. Their original purpose has been lost by non-hunting breeders. The second goal of our club is to help make members' next hunting retriever even better than the present one. Hunting stories are a little like fishing stories and it seems everyone tells of "great" hunting dogs. Dogs that can master the difficult standardized NAHRA tests in all the hunting areas are prime breeding stock for HUNTING. Watching dogs run tests, or at least checking hunting retriever titles, provides a basis for our members to choose their next pup and helps to protect one of the most important animals in the waterfowl sport - retrievers with real hunting talent. Around here, those same dogs are a major asset in the uplands. Hunting talent takes nothing away from their wonderful people oriented personality; four of them are helping with the typing right now, while the fifth has claimed her spot on the old couch by the TV.

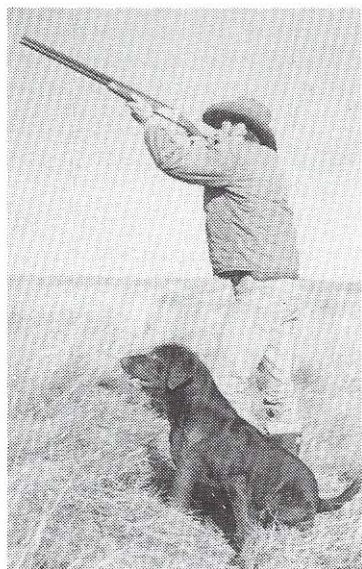

# Training Tips

## "Professional Trainers"

Your young dog is firing out after those single retrieves but you can't get him to stay until you release him.

You have him steady but, when working on double retrieves, he likes to do a lot of switching or he balks at going for the second bird.

Your dog looks more like he's upland hunting than trailing. It just doesn't seem that the dog concentrates on any particular scent but rather the smells of the entire field draw him over hill and date.

When running your dog on blind retrieves, it looks more like he's giving you directions rather than you telling him where you want him to go.

Instead of stopping immediately upon hearing the whistle blast, the dog tends to cruise to a stop when it feels like it. And, instead of going quickly in the direction ordered, the dog has a tendency to go where it feels like first and then, maybe, goes in the general direction you intended.

The dog hunts upland birds like a dream but when it's time for the flush it's more like a nightmare. Your dog breaks at the flush and is usually there to catch the bird as it falls from the sky.

Pup has always found it quicker to go by land on water marks and now that you are trying to teach him doubles, he constantly gets lost on the memory bird because of his bank running.

Any of this sound familiar? An amateur training may not have enough patience, experience, knowledge, equipment and/or help to get their dog through troubled times and they find it necessary to search out the aid of a professional trainer.

Along with the advent of hunting retriever field tests came a huge influx of individuals calling themselves "professional" dog trainers. Some of these individuals came from the traditional trial ranks but many where those that saw a need and are doing their best to fulfill it.

There are a few of our "professionals" that haven't a clue as to what professionalism is all about.

When I got started with dogs, back in the late sixties, it was in the traditional trial game in Portland, Oregon. At that time there were numerous successful professional trainers on the circuit. One in

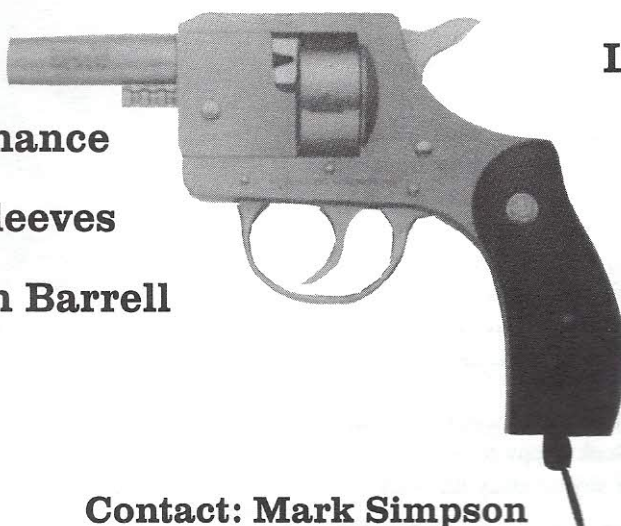

particular stood out among all of the rest. His name is Paul Shoemaker.

Paul always went to the line wearing a starched white shirt and pheasant feather bow tie. He felt that because he was a professional the trial grounds were his office and that he should dress and act accordingly.

He as well as other "professional" trainers had "class." They were always extremely courteous to judges, marshals and other handlers. The majority of the successful pros, in the traditional trial game, remain that way today.

Anyone can claim to be a professional trainer. All it takes is hanging a sign up at the end of the driveway and taking money for training dogs.

You, the potential client, must beware!! You must carefully research your decision if and when your dog needs the guidance of a professional. Some individuals use a pro to rid their dog of a particular problem. Others find it necessary to send their dog to a pro on a full time basis to be trained and campaigned.

One of the major reasons that many people came into NAHRA in the beginning from the traditional trial world was because they were sick and tired of the pro dominance in that sport. They wanted to be competitive without going up against some individual that was running five, ten or twenty dogs in their category. There are only four placements and what chance did the little guy have against those odds.

Other individuals that came into NAHRA were purest hunters who truly loved their dogs and didn't want them away from home. Their hunting dog was also the family companion and mom and the kids weren't about to let old "Gunner" go away to some dog pound looking facility for schooling.

However, as time has gone by, many are learning that sometimes they have no choice but to send "Gunner" to a pro. You can't keep entering Field Test after Field Test and continually joining the ranks of the un- Qualified. You love the game too much to just quit entering! You know "Gunner" has what it takes, its just that you aren't sure how to get it out of him in front of those judges!!

My advice to you, after you finally decide to send "Gunner" to a pro, is to do a lot of research. Pros tend to specialize with particular ability groups. Some are better with young dogs that require more patience and others are far better with the techniques involved in the drills for older dogs to make them more accomplished as a finished retriever.

Check the professional out. If at all possible, watch how the pro handles his/her dogs. Do the dogs look happy to work or are they slinking around at the pro's feet or shying away like they've been mistreated.

How about the pro's attitude. Is he/she a big mouth and always whining, crying and complaining or does the pro go about his/her work with professionalism? Attitude is extremely important because what you see and hear is what you are doing to get as a customer.

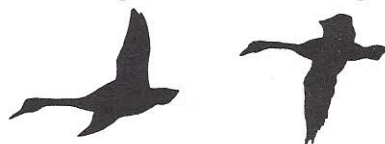
Get references. Talk to others that have sent their dog or presently have their dog with this individual. Are they happy with the results and with the care their dog received?

Take the time to go to the pro's facility to see where the dogs are housed and to check on the conditions there. Are the kennel areas clean? Is there old food left in feed pans? Do the dogs all have fresh water to drink. Are there more than two dogs in a run? Are the runs large enough? (They should be at least four foot wide and twelve feet long.) Are they safe and secure? Can the dogs get out of inclement weather or the hot sun? Bottom line is do the dogs look like they are being well taken care of or neglected?

Talk honestly with the professional. Tell him/her exactly what your dog's problems are and what your expectations are. It is important that you don't wait for months and months after your dog establishes a problem. Each time the dog does something incorrectly and gets away with it he must be made to correctly respond many times to eradicate the problem.

The longer you wait to send your problem dog to a pro, the longer it's going to take for the pro to straighten your dog's problems out.

Remember! You are the one that is paying the pro trainer's salary, that makes YOU the BOSS. You are hiring him/her to perform a job for you and because your dog is on his/her truck, he/she is representing you. If you see or hear something you don't like, don't hesitate to respond in a manner fitting of an employer.

# Old Brown Dog

As I sat on the gray industrial quality linoleum floor of the vet's office I somehow thought it would be different. Maybe we'd simply have found her dead at home. Or maybe she'd just disappear. We'd search, in vain, and perhaps find bones way later in the woodlot where wild quail hid when she pushed them from the bean field. She loved to do that, her magnificent brown nose snuffling along the turn row into the wind.

Instead she just got more infirm. Spinal discs collapsed like play dough in a vice-grip. Nerves pinched off, muscles atrophied and her gait slowed. The drive was still there. Toss a few training ducks her way and she'd try like she did that first summer 12 long years before. Back then she fit under the TV set and often hid there, running away with a mallard wing to that secret spot. Took half a dog biscuit to get her out. Those old worn teeth couldn't even chew one now.

She was always birdy. One time she broke out of her dog box during a dove shoot. There I was sitting in the middle of a cut sunflower field with her daughter, now a GMHR and MH. I spy this big, good looking chocolate Lab fetching a bird for some guy over by the parked vehicles.

"Beautiful dog," says I to myself, "looks a lot like Meg. Damn!!! It is her!!!" Performed that stunt three more times before I wised up, threw away the homemade wooden dog box and bought an aluminum crate. All she could do then was tear up the floor mats.

Woodcock were her thing. Plunge through multiflora rose and greenbriar to pin these long billed swamp wraiths. In eastern Maryland woodcock, mostly migrants, fan out from a South facing L Z into creek bottoms to look for spring seeps and earth worms. That brown dog would do a search and destroy foray into the wet spots. I'd trail behind, hoping for a flush. If I got lucky and hit one, it wouldn't matter where the bird went down. She'd mark the fall, then swim or bull her way to the bird. Her incongruously gentle retrieve, russet feathers unruffled in that big mouth, was a joy to behold. Sometimes, for reasons known only to her species, she'd try to bury one halfway back. You never really know a dog. They always teach you new tricks.

Ah, that glorious nose! One bright autumn day three quality retrievers couldn't locate a downed dove in standing milo. We had marked that bird within a 20 square yard area. Still no one could find it. In turn each dog became overheated and stopped hunting. Then I brought out my handsome chocolate lady. She hunted hard and made game, but couldn't pin. Finally she raised up on her hind legs and plucked the dead bird from a milo crown, like a stock boy picking a can off a high shelf. Had to see it to believe it. She proved that a keen nose must be operated intelligently.

These moments flooded back as I sat on the cold floor, watching for any sign that her arthritis, cancer or liver failure would relent a little and let her be 10 or 8 years old one more time - - - if only for a few minutes. That never happened.

She had beat cancer six years before. Two operations, chemotherapy and a six-months- to- live prognosis by the high priced vet specialist, plus her strong constitution, won that one. We got five more seasons of doves, woodcock, and waterfowl from that victory.

Geese, lordly, wary Canadas, were special to her. She had been beaten soundly by the first one she tried to retrieve. I was, still am, not a terrific wingshot and only crippled that first goose. It whipped up on her. I killed it on the water, after she came back, without it, afraid. She finally fetched it. The

next one she killed herself. Drowned it. Killed every one she was ever sent for, unless it was already dead. Pounced on them, held the breast to smother, crushed the head, but never tore meat. Went under ice one time after a cripple, then dragged it back by the head, like a big, floppy, grey lollipop. Crushed its neck. Dog had a gleam in her eye. Meat was perfect. Another time, a Saturday hunter from Baltimore accused her of eating his bird. We were gunning out of a pit and it was a long blind retrieve in cut corn. I told him she was just doing the job he should have done with a shotgun. Bet him \$20 he couldn't find a tooth mark on breast, leg or wing. Bought a half gallon of Jimmy Beam after the hunt. Helluva dog.

The vet had known her since puppyhood. They had a special bond, I guess. Going to that office usually made her irritable and tremble a lot. This night, though, she just lay on the mat, panting, trying to keep her head in touch with my leg. I told her she was good and pretty and smart. All the stuff to let her know she'd done well and that I really appreciated her. Like lining the water blind at her last hunt test after we came into the final series with weak, weak following our number. Or the time she saved all but 3 of her 13 newly weaned puppies after the kennel caught fire at 3 a.m. on the coldest night of that year. Only her barking saved the house and ten little retrievers. Three went on to earn titles.

The vet was gentle, patient, firm. Spend as much time as you want, then leave. Remember her alive, running, swimming, bringing back birds, tail high, eyes glistening, enthusiasm unbridled. Not the way she would soon be - - lifeless and still. Rejoice in her accomplishments, her memories, and her genes running through four generations of gun dogs, hunt test competitors and family companions.

Geese were flying and the air was sharp. I couldn't stop my tears as her ashes were buried and the little cross was erected in the pine grove by the pond. My heart filled with sorrow that she was gone. She loved this place so. A nudge against my leg brought me back. There were other cycles still running, mine included. The old brown dog was gone, but her daughter was here, eager, animated, ready to go. Decoys needed to be painted, blinds brushed, boats and motors readied. There was work to be done before the first bird could be admired in hand. I'm sure she would approve.

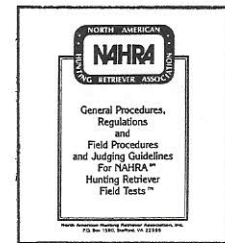

### Interpretation Article: Handling on Marks

The phrase, "a crisp cast is preferred to a long hunt," may not always be clear in practice. Of course, we all know a crisp cast when we see one. We all know a big hunt, too. But when is handling crisp enough? And when is a time consuming, thorough, tight hunt a sign of persistence and confidence and not a "long" hunt that should be interrupted by the handler? Perfect marks don't involve handling, but how much should we deduct for handling on marks? These questions don't have answers that we can cast in stone or can print in the rules; they require experience to make correct judgement in each case.

One regional report pointed out an important distinction in evaluating handling on marks. Your scoring should reflect whether the dog was:

a) First handled in or close to the area of the fall. We will call this Handling ON the Mark.

b) First handled from a location which is clearly away from the area of the fall. We will call this Handling TO the Mark.

An example of Handling ON a Mark is a dog that goes to the general area of a fall, but hunts up wind of the mark. He hunts the up wind side of the area and widens his hunt more in the wrong direction, so the handler gives him one crisp cast directly to the bird. Precise responsive handling of a dog that has indicated the correct area of the fall should be only a minor deduction; "a crisp cast is preferred to a long hunt." These dogs might merit

an overall score of 8 or 9 on the marking series if the other legs of their double or triple were good or excellent.

Handling TO a Mark refers to cases where the dog is handled all the way to the general area of the fall without ever giving an indication that he remembered that fall. For example, suppose a dog takes a line directly toward an old fall that he already retrieved. He gets halfway to the wrong fall and is stopped and cast to the correct area. This might be considered a major deduction or failure, even if the handling is clean. Judges need some latitude in this area. For example, a dog might have rushed when leaving for the second or third bird, but once stopped go directly to the correct area, indicating that he does remember the fall. Assessment of handling in cases like these requires a more difficult judgement, remembering that, "Repeated evidence of lack of marking ability may be grounds for elimination." The same precision of handling that merited 8s or 9s in the previous cases might be a major deduction when the crisp handling is all the way to the mark. It may be failure if repeated.

"Handling on a mark" and "handling to a mark" are not black and white, but separated by many shades of gray. Moreover, sometimes a dog does not see a fall, but can be handled through the test in a decent manner. In this case you have to make a judgement on the size of the deduction based on the particular circumstances. If the other one or two legs of the marking test are good, you may feel the deduction should be minor. Also be careful with your assumption that the dog did not see a fall. Dogs have keen, wide peripheral vision and sometimes can mark well with only a glimpse. If a dog lines a bird you think he may not have seen, he should probably get the benefit of the doubt, especially the first time.

A tight, thorough hunt close to the fall area should not necessarily be interrupted by handling. "The dog is being tested for its marking ability and memory..." When scenting conditions are difficult or cover is heavy, we want to regard dogs that confidently stay in the area. In fact, a dog that hunts an area for a short time and then begins to leave the area to switch to another fall may be on the verge of failing the test. This dog should be handled back to the bird, but this may leave doubt in the judges' minds about the dog's marking ability. In this case, the judges might make a small deduction, but also note that they should look for "repeated evidence."

Don't set tests up that encourage or require handling if you can avoid it. For example, suppose you want to run a blind with Senior marks and the wind off the blind is blowing near one of the falls. Plant the blind after the dog has picked up the marks so that handlers aren't forced to handle a dog that is only slightly away from a mark because he can wind the blind.

Tight water marks where the wind is making birds drift could also turn your marks into a handling test. If a dog goes directly



to the place where the mark fell, he may be a good marker who would work out the drifting, but if he drives a little deeper and winds another bird that has drifted near this area he has "switched marks." In an extreme case this test might be unfair, and in the many gray areas between it encourages a handler to take a deduction for handling rather than risk a switch to a drifted bird.

How "crisp" is crisp enough? Sloppy handling should not be rewarded, but we are talking about handling on marks and NAHRA has blind retrieves to evaluate handling. A dog working a mark might give a cast refusal, yet be controlled and then cleanly handled to the bird. The rule book refers to a "crisp cast," singular, but it does not say that the dog may only be handled once, nor does it say one cast refusal is automatically an elimination. The rules do say that repeated evidence of lack of control may be grounds for elimination.

We have heard judges say, "If you put the whistle in your mouth, you start at a 7 in my book and go down from there." This is not a NAHRA rule, but we can also not give you a simple formula to score the marking tests when handling is involved. Some judges have very methodical scoring systems, deducting half a point for each occurrence of this and a point for each occurrence of that, but fair application of these systems also requires experience. For example, a dog in running water on a windy day may actually not hear a whistle, so judgement is required to know whether to apply a penalty for a whistle refusal. About all we can do beyond the discussion above is to repeat Section 4 of the Senior and Intermediate rules: "A dog may be handled on marked retrieves with voice/whistle/hand signals, if, in the opinion of the handler, the dog cannot find or

has missed the mark. (The dog is being tested for its marking ability and memory, not handling; however, a crisp cast is preferable to a long hunt. Repeated evidence of lack of memory, marking ability or lack of control may be grounds for elimination.)"

What if a dog is handled on more than one mark, say 2 of 3 on a triple? One regional report sought a fixed answer and could not agree amongst themselves. Is this an automatic failure? It's not automatic by rules, but you have to ask whether it is repeated evidence of poor marking. You also have to ask whether your test is encouraging or unnecessarily requiring handling. This situation certainly is not desirable, but what if the 2 casts are single crisp casts of a dog that has gone to the correct area and only missed the bird by a few feet? Or what if the dog has gone to the exact position of the fall, but the bird has drifted?

If your test is designed with the latitude to allow for a drifting bird, heavy cover or poor scenting conditions, you might encourage handlers to allow their dogs to work the problem out and not handle prematurely. Just be careful with your instructions; the best laid plans can fail - wind can change, storms come up...

it being too hot in Nuyawk. But she's starting in heat (Boy, do I know about that!!). Boss and I got the 2 little birds on land. And they were tough!! Three shots right after each other, one right from where I was sitting. Two birds went down. I couldn't leave until Boss said, "READY, BACK!" And I did sniff out where they hid that other bird in the woods, too. The water stuff was fun, 'cause it was warm and I love to swim. Got both ducks real fast. Then I got whistled at a lot and found another duck hidden way across the pond. Those wooden ducks didn't fool me. They were just like Boss and Buddy use for the "real deal." But when they turned me loose in that field with all those neat smells, I lost it.

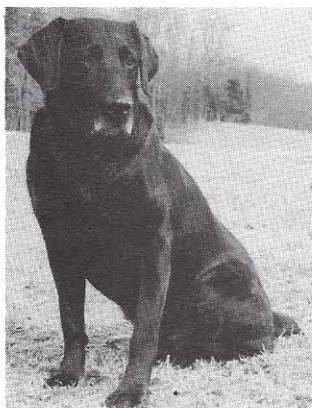

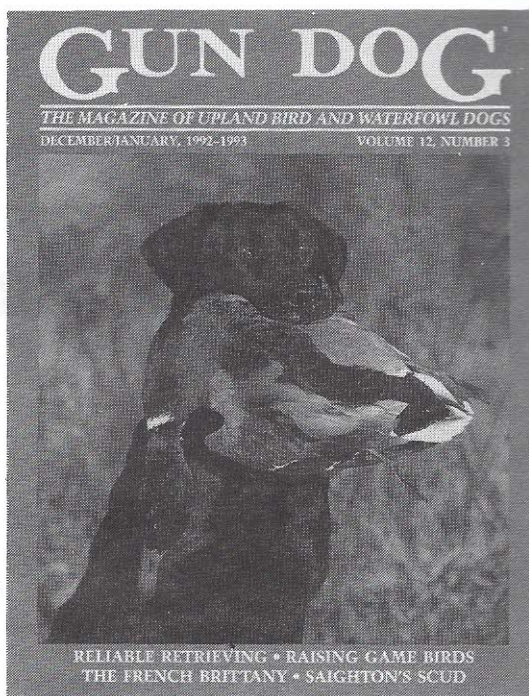

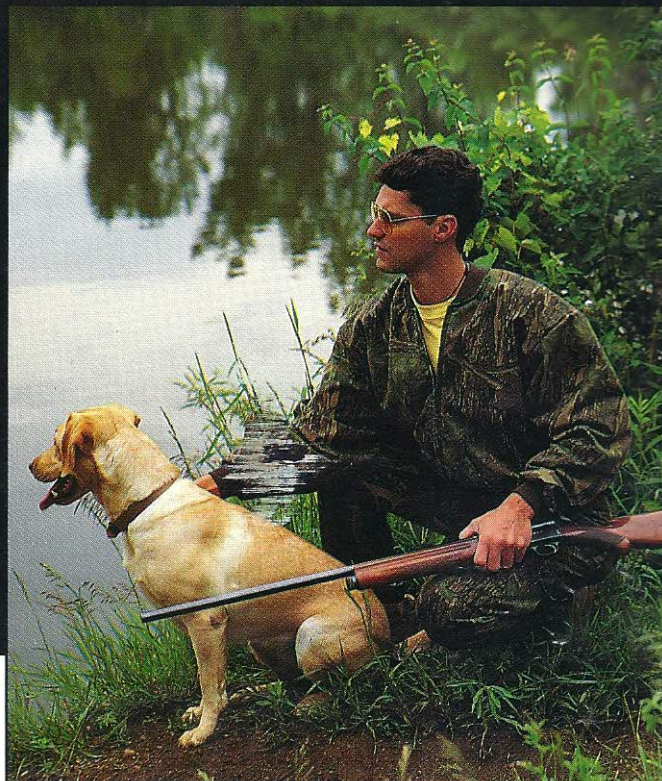
