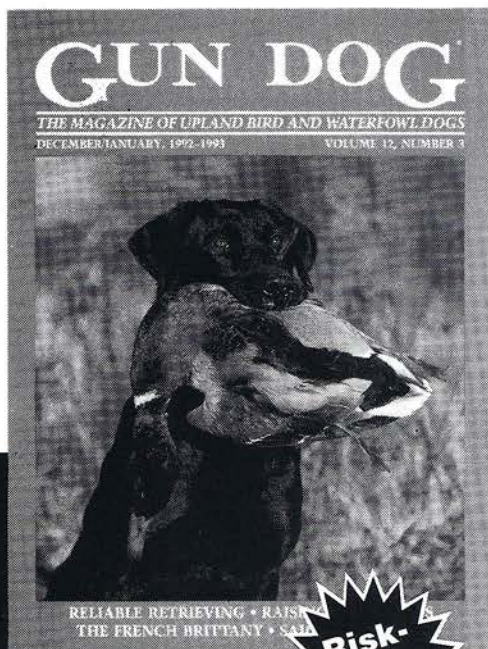

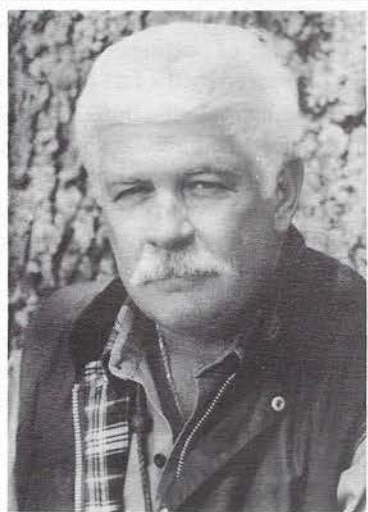

Perhaps the most important request would be to formulate and conduct an annual meeting of regional liaisons. One concept would be to include this meeting as part of the agenda for the annual NAHRA Invitational. If you have specific thoughts please contact your liaison or the International Liaison, Keith Stroyan. I had mentioned to you in the February NEWS that things would be hectic at the NAHRA office with Rosemary having her baby and I asked that you give us a little understanding and consideration. We have gotten behind but are close to being caught up. Thanks for your patience.

By the way, Rachel Haynes was born on March 18, 1994, weighed 7 lbs. 8 1/4 ozs and was 20 inches long. She still isn't house broken but they're working on it. I suggested that they put some newspaper by the back door. Another thought that came to mind was the breeding. They are working on sit, stay and come. The book says

On June 25th, 1994 I participated in a NAHRA hunt test. This was not my first. The purpose of this letter is to commend the two judges for setting up an excellent test. This test was not easy but if the dog

had the ability and the training he had an excellent chance of passing.

I was impressed by the fact they tried to duplicate the natural situation. There was noise just before the bird was shot (not this throw the bird, shoot it, and hope the dog locks in). Just as I would expect of a hunting partner in the field to talk with me. They used the test area they were given in the best possible way. They used two dead ducks and a live duck in the trailing exercise as the day was hot, grass was high and dry and the wind was blowing. They also dragged the birds before every dog. After 6 dogs they went to another area very similar and set up another trail.

It is always difficult to write, create, formulate or set up a test for anything so one can judge the true ability of the person or animal being tested. I would judge these two intermediate judges to be excellent in their abilities to set up a test, run it with reasonable speed (hot day), and leave the field in approximately the same condition that they found it. Their names are Brent Helgeson from Wisconsin and Brian Miller from Minnesota. May I also state I cannot think of anything I would criticize them for.

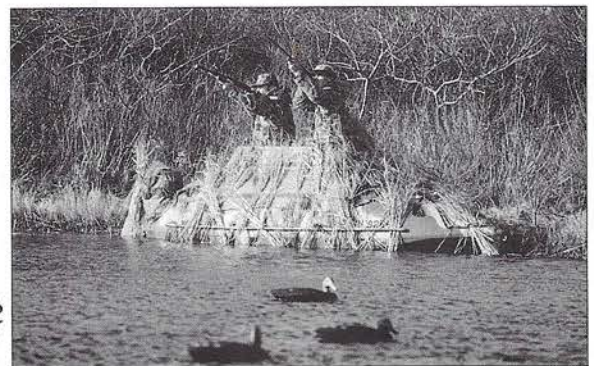

# Veterinary Corner

## Amitraz Toxicosis in a Dog

A spayed female Labrador retriever was admitted for an acute onset of lethargy, which had begun 2 hours before examination. The dog had ingested 2 inches of an acaricide collar containing amitraz (a formamidine pesticide used to control ticks, mites, and other insects on cattle and demodectic mange in dogs) approximately 2.5 hours before the onset of initial clinical signs. The dog had ingested approximately 10 mg of amitraz/kg of body weight.

Physical examination revealed cool, tacky mucous membranes with a capillary refill time of 2.5 seconds. The dog's eyes were mydriatic and had a slow pupillary light reflex. The heart rate was 54 beats/minute with normal sinus rhythm. On palpation, the abdomen was tense, mildly distended, and splinted. Complete blood count and serum biochemical analysis were performed before treating the dog for amitraz toxicosis.

Atropine (0.02 mg/kg IM) was given to reverse bradycardia and syrup of ipecac (1.5 ml/kg PO) was administered to induce vomiting. Because the dog had not vomited 25 minutes after the ipecac was administered, 5 teaspoons of activated charcoal in 100 ml of water was given via stomach tube. About 10 minutes later, the patient vomited approximately 400ml of undigested dry dog food. After another dose of atropine (0.35 mg IM) was given, the dog vomited three more times over a period of 20 minutes. In the last vomitus, small (1-to2-mm) pieces of material resembling the collar were observed. The dog was then treated on an outpatient basis.

The serum biochemical analysis revealed a blood glucose concentration of 218 mg/dl. The next day, the owner reported that the dog had vomited cat food it had gotten into the morning after treatment. Upon reexamination, mild bradycardia (75

beats/minute) was detected in the dog. Atropine (0.35 mg IM) and sodium chloride solution (400 ml of 0.9% SC) were then administered. No abnormal clinical signs were noted in the dog upon examination two days after initial presentation. When examined three days later, the dog had a heart rate of 95 beats/minute and was clinically normal.

In a commentary that follows the article, the commentator notes that yohimbine at 0.1 mg/kg IV is a more effective antidote than atropine for amitraz intoxication. Yohimbine competitively displaces amitraz from  $\alpha$ -2 receptors and reverses bradycardia, hypotension, sedation, and gastrointestinal tract hypomotility.

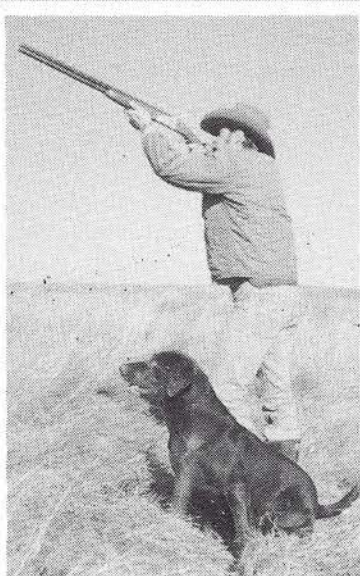

# Training Tips

by Gary Erickson



The following three Training Pyramids will help you visualize what you must teach your dog and the order that it must be done. You must not skip any Box or Tier if you are to be successful with your goal of having a "Finished Dog"

Not all dogs will be able to reach the top. I like to compare gun dogs to athletes. There are grade school athletes, high school athletes, college athletes, and professional athletes. Your dog will eventually fall into one of these categories and progress no further. Your dog won't make it any further because of his/her inherent characteristics or your lack of talent and ability as the coach. All athletes follow a strict training program to get to the top and so must you and your dog.

Some dogs, being the individuals that they are, will progress faster or slower than others. You must learn to know your dog and its weak points. Your dog must be performing what you have already taught it, consistently well, before you add anything new.

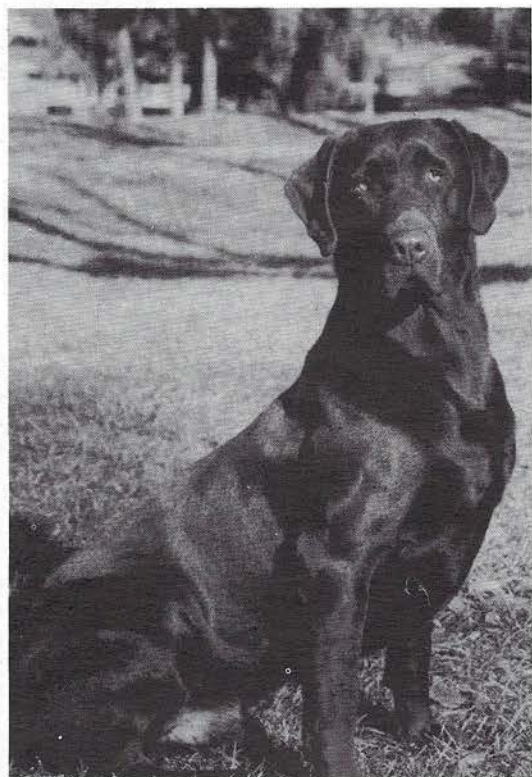
The base for all three "Pyramids" is a good dog. You'll never make it to the

top with anything less than a good dog. It must have all of the proper inherent characteristics to become a "Finished Dog". It must have a good conformation to allow it to perform its physical tasks with ease. The dog must have a good nose and eyes for locating game and possess a tender mouth for carrying it. The dog must search for game with intensity and retrieve with desire. Lastly, the dog must be willing to be trained. If your dog fulfills all of these requirements, you are ready to scale the "Pyramids" and reach each peak.

The term "Finished Dog" is not a true statement. You will never be finished training. When you reach the peak, you must continue to repeat all of the lessons to keep your dog at its level of competence. A dog does not learn in the same manner as humans. They do not retain knowledge the way that we do. The dog does what he does out of instinct and constant repetition. Therefore, you must continue repeating if he is to retain what he has been trained to do.

The "Training Pyramids" show you there is much to do with your dog. If you were to concentrate your efforts on

just one thing at a time, your dog would die of old age before you could get to the top of the pyramids.

The six basic training areas are: obedience, force training (if you so choose), marking, quartering, trailing and blinds. The following is a training schedule so you will understand what and when you should be working your dog on:

#### 7 weeks to 6 months:

Informal Obedience

Upland Hunting (Just getting the dog out in front of you to search for game)

Trailing (getting the dog to concentrate on a particular scent on command)

Simple baseball (handling)

Straight Lines (handling)

Short Marks (marking)

Extending distance (marking)

#### 6 months to 18 months:

Formal Obedience

Force Breaking

Marking doubles and triples

Quartering & stop to flush

Trailing

Blinds (advanced lines and angles)

#### 18 months and up:

Blinds (advanced lines and angles)

Marks (advanced angles and lines as well as multiples)

Formal Obedience and Force Breaking may be done at the same time but should be done in completely different training sessions and the field work should be put on hold for the first four weeks of this training. The Formal Obedience training and Force Breaking will take approximately six to eight weeks to complete if you work hard at it.

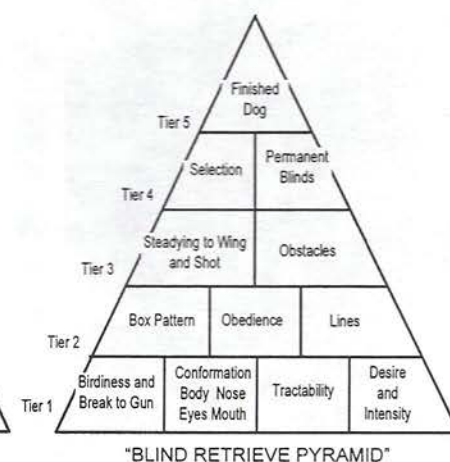
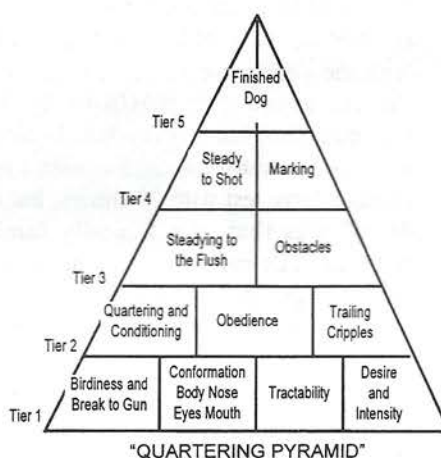
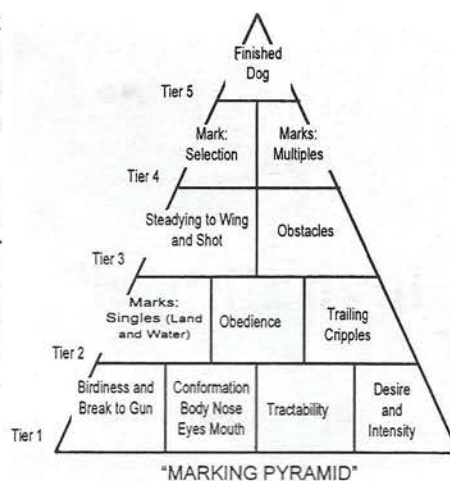
(Approximately four to six ten minute sessions daily for the entire eight week period. One session Obedience, the next session Force Breaking, then Obedience, etc.)

Vary the marking, quartering, blinds and trailing with each training session. Concentrate on one area per session and work the training according to your dog's pace. (The quicker the dog learns, the faster you can progress.)

It may take four weeks to condition your dog to perform 100 yard marks

consistently, but, you may have brought your dog through to the Intermediate level of Quartering and through to the Senior level of Trailing in that same time frame.

You may have to devote more training sessions to your dog's weak areas but you cannot forget the other areas if the dog is to make it to the top in a reasonable amount of time. Be persistent and patient and you and your dog will make it to the top of the training pyramids in but a few years.

## Wing Launcher (Rotary)

The Wing Launcher (Rotary) is a mechanical device designed to simulate a hand thrown bird "MARK" with extreme accuracy.

It's a judges's best friend. No more (NO BIRD) caused by low bowling ball throws or skyers, straight up or birds falling behind the bird boys. The launcher can consistently place birds within a six foot diameter up to sixty plus yards away. All dogs in the test or trial see and get exactly the same arc and fall "MARK".

It's a dream come true for the owner/handler, amateur or pro trainer. Training with the Wing Launcher will enhance your dog's marking. He gets a good look at the bird because its in the air longer due to the consistent arc and fall. He learns to mark the fall of the bird and not the bird boy station. His attitude and interest are greatly perked up because the wing launcher makes a dead bird look just like a shot flier. Speaking of shot fliers, it's awesome——!!! It will consistently place a bird up and out where the gunners should not miss and makes the test, trial or training more consistent and realistic.

The Wing Launcher Rotary is a two piece assembly weighing only fifty-one pounds. It is easily carried and stored. You can set it up and throw a bird to a designated spot within a couple of minutes. The rotating yoke allows you to throw a bird in a full 360 degree circle.

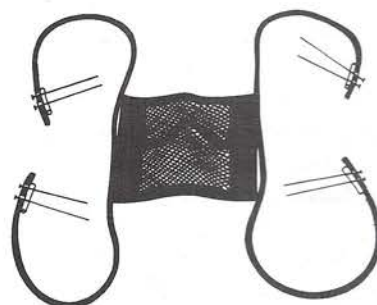

# Hunting Doves

by John W. Scanlon, M.D.



The dozen or so gentlemen in attendance represented the small rural town's social, religious, professional and economic life. Several small businessmen, a lawyer, two farmers, one physician, a real estate speculator and a clergyman vigorously discussed their active participation in the local propagation and harvesting of the American Mourning Dove. This was the immediate preseason meeting of a dove club. They were planning the best time to cut sunflowers on specific farms, how many birds were now located in which fields and just who would attend the various planned hunts. They were also debating personal qualities of several newly proposed members and the merits (or their lack) of recent hunting regulations. It was a spirited, democratic and vocal meeting. Although the club's vowed missions seems to conflict, both to preserve and to kill, such dual focus is at the very heart of a hunter's philosophy. One major anthropological junction in Homo sapien evolution is well described as the transition from hunter-gatherer (perhaps even scavenger) to stockman-farmer. It is only logical to assume that more than one foot-sore, injured, frustrated primitive human hunter

must have realized that conserving, even domesticating prey would remove much of the capriciousness involved in regularly obtaining food. No doubt the hunter-as-conservationist sprang from such early recognition. Shooting the Mourning Dove epitomizes this philosophical dichotomy today.

The Mourning Dove's not very distant relative, the American Passenger Pigeon, became extinct due to savage overhunting and from loss of its unique habitat requirement. Passenger Pigeons needed to have dense, virgin forests to breed in giant flocks. Americans, hell-bent on Westward migration, felled trees and levelled the forest primeval. Gunners annihilated survivors. Yet the Mourning Dove has thrived in its association with Americans. It has spread its numbers throughout the continental United States, extending in range even to the southern tip of Alaska. Doves are harvested in astonishing numbers each Fall. Estimates are that 25-30 million birds fall annually to American gunners. The Mourning Dove clearly adapts well to changing habitat unlike the Passenger Pigeon. Doves are equally at home in a suburban backyard, in a recently cut sunflower field or roosting in dense woods. They eat most all grain crops, many insects and will mob your home bird feeder. They may take their digestive gravel at interstate roadsides or on suburban shopping centers.

Doves are often the first bird to be hunted by newcomers to the blood sports. A dove shoot is a distinctly social event. Experienced hunters bring their less seasoned friends for a few hours afield followed by a tailgate party and lots of loud talk. It's a great way to introduce puppies to the excitement of retrieving real birds. Hunting other game birds usually requires stealth, quiet and infinite patience. Dove hunting demands only enough shooters to keep birds moving over a sufficiently wide area to provide sport and a full game bag. The beginning hunter soon realizes that the dove's darting, diving, and twisting aerial maneuvers make for difficult shooting. This pigeon is no patsy!

The adult Mourning Dove is a sleek bird possessing a subtle beauty. The bluish-gray crown on its head gives way to an iridescent olive brown which merges into buff colored cheeks and neck. The dove's back and rump are a deep olive brown and its under parts blue-gray, like its wings. Mourning Doves have a slender black bill and handsome brown eyes. Their

feet and legs are Chinese red. Outer tail feather edges are white and flash when the dove flushes from ground or roost. The dove's soft, cooing sound resembles the lowing sobs of one bereaved; hence Mourning dove.

Doves are monogamous and mate for life. They seem to act affectionately toward each other, billing and cooing frequently. During breeding, males perform a courtship display which rivals the Peacock in everything but size. With fantail spread, this strutting, puffed up little dandy is a sight to behold!

Female Mourning Doves usually lay just two eggs, rarely more. Both male and female take turns incubating them. Just before hatchlings appear, both parents start producing a remarkable secretion in their crops called "pigeon's milk". This white, cheesy high calorie, protein rich material is squirted directly into the nestling's throat during the first eight to ten days of its life. Gradually insects, seeds and other grown-up dove food get mixed in this "milk" until the chicks are able to feed on their own. Flight takes place at two weeks of age and the offsprings become independent. Doves may brood twice, even three times, each season. They are quite prolific and will nest most anywhere, but seem to prefer evergreens. Doves are migratory, moving north in the Spring to breed, then south in the Fall when cold weather reduces food and water availability.

Why do grown men take so seriously hunting a small bird who weighs, at most, five ounces? There are, of course, the social aspects and abundant challenges in the gunning. Doves are tasty and can be prepared in a large number of scrumptious ways. Also the logistics of planning dove shoots for upwards of 20 people can be a stimulating endeavor. But I think the enthusiasm for dove hunting is really more a growing excitement that another Autumn is arriving with its affirmation of nature's bounty and the seasonal movement of her creatures. This heady notion happily brings together people from diverse backgrounds to wonder about the miracles of harvest and migration. Quite a feat for one little bird!

## Sunday, May 8:

Handlers arrived at the Holiday Inn in Culpeper, Virginia. A meeting room was reserved for handlers to gather and renew old acquaintances and make new friends.

## Monday, May 9:

Handler orientation began at 8:00 A.M. Vests, hats and handler packages were distributed to all participants. A financial projection which included relative costs for the Invitational was also handed out. Judges were introduced and gave a brief statement as to their expectations of handlers and dogs. Handlers traveled to the training area at Shady Grove Shooting Preserve in Remington for a casual training session and acclimation. At 6:00 P.M. handlers and guests attended the recognition banquet and auction held at the Willow Grove Inn. It was a festive occasion in honor of Richard A. Wolters. Mike Jackson, former Invitational handler, was the auctioneer. Special prints, decoys, hunting and fishing trips were among the many items included in the auction. A remarked print of Tar Babies First Swim by local artist John Shaw was the last item on the list. It sold for \$2,400 to TREBARK camo creator, Jim Crumley and his wife Sheri.

## Tuesday, May 10:

The Invitational Field Test began with triple land marks and blind down the middle. The center bird was slightly indented and close to the left hand flier station. Some dogs had difficulty pulling up on the center bird and had to be handled.

## Wednesday, May 11:

The testing continued with the trailing test. Handlers were transported a few at a time along the edge of a huge open field. A drag trail was laid for approximately 20 yards and a live pheasant released. The birds cooperated and ran offering a spectacular series and some terrific trailing by the participants. The testing ended early and handlers returned to Shady Grove for a picnic including a bumper toss competition and greased pig chase.

## Thursday, May 12:

Testing continued at Shady Grove Shooting Preserve with the upland hunting. Handlers and dogs hunted in a double brace with each dog and handler hunting down opposite sides of a long narrow field with varied cover. Release traps were placed at the end of the field offering each dog a pheasant flush and honor situation.

## Friday, May 13:

The Invitational test moved to Mountain Run Kennels in Culpeper, Virginia. Mountain Run is owned by veteran field trialer and trainer Jane Kelso. The venue offered a series of spectacular water areas with unlimited possibilities. A water blind with a poison bird was the next test. Most of the work was very good considering the poison bird and angle entry into the pond.

## Saturday, May 14:

The final test was a water triple with a high shot flier on the right hand side as the last bird down. The flier was launched by a "Winger" - a mechanical device resembling a slingshot. It provided precision placement of each bird. The marks were straight forward with clearly defined fall areas through decoys past small islands. The dog work for the final series was spectacular adding a feeling of exuberance to the grand finale. Fifty-five dogs qualified at the 1994 Invitational Field Test in Virginia. The awards presentation followed the testing on Saturday afternoon.

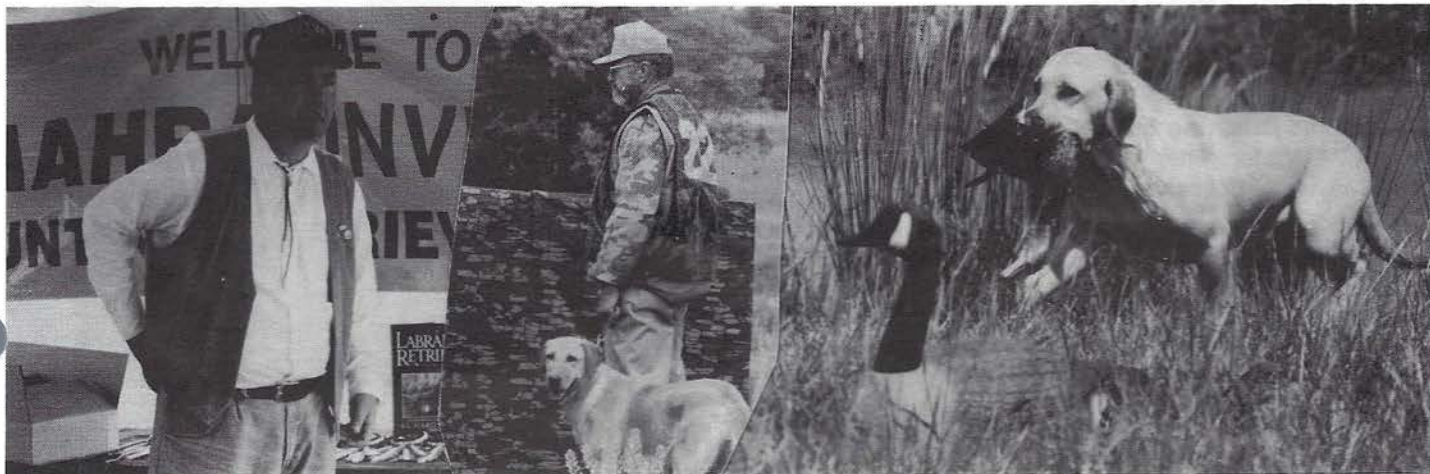

The definition of a switch on marks relies on two important concepts "the area of the fall" and the notion of "establishing a hunt". These ingredients are present in the definition found in the NAHRA rule book on page 22, Section 24:

Any dog that goes to the area of a fallen bird during a marking test, establishes a hunt, leaves ("switches") and retrieves another bird or returns to an old fall and establishes a hunt shall be eliminated.

A complete understanding of the concept of the "fall area" as discussed in the rules on page 41 paragraph 4 is extremely important:

What precisely constitutes the "area of the fall" defies uniformity of definition from test to test, yet, at the outset of each test, each judge must arbitrarily define its hypothetical boundaries for himself, and for each bird in that test, so that he can judge whether dogs have remained within his own concept of the "area of the fall", as well as how far the dog has wandered away from "the area" and how much cover has been disturbed unnecessarily. In determining these arbitrary and hypothetical boundaries of the "area of the fall", due consideration must be given to various factors: (1) the type, height and uniformity of the cover, (2) lighting conditions, (3) direction of prevailing wind and its intensity, (4) distance to the "mark", (5) the speed of individual dogs, (6) whether there is a change of cover (as from stubble to plowed ground, or ripe alfalfa, or to machine picked corn, etc.) or whether the "fall" is beyond a hedge, across a road, or over a ditch, etc., and finally and the most important, (7) whether one is establishing the "area of the fall" for a single retrieve, or for the first bird a dog goes for in multiple marks, or for the second or third bird since each of these should differ from the others.

In general, the "area of the fall" for a first retrieve in a "double" should be smaller than for the second bird since each of these should differ from the others.

In general, the "area of the fall" for a first retrieve in a "double" should be smaller than for the second bird, and both of these should be larger in "triple" and larger still for the third bird in it. Also, "the area" for short retrieves should certainly be smaller than for longer retrieves.

Once we establish the fall areas for the test that we are judging we can begin to judge the dog work on our test. To determine if a dog has switched during the test we need to define another term which appears in the definition of a switch. What do we mean when we say that a dog "establishes a hunt"?

### RULE BOOK

A dog establishes a hunt when he begins a methodical or random search of an area. If this hunt takes place outside of our established fall area then we generally begin to mark a dog down but we are not concerned about a switch at this time. But if the dog enters our fall area and continues his search or goes directly to the fall area and begins the search then we can anticipate the possibility of a switch. Once the dog establishes a hunt in a fall area he must complete the retrieve of that bird before entering and hunting within any other fall area.

### JUDGES' QUIZ ON SWITCHING

(1) In a multiple marking test the judges have discussed the fall areas. Several dogs run the test with good results, but as the current dog takes his line to the last bird down he can't seem to decide which bird to take first. He passes the closer mark (first bird down) gets wind of the bird and runs into the fall area, slows briefly, but then decides that he knows where the last bird down is and continues on to make a short hunt and retrieves the last bird down. This is a switch. TRUE or FALSE

(2) After delivering his first bird, the dog in question (1) is sent for the remaining bird (first bird down). He enters the fall area, hunts the area but is unable to come up with the bird. He expands his search until he is near the old fall and remembers that there was a bird in that area and begins to hunt the old fall area, he is handled back into the fall still containing a bird, is handled to the bird and makes the retrieve. This is a switch. TRUE or FALSE.

(3) A bird that lands in the water with a splash which is clearly visible to the dog must have a fall area entirely of water. TRUE or FALSE.

(4) A bird thrown on land with the dog's view of the fall unrestricted must have a fall area entirely on land. TRUE or FALSE.

### OPINION QUESTIONS ON SWITCHING

(1) Can two fall areas overlap, and if they can how would you judge a dog that established a hunt in both areas prior to retrieving one of the birds.

### ANSWERS TO THE QUIZ.

(1) TRUE, this is a switch on marks PROVIDED the dog "slows" enough to truly establish a hunt. It is NOT necessarily a switch if the dog looks toward the bird or perhaps even veers slightly toward the bird, but truly does not establish a hunt for the bird. Simply running through a fall area does NOT constitute "establishing a hunt," but having the dog veer toward the bird and slow slightly could make for a difficult judgement call.

(2) TRUE, this is a switch if the handler allows the dog to establish a hunt in the old fall. It is certainly permissible to handle a dog that is about to switch without elimination, but it is not passing work if the dog first clearly switches, establishes a hunt in the wrong area and only then is handled back to the correct bird.

Again, this scenario can sometimes create difficult judgement calls. A dog that appears to give up his hunt has committed a very serious fault.

(3) FALSE, a fall in cover near the edge of water with the wind ashore certainly has an area including land.

(4) FALSE, a fall on land near water might well include water in its area of fall.

(5) TRUE, the type of cover, including transitions from land to water must be taken into account when determining the area of the fall.

## Horseshoe Hunting Retriever Club - Nahra's 1st Base in Ontario.

What a job she did: baking dozens of cookies; cleaning out the hospitality trailer from the mess it was in; shopping for snacks, sandwiches, and sodas for the workers and judges. Then Steve got to work on the equipment. One of his happy discoveries was that the trailer had no lights. He began to rig up the lights and discovered that the wiring on the trailer had a big gap in it. Frustrated, he set about to fix the whole thing before hauling it to Estrella Ranch on Friday morning. He had worked several days before the test with Sharon. They both worked all day Friday. Steve came back to work at the Judges' Clinic. Then on Saturday morning bright and early they both showed up very early to get things started by checking in the guests and handlers. By Saturday night they were so tired that all they could do was gather about \$1,500 in sales and help us get the awards event off and running. After cleaning up Saturday night they grabbed a little sleep before busting in to the Test site. We had no beans for the Sunday lunch so Sharon whipped up a batch of delicious beans on Saturday night-after the day at the test-brought them to the hospitality trailer on Sunday morning and began checking people in for the club test. Steve had asked me to bring an extra gun so he could help with the work so after a while when things settled down a bit off he went to throw birds and help with the tests. Then it was time to fold up the camp and get ready to clean up. Sharon worked at that while Steve went off to shoot or throw or whatever was needed. She drove one pickup load home to begin the big clean up. Steve hauled the trailer with his Pathfinder. So then it's over, right? Wrong!!! Now it's time to unload the trucks and get things put back in place. So now it's all over, right? Wrong!!! Steve and Tim Booth have agreed to go back out to the Estrella Ranch on Monday to finish the clean up and haul the port-a-potty back to town. They did. No wonder it takes so long to recuperate.

This is just one of the stories. There are other: John Wilkins, Tim Booth, J.P. Hoagland, Kathy Pry, Mike McGann; the happy bar-b que trio: Dave Carey, Larry Culver, Herb Connor; another faithful oldie but goodie-Ron Sauls; Jack Jagoda also helped by running a test dog. I might mention that Mr. Jagoda said to me on Friday evening, Warren, if you need me to do anything this week-

end just ask-like throw birds or run errands or anything. He meant it. I think it's great when the number one person in the organization can be so willing to help out. Truly, a fine example of human generosity and willingness to help on whatever level. Bethanie Alderson volunteered to help with the marshalling. I stayed at the hospitality trailer and met with a lot of people including some beginner people. I certainly did not plan to be there with a broken fibula on my fight leg when I took on this responsibility. We also had a place to hold all that activity when we began.

Let's begin to look at next year. A person to step forward to get us going; a place to have the event(s). We have asked for March 11th and 12th in 1995.

It takes a lot of people to put on one of these hunting tests. It takes people like Jim Pry who will call up and say, "I'll do the clean up"; like J.P. Hoagland, "I'll get the birds for you". This is the message we have to get across to our new folks, those running the beginner dogs: the message also is, "If you say you'll do something then do it". If you are not going to follow through then just do the Nancy Reagan thing and say "No"!

We have a wonderful club. We have done a lot for people and for the dogs over the past 10 years. I know that the next 10 years can do a lot also. It can even be a better 10 years for training and testing and hunting and having fun with people and with their dogs.

Good training and testing and hunting to all of you: may your lines be straight and your marks pin pointed with beautiful dogs which have the line manners of Lassie, the courage of Rin Tin Tin, the marking of River Oaks Corky, the stamina of Super Chief, the line ability of a laser beam.

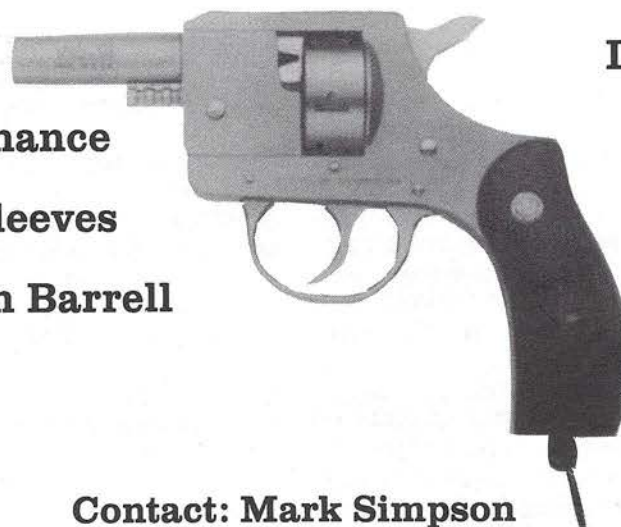

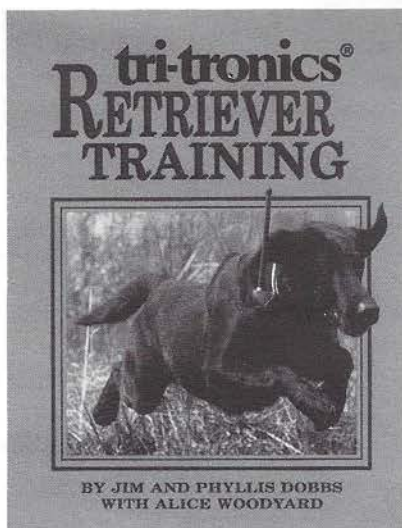

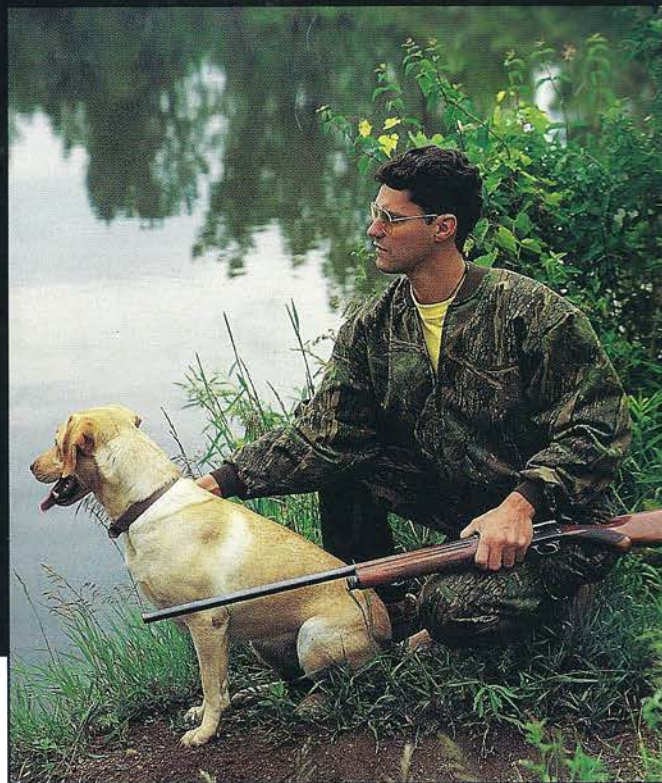
