PRESIDENT'S BARK

1992 will go down in the history of NAHRA as a year of many changes. Some new philosophy and the strengthening of primary concept will be remembered. he Regional Liaison program has helped us to reflect on our infancy. Progression is healthy yet we must always remind ourselves of the origin of our existence. I can remember one weekend in June nine years ago. A small group of hunters met to officially give birth to the North American Hunting Retriever Association (NAHRA). The concept of the non-competitive approach of testing retrievers was introduced by David Follansbee, the associate editor of Gun Dog magazine. David owns Fench Brittany Spaniels and was the only member of the original NAHRA Board that did not own a retriever. We were fortunate to have David; he was a good thinker and not blinded by the traditional approach of running dogs against each other for placements. I must say, however, that each

member of the Board was open minded and focused on one issue - preserving the hunting instincts of the retriever breeds. We weathered a storm of confusion in those early days for bucking 50 years of traditional thinking. It became evident that NAHRA was setting the pace for the competition. We realized that to encourage retriever owners to stay in the game we must create incentives to keep the human faction interested.

We created the NAHRA Invitational to keep the Senior handlers in the game. The less experienced Started and Intermediate handlers were awarded a brass duck band for qualifying four times annually. Later, the Regional Field Test concept was offered as a local alternative to the highly competitive Invitational. Club representatives from across North America have interjected their thoughts and reminded the NAHRA Board of its early direction. With the introduction of the 1991 NAHRA rule book ("Blue Book"), a change was made that directly affected the accumulation of points toward the NAHRA titles Working Retriever (WR) and Master Hunting Retriever (MHR). Prior to 1991 any dog that earned a Working Retriever title (20 points) would only have to earn 80 points to become a Master Hunting Retriever. It seemed like a very small issue, however, the impact was catastrophic. We have reviewed the existing points system and are submitting recommendations for the Regional Committee to review at their next meeting. If all goes well, the following changes will go into effect in 1993.

The Beginner category will inherit the current Started running rules. Any dog that qualifies two times in the Beginner category will receive a certificate of completion. Previous Started points will be grandfathered and count toward the Beginner certificate.

The Started category will carry a title. Once a dog qualifies four times he will be awarded a SR (Started Retriever) title. He will be required to be steady, deliver to hand. The distances will be the same as Intermediate.

Intermediate dogs will still have to qualify four times. If a dog has earned a SR (Started Retriever) title, he will only have to qualify three times in Intermediate to earn his WR title. A land blind will be added to the Intermediate category.

The Senior category will remain the same with five qualifications to earn a MHR title. Any dog that has a WR title will only have to qualify four times to earn the MHR title. We will grandfather Intermediate points from January 1, 1991 to December 31, 1992. Any new MHR will be invited to attend the Invitational regardless of the number of points earned during the year.

GMHR titles will remain the same with 15 Senior qualifications to earn this title. A new recognition "1,000 Club" will be implemented in 1993 for all dogs with 1,000 lifetime Senior points. The dog's photo will appear in the NAHRA NEWS with a short biography.

Your feelings toward the proposed changes should be voiced through your local NAHRA club. If you do not have a club in your area, contact our National Liaison, Randy Carlson, 4l Iris Circle, Beacon, NY 12508.

The NAHRA Invitational will take a slightly different complexion in the years to come. In the past, the responsibility for hosting the Invitational was charged to a single club. This year's Invitational was hosted by the Greater Pacific Northwest Retriever Trial Club with help from NAHRA members throughout the Pacific Northwest region. Dick Weiner was the Chairman of the 1992 Invitational Committee. Dick has agreed to act as chairman of a National Invitational Committee to generate funding and oversee this prestigious event. Eleven individuals from across the NAHRA land have been selected and have accepted the responsibility. A special 1992 Invitational issue of the NEWS will be mailed to all NAHRA members prior to September 1. Tests will be diagrammed and photos and test scenarios will be included. Each year the Invitational Committee will work directly with regional club representatives to ensure a quality event second to none.

The NAHRA pedigree is now available to all NAHRA members. The pedigree will show all NAHRA, AKC and CKC titles reported as of January 1, 1992. (See page 22.) These pedigree certificates may



VETERINARY CORNER

Questions from Our Readers

Q: Can you advise me on any treatment that can help my 10-yearold dog that has already been operated on for hip dysplasia?

A: Arthritic changes in the hip are often the source of pain in animals with hip dysplasia. Treatment to relieve the pain associated with arthritic changes involves moderate restriction of exercise, weight loss to decrease the stress placed on the joints, and aspirin for additional pain relief. Physical therapy or gentle swimming may also help to increase flexibility in the joints. We are not aware of any braces that can be used to help in this condition. A thorough orthopedic examination with X-rays of the hips is necessary if the above conservative measures do not provide relief. The dog may be a candidate for further surgery that would improve the level of com-

Q: We have a porch deck that is reated with chromated copper arsenate. Could this be a health hazard for our dog and cat?

A: Pressure-treated woods contain copper, arsenic, and chromium. There should not be a problem with your dog or cat because the preservative will not penetrate the skin. The levels are low enough so that even if the dog or cat eats some of the wood, it should

not be toxic. Ingestion of the wood should be avoided, however.

O: My dog insists on eating the cat's feces out of the litter box. Is this a possible source of infection?

A: In general, a dog will not get infected with any parasites by eating feces out of the cat litter box. It could perhaps contract the cat's Giardia, but some experts believe cats have their own species of these parasites. Another possibility is Toxoplasma, especially if the feces have aged a few days. However, the dog probably already has a titer, indicating previous exposure, so even if it is infected, it will probably not become ill. Very few other parasites will be cross-transmitted from cat to dog-this is especially true if the litter box is cleaned daily.

Q: Can you give me some information concerning crytorchidism in dogs?

A: Testes are located in the abdomen at birth and descend to the scrotum at approximately 10 days of age. Evidence regarding hormonal influence on testicular descent in dogs is lacking. Although testis descent has been reported to occur as late as four to six months of age, it is reasonable to expect both testes to be palpable within the scrotum by eight weeks of age. If the testes are not in the scrotum

(unilateral or bilateral), a diagnosis of cryptorchidism is warranted. If the testis has not descended by one year of age, it is unlikely to ever descend.

Cryptorchidism is the most common abnormality of sexual development in dogs, occurring in 10 to 13 percent of male dogs presented to small animal clinics, and usually is an isolated abnormality.

Q: Could you tell me just how effective flea collars are, especially against ticks that could be responsible for Lyme disease? Is there any research on how flea collars are tested and evaluated for effectiveness?

A: Chemical flea and tick collars can be thought of as "slow kill" types of pest removal mechanisms. Whether the insecticidal and acaricidal material in the collar kills the pest by translocation over the body surface or by becoming a systemic protection mechanism, the deaths of the attacking fleas and ticks still take several hours (fleas) or days (ticks) under optimal conditions of collar function. Thus, if an owner wants to prevent any fleas from being on a pet or any ticks from attaching to the pet, other forms of protection, such as environmental control and repellents, must be used. If the goal of the collar is to prevent



Wolters Says..

A lot on my mind from under the white hair

By the time you read this we will both know the answer.

I received a phone call from Steve Hakala, of Hampshire Kennels, in Norridgewock, Maine, who specializes in Labs. Here is the story he told me. He has a group of local Labrador folks who were interested in learning how to train their dogs for field work. He got them together and invited a professional trainer to come and demonstrate his training technique. His training methods were so violent that he turned the audience off completely.

Upset with the outcome of the trainer's seminar, but not discouraged, he made the call to me. Through Game Dog he learned about NAHRA and realized that was the way to proceed. He recognized that for these people, as beginning trainers, the collar, forcing and the whip were not the way to start. The NAHRA hunting concept was what he was looking for. My guess is that we will have a young club starting in Maine. And that is what we will know by the time you read this.

This is going to be fun for me because it is just people like this that initiated the idea for NAHRA in the first place some 10 years ago.

We all know these years later that the collar can do fantastic things for the experienced trainer, but to start there can spell disaster and it has a repugnant flavor for the uninformed. So Duck and I will go to Maine and

demonstrate how to train a dog without any force training or the collar and see if we can win them over into our camp and get them training their dogs and start a NAHRA program

The first thing I will do is hand out some issues of the last NAHRA News with Lenda Lee Barker's story on how she trained her dogs using the natural system. It is a good piece and you should go back and reread it. Duck is a fine example of what she says.

First you have to understand that Duck wakes up every monring, someplace on the floor in my bedroom, looks out the window and proclaims, "There is the sun and it just came up for me!" And as the morning wears on and the door bell rings. Duck proclaims, "Someone is here to see me." He is a happy dog like all the dogs I have trained. He is happiest when he works.

Work is his middle name and it has been like that since he was a dozen weeks old. I swear I have him trained to two words and they are as sure as the collar. If I say, "B-A-D" he is crushed. The sun sinks. The world is a horrible place. If I say, "G-O-O-D B-O-Y" he runs in circles around me, head high, showing off whatever he was told to retrieve. It just so happens that he came from Southland Kennels with a drive that is so vibrant that I would hate to take any of his steam out of him as a byproduct of his

learning his job.

Yes, Lenda, you are right. It is a creation to produce such an animal using his natural ability, and our Labs have that built in. Many of the young collar dogs get their MHR before they are 2 years old. Duck got his at 16 months and earned a berth in next year's Invitational at 17 months. Oh, do not think for a moment that he is a faultless machine. That is the excitement about running this dog. He is so quick. Boy, can ge get into trouble fast. He is a marking fool but in the last event he did his land marks, and was one of two dogs called back weak. I would say, hanging in there by the skin of his teeth and tail. In the water work he was the next to last dog to run. He nailed the job! When I walked off line the judge said that it was the best water job he had seen all day . . . not bad with 53 other dogs. He is young and still inconsistent but that is his excitement because whatever he does he does it with outstanding gusto and style. I walked back to the car and could taste the Invitational '93.

The Invitational '93 is already being worked on. Big time worked on. It is going to be hard to beat the 1992 Invitational that Dick Weiner ran in Portland, but I think we are going to do it. The reason we can top it is because Dick Weiner is now the Nation Chairman of our new Invitational Committee. He'll be running this coming Invitational and future ones. What he learned to put on that affair in Portland even he will want to beat with his new-found experience.

Let me give you a little inside stuff. Dan Daily, who owns Mashomack Hunting and Fishing Preserve, the home for the 1993 event, and I walked and drove around the 2,500 acres. These are "his" acres. Dan speaks of them as if God gave him the charge to keep them as He made them. While we examined fields, lakes, and ponds Dan would stop and say, "Richard, look at that view." He has seen it a million times but it is never the same twice to him in all its glory of the four seasons. We saw or flushed every kind of game: quail in the flat valley, grouse in the mountain, geese in the big pond, pheasant in the miles of hedgerow and ducks waddled across the lawn in front of the century old Victorian club house, which sits watching over the big lake ... with bass, trout and sunnies for the kids. Only a b stone's throw from the bustle of New York City, Dan keeps it pristine pure but it is used heavily by the sportsman ... and Dan makes sure to belong to his club that you are a sportsman. You, too, have a charge and a responsibility. No developer will ever touch Dan's world and I consider it a privilege to shoot, run Duck, play sporting clays and just climb to the spot on the side of the mountain where Dan quietly said, almost under his breath, "Someday I would like to build a two room cottage on this spot." He surveys the view of New York's rolling country and added, "But I'll never do

For the sportsman, Mashomack has it all, the finest tower shoots in the country, walk-ups behind dogs as good as England. Holland and Holland designed their Sporting Clay course and send over instructors every year. This was one of the early courses in the country and where the shooting challenge was made between the House of Lords and the U.S. Senate. It is sportsman's paradise with six po. fields, if that might be your game. If New York is the urban social center of America, Mashomack is the "country" social center of the East. Its membership is like Who's Who of the

sporting world. As I write this I watch the time because shortly, I must dress and go to one of their many weekend dinner dances. Four-hundred people will dine under the big tent. It is lobster flown in from Maine tonight and dancing to music from my era to the nonsense of today. It'll have a touch of elegance.

A mile-long field 400 yards wide that sits under Stissing mountain is where you will run your dogs on land in the '93 Invitational. It has a grass knoll along its full length where you can watch and see down on the dog work like from a Greek Amphitheater. Water! Have the judge close his eyes, spin him around ... let him point, open his eyes and that is where the blind can go. And oh yes, bring your shotgun and try for the handler's prize at Sporting Clays.

If your dog does not make it to this event it will be a privilege to come and be part of it as a worker/observer. It will be an event, a holiday to rememer. All social activities will be under the big tent. (And it will be a first for Mashomack ... they have never held a Camo dinner-dance.)

This will be a milestone. We will make a big thing of this. At a table under the giant oak on the lawn outside the Victorian club house, and on the shore of the lake ... NAHRA WAS BORN ... STARTED AT THAT SPOT AT MASHOMACK ... We are going home for our 10th anniversary. Richard Weiner will be running this as a regional event through his national committee. All the Northeast clubs will be hearing from him.

Just recalling those early days of NAHRA can bring tears to the eyes of a working retriever. How naive we were. Those high ideals we had someplace in the back of our heads. The seven men all knew what we wanted and slowly articulated it and finally got it on paper. The final chapter in my new book on the Lab will tell the full story with its defeats and glory, but we survived and have the best program in the country. Our board has been dedicated to the hunter. But we have gorwn, and the byproduct of our success has been a new business for the professional trainer. He and she have helped to bring us a long way. But you, the average guy and gal

with one or two dogs have learned how to train retrievers. Today our dogs are so superior to what they were 10 years ago. But it shall not be forgotten that the basic aim of NAHRA is the hunter. We may have drifted from time to time over the 10 years but be assured that we are back on course.

Ten years ago NAHRA was born under that tree for the hunter's dog and in the 10 years since, I just heard of a story that made the whole thing worth it. I was feeling pretty good because Duck was one of only four dogs that passed the standard in both Senior events that day. I went out to dinner to celebrate with Roy Sheppard and his family, but first we went sightseeing at Niagara Falls. This is the spectacle for lovers and the story I heard I loved. This was Roy's story:

"We always had Labradors but I did not understand their potential until I read the story in Connoisseur magazine. We went out and bought a Zip Code pup from a breeder who would only sell it to us if we promised to train it for the field ... that is what we wanted ... but were not to sure how to go about it. We became friends with Lindy Hochberg and when the new NAHRA was started we joined. My

wife got into it in a big way and started to run Velvet. I was running Missy. Our kids saw all this fun, I liked it, so one by one, they got into the act. Daughter, Kim Mandarino is running Jenny. Her husband, Joe is running Lady. My son, Mark, is running Clancy and a non-registered dog part Lab and part Rottweiler, who has made his Brass Band. When we go to a NAHRA event it's like a family picnic. This game has brought our family very close together because we all do the same thing together. Actually we are three generations running dogs. My grandchildren, Ilena and Lee, ages 9 and 10, run our dogs in Started.

"We run six dogs at every trial and the whole family is working, marshaling, judging, throwing birds. At the regional we qualified five dogs ... five Started All American Team for 1992. That makes a happy family. Last weekend we made four Working Retriever titles.

any flea bites from occurring or to keep any tick from attaching long enough to transmit tick-borne diseases such as Lyme disease, babesiosis, and cytauzoonosis, it will probably not prove successful. Also, the collars seem to be more successful on some animals than on others.

As to whether any research occurs, the answer is yes. Research occurs before the product is approved by the Environmental Protection Agency and is often tested independently after the product is in use for a while, usually from scientific curiosity. How the product is tested and evaluated is a complex matter, involving the phalmaceutical company and the EPA. There are probably very specific guidelines as to what must occur for a product to be approved, and these could be obtained from the EPA.

One last point: Ultrasonic collars have also been tested on numerous occasions and appear not to function as the manufacturer hoped they would. Thus, the above comments deal solely with the collars using chemical means of control.

Q. Are dog biscuits helpful for tartar control?

A: You have a choice of dog biscuits to buy for your dog, but whatever you buy, continue to do so. That's the word from a study in which two kinds of biscuits manufactured by Nabisco Brands, Milk Bone Tartar Control and Milk Bone Regular, were given to two groups of dogs while a third group received no biscuits at all. All the dogs were fed canned dog food in the morning. After nine weeks, both Tartar Control and Regular biscuits (10 per day) had significantly retarde tartar accumulation compared witi. the no biscuit control diet, although the Tartar Control had an edge over the Regular.

The conclusion: Biscuits given as part of a total diet and a dental checkup by a veterinarian make up the best protective program against tartar accumulation and the ills that result, primarily periodontal disease.

TRAINING TIPS

by Gary Erickson



Most hunters turned dog trainers swear and down all they ever want or expect is a Started Certificate and, maybe, someday, a Working Retriever title. However, once they are in the Intermediate, they find that it isn't nearly as difficult as they thought and they begin setting their sights on the Senior.

The problem is that many trainers find themselves in a bit of a dilemma because they have failed to demand more precision from their animal with his early training. The dog usually doesn't go straight out for marks and blinds and/or doesn't immediately comply to commands.

A dog that performs his skills loosely is a dog that qualifies periodically but not consistently in the Intermediate and you'll have nothing but nightmares at the Senior level.

The Senior level is the goal everyone should be shooting for when they start out with a puppy. At the Senior level, the dog is confronted with extreme angles to obstacles and suction like a "Hoover" couldn't even begin to generate. However, the skill areas are exactly the same as the Intermediate level. Marking, blind retrieves, trailing and upland hunting.

You can't make it to the top by restricting your training for each individual catethat you're confronted with or by al-

ing your dog to perform his hunting skills in a sloppy fashion. You must train for the Senior and participate in the other categories as your dog becomes more proficient at his hunting skills and strive for perfection from the time your dog is a Be-

ginner.

The Beginner and Started levels are nothing but marking, but, the upland hunting, trailing, lines and simple baseball should be started when the dog is a Beginner instead of waiting until he has completed the Started category.

Every step in dog training follows a naturally progressive path. You can NEVER put the horse before the cart and be successful at training dogs.

Examples of natural progression:

Marks: Short singles are taught first. Then, you teach the dog to use its eyes to get to the area of the fall and then to use its nose to locate the bird. This is done with "extending" drills as I discussed in Volume IV, Numbers 3 and 4. Once the dog is properly extended, then you start adding a bird for doubles. Then, a third bird for triples but only after your dog has demonstrated his consistency on doubles.

Blinds: Short sight blinds are used first. Then, the dog is extended for distance by running to piles of bumpers or to white markers. At the same time this training is going on you also do sessions teaching the dog its "Overs" and "Backs." (See Volume VI, No. 4 and Volume III, No. 1.) This can all be done while your dog is learning about marks as long as this training is done in separate training sessions.

Upland Hunting: Dogs are started out in small bird fields that are heavily salted with dead birds, wing clipped birds and fly away homers out of traps. As the dog's proficiency at searching and finding birds progresses, you gradually reduce the number of birds in the field and increase the size of the field you are hunting. Then, you teach the dog to stop at the flush with the use of homers and only after the dog performs this task flawlessly do you start shooting flyers on the flush.

Trailing: Trailing is taught by doing short straight line drag trails with the dog on collar and check cord. Every time the dog loses its concentration on the trail and tries to go off in another direction, he is check corded back onto the trail and encouraged to "Find It." Once the dog associates the command with the task of trailing, the trails are made more difficult by lengthening and making turns in them.

This is how training any dog must progress. There are no short cuts!!! Some dogs will learn things faster than other dogs but that's the only thing that reduces the time it takes to train a dog.

There is a lot more to dog training than just going out into a field and throwing a mark here and another one over there and a third one way out there.

WHAT do I want to accomplish with this training exercise?" is the question you should ask yourself on the way out to your training grounds. Are you going to work your dog on obedience, delivery to hand, steadying, single retrieves, singles progressing into doubles, doubles progressing into triples, upland hunting, trailing, lines, handling or combining marks and blinds?

With so many skill acreas to cover, the best advice is to dedicate each day of the week to a particular skill.

Monday do trailing and upland hunting. Tuesday is marks. Wednesday do lines and handling. Thursday is for trailing and upland hunting. Friday is Marks. Saturday is lines and handling. Sunday is a day off.

If you are going to be successful at training a dog or dogs, you must always take a serious look at what you have set up and ask yourself first if it is in the natural progression of things, is your dog ready for this step and then WHY are things set up the way they are.

Exactly what do you wish to accomplish with this exercise and does what you have set up going to accomplish your

goal?

Follow these guidelines: Determine what you want to accomplish. Set up a training exercise that will accomplish your goal. Then, after you have everything set up, ask yourself if this is really going to work. Then and only then do you run your dog and see if you were right.

Hopefully, if you have taken your time and thought things through and paid attention to every detail, your training session will go off as planned and your dog will have learned from the experience and be on his way to the Senior category and the National Invitational.

Fuzzy Brown Dog Makes Double Good



Eastern Iowa Hunting Retriever Association hosted an historic Intermediate Test on Sunday, 21 June 1992 at Palo, Iowa. That same day an AKC Bench Show was being run 15 miles away in Cedar Rapids, Iowa. The history made was by WR-CH Beau's Spirit of Autumn - known as "Ruger," owned by Wayne Trygestad of Edina, Minnesota. Ruger is the first American Water Spaniel to achieve Working Retriever and the first dog to receive NAHRA's new dual achievement certificate. "Ruger" is a confirmation champion and also took best in breed at the Cedar Rapids show on the same day he finished WR. Can you imagine the grooming needed for a show and a field test on the same day?

American Water Spaniels originated in the late 1800's in Wisconsin and are currently the official State Dog. They were first known as "Indian Dogs" and were developed to hunt ducks in Wisconsin's cold water. Water Spaniels are also eager upland hunters for fur and feather, quartering like their spaniel cousins. Their foundation stock includes Irish Water Spaniels, Chesapeake Bay Retrievers, and Curly Coat Retrievers, though lines expressing too much of the appearance of these breeds are faulted.

American Water Spaniels were registered by UKC in 1920, by the Field Dog Stud book in 1938 and by AKC in 1940. They should weigh between 25 and 45 pounds and measure 15 to 18 inches at the shoulder.



Ruger is near the top of the standard at 16 inches and 43 pounds. Ruger is OFA good and has a CERF certificate. His sire is the top confirmation winner, taking #1 on the bench in 1988, '89 and '90. His sire has a NAHRA Started certificate and a working certificate from the American Water Spaniel Club. Ruger's dam is the top produced of confirmation champion American Water Spaniels with seven champions in three litters. She was also the first American Water Spaniel to receive an OFA excellent rating.

Doggone Child Raising

by John W. Scanlon, M.D.



As a Pediatrician, I have been taught a lot about child development. As a father, I have had to learn a great deal of practical stuff about their behavior, too! As a dog owner, I've also learned that modern theories of behavioral development are extensively used to train puppies. Many readers might think that human and canine psychosocial development are far apart. But there are a number of common basic principles. Centuries of experience and folklore about how young animals learn has recently been enhanced by insights gained from careful observations of early human learning experiences using theoretical models of child development. Thus, the scientific framework for understanding knowledge acquisition and the development of appropriate social interaction has been advanced for both dog trainer and parent.


My personal enlightenment about this area has been stimulated by the writings of Richard Wolters and Thomas Quinn. My practical role model has been a gentle, extraordinary trainer of retrievers, Walt Manuel, from Cambridge, Maryland.

For the first 49 days of their lives, puppies have an aversion to any stranger, whether human or canine. Strange sounds, novel sights, even unusual aromas send the newborn puppy clinging tightly to its mother. It is absolutely critical that a puppy maintains close, initmate contact with its own mother during the first crucial seven weeks of life. Indeed, puppies removed before the 49th day may not survive at all. If they do, serious character defects are often noted later on. Weaning takes place during the last part of this period, but mother must still remain in very close contact for optimal development. There a direct parallel for the human circun stance. Not only is the human mother important for biological nurturing, mothers and their infants need close, continued contact during early life to optimalize eventual social behavior and to develop a rich repertoire of verbal and body language communication. Indeed, young infants not maintained in close contact with their mother have been reported to develop problems with non-verbal communication and difficulties with certain kinds of social interaction during the preschool period.

The next puppy phase extends from 7 to 12 weeks. During this time the puppy's curiosity increases. Novel environments and new stimuli can now be handled. Rote (Pavlovian) learning takes place during this period. Indeed, such learning always occurs as pup tries to sort out meaningful signals from the vast flood of new experiences engulfing his world. In the puppy's mind, meaningful experiences are those which ultimately result in food, comfort or physical affection. During this time, puppies can be trained to perform simple tasks such as sitting on command if a sufficiently powerful stimulus is applied on a repeated basis. Just watch pup learn what kitchen cabinet contains the dog biscu Continued on next page

While there is no specific parallel for this epoch in human behavior, the first year of an infant's life has some common ground with the second puppy phase. The yearling human quickly differentiates caretaker from others and can easily make his demands and desires apparent. The vast array of human expression, and the depth of sophisticated human neurological processing, clearly distinguishes man from other animals. Yet the non-specificity of infant learning is readily apparent for baby or puppy.

For the young dog, a third phase emerges at approximately 12 weeks of life. There is a rather sudden, even abrupt, transference of learning from the repeated stimulus to the person who provides that stimulus. The puppy begins to take its cues directly from the trainer, seeking, by sound and eye contact, to learn what to expect. Cues can be reinforced, usually with praise, occasionally by tidbits of food. Such learning is never only confined to formal training exercises. Puppies watch. with a sharp eye, for any hint about what is coming, and what is good or bad. Durng this phase, a dog can be taught a great umber of skills given sufficient time and なのむめのむしのしのしのしのしのし patience. A dog will also learn bad habits at this time too, such as jumping on people who think a tail wagging pup is cute. These folks forget that a large dog's pounce is not fun and can floor you. This is also a time when a dog can be ruined by inconstant or inconsistent training. At this early stage, if a dog is handled carelessly, for example by children, he or she may grow into an undisciplined, wild-running pest. Puppies are fun for children to play with but should not be disciplined by them. Puppies quickly learn the can get away with things from some people, but not from others. Children invariably fall into the first group.

Again, a distinct human epoch for this last puppy phase is not readily apparent. However, preschool or early elementary school time is roughly parallel. Again, consistency in education, socialization and discipline are major ingredients. Lots of love, lots of affection and minimal punishment done only for specific, willful disobedience are essential for success.

Applying such basic dog training principles has resulted in some remarkable canine education. Seeing-eye dogs are now starting their training at two months of age. By nine months they are ready to independently help a blind person. Dogs started this young are also capable of learning those complicated skills involved in hunting, field work, police activities, avalanche search and rescue or other important jobs.

The old rule about one year of a dog's life being equal to seven years of human life counts only for longevity. Physical growth follows a different time table; so does sexual maturation, neurological and behavioral development. The latter follow a very accelerated course when compared with human development.

What lessons can be learned from such canine/human comparisons? There are discrete and identifiable stages in the behavioral development of both. These stages have certain capabilities and limitations which much be appreciated before the next stage can be reached. You can't toilet train a six-month old human baby because its neurological and social development are inadequate for the task. You can't housebreak a puppy before 12 weeks of age for similar reasons. Forcing either to do something not physically or developmentally possible is frustrating for trainer and trainee. Worse, forcing leads to long term problems. Ultimately gentleness and consistency in approach, using lots of affection and minimal physical discipline, as well as maintaining an earnest desire to understand the child's or the puppy's abilities and needs are the most important factors.

FROM THE **NORTH** COUNTRY

One of the most important challenges the NAHRA program has and will continue to face is removing, to the extent possible, subjectivity among judges in interpreting the NAHRA standard and deter-

mining what constitutes qualifying work in the various categories. The NAHRA rule book, if read carefully, goes a long way in eliminating the need for interpretation - most requirements are clearly spelled out. There will always, however, be some subjectivity involved, and further "standardizing the standard" may require another means of getting a centralized message to all judges. Evan and Lee Salmon of Alaska's Peninsula Retriever Association believe that expanded use of judging clinics in such a vehicle.

A commonly heard complaint from those who present and regularly attend NAHRA-sponsored judging clinics is that most folks in attendance are not the ones that really need to be there. Evan and Lee suggest that attendance of at least one such seminar be a requirement for all judges, and holding a card from that point on require attending seminars at least once every other one very third year. Incentive for attending the seminars would include a judging point for the first, and possibly publishing the number of seminars attended alongside the number of tests judged by individual judges in the NAHRA Judges List.

Obviously, this requirement would necessitate a considerable expansion of the current judging clinic program. Several questions would have to be addressed, including: 1) how would the program be administered? 2) how would it be funded? 3) who would present the clinics? 4) how many clinics per region annually would be required to present reasonable opportunity for judges to attend? 5) how long a grace period would be granted to current experienced judges in which to attend the first clinic? Is it an idea whose time has come? The first big stumbling block in my mind is the real dollar cost, but the more important question might not be whether we can afford to but rather whether we can afford not to.

While we're on the subject of judging... a few thoughts published several years ago in this column now seem appropriate to resurrect.

When a Club asks individuals to judge, they are in essence making a basic assumption that these people are competent and will judge dogs fairly. It therefore becomes that Club's responsibility, through their Field Test Committee, to support those judges in the very difficult decisions they have voluntarily agreed to make. These decisions, as specified in our rule book, "... shall be final." The reason the decision-making power is in the hands of the judges is very simple - the system doesn't work if the power is anywhere else. Put the power in the hands of the participants, and it won't be long before the decisions will be nothing but favorable for the most powerful participants. Any action which in any way undermines the decisions you have requested these people to make undermines the very foundation of our program.

The judges are not, as seems to be the opinion of some, "designees" of the Field Test Chair or Committee to be manipulated into conducting tests in ways deemed proper" by the Chair or Committee.

Again, the reason is simple: let that happen and all you'll get is "safe" tests for the folks running the show. The judges have been placed in the hottest of seats, and for volunteering to accept that, they must be given the freedom to conduct the test. The only time a Field Test Committee can and should interfere with the judges' conduct of a test is when an obvious infraction of NAHRA Rules and Regulations is occurring. The most important role that the Field Test Committee plays is making sure that logistics are in place such that the judges have everything possible at their disposal for putting on a good test, not the other way around.

Statistics tell us that an average of two of every three dogs will not qualify in a given category on a given day. That folks, means that the potential pool of unhappy customers is one heck of a lot bigger than the pool of unhappy ones. On whose shirts have you the Clubs emblazoned the big bull's eye? Those two people sitting in the blazing sun or pouring rain all bleeping day, that's who. You've asked these people to, on a given day, decide who gets a Started certificate, a Working, Master or Grand Master Hunting Retriever title, who qualifies for the Regional or the Invitational, and, unfortunately, who doesn't. If you don't believe these people will take these responsibilities seriously, don't ask them to judge. But if you do, you'd better stand behind them, no matter who or how big or how influential or how loud the

complaints from the individual who, through the judges' decision, lands in the unhappy customers' pool.

Speaking of the unhappy customers' pool, one final point. One of the earliest Judge's Newsletters, written several years ago, among several excellent points included the statement that only "bad" tests or judging decisions receive publicity. To that, Rick, I'll add the tests at which neither bad tests nor bad judging are to blame for the publicity, but rather the behavior of individuals who by their experience, knowledge and stature, should know better, but nonetheless berate the judges, the program, and everything and everybody to anyone who'll listen when the decision doesn't go their way. Unfortunately, the more the experience, knowledge and stature that accompanies this behavior, the more the publicity and the more damaging it is to our program since these folks are looked up to. These people know better than anyone that a decent dog will soon collect more camo ribbons than needed to sew a coat, and that Christmas will come early as many or more times than a ribbon gets taken away unfairly. Hey Field Test Committees and Clubs, the next time one of these people performs at your event, invoke Article 12 and send them packing. You'll be doing the program a favor.

Ruger is a real hunting dog, too. He was whelped on Mother's Day, 13 May 1990, and found his first dead goose before he was six months old. He didn't bring that one in, but on last winter's opener, he retrieved a limit in ducks and an 11.5 pound and a 13.5 pound goose. Ruger is also an eager grouse hunter who marks off the gun when his height and the cover conspire against him. Last fall, Wayne winged a grouse at 50+ yards and was ready to give it up for lost. NOT Ruger. He went in the direction of the shot and didn't give up until he had the bird.

The non-competitive, but high standards of NAHRA Field Tests offer owners of every breed of retriever the chance to prove that they've got the right stuff. If I were looking for a pup, one of the less popular breeds like a Flat Coat, a Toller, a Curly Coat, etc., I would want some assur-

ance that they didn't just look like a hunting dog, but really could hunt. Like fish stories, I never heard a hunter that didn't say over the fire that he had a "great" hunting dog. But I've hunted with some of those "great" Labs and wanted to quit early. Apparently, the hunting stories about Ruger are true. I've seen him in NAHRA and so have four teams of Intermediate judges - judges who aren't beholdn' to a breed club or registry.

NAHRA's program offers all the breeds a serious independent measure of hunting retriever work. In a race, a small dog like Ruger wouldn't have much of a chance beating a big greyhoundy looking pooch like my Vico (two times singles race champion of Iowa). If we had to place dogs, one style or size might consistently win over another, as Labs do in the traditional trial game. Speed and size is NOT the name of NAHRA's game - hunting is. Ruger has his own style that is a delight for me to watch. He has confirmation to boot. If you're looking for a small hunting retriever for your cold water duck skiff and occasional grouse hunt, and want something a little different, consider a Ruger pup.



BIG THREAT

The third bird was a flyer which the "guns" finally managed to hit. Actually, they blew the pigeon apart 30 yards from the line and 40 yards form the gallery. A spectator's minicam recorded the event, capturing, in vivid color, the slow descent of both halves. The edited videotape, shown slow motion over solemn background music, found its way to local television. Next thing, hunting tests were protested, access to public game lands lost and a BIG ISSUE ensued!!!

Billie Joe and the Old Pro prepared 12 ducks for the Intermediate water test by rapping each bird's head on the truck's front bumper in full sight of passerbys and bird boys! One of the latter tossed breakfast, ran off and told his mom. Bad, bad P.R.! Mortally wounded birds flopped around the ground like headless chickens, which, neurophysiologically, they were. More negative publicity and some tough questions to be answered by the host club.

A terrible stench emanated from the creek. It was finally traced to 30 decomposing ducks lying in the reeds. Even without their leg bands, it didn't take Perry Mason to figure out where they came from. Health Code citations, bad feelings and bad press were heaped on the local retriever club.

Think these things can't happen? Guess again!

Our hunting retriever movement, in my opinion, is facing its biggest threat to date. This challenge is not insufficient interest, egocentric infighting, organizational turf wars or the current economic recession. It has to do with the way game birds are treated at hunting tests and the growing power of animal rights activists. Fortunately, these terrorists haven't discovered this issue, yet.

What can we, as NAHRA Members, do?

First, practice discretion. Kill birds humanely, and discreetly, completely out of the public's real or potential view. The public includes bird boys and handlers, as well as casual observers.

Second, reexamine the need to shoot live flyers at any stake. "No birds" occur, in part, because a lot of "guns" can't hit the ground with their club donated NAHRA hat. Live ammunition invites accidents. A serious gun-related injury at a test is only a matter of time if live ammo is used. If a flyer is needed, shoot it far off the line and kill the bird cleanly. Use "guns" who know how to shoot. Flyaways and/or dead birds thrown by release trap may be an alternative in the flushing test.

Third, handle dead birds on the line with respect. Don't toss them in a big pile. Put them immediately into sacks and/or out of

Fourth, dispose all dead birds in compliance with local laws and common sense. Don't dump them in the water, in a deserted field, or unbagged in a dumpster.

Fifth, encourage NAHRA, AKC, UKC, and every other hunting test organization to come together and develop guidelines about the humane, senisble way to manage and dispose of gamebirds used for test and training.

If we don't take a leadership role about this NOW, in the future, testers may be facing bumpers, not birds, if tests exist at all.

FIRSTS

There are some things that a person never forgets. Your first date. Your first kiss. Your first car. Your first shotgun. Your first bird. Your first broken heart.

And no one ever forgets their first dog. I'm talking about their first sho' 'nuff working gun dog. A dog that you carefully selected from a reputable breeder. The one that, to the best of your ability, you trained to be your hunting buddy. You watched him grow, develop, and learn. You helped him through his early mistakes and bit your whistles in two when he should have known better. But as you bond, you realize that he is giving you something that few people ever really know - unconditional love.

When you spend some time thinking about it (and my wife says that I spend more than my share), you come to realize that dogs ask very little of their masters. All they want is some good food, a clean place to sleep, a little play time, and the opportunity to do the job that their ancestors did. That is peanuts in comparison to what we ask of our fellow man, and even of ourselves.

There is no yardstick by which you can measure a good-natured, well-trained hunting dog. Whatever their cost, whatever you spend on them during their lives, nothing will amount to what they give in return. Not only do they preserve otherwise unfound game, but they unfailingly do what men seem incapable of on a daily basis, and that is to put their heart and soul in all that they do.

My home is filled with doggie stuff. I would not have it any other way. There are enough prints, posters, and pictures to start a small art gallery. Field test ribbons hang on one wall. Assorted whistles and lanyards of various make and color hang in a corner. Dog books sit on a shelf. These are all in place by choice. My pup, who doubled as an interior decorator, left her own personalized touches without prior consent. Chewed carpet, broom handles, shoe shine brushes, old gloves, et al, are still useable, but they are in somewhat less than new condition. Torn screen wire has been left unrepaired because even at the age of 3 she still relished putting finishing touches on anything I did. Tufts of unvacuumed dog hair lay close to a worn spot next to my recliner. I never asked for any of these additions. Change them? I would not, for they remind me now and always, of a free spirit that cavorted about a house that was as much hers as it is mine.

Two full seasons were far less than I expected to share with my friend. On her first dove shoot she promptly ran out to the first bird down and had an early supper. All of my high hopes came crashing down, but with a little patience and a few more yard lessons, she developed a mouth that was as tender as a prime rib steak. Last fall she delivered five straight doves that were all very much alive. I recall a duck hunt this past fall where she picked up my limit on one mark and two blind retrieves, the last of which was a green wing teal that sits on my book case. Her training paid off, and I got to go home dry instead of soaking wet from chasing crippled birds as in days past. On one of our last outings, I knocked down a quail that fell a full 75 yards away in some thick leaves. I thought that the bird was only crippled and had flown away, but after a short hunt, my dog came prancing up beside me as if to say, "Hey, fellow, look what I found!" A bird that would have otherwise been left to rot and waste went home to the table.

Hunting is a dog's job, and the well bred ones do it with unparalleled splendor. But if the dog lives with you, then you get the best of both worlds. You have not only a faithful companion in the field, but you also have a confidant/babysitter/therapist around the house. My 2-year-old daughter could sit and "read" a book to my buddy, and she was just as eager to listen patiently as I told her about how rotten things have been at the office. Regardless of what I had to give her, she was ever ready to give me a wagging tail, a playful leap, and a lick on the hand as if to say, "It'll be alright. How 'bout a game of fetch?"

Puppies have a way of bringing out the best in you. They can make you believe in magic. And if the truth were told, something magical really does happen between a person and his dog. I see it. I watch it in others. I have had the joy of experiencing it first hand. But I dare not try to explain it. Like a walk through the mountains or a stroll along the beach at sunset, all you can do is take deep breaths, soak it in, and wish that the moment would never go away.

When I bought that first pup, I wanted to teach her all that I could. I wanted her to develop to her full potential. Sadly, she is gone, and I am left with trying to explain to my 2-and-a-half-year-old daughter, where she is. My wife has told her that Jesus needed a good dog. That still has not satisfied her, or her father, but as fledgling parents it was the best we could come up with.

The coming days will find a new pup on the rugs. I debated about the wisdom of diving in again so quickly while the hurt is still so strong, but I know that it is the best decision. I will never forget my first pup. Her joy, desire, and love will always beat loudly in my heart. What she taught me will show through in the dogs that come after her. When she first arrived in our home, I considered myself teacher, instructor, and master. Now, three years later, I realize that I was only the pupil.

THE 1992 MIDWEST REGIONAL

The 1992 Midwest NAHRA Regional Field Test was held on the beautiful grounds of the Minnesota Horse and Hunt Club south of Minneapolis on Saturday June 27, 1992. Twelve Started hunting retrievers and 10 Working Retrievers qualified from their work in 1991. Open entires rounded out the Started stake to 21 dogs and the Intermediate to 29.

Eleven of the regional qualifiers were from Minnesota, six from Manitoba, three from Wisconsin, one from Illinois and one from Iowa. The southern dog and northern dog live 900 miles apart. This is a big sparse region. I don't have the breed and color records, but there were Labs, Goldens and an American Water Spaniel, "Ruger" whose amazing story appears elsewhere in this issue of NAHRA News. A couple of nice Chessies rounded out the open entry. Handlers ranged in age from six to 60. The weather was beautiful to look at, but hot to endure - hard to imagine the two-foot snowstorm there six months before. Sunday the heat was broken with a midwestern thunderstorm that stuck a couple of vehicles in a dirt turned mud road.

After brief opening ceremonies at 8:00 am we were off to the test grounds. Started began with a live flyer pheasant walk up, followed by two pheasant land retrieves. The summer covers was fairly heavy, but the hardest land retrieve was mostly through light cover to an angle line of heavier cover. The last set-up was a flyer duck encountered on the way to our boat blind, where we

called in another duck dropped in decoys.

A special award was offered to the handler who could call better than the judge who ran test dog or make the club call sound something like a duck, whichever came closer. The winner actually played a little melody, but later refused to be identified. The

club kept the prize call for next year.

Intermediate began with a combined series including work from a hay bale blind dubbed "Fort Inman" or "Fort Parnham" depending on who you talked to. Senior used the Fort on Sunday and Vico didn't trust the engineering. Apparently she heard about the quake in California. At least that's what I told the judges about her sneaking around the side for a better look at the last bird down.

The first Intermediate set-up quartered in brace up to Fort Parnham, where one dog retired to a holding area while the other ran a land double. The first bird was a flyer and many dogs had trouble looking for the call on the widely separated second bird. The scenario included outstanding shooting, because after the double, there was a water blind. The quarter, double mark, and water blind concluded the first series, but the scenario kept going. The trail was on the land behind the double where "another bird went down and ran."

The Intermediate water marks were on a different marsh pond and didn't conclude until almost dark. Twenty-nine good working retrievers stay the course for the most part. That makes for a

long day of good work.

The Started and Senior handlers saved some of the delicious chicken, pheasant and duck bar-be-cue for the after dark arrivals, thanks to the kegs of "sauce," A beautifully framed print of the NAHRA's First Lady, GMHR Trieven Thunder Annie, was raffled to support NAHRA's expenses for the Regional. Dark brought with it flocks of Minnesota's state bird, so after a few dozen bites through socks and bug repellant, we retired for the night.

Lake Country Retriever Club did an outstanding job in every respect from a Friday night clinic with Jack Jagoda, to the opening ceremony, to the bar-b-que. As judges in Started, Brian Sparks and I couldn't have asked for better grounds, birds or workers. Not a single flyer was missed. Every time we needed something and turned around to begin to ask, Stephanie Mealman or Paula Crowley was standing there with just the







thing we needed. Stephanie also marshalled Senior on Sunday with charm and precision, including hazard duty in a thunder-storm. Special thanks to her and all the workers.

I judged the Intermediate Regional last year and the Started this year. I enjoy watching the dogs anytime, but the Regionals are special because you get to see almost a year's progress in dogwork. Several new WR's ran the Started Regional, just to celebrate, including Ruger. My Nell couldn't run the Intermediate Regional, because of my judging assignment, but her new 10-month old kennel mate, Kate, got to be test dog. The next day Nell typified the whole spirit of the Regional training progress by finishing her MHR while her older kennel mate, Vico, finished GMHR and Kate got her third Started ribbon. We'll see you at the 1993 Regional!

PACIFIC NORTHWEST REGIONALS 1992

It all began on Friday, June 12 at 7:00 p.m. This is when the Columbia Hunting Retriever Club opened up the hospitality room for all handlers, judges and guests. Here, the handlers were able to pick up their bag of complimentary goodies and receive the programs for the Northwest Regionals. This was the first time they were able to see the running order of dogs.


