




The NAHRA pipeline of information has always amazed me. Current scuttle-butt can be dropped into the member information pipeline, and in a matter of hours it reaches the most remote regions of the NAHRA world. Unfortunately this cryptic messaging service often lends to rumors and ultimately triggers a barrage of phone calls to the NAHRA office. I received a call from Nancy at the NAHRA office informing me that several had contacted people her, asking about new NAHRA regions. As most of you are aware I have been working with the NAHRA regional liaisons through Dave Cannings to improve communication between members and

NAHRA. One of the improvements is to realign regions based on past history and current NAHRA activity. This realignment will begin immediately to allow ample time for election of liaisons, to facilitate and plan regional events for 2001. The final administrative implementation by NAHRA will become effective January 1, 2001.

The 2000 RAW/NAHRA Invitational held in Edmonton. Alberta, Canada was a great success. Thanks to Dave Cannings, Randy Treasure. members of the Alberta Clipper HRC and NAHRA members from the Pacific Northwest. This vear's Invitational was rated one of the best ever by those who attended. Daily updates, complete with photos and test drawings were posted on the NAHRA website and Working Retriever Central. Invitational judges, Ron Samuels, Bonnie Moothart and Bob Clark, presented challenging tests with realistic hunting scenarios. The 2001 Invitational will be held near Des Moines, Iowa, and open to all dogs that meet the qualifying criteria by April 30th, 2001.

Many of you have seen the new Regional Field Test hats with the PetSafe endorsement on the back. Radio Systems, PetSafe division is sponsoring regional and national NAHRA events this year. PetSafe manufactures pet containment systems and a wide variety of electronic training devices distributed by K-Mart, PetSmart, Cabellas and others.



I would like to take this opportunity to thank the organizing committee of the Alberta Clipper Hunting Retriever Association and all the volunteers for a memorable event. A special acknowledgment goes out to the three judges (Ron Samuels, Bonnie Moothart, Bob Clark) who set up fair but challenging tests.

I am pleased to announce the site for the 2001 Richard A. Wolters Invitational will be held in the Midwest Region near Bondurant, IA. Bonnie Moothart and Sandy Zandlo are doing the honors of co-chairing the upcoming event.

Now that my responsibilities have come to a close with regards to chairing the R.A.W 2000, I can focus my attention back on the tasks at hand with the National organization. With the help and support of Jack Jagoda I am pleased to announce two significant changes that will help us move forward as a National organization. In summary the two changes are as follows. First and foremost, effective immediately there is a regional realignment affecting three existing regions and adding two additional regions within the national system. AN INVITATIONAL EXPERIENCE...

Thanks to the very special people in the Alberta Clipper HRA and the RAW 2000 Chairman, Dave Cannings & his crew, I have just completed the most memorable and inspiring and enjoyable NAHRA experience that I have ever had, bar none, (and I have had some GREAT experiences with NAHRA!) Their group got behind Dave from the beginning and put together a most memorable event that was certainly befitting a national showcase. Surrounding the finely tuned testing setup, was a set of "extra curricular events" hosted by the warm & genial folks of ACHRA who created a village of camper trailers near the grounds where one could always retreat for a cold drink, a rousing conversation, or a meal if you were hungry! We were also treated to nightly feasts including a banquet & kickoff raffle and auction at historical Fort Edmonton, a Buffalo burger feed, a roast beef dinner put on by the Wild Rose HRA of Calgary, and a pig roastcomplete with entertainment including music, bands, dog contests (will your dog deliver a hot dog to hand???) And we were led into the first day's test field by a Scotsman in traditional kilt playing bagpipes!

Have you ever been entertained by a judge at a NAHRA test? I cannot say that I have before now! My co-judges were Ron Samuels of Jetersville, Virginia, and Edmonton's own Bob Clark — a stand up comedian in his own right. While Ron & Bob and I meshed very well in our philosophies and commitment to uphold (without exceeding) the standard, we also enjoyed fun and laughter with the handlers and the gallery, thanks to Bob's never ending hilarity and Ron's warm and

congenial sidekick nature.

The tests began on Monday, June 3, a clear day of spring like warmth, with a land triple and blind for 47 dogs. The handlers, committee, judges, and NAHRA's President, Jack Jagoda were escorted into the field by the Scotsman & his bagpipes, giving the moment a very grand and lofty air! The walk up triple was delayed, with the dog looking at another bird falling on his way back from his first retrieve. Dozens of snow geese decoys were scattered over the area, Alberta style, and the dogs handled the challenge with great skill for the most part. The line to the 90 yard blind was down a side hill, between two large bales of hay, up another side hill to a point a scarce 20 yards away from the go bird of the triple. Several dogs in the pack lined

Tuesday July 4 found rain and a

threatening sky that got us a little bit wet, but miraculously moved around us. The upland series were the mode of the day, beginning with a 60 yard trail around the edge of a pond. The trail held up for over 30 of the 42 dogs, before needing to be refreshed. ALL the dogs had great success on the trail, adding up to happy handlers!

After a morning of trailing, the handlers were treated to an Iowa-style pheasant hunt, where the funny looking little gray pheasants (that looked strangely like pigeons) ALWAYS eluded the shot, and flew away! All the dogs quartered adequately, and NOT ONE BROKE. Wow. Tuesday evening found us back at the camp enjoying a feast under the tents, and rain forced postponement of the fireworks ACHRA had procured for the enjoyment of the Americans who were forgetting it was the 4th of July-all bundled up in our flannel shirts and sweatshirts and raincoats!!

Wednesday morning broke rainy but non-threatening, so the water series began on time. It was a wonderful duck hunt set up, with a blind for the handler to hide in, with Fido sitting in front. The first duck downed came from behind, out of nowhere, seemingly, with a lot of quacking and shooting. The second fell 15 yards off a beaver hut behind some sparse dead trees, and the third was picked off as it tried to fly away-and landed about 80 yards back at the end of the pond, in a bay surrounded by water grasses. The blind was also at the back of the pond, between the 2nd and 3rd marks. Slightly over half the field completed the water tests before we broke for the evening entertainment - a wonderful roast beef feast catered by the Wild Rose HRA of Calgary. Some fun and silly dog races were the hilarious entertainment, and the postponed fireworks brightened the night sky for the stalwarts who stayed up late enough for it to finally get dark enough. (Does it EVER get dark in Alberta??)

Thursday morning dawned clear and warm, and a bit more still than Wednesday, so the remaining dogs had less wind help on that beaver hut mark. Judge Bob Clark had the gallery loose and laughin' with his notorious duck hunter pantomime! I can't explain it—You will have to ask someone who was there!! (Are you wishin' that you had been???) A total of 42 dogs ran the test, with 30 completing with qualifying scores.

The Thursday evening pig roast was wonderful, complete with a band for

music and dancing, but the highlight was, of course, the RIBBON CEREMONY, where the judges' results were first made public. The emotion of that ceremony was incredible. Amid whoops of pride and happiness from successful and sometimes surprised handlers, thunderous applause from everyone in attendance, and teary, laughing testimonials from the judges—emerged a kinship forged as a result of our incredible week together.

We left that tent crying happy tears, hugging, promising to stay in touch, signing ribbons and catalogs, posing for photos & just generally thrilled to have been part of the week—handlers and judges alike. Well, you missed a GRAND time if you weren't

Ralph Luedtke had the results posted the next morning on the RAW 2000 website (accessible from the NAHRA website)! My hat is off to Ralph for keeping the website updated every day during the test, in order that our friends and absent owners could keep track of what was happening.

The Midwest Region family of NAHRA folks has its work cut out — topping the Alberta experience will be largely impossible, but we are committed to make it a memorable experience as well. 

Also make a sketch of the tests and figure out what the judges were looking for. Ask the judges what they expect. Keep copies of all the tests your team runs and review and practice the test setups so your team will be familiar with many test concepts.









If All Else Fails...

My dad was a tinkerer. I remember one day when he opened a device that needed assembly-and there was a fancy bordered note included in the box that said: "If All Else Fails, Read the Directions." We chuckled, and Dad stapled it onto the wall in his machine shop. He was the sort of classic male for whom the saying "Real Men Don't Ask Directions" was coined. It seemed he was born just KNOWING how things worked and how they went together. (How I wish he was still alive to share retriever training with Doug & me. Sigh.)

You are clever enough to know where this is going....Yep, whether you are a new handler, an old pro, or a judge (for heaven's sake) you need to have read the NAHRA rulebook! Judges have an obligation to know the rules for the stake they are judging frontwards and backwards, but sometimes they slip up, unfortunately. Handlers--you have the right to have a test presented to you that is within the rules. If something isn't right, say so. Also, as handlers, reading the rulebook will help you to PREPARE adequately for the test, and to have a better understanding of what will keep you and King from getting dropped. So many of your questions can be answered quickly and definitively! There are just too many reasons why we should all review the rulebook each time we run or judge a test. If you need one just contact your regional liaison or the NAHRA office. REAL MEN (& WOMEN) KNOW THE RULES....don'tcha know.







The Saco River Valley Retriever Club held its first licensed field test on June 17, 2000 in Brownfield, Maine.

Not being quite sure what to write for this article, I spent some time reflecting on the different tests I have had the opportunity to participate in, and have often asked myself, "what are the ingredients necessary for a successful NAHRA field test (besides having dogs qualify)?"

The day started out as the hottest of the year with temperatures quickly climbing into the 80's. It was sweltering until late morning when a fast moving, severe thunderstorm front rolled in, delaying testing for approximately one hour due to safety considerations. The rains quickly cooled things off for the dogs, judges and participants, and the rest of the day was picture perfect.

Our test was held a the Brownfield Bog Wildlife Management Area, a pristine, 5,624 acre parcel managed by the Dept. of Inland Fisheries & Wildlife. This parcel consists of mature upland forest, rivers, open water wetlands, fields, and flooded timber. The habitat supports large (deer, bear & moose), and small (beaver, muskrat, & mink) game, as well as woodcock, ruffled

grouse, and snowshoe hare. Of most importance to the readers however, is that the "bog", offers some of the best waterfowl hunting in southern Maine. Everything in the Eastern Flyway has stopped by the "bog".

We were fortunate to have some of the best judges available for our test. All the judges had a wealth of experience running their own dogs as well as being avid waterfowl hunters. Bill Armstrong, and Steve Hakala judged the Started entries. The two land marks were dumped into some nice cover, and the three water marks had it all...current, distance, banks, and cover. 29 dogs ran and 18 qualified. Wesley Reed and Pete Lamere judged the Intermediate entries. The land double featured a live flyer, natural obstacles, and cover, and the water double featured another live flyer and two water entries from a Jon boat. Watching dogs quarter a field loaded with natural scent was truly enjoyable. 12 dogs ran and 6 qualified. Both the Started and the Intermediate tests were challenging, yet fair, in tough cover, and surreal hunting conditions.

We had a very good turnout of family, friends, and club supporters who volunteered throughout the day handling wingers, guns, boats, marshalling, and preparing the evening supper. We couldn't have done it without their efforts!

A special thanks to Granite State (NH), and Yankee Waterfowlers (CT) clubs for the use of their equipment, as well as their expertise in helping us with our first NAHRA event. Thank you to all the participants (and their owners who drove them), who traveled from PA, NY, RI, VT, NH, ME, MA, Ontario, and Nova Scotia, Canadal

Our sponsors and supporters deserve recognition for their assistance with our event as well. Blue Seal Feeds, Limerick Mills Animal Hospital, Pegs Pals & Pets, The Kennel Shop, Home Depot, Dunkin' Donuts, Wooodland Acres Campground, as well as SRVRC club members.

The days' events concluded with a ham supper, award ceremony, raffle (why do the judges always win?), and good conversation with old and new friends. The talk invariably returns to the dogs of course, and we couldn't think of a better way to thank them enough than to plan for and hold another NAHRA test next year. Chelsea's First Retrieve

Chelsea left us last August. She was the senior member of my second generation of Labradors - a Fox-Red (vellow) dog with a weak pedigree and marginal confirmation. I never should have bought that dog, but I had just lost a lab, and had a friend with a litter. Let's just say, it was one of my weaker She was somewhat of a cull with perpetual health problems. However she was blessed with a great nose, and what she lacked in physical ability, she made up for in intelligence and heart. Chelsea earned her Master Hunter at age three and was the retrievenest and birdiest dog I have ever hunted over. Although, her combination of marginal athletic ability and high intelligence resulted in a dog with an interesting character - the canine version of a nerd.

That dog would fetch anything and everything. Our yard was littered with various objects that she amused herself with. She was unrelenting, and no time was spent outdoors without being forced to throw things for her to retrieve. Gardening, lawn mowing, painting, and snow shoveling were all hampered; intermixed with throwing bumpers, sticks, balls and kongs. However, her favorite toy was indisputably a tennis ball. Or, I should say, all tennis balls. She hoarded them, and hid them in every corner of the house and vard, never wanting to be more than a few feet away from one at any time. At any sign of an opportunity to exact a retrieve, Chelsea would execute a sub-second maneuver, resulting with her muzzle in your face with a mouthful of slimy fuzz. Most of her life was spent with the words 'Wilson' or 'Dunlop' visible between her lips.

Retriever training with Chelsea progressed well. She had excellent marking skills, and by ten months, she had progressed beyond pattern retrieves and was handling well with cold blinds inside of 100 yards. I had few opportunities to do live-bird training with Chelsea as a puppy. Although, I had a freezer full of ducks and pheasants that I used to expose her to feathers, and the few training sessions we did with live pigeons and ducks went well. Consequently, when Duck Opener rolled around that fall, I felt confident bringing Chelsea into the field.

We were living in Maine at the time, and I had scouted an isolated grass island in the center of Merrymeeting Bay. I had located a spot that had cover at high tide, yet still had water for decoys when the tide had gone out. While Merrymeeting was no longer the legendary waterfowling Mecca of the thirties and forties, it had a tremendous population of Bluewinged and Greenwinged Teal. I

anticipated there would be plenty of shooting. If I shot well (with the three-bird limit), we would have a short yet action-packed hunt that would grab the interest of a young dog.

Opening Day came, Chelsea and I went out onto the bay at midnight to secure our spot. We slept in the jon-boat until set-up time – it was a beautiful, warm night. An hour before sunrise, the Herter's model 72s went into the water and we were ready for shooting time. It was a gorgeous morning; sunny skies, temps in the fifties and just enough wind to move the decoys. The rest of the hunters on the bay started the season about fifteen minutes early that day. But, I had planned to wait until a few minutes past shooting time in order to be sure the dog would have enough light to mark effectively.

Dozens of Teal had whizzed overhead and several had communed with our decoy spread before I determined there was enough light to take a bird. Needless to say, the dog was very excited at the sight of all the ducks, and was ready to go when she heard her name. At about a quarter past shooting time, a double came through the spread. I missed on the first shot. But, the second trigger pull folded a Bluewinged Teal into the edge of the grass, about thirty yards away.

Chelsea held steady and had obviously marked the fall. When I called her name, she lined perfectly toward the bird. The grass was tall, and I could not see the dog. The top of the reeds moving in her path was my only indicator of how and where she was hunting. She seemed to be working a little wide of the fall. But, I decided to let her hunt rather than call her back. After a few minutes, Chelsea headed back toward the boat at full steam. I was elated at the prospect of her completing her first retrieve in a real hunting situation. When she arrived, she had a look of pride on her face from her wondrous achievement. And, there in her mouth, was a mud-covered tennis ball.

Chelsea did go back to retrieve that Teal, and made two other retrieves that day. Between shots she was absorbed with where I had hidden that tennis ball, which I had dispensed of into the outgoing tide while she was out on a retrieve. Eventually she did come to be more focused on birds than balls. But I know I'll remember that first retrieve even more vividly as it turned out, than had she returned that Bluewing perfectly to hand on her first try.




