



#### The President's Bark



Fellow members,

What a great summer it has been—meeting up with not only existing NAHRA friends but also meeting new people in my travels as a Judge or running tests. I am also having the opportunity to be working with our newest family member a black lab pup (8 months). At this point I'm not convinced whether we are blessed or cursed. We however are truly having fun and I would like to say to Jim and Steve who judged him in his second ever Started event, Guys send me your cleaning bill!!!!

Twenty years ago can you imagine if email existed. The traditionalists would have been typing feverishly to each other. "Can you believe the gall of these seven disengaged who are planning a new concept called North American Hunting Retriever Association? They are actually going to dress in camo and hide behind cover to throw marks and try to simulate hunting situations. Can you believe it, they are not going to have

a winner, and they are going run to a standard. "The Retriever breed is done as we know it, as every dog they run will qualify." I bet the telephone company at the time saw a huge power surge! However, the foresight of seven enabled you and me to participate in a game simulating hunting situations. The foresight of these seven has since been copied. Three other groups offer like programs. NAHRA has been the leader in the working retriever testing program since its conception. We arguably play the game to the best running rules.

Will change continue to happen? It is inevitable. It is the mandate of this administration and the responsibility to be the stewards of the process. There is not one of the Board members who do not take this responsibility seriously. Could we communicate better? Most definitely! As indicated in my last Bark column we have been working on and have implemented a monthly newsletter to try to create a link between the NAHRA Board and the members. The two editions to date have had good feedback and ultimate communication is happening. I would like to take this opportunity to thank all that have taken the time to write in to (nahrafeedback.org). I can tell you that all the comments and suggestions have been read and we have tried to answer as many as have written in. I see positive results and look forward to maintaining this process.

In summary review I would like to pass on to all of you that the Board feels that we are approximately 90 days behind our one-year goals we set at the outset of our administration. As has been

expressed openly we had five key priorities we are concentrating on and expecting to complete within the first year of our administration. Along with completing these priorities we will be sitting down at some time between now and December 31<sup>st</sup> to lay out the plan for both the short and long term objectives of this program.

Another mandate the Board members had at the outset was to travel around to as many regions as possible to talk with the membership. To date we have had exposure to the Northeast, South Central, Rocky Mountain, Southeast and Northwest regions by one or more of the Board members either judging, running or just there for observation and dialogue. I was involved a month ago with a conference call with the Alaska Region as Dave Renkowski their Regional Liaison requested that I participate in the Alaska Regional meeting. I would like to thank the Alaska club members who participated in the conference call for inviting me to discuss NAHRA direction with their region. #### NAHRA Updates By: Jim Vandergiessen

I hope this note finds everyone well and getting ready for the upcoming hunting seasons. It's been a great spring and summer for me. I have been able to get around to a few additional regions to meet more of our members and in some cases have been honored to judge their dogs. It really strikes me how good the Started dogs looked this year. Many are delivering to hand and are completing their marks with precision and enthusiasm. Likewise I find the Intermediate dogs are looking like the working retrievers NAHRA'S founders envisioned.

As many of you have called the office for copies of the rulebook have learned, NAHRA is out of printed rulebooks. We will be printing more in the very near future. This printing will be a bridge to get us though the upcoming Field Test season. The next printing of the rulebook will take place after a complete review of input received by the NAHRA office over the past several years. I would like to invite all NAHRA members and especially NAHRA's judges to take a good look at the rulebook and their past experiences and see what changes could be made to improve it. I don't see this as a great sea change in the NAHRA rules. The rulebook has served us well with relatively little change over the years. I'd like to call your attention to Chapter one Section A of the Rule Book:

"NAHRA's purpose in establishing this concept is to discover and reward dogs that can fulfill the hunter's needs in the field by performing in a manner consistent with the demands of actual hunting conditions. The purpose is not to confront the dog with trick problems, but rather to test the dog's natural ability and acquired training. NAHRA Field Tests utilize duck blinds, numerous decoys, boats, calls and other hunting implements in a manner simulating normal hunting. Under the NAHRA concept, the objective is to recover the bird as quickly and efficiently as possible, to create the least amount of disturbance in the marsh and upland and to give the hunter the maximum amount of time to actually take game."

As we review the rulebook I think it's crucial we keep this section in mind. As our training methods evolve and improve, our dogs' work improves. This is a good thing and the resulting improvements in the dogs' performance in Field Tests should be celebrated. The standard should not be pushed up because we are successful.

If you chose to make recommendations for the rule book I'd ask that you do so in the following format:

- 1. Identify the Chapter, section and paragraph.
- 2. Identify precisely what you think needs amending.
- 3. Provide a brief but concise explanation why you think the changes are needed.
- 4. Include any notes you think are relevant.

If at all possible please make your input electronically to NAHRA by email.


NAHRA will compile all the changes received and merge them into a summarized list of recommendations. A summary of the received recommendations will be made available approximately 90 days after all input is received for member review. Changes to the rulebook will take place after this review based on both the amount of input received in specific areas, and their impact on program as a whole. All input is due by 31 December 2002.





#### LETTER TO THE EDITOR

To the Editor:

The North American Hunting Retriever Association took a very responsible step with the decision to allow NAHRA clubs the option of using dead fowl trainers in hunt tests. Avian influenza has been quite severe in Virginia causing the Virginia State Veterinarian to issue an order that prohibits the public sale and/or exhibit of poultry until further notice. This ruling has affected the state of Virginia's county and state fairs and other events where poultry may exhibited and sold.

More avian influenza viruses have been isolated from ducks than any other species. Waterfowl act as a reservoir of avian influenza by carrying the virus in their intestinal tracts and shedding it in their feces.

Viruses that cause no obvious disease in waterfowl can be highly pathogenic in domestic poultry. Not all states are affected so one has to check with his own state on local prohibitions.

Let's all give our support to NAHRA's decision in this very serious mater.



This was NAHRA's first licensed event using Dokken Deadfowl Trainers, (DFTs). We were very fortunate that we had planned on using DFTs, as we were notified 10 days before the test that our Game permit was denied. This was due to a little a little known regulation, that bans field-testing or trialing in Virginia during the time period of May 31-August 1 using live game birds. On a side note, I was surprised to learn that the pigeon is considered a game bird in VA if they are being used to train or Despite all the controversy and test dogs. confusion that arose from this issue, the dogs did not seem to mind as 42 out of 45 dogs qualified in the 3 levels.

As I reflect back on this year's Regional, several things come to mind I feel make the NAHRA program stand out among the other programs. The first and foremost is the dogs and the work that they do. A Regional is not an average type of test. The dogs that are under judgement are the cream of the crop, so to speak, in their respective divisions. Therefore you would not expect average dog work, and we were not disappointed. As the qualifying percentage would indicate, there was some awesome dog work on some challenging tests.

Secondly, the people of NAHRA make it special. At a typical NAHRA test you have people from all walks of life, many vocations and backgrounds. When it was time to begin the tests, we asked for volunteers to throw the marks. A large percentage of the folks in attendance were willing to take their turn doing some of the work. I have been involved in several organizations in my life. NAHRA is one of, if not the only one, where the majority of the people want to see everyone else succeed.

A great example of NAHRA fellowship was at the Senior water test. The Senior water was the last series of the weekend's activities, and consequently, there was a large group of armchair handlers observing the Senior dogs run. As each



Judging with Lisa DeSilva was a serious event, we both worked hard to put on a challenging, but fair, no tricks Started test. But, I had the most fun with Geordie. Also, Geordie and I feel the same way about NAHRA and what a NAHRA dog is; a hunting dog.

The Central Coast test really lacked for help, but their members worked themselves to death to fill in the vacancies. We had to shuffle handlers and workers in and out. Thankfully at NAHRA tests everyone is patient, understanding and helpful. Everyone always pitches in and helps.

This test has a great tradition after the Saturday tests are over. We all meet at a great grassy and shady spot for a BBQ dinner. After dinner there is the fastest dog competition. The clock starts when the handler lets the dog go and stops when the dog gets to the handler. It is always a fun event, as you never know what the dogs may do. This year we had a few youngsters take off and forgot their mark and go visit the gallery. One dog seemed to really mark the spot the bumper had landed, but when she took off she went in a completely different direction. What was she doing? She ran underneath a truck and started gobbling down a sandwich!

I do have to tell you a funny story. It may seem a little mean spirited in print, but you just have to know the people involved.

This Central Coast test takes place at Camp Roberts, a California National Guard training Area. Usually one just drives through the front gates, no one is there to check you in or out. Well, due to 9-11 they make you stop right inside the gate, fill out paper work and show ID, registration, etc. before letting you drive on through to the test site.

Well, Geordie Wise saw Johnny Walker driving behind him and asked the guys at the desk to
