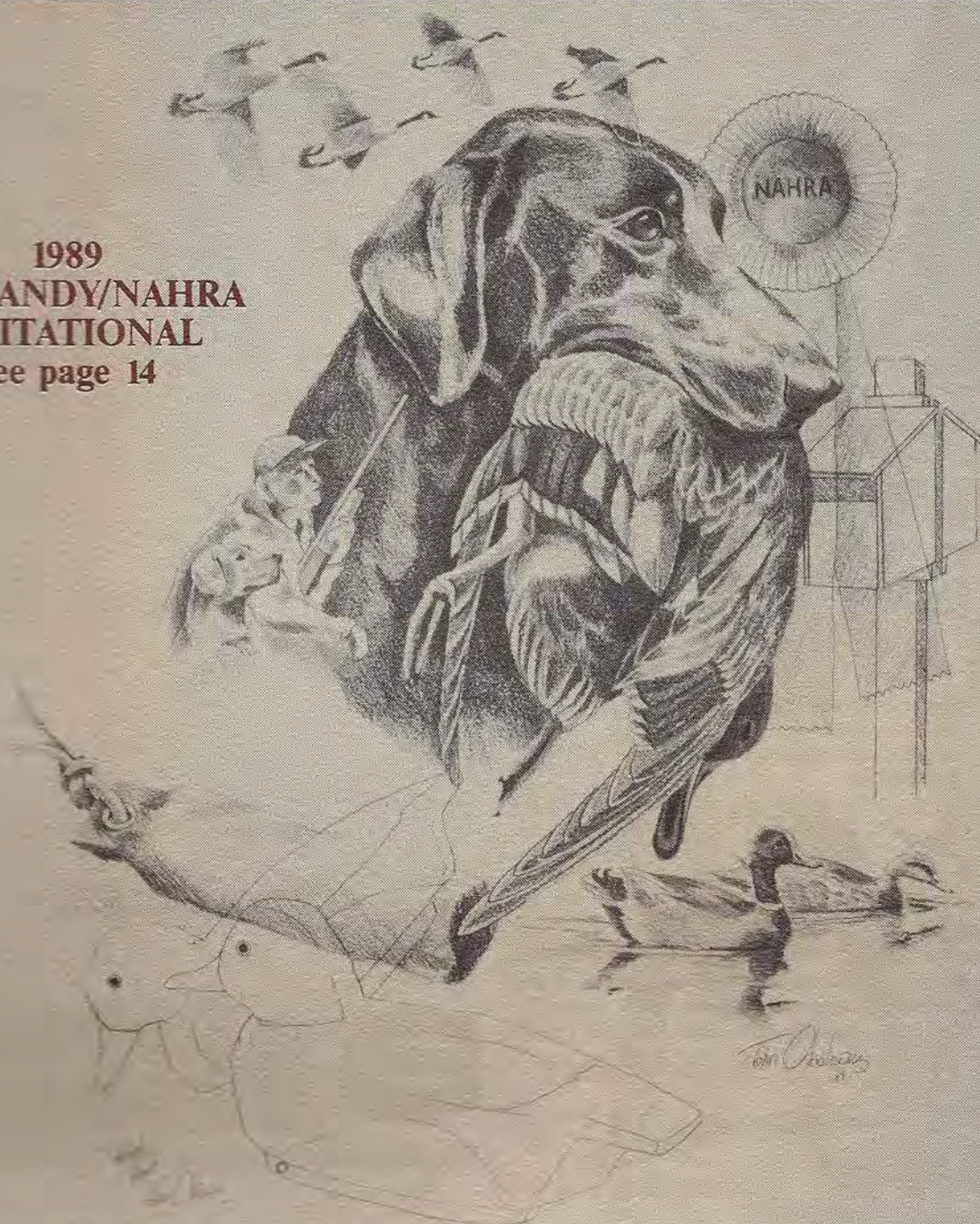

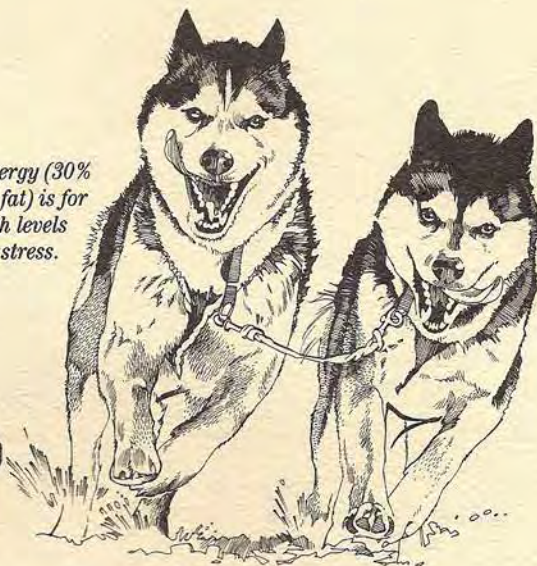

# PRESIDENT'S BARK



Life goes on as usual in the NAHRA world. With well over half of the 1989 field test season behind us the concerns are the same. How many points will it take? There has to be a better way to select dogs. I would have more points if the judges I ran under knew something about dogs. Only two months ago the 1989 Jim Dandy/NAHRA Invitational went down in history as the third annual event to be conducted by NAHRA. Twenty-six dogs qualified and were named to the 1989 NAHRA All-American Team. (See list on page 18.) Jim Dandy Petfoods, Inc., the sponsor of this year's event, went all out to ensure we had what we needed. Dogs were even fed. The Great Southern Hunting Retriever Club worked countless hours to put on a top quality event, it couldn't have been better. Two handlers from Africa competed as guests. Roxie McCormick and Bill Tait made a good showing but admitted that their dogs were not up to snuff after the grueling 24-hour flight. I have seen their dogs in action on their own turf and can vouch for their ability.

New clubs are popping up in some of our outer fringes. The Dallas/Fort Worth

Hunting Retriever Association was formed and has gained considerable growth considering the heat and the length of time it has been in existence. The club has a good nucleus and enthused members. In Alaska, the Interior Alaska Gun Dog Association in Fairbanks and the Midnight Sun Gun Dog Association in Anchorage have recently been formed and have both acquired numerous members. A new club is forming on the Kenai Peninsula with talk of a club in Kodiak. Two requests for club information have been received from Oklahoma as well as interest in Idaho and new club affiliation from an existing retriever club in the Minneapolis/St. Paul area. The Valley of the Sun Hunting Retriever Club in Arizona conducted its first event in August. The Hoggard Hunt Club near Laurinburg, NC will hold an event this fall. The Tri-State Hunting Retriever Club in New York has recently been formed and is considering an event this fall. The Puget Sound Retriever Club in Washington held its first event in July. The Reedy Creek Hunt Club in Virginia held its first event this spring and will host another this fall. The Dorchester Hunting Retriever Club on the fabled Eastern Shore of Maryland held one spring event and will host its first Senior event in November. Pretty impressive growth with a 35% increase in events compared to 1988 and the year hasn't come to an end. Canada is flexing with continued support from our old friends and several requests for new club packages. The Sunpoke Hunting Retriever Club in Fredericton, New Brunswick will hold its first Senior test in September. I'm sure I failed to mention some of the clubs that deserve credit. If so, I apologize but it's becoming hard to keep track of the NAHRA family.

The NAHRA sponsor program is strong but could use additional support. Maybe some of you could fast for a month and send the saving to NAHRA. Annually,

sponsors are entered in a lottery for a Browning shotgun. This year's gun was awarded to Charles and Kathy Jurney of Mooresville, NC.

Wayne Pearson of Outdoor Trail covered the 1989 Invitational and will be airing the program on ESPN, October 28th at 8:00 a.m. (Check your local listings.) A 50-minute tape will also be produced and made available to NAHRA members for \$35. The tape will be available after the ESPN viewing.

Started entries are up in most parts of the country which is a good sign. Considerably more Brass Band Awards have been awarded to Started and Intermediate dogs than last year.

Judges' clinics have been conducted in most heavily concentrated areas and are well attended. Existing judges, especially those with three or more points have been in poor attendance. Much has been learned in the past few years and would be beneficial to those of you in this category. Considerable concern has been voiced by members to require judges to attend clinics periodically or be currently running dogs in the event they are to judge. The same judges appear on the majority of the field test applications that are submitted. We have over 300 judges on the "Judges List," yet a vast number have never been asked to judge.

Let us hear from clubs and individuals. This is your publication and without input we cannot reflect the happenings in your part of the country. If you don't contribute, then don't expect coverage. Perhaps someone from your regional area could summarize activities quarterly and we can publish it in the *NEWS*.

Generally, all is well despite the occasional gripes. Congratulations to all of you earning titles this year and achieving brass bands. The hunting season is upon us and the NAHRA retriever is ready.

# ASK THE DOCTOR

**Q:** My lab is having increased difficulty in marking and finding both birds and dummies. Recently she ran into a post that was right in front of her. She never used to have these problems-any ideas?

**A:** The first thing to do is have your dog's eyes checked by your vet. Both labs and goldens can inherit central progressive retinal atrophy (CPRA) which causes the dog to lose central vision but retain peripheral vision for a while. Consequently the dog will not be able to see objects directly in front of it. Some dogs compensate for awhile by looking to the side and relying on their peripheral vision until they get within scent range.

Unfortunately this disorder is progressive and there is no treatment. Because this is an inherited condition affected dogs or closely related dogs should not be bred.

**Q:** My lab has a broken tooth and my vet says if he doesn't get a root canal he will lose the tooth. How common are root canals in dogs?

**A:** Animal dentistry today is making great strides. Most medium to large cities will have one or more veterinarians equipped to handle those dental problems beyond cleaning, polishing and pulling teeth. Root canals are becoming customary and tooth restoration and gum surgery are increasing with education of practitioners and acceptance of owners.

Doggy dentistry is the number one procedure that most owners neglect. Fre-

quently, professional attention is sought only after the dog's breath is unbearable and periodontal disease is in advanced stages. Certainly, brushing your dog's teeth once or twice a week with a pet dentifrice can help prevent many dental problems as well as reduce the associated risk of heart and kidney disease. However, regular dental examinations by your veterinarian are important.

One other note, chewing bones or retrieving rocks frequently causes broken or badly worn teeth-a big price to pay for fun that could be had by chewing or retrieving more appropriate items.

**Q:** What do you recommend for first aid for cuts?

**A:** First-and foremost-you must control the bleeding. This can be accomplished with hand pressure or, depending on the location of the injury, bandaging. This is an occasion when a first aid kit is really helpful.

Second, you must keep the cut as clean as possible. An item that is useful is a hydroactive gel dressing such as Derma-heal®. A piece can be cut and taped over a small cut to protect it until it can be examined by your vet.

Third, take your dog for a veterinary examination as soon as possible-a wound will become infected within six to eight hours.

### Fetching a New Stake

A new kind of retriever trial is on the way! And it is about time. The hunter is finally going to get what he wants and needs. He has been locked out of field trials except for a crumb thrown to him by the Establishment. There has been no meaningful place for Joe Hunter and his dog in trials as they are run today, but there is a change coming and you readers brought it about by all your unsolicited mail about the Gun Dog Stake. This column is the only way we can respond to your overwhelming number of inquiries.

Dog writers have been clamoring for a meaningful trial for the hunting dog for years. Bill Tarrant of *Field and Stream* has been blasting away for 10 years on this subject, but no one in the field-trial circles paid any attention. Look up Bill Tarrant's column in this year's April issue. He writes with fire in his pen instead of ink. While you are at it, look up Jerome Knap's column in the April issue of *Hunting* magazine; he tears things up a bit too.

There have been a few isolated groups in the country who have taken it upon themselves to do something about it. One group is the Lake Champlain Retriever Club, which has been working on a hunt-  
Gun Dog Stake for about four years. Another group is an association of seven clubs called *Pendelmarva*. I reported on their activities back in the May/June 1982 issue and what a fun day it was. It brought me a big batch of mail; hunters wanted to

know more about the Gun Dog Stake and how they could get involved.

That gave me an idea, so I sat down with Dave Maynard of the Westchester Retriever Club and we made up, off the tops of our heads, a set of rules and regulations for just such an event. We tested them out and published them in this column (Sept./Oct 1982). The response was backbreaking for my postman.

Then Jerry Robinson, the *Sports Afield* dog columnist, went to the Lake Champlain Gun Dog trail and reported it. I judged the event, using the rules that Dave Maynard and I had devised. Bucketfuls of mail from you hunters arrived. We had a wildcat by the tail.

Ray Arnett, the Undersecretary of the Department of the Interior, hearing about this response, got hold of me and said it was up to me to start a national gun dog organization for the hunter. I told him "no way." I made the finest excuses a man could make: I did not have the time . . . I did not have the know-how . . . It wasn't my job. He just kept letting me talk and had a few more "milkshakes" brought to our table.

Then he gave a two-sentence answer to my best arguments: "You writers are all the same. You give us good ideas, then cop out." That shut me up!

I got on the phone and called attorney Ned Spear in Vermont, a member of the Lake Champlain Retriever Club, a very dynamic guy who is devoted to both licensed field trials and the Gun Dog Stake, plus he has been a duck hunter since he was eight years old. We talked it over. I was ready to use Ray's "cop out" answer on him, but instead he enthusiastically agreed to head a committee to look into this idea of a new national organization.

Six people flew into New York in February of 1983, and we had our first meeting. We organized under the name of The North American Hunting Retriever Association. Ned knew how to incorporate and do all those other things lawyers do, so that we are nationwide.

Meanwhile, back at the ranch, the mail kept coming. We had asked for no response from you readers, yet Ned's computer already has in its memory 1,400 of you people who wanted to know more. Forty AKC-licensed field trials clubs sent letters requesting information. Chaos broke out in Ned's law office. Secretaries could not find out how to spell retriever by looking in their law dictionaries.

Ned's postage and phone bills skyrocketed. The purpose of this column is to take the monkey off Ned's back. We feel that although we are not ready to go as yet, we wanted to let you know that mother and child are doing fine—and we love you. When we have hard information, you will receive it.

But we want you to know what is happening. First, we are so sure at this point of what we are doing that we are willing to go out on a limb and make this announcement, even though it is premature.

A second meeting took place in New York (while back in Vermont, a court case of Ned's was postponed). A rules committee started on the nitty-gritty of setting procedures and running rules. A judges' handbook is being started. Believe me when I say that judging will make or break our concept.

We have flown people in from as far as Texas to talk about how other dog groups started their organizations and what the pitfalls were.

There is so much that we cannot tell you at this writing because we do not have certain answers as yet. But this much is sure: even those things we do not yet know will not be able to stop our movement. I am not saying that some of the unanswered items are not important, but I am saying that we have alternatives and cannot make a fair decision until we have all the information.

Here is what we want you to know right now: Those of you who have participated in the Gun Dog Stake at field trials will have to unlearn what you think you know about them. **WE ARE NOT TALKING ABOUT THE GUN DOG STAKE THAT HAS EXISTED FOR THE LAST 30 YEARS.**

To make sure there will be no confusion, we are dropping the name "Gun Dog Stake" and replacing it with *Hunting Retriever Stake*. Our new game will be for the hunter, and the tests will be true hunting situations. This will not be an artificial game. It will be broken down into three groups so that dogs of all abilities can take part. Dogs will not be grouped by age but by ability.

Traditionally, the Gun Dog Stake has been for older dogs who were not trained, and they were required to do little more than puppy work. That will not be so in the Hunting Retriever Stake. If the national field trail champion wants to enter this stake, he can, but he will have to learn to quarter a field as a springer does for upland game and learn to track. He will have to learn to mark falls where no guns or bird throwers will be in view. There will be no more of this bringing a dog to line and showing him where the birds are going to land on being shot—that's not the way we hunt. A lot of old ideas are going to be brought back to the game, and some new ones also.

Eventually, we will hold the stake for championship points and at some time down the road we will declare a National Champion. Don't hold your breath, but it will come.

It's about time we hunters had a system of evaluating the dogs so our breeding programs can be planned instead of hit-and-miss. The hunter too often gets caught up in the showdog breeding because he knows of no other place to go. Most hunters do not even know the guys who hunt in the next county, let alone what dogs they might have to breed.

# TRAINING TIPS

## "Extending Distances for Marks & Blinds"

The greatest difference between trained and untrained dogs is the distance that they will travel to recover a bird. The majority of the so called hunting dogs in this world won't go more than 25 or 30 yards before they drop their head and start searching for the bird with their nose.

Efficient recovery of a marked bird or a blind retrieve occurs when the dog keeps his head up and doesn't use his nose until he is in the area of the bird.

A good score on a "mark" or a "blind" is given when a dog goes directly to the bird, keeping his head up and utilizing his eyes to get there, and then, using his nose to locate the bird.

An untrained dog will drop his head just a few yards off of the point of origin and will start searching for the bird by using his nose long before he gets to the area of the bird.

Too much time is wasted when a dog tries to recover a long fall this way. Crippled birds can sail down 100 or 200 yards away and if the dog has dropped his head at 30 yards to use his nose, he'll never get all of the way out to that bird. The same holds true if the dog is constantly trying to use his nose to locate the bird when you are trying to handle him to the bird via whistle and hand signals (a blind retrieve).

Going long distances to recover a bird (50 or more yards) doesn't come naturally for any dog. A dog must be trained to use his eyes first, ignoring his natural tendency to use his nose until he gets to the area of the bird. This is called "extending". The same approach to extending for distance applies to both marked and blind re-

trieves. The only difference is that, for extending on marks, you need to employ the services of an assistant to throw the birds for you.

It is important that you keep in mind that we are *training* and not testing the dog's ability. I like to begin the extending for distance on a relatively flat field with little or no cover. A football field or large playground is ideal.

If it is marks you are extending, you will need a person to throw for you, five or six bumpers or birds, a hunting vest, your whistles and "Pup" with his leash and collar. (Extending on blind retrieves requires all of the same equipment with the exception of the person to throw for you. Instead of throwing the bumper or bird, you spread them all out in a small circle.)

Place your thrower or bumpers at the far goal line of the football field. Put your hunting vest and whistles on and get "Pup". Let him "air out". ("Airing" is important as the dog won't have anything on his mind but retrieving if he is given the opportunity to relieve himself before the training begins.) When he has finished his business, put the leash and collar on him and walk him at heel to the 10-yard line nearest the thrower or pile of bumpers. Blow your whistle once and make "Pup" sit and stay. Tell him to "Mark" for marks or "Take a line" for blind retrieves. Signal your helper to toss the bumper and send "Pup" for the retrieve. Get the bird or bumper from "Pup" before it hits the ground and put it in your hunting vest.

(It is important that you get the bird or bumper from "Pup" before it hits the ground as we don't want to scent the area short of the mark or pile of bumpers. Your hunting vest should hold all five or six bumpers or birds leaving your hands free to restrain "Pup" or to give him a line.)

Now that "Pup" has executed the first retrieve, go back to the 25-yard line, in a straight line away from the pile of bumpers or from where the mark fell and repeat the exercise. (It is critical that you always back up in a straight line as this forces the dog to retrace his steps eliminating any reason for him to drop his head to hunt as he is going back over familiar ground and scent.)

Now you can back up to the 50-yard line and send him again. (Remember, it is critical that your helper throws the bumper to the same area each time, you always back up in a straight line and you don't let the bumper or bird drop to the ground when the dog delivers it to you! ! ! !)

Back up in a straight line to the 30-yard line that is furthest from the pile of bumpers or the thrower and repeat the mark or the line to the blind. Finally, you back up to the goal line and send "Pup" for one more retrieve.

"Pup" should be running in a straight line the entire 100 yards for the bird or bumper and he should be keeping his head up all of the way. Now, give "Pup" a drink of water and put him up in his crate

for a breather. Keep in mind that "Pup" has just run a total of 510 yards while you walked a total of 180 yards and just stood around waiting for him to do his job.

Twenty minutes have gone by so get "Pup" out and repeat the entire exercise and then quit for the day. Tomorrow come back here and do the same thing over again. The day after tomorrow, you and "Pup" start at the 50-yard line and back up as far as you can go without getting out into the street. (Now I know NAHRA has a maximum test distance of 100 yards, however, just think how easy a 50 or 100-yard mark or blind will be for "Pup" if you can get him extended out to 150 to 200 yards! ! ! !)

After a couple weeks of drilling on the football field, it's time to move to a normal field. Try and find a field that is relatively flat, has light to moderate cover and is a couple of hundred yards long.

Park your car at one end of the field, get your thrower and/or bumpers out, put your whistles and hunting vest on and get "Pup" out of his crate and put him on his leash and collar after he has "aired". Walk to the far end of the field and place your bumpers in a pile or situate your thrower and show him the area you want the bumper to fall each time. Walk "Pup" at heel in a straight line toward your car for about 10 yards, turn and face the area the bumper is to fall in or the pile of bumpers that you laid out. Go through the entire exercise each time moving 15 or 20 yards further away from the "mark" or pile of bumpers.

At any point of origin (the spot "Pup" is sent from), if "Pup" has difficulty going straight and keeping his head up until he gets to the bird either stay right where you are and repeat the retrieve or move up to the last point of origin and send him for the retrieve from there and then quit. You may not make it all of the way back to the car the first few days but keep trying until "Pup" learns what you want and can finally go the distance.

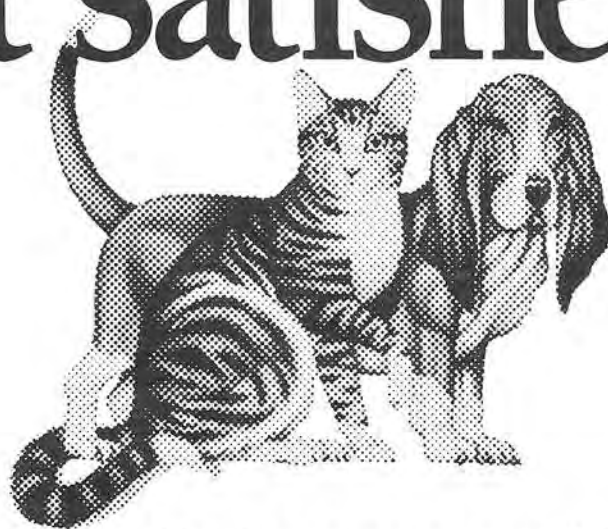
After a few weeks of extending "Pup" for distance, it's time to test "Pup's" ability. Place your thrower out in the field 75 or 100 yards away. Get "Pup" out and let him air. Bring "Pup" to the point of origin for the long mark or blind and let's do it. Don't rerun "Pup" on the same mark once he does it right. Just put him up and set up another mark or blind.

If "Pup" fails to do the job correctly (a straight line with his head up until he gets to the area of the bird), have the thrower toss another bumper and rerun "Pup" from the same point of origin once or twice more. You can plan on spending more time with the extending drill if "Pup" can't get it absolutely perfect after the third trip out.

When "Pup" is consistently going for marks or blinds in this flat field with little cover it's time to move on to water and more challenging fields. I'll be explaining this training in the next issue of the NAHRA NEWS.

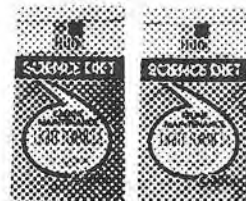

# From The North Country

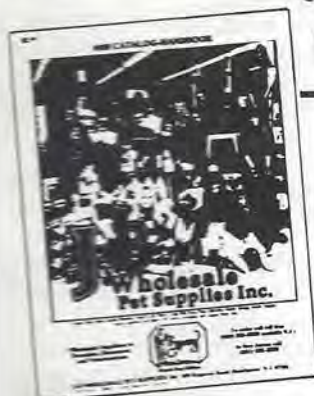

## "DEEP IN THE HEART OF TEXAS"

The newly formed Dallas/Ft. Worth Hunting Retriever Association becomes the Lone Star State's only NAHRA affiliate.

A chance meeting between two local duck hunters, Ched Kinler and Don Otey, during an off-season training session with their dogs provided the impetus for the association's beginning. Voicing displeasure over thwarted attempts to join the local UKC/HRC organizations, the two decided to investigate NAHRA, of which Otey was already a member.

A phone call to Rosemary Haynes at NAHRA headquarters provided a sobering if not startling fact: there were no NAHRA affiliated clubs in all of Texas or the surrounding states! Rosemary indicated that the D/FW area was a possible target area, and suggested a call to NAHRA president, Jack Jagoda. Subsequent calls to Jack convinced the pair that not only were they on the right track, but that NAHRA was ready, willing, and able to provide support through training clinics, judging clinics, providing judges for first Licensed events, and more. It didn't take long to find out that this type of assistance was not available through the AKC or UKC/HRC programs.

An organizational meeting was held in April with five in attendance. Present, in addition to Kinler and Otey was another NAHRA member, Tamara Day, Bill Medcalf, author of the book *RETRIEVE*, and Jack Mounts. Both Medcalf and Mounts are respected judges in AKC and UKC/HRC events. It was unanimously agreed that the NAHRA concept was needed and that an advertised training clinic and membership drive should be held in May or as soon as a NAHRA official could be present.

On Friday, May 19, 1989, a big Lab named Lucky with owner Jack Jagoda in tow arrived at D/FW International Airport. Within an hour Lucky was completing triples with a blind and diversions in a wooded Texas stock tank -- exhibiting a style befitting the Master Hunting Retriever he is.

Saturday dawned clear and "Texas hot". Fifteen serious retriever enthusiasts were on hand as Jagoda gave an upbeat introduction to NAHRA. Ably assisted by Bill Medcalf and his two Chesapeakes, Topaz and Ace, a series of land and water tests were run, emphasizing the NAHRA concept. After watching three top flight senior dogs perform, the crowd was treated to possibly the best training seminar ever held in this area.

Sunday brought several new faces including several onlookers without dogs. A hands-on session was the order of the day, and Bill and Jack worked on an individual basis with each handler and his dog.

Attendance in terms of numbers was disappointing, but the level of enthusiasm for NAHRA and the new Dallas/Ft. Worth Hunting Retriever Association was very high. Eight paid memberships resulted with more promised.

One of the bystanders, Mims Reed, owner of Hunters Headquarters in Bedford, Texas, brought two friends out for a few minutes just to see what was going on. The trio was soon caught up in the excitement. The "few minutes" turned into practically an all-day affair. An enthusiastic Mims later offered a backroom in his store as a meeting place.

The Dallas/Ft. Worth Hunting Retriever Association plans to have their first Licensed event in early fall. Details of the event will be available later.

The next event scheduled by the group is a training session featuring an introduction to birds, followed by a fun test for started dogs. The date for both is June 17, 1989.

The Dallas/Ft. Worth Hunting Retriever Association is deeply indebted to Jack Jagoda and to NAHRA for putting on this clinic and for their support and encouragement. A special thanks as well to Bill Medcalf for his assistance with the training clinic.

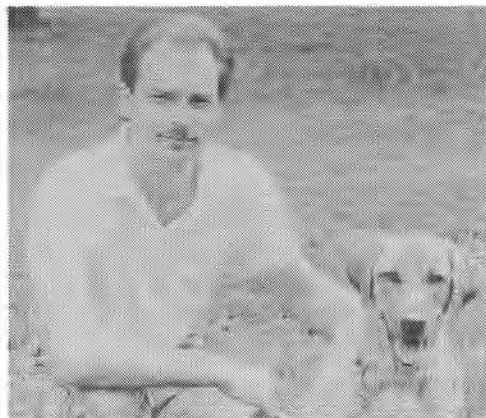


# SILENT AUCTION

## Sick Dogs Should Eat

It's perfectly obvious to animal owners that animals always eat -- unless they are sick. And there the problem lies.

Sick animals need nutrition too. In fact, following surgery when their bodies must repair damage, the need for nutrition may be even greater.

The practice in many veterinary surgeries is one of "benign neglect," or allowing critically ill animals to eat only if they choose. Working at the University of California, Davis, through a grant from Morris Animal Foundation, Drs. Steven Haskins and Tony Buffington (now of The Ohio State University) observed critically ill dogs and found that their energy and protein expenditure continues even when they do not take food in.

Drs. Haskins and Buffington believe these patients need nutritional support to support wound healing and resistance to infection during critical illness.

One of the newest directions in veterinary medicine is the use of laboratory-grown cells for testing new drugs and techniques. This reduces the need for direct animal testing, and can give veterinarians a good idea of which drugs may work best for the particular problem they are treating.

Lauren G. Wolfe, D.V.M., Ph.D., of Auburn University, has been refining techniques for growing different types of cancer cells from dogs under laboratory conditions. His work is sponsored by Morris Animal Foundation. He was successful in culturing cell lines from canine mammary tumors, melanomas and fibrosarcomas.

During the study, he learned that the cells retain most of their original properties, and that the laboratory-grown cells are useful in pretesting drugs. Though the technique is new and requires further testing, Dr. Wolfe is optimistic that in the future, it will be possible to take cells from a dog with cancer, grow them in the laboratory, and apply drugs, radiation or immunologic reagents to determine the best treatment before actual therapy on the dog is begun.

## Iowa Handler's Clinic Conducted By Lewis Brothers



*EIHRA speaks its mind to NAHRA Board.*

On Friday evening June 9th, before our third and final licensed NAHRA test for the spring, NAHRA Board member Lewis Brothers held a handlers' clinic at St. Pat's hall in Iowa City. It was a successful start to a magnificent NAHRA weekend.

The clinic started with some free refreshments and talk. Since the clinic consisted mostly of experienced people and we needed to get to bed at a reasonable hour, Lewis jumped right into an explanation of how and why the NAHRA Board made the rule changes in the new rule book. (Two years ago Jack Jagoda gave a day-long detailed clinic that many of us attended.) Our club, Eastern Iowa H.R.A. is new this year, but was formed out of two Iowa clubs, Retrievers Unlimited Forever and Northeastern Iowa H.R.A., both of which had sent suggestions to the Board last fall. Lewis explained how the Board tried to balance all the suggestions they received from various groups. For example, Started rules were tightened up a little because some regions were a little lax and others somewhat tougher. The Beginner stake, left almost entirely up to clubs, can serve as a training ground and the new Started rules will keep the whole North American continent together on one Standard. (We didn't forget our prairie region friend in a different country, Manitoba Hunting Dogs, Inc., though none of them could make it this time.) There were other questions on Started which Lewis explained clearly and carefully. On one we sited chapter and verse when he was a little rusty

on a detail, but what came through was a genuine concern for the dogs and hunters and a Board effort to make the rules reflect that concern clearly.

Intermediate upland rules were one of the other things we wrote to the Board about last year and Lewis explained how our input and that of clubs in the Northwest had influenced the new rules. The changes weren't exactly what we suggested, but Lewis made it clear that our voice was heard and that the bottom line was how people really work with their dogs in the regions where upland hunting is strong. There was some discussion about how we hunt upland in Iowa and the group as a whole seemed to agree that the Board did the right thing to test Working Retrievers the way we work them.

The questions were detailed and someone even found a typo in the Senior rules, though they actually seemed clearest overall. There will always be some fine points to clarify. What Lewis made clear is that the Board will listen to its members and make rules designed to test HUNTING retrievers.

Next, Lewis opened up discussion to general suggestions, comments and questions. Some local matters and representation at the Invitational came up. Invitational "percentages" were discussed at length, but the more we talked about that, the more complicated and un-workable it became. There was some talk about a Regional Field Test, which Lewis started, but which we have taken up since he left. The Southeast had a regional NAHRA benefit test last fall combined with a Board meeting and representatives from around the continent. We're working on some ideas that grew out of the clinic. Maybe you'll hear about it later - or come up with your own better ones.

We took a short break and Lewis briefly described the '89 Jim Dandy/NAHRA Invitational which he judged. It started getting late and I need my sleep, so I raised my hand and said in a loud voice, "I have a complaint." My complaint was that we never get to thank the Board for all their effort and innovation. You may have heard that there are other hunting retriever programs. (There aren't in Iowa!) A little east of us, one is even bigger, but if you think about size and quality, you have to compare the program that listens to their members, has Brass Bands, an Invitational, GMHR, a clear rule book and sound program with whatever those other ones are. It's like parts of the dog. The hindquarters are bigger than the other end, but a nose, eyes, ears and a brain sure do seem important in a good hunting dog. Add to that a good disposition and you've got the NAHRA Board of the hunting retriever movement. The big part follows anyway. EIHR presented the Board with a small plaque as a token of our gratitude and we went home for a little sleep before the real fun began; our Field Test. That's another story and good one, too.

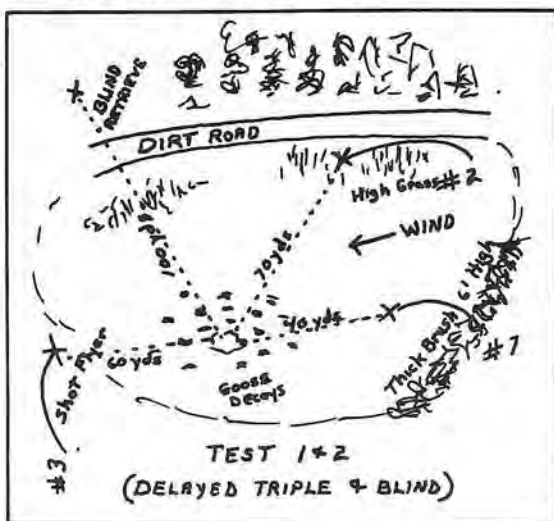

# 1989 JIM DANDY - NAHRA INVITATIONAL

## TEST 1 & 2 (Saturday morning)



**SCENARIO:** Field shooting for geese and ducks over decoys. A flock of ducks are approaching us from behind and we put our dog at sit and stay and take cover under a camo tarp. We then start calling to see if we can bring the birds within shooting distance. After considerable calling, the birds finally come within range on our right side, we stand and shoot two out of the flock. The birds pass over our hunting partners, positioned 50 yards off to our left, they drop two more birds out of the flock. However, the dog only has the opportunity to see one of their two birds fall. The other bird was an apparent head shot and fell dead on the timbered hillside in front of us.

**OBJECTIVE:** This is a straight forward marking test with a blind retrieve. Remember, Chapter V, Section 4, "A dog may be handled on marked retrieves with voice/whistle/hand signals, if, in the opinion of the handler, the dog can't find or has missed the mark." Because the dog has plenty of opportunity to see the birds fall and they are relatively close, you will be severely marked down for handling on any of these marks.

The dog must first demonstrate its obedience by quickly taking position as the birds are coming in. There will be no time for jockeying the dog around.

The first bird thrown is a give away at 40 yards and into the wind with no real obstacles between the point of origin and the bird.

The second bird downed should prove to be the most difficult for the dogs to recover as the thrower is positioned on the near side of the dirt road and has thrown the bird on this side of the road in the heavy cover. Most dogs will push through the heavy cover, past the thrower, across the road and will search on the far side. Because the wind is primarily from right to left, the dog will not be able to wind the bird if he hunts on the far side of the road and due to the high cover in the area of the fall, he will be forced to correct his position on his own as it will be quite difficult to handle him to the mark when you lose sight of him in the heavy cover.

The last bird dropped represents some challenge as it is downwind and your dog must demonstrate its obedience skills to turn with you in order to see the bird fall.

The objective of the blind retrieve is somewhat challenging as the proper line to the blind runs along the top edge of a gradual knoll that drops off toward the live flyer. The heavy cover at the edge of the field will cause you to lose sight of your dog for a short period of time if the dog drives across the road and takes the angle up the hillside to the blind. However, the dog might hunt the road once he/she gets out of sight of the handler and if this occurs, the dog may end up back on the #2 bird or come out way off to the left in the bottom land. The dog must be sent from the point of origin for the blind but you may then move up to the last decoy to keep sight of your dog and to handle.

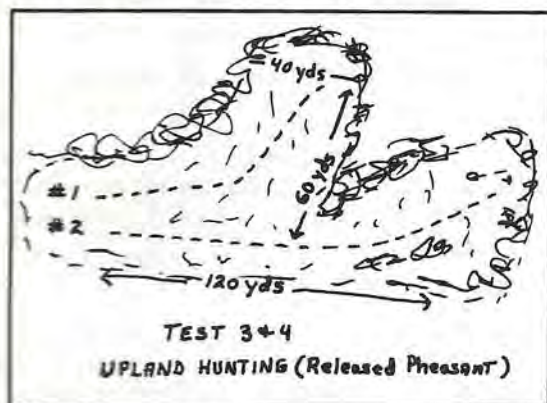
**MECHANICS:** The birds are seen by our hunting partner as we approach the decoys so he starts calling and we must quickly position our dog and take immediate cover under the camo tarp. Number one thrower will answer with a call. Then, the handler will call and Number 2 thrower will answer. The handler calls again, signalling that he/she is ready, and the first bird is thrown and a shot is fired from the point of origin. As soon as the first bird hits the ground, the second bird is thrown and another shot is fired from the point of origin. There will be a two to three second delay and the live gunners on your left will call, throw and shoot a live duck. We will tell you when to send your dog. Pick up the three marked birds in any order and then pick up the blind retrieve.

**RESULTS:** 1 dog failed the marks and 1 dog failed the blind. Most dogs handled the land marks and land blind without a hitch. We had a couple of near perfect jobs. A few dogs had either rough work on the marks or a loose blind retrieve. A couple of dogs had loose work on both their marks and their blind retrieve.





### TEST 3 & possibly 4 (Saturday afternoon)



**SCENARIO:** Upland hunting for pheasants, you and your dog and your hunting partner and his/her dog. You both start out hunting the same lowland area together and halfway through the lowland you split up and go in two different directions to finish hunting the field. After entering the lowland area or the bird field the dog may demonstrate its trailing capabilities as the birds are free to run as they please. Dogs that do demonstrate trailing to produce a bird will be scored on trailing as well as the upland hunting.

**OBJECTIVE:** The dogs and handlers are to work with each other through the first half of the hunt. They must maintain a safe distance from each other and push the cover for any birds that may run out of the bird fields and up into the beginning of the lowland area where the hunt is to start. We want to see the dog aggressively searching for birds leaving few birdie objectives unsearched. A dog will continue to work until he/she has located and flushed at least one bird. Other birds may be flushed and will be judged in the same manner as the first. In other words, if your dog has more than one

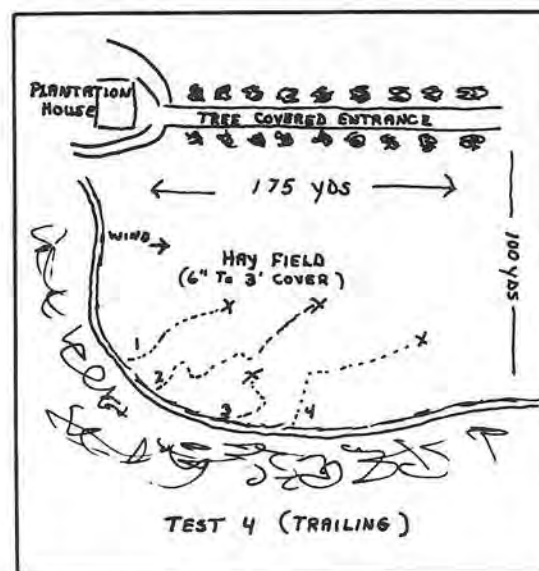


flush either at the same time or at a different location and time, the dog must be under control and will be judged on all flushed birds.

**INSTRUCTIONS:** Two unshackled rooster pheasants will be dizzied and released in each of the two bird fields for the first brace of dogs. Birds will be replanted according to what has been harvested or seen running or flying out of the bird fields before each brace is to run. If a bird is scooped by the dog before it is flushed, the dog and handler will continue to hunt until a legitimate flush occurs. If a dog obviously trails a bird, he/she will be given a score for its trailing ability and will not have to participate in the trailing test on Sunday.

**RESULTS:** 3 dogs eliminated themselves because they broke at the flush. 4 dogs were dropped due to low total scores on Tests 1, 2 & 3.

### TEST 4 (Sunday morning)



**SCENARIO:** You are riding back to the clubhouse after a day in the field hunting pheasants. The driver sees a crippled pheasant run across the road. He stops the vehicle, gets out, loads one round and attempts to shoot the crippled bird to fill his limit. He misses but you get your dog out and put him/her on the trail of the bird.

**OBJECTIVE:** The dog is to demonstrate that not only does it have a nose but knows how to use it. The dog should demonstrate its ability to concentrate on the scent indicated by the handler and should follow that scent directly or indirectly (short quarter back and forth across the trail or downwind paralleling the trail) to locate the bird and deliver it to hand.

**INSTRUCTIONS:** A wing clipped unshackled pheasant will be released for each dog from different locations. Do not get your dog out of the crate until you hear the shot fired. The bird will be dropped into the cover and we will not shoot until the bird has started running. The handler is to remain at the point of origin unless otherwise instructed by the judges.

Because time is of the essence, there are two crates in the back of each of the two trucks we have available.

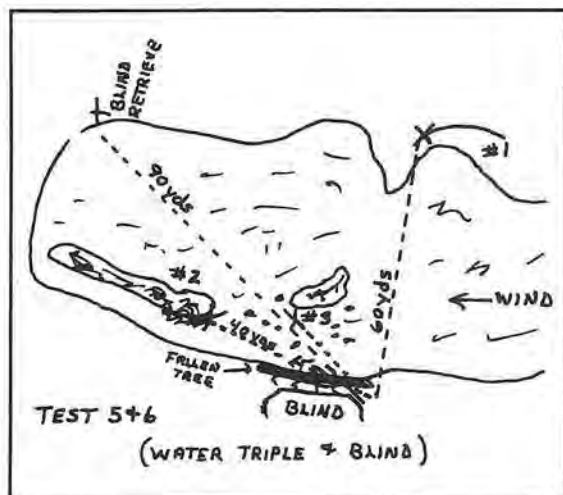


Two dogs and two handlers will be on each truck at all times. The low number of the two dogs on the truck will run first. After the first dog has completed his test, we will move to a different release point so the previous trail will not interfere with the next working dog. Handlers are to remain on the tail gate until the truck has stopped. The handler of the working dog may have his/her hand on the crate latch but is not to open the crate until the shot has been fired. Once the shot is fired, you may proceed as quickly as you wish to the point of origin and release your dog on the trail when you are ready.

**RESULTS:** One dog was dropped due to a lack of sufficient points to qualify.



## TEST 5 & 6



**SCENARIO:** Duck hunting out of a blind and over decoys. A flock of ducks are coming up the lake from right to left. You blow your call to bring them within shooting range. You and your hunting partner manage to take four birds out of the flock. You send your dog for the closest birds thinking that all birds are down and dead. As your dog returns with its second retrieve, you notice the farthest bird was not dead and it has gone across the pond and up on the far shore. By necessity that bird is to

be recovered next, which will be a water blind retrieve. After the blind is recovered, send your dog for the remaining marked bird.

**OBJECTIVE:** The dog may pick up any two birds before being sent for the blind. The last bird down is right out in front of the point of origin and we, as judges, expect the dogs to either break on this short flyer or at the very least to unnerve them so they may lose their concentration on the remaining marked birds. It's a wise handler that takes the left hand bird next as it is in a position to really suck the dog off his line to the blind.

The obstacles in the dog's way for the blind retrieve are: the decoys out in front of the point of origin, the suction of the flyer that has been retrieved right out in front, the suction of the small island on the right, the suction of the previous mark on the left, the suction of the island point on the left and the angle down the shore line to the water blind.

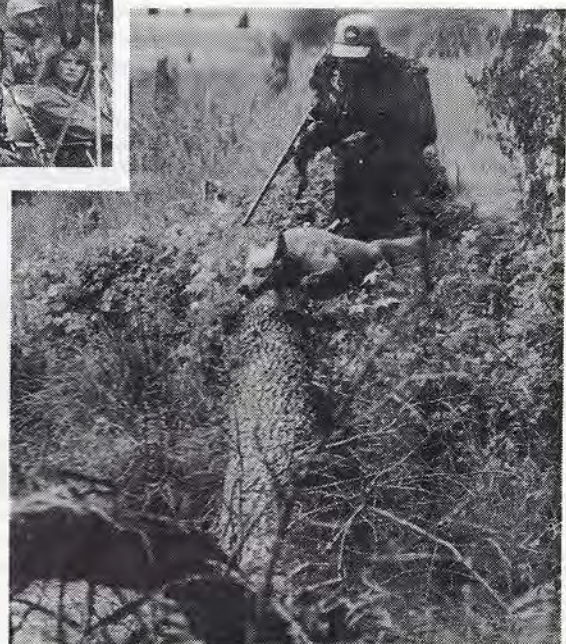
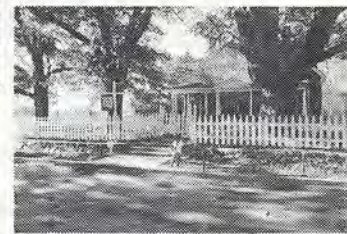
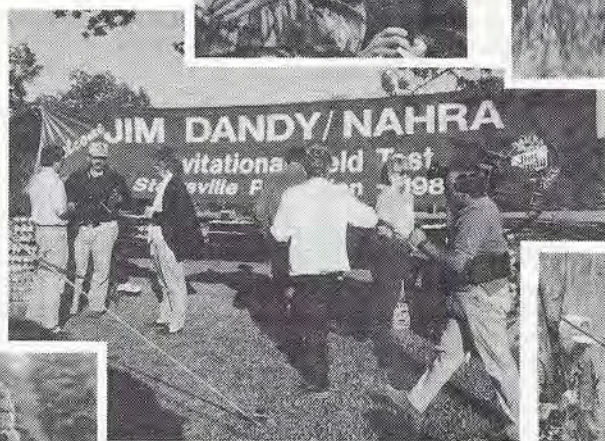
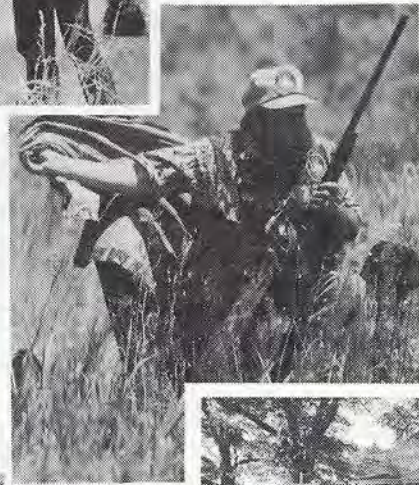
**MECHANICS:** The blind is planted before the dog is brought to the point of origin. The handler may locate his/her dog anywhere in close proximity of the hunting blind. The handler takes his/her place inside the blind with the live bird gunners and signals when ready by blowing the duck call. Number one thrower blows a call, throws a dead duck and fires a shot. Number two dead duck is thrown from shore to the point of the island as soon as Number 1 duck hits the ground and a blank shot is fired from the running blind. Then, a live duck is thrown out over the top of the hunting blind and is shot out in front by the live bird gunners situated in the hunting blind.

The angle of the throw of the live duck is critical so that no one is in jeopardy of being hit with pellets. To give the gunners a little more leeway, the blind is planted first and the blind planter took cover behind a large tree at the far end of the pond.

**RESULTS:** The good news was that we had 29 dogs back for this test. The bad news was that this test took an average of eleven minutes per dog from start to finish. Add to this the torrential rains that came when we were 3/4 of the way through the field of dogs. That gave us an hour or so delay. Unfortunately, we didn't finish until almost dark and the awards were not presented until 9:00 Sunday night. Not much time for celebrating but those that made it through the weekend intact are probably still celebrating. 3 dogs either failed the test or didn't have enough total points to qualify.

# Ticked off About Lyme Disease?

## Here are the facts

Lyme disease is an illness, which if not diagnosed and treated promptly, can cause serious problems involving the heart, joints, and nervous system. In Wisconsin, Minnesota and eastern coastal states, this bacterial disease is transmitted to people and animals by the bite of the deer tick (*Ixodes dammini*). In California and other parts of the west, the western black-legged tick (*I. pacificus*) is the carrier.

Lyme disease was first officially recognized in the United States in 1975 in children from Old Lyme, Connecticut. A similar disease was reported in a grouse hunter from Taylor Co., Wisconsin in 1969. It wasn't until 1979, however, that additional cases of Lyme disease were reported in northwestern Wisconsin. In fact, the bacterium that causes Lyme disease (a spirochete called *Borrelia burgdorferi*) was not even identified until 1982.

Since 1982, Lyme disease has been reported with increasing frequency on the east coast (from Massachusetts to Delaware), in the midwest, and in western states (California, Nevada, Utah and Oregon). Over 600 cases of Lyme disease were reported from 1980 through 1986 in Wisconsin. Although initial reports of Lyme disease in Wisconsin came from northwestern counties, the disease and the deer ticks occur throughout the state, particularly in northwestern, western, central and southern counties. A few scattered cases have been noted in eastern counties.

### Signs and Symptoms of Lyme Disease

Lyme disease typically progresses through three stages, depending upon how soon the disease is diagnosed and treated. Prompt medical attention will minimize complications involving the heart, nervous system and joints.

#### Stage 1

In the early stage, people with Lyme disease may have any combination of the following symptoms:

- \*headache
- \*chills
- \*nausea
- \*fever
- \*a spreading rash
- \*aching joints
- \*fatigue

Without treatment, these signs and symptoms may disappear altogether, or they may recur intermittently for several months. The characteristic red rash, called erythema chronicum migrans (ECM) usually appears within 3 to 32 days after a person is bitten by an infected tick. The rash is circular in shape and can attain a diameter of 5-20 inches, with the center of the rash becoming cleared. ECM is not restricted to the bite site and can occur elsewhere on the body. Up to 30% of the people who have Lyme disease do not develop ECM lesions, making diagnosis more difficult.

If Lyme disease is diagnosed during Stage 1 (based on characteristic symptoms and sometimes on a simple blood test), it is easily treated with antibiotics such as tetracycline, penicillin and erythromycin.

#### Stage 2

Weeks to months after initial exposure to the bacteria or after the first symptoms appear, some people may develop complications involving the heart and/or nervous system. Specific disorders may include various degrees of heart blockage, nervous system abnormalities such as meningitis, encephalitis, facial paralysis (Bell's palsy), and other conditions involving peripheral nerves. Painful joints, tendons, or muscles may also be noted during this stage of the disease.

#### Stage 3

Arthritis is the most commonly recognized long-term sign of Lyme disease. From one month to years after their first symptoms appear, people may experience repeated attacks of arthritis. Research has shown that even if Lyme disease was not diagnosed and treated promptly, people who eventually received appropriate antibiotic therapy had fewer relapses than those who were never treated.

#### Treatment

If you develop any of the symptoms listed under Stage 1 and recall being bitten by a tick, or have been in an area where ticks are abundant, discuss your suspicions of Lyme disease with your physician. Your physician will make a diagnosis based on your symptoms and on information you provide about recent travels, or history of tick or insect bites. Prompt treatment with antibiotics can cure the infection and prevent later complications. Treatment during later stages of the disease often requires more intensive antibiotic therapy.

#### Lyme Disease in Domestic Animals

Domestic animals can also develop Lyme disease. Lyme disease has been diagnosed in over 40 breeds of dogs, but is most often reported in hunting or working dogs that spend a great deal of time outdoors. Most Lyme disease infections in dogs have occurred during the months of May and November, although veterinarians have reported the disease during all months of the year. Signs in dogs may include various combinations of the following:

- \*fever of 103-106 F
- \*severe pain
- \*sudden onset of lameness
- \*poor appetite
- \*intermittent lameness for weeks or months
- \*signs of illness observed within a few days or up to several months after initial exposure.

Prompt diagnosis and antibiotic treatment with tetracycline or penicillin can rapidly alleviate the signs and pain of Lyme disease in dogs.

Cattle and horses can also contract Lyme disease. They may exhibit a variety of signs, including fever and lameness.

#### The Tick

Deer ticks (*Ixodes dammini*) are by far the most common carrier of Lyme disease in Wisconsin, Minnesota and eastern coastal states. The highest density of deer ticks in Wisconsin is in the western half of the state.

Recently, other species of ticks such as the lone star tick (*Amblyomma americanum*), the wood tick (*Dermacentor variabilis*), and insects such as horseflies, deer flies, and mosquitoes have been shown to carry the Lyme disease bacteria. It is possible that these insects may also successfully transmit Lyme disease.

The deer tick lives a rather complex life. Like many other insect-like creatures, its life cycle involves developing from an egg to a larva, larva to a nymph, and finally from nymph to an adult. The deer ticks are among the first ticks to become active in the spring, and they remain active in various life stages until the first snow in the fall.

### Life Cycle of the Deer Tick

#### Fall/Winter/Spring

Adult ticks feed on deer and other large mammals.

#### Early Spring

Female ticks drop off large mammals and lay eggs.

#### Late Spring/Summer

Larvae hatch from eggs and attach to mice and other small mammals and birds. Larvae may ingest Lyme bacteria as they feed. Before larvae find their first host, they are unlikely to carry Lyme disease bacteria.

#### Late Summer/Fall/Winter

Larvae moult and become nymphs. Nymphs overwinter without feeding.

#### Spring/Summer

Nymphs emerge and feed on small mammals. While taking a blood meal, the tick may inject the Lyme disease bacteria into the small mammal. Later in spring, newly hatched larvae will feed on these animals and become infected with the Lyme disease bacteria. Nymphs are likely to attach to people from May through July, making this the period in which most people acquire infections.

#### Fall

Nymphs moult and become adult ticks. Adults may feed on dogs, people, and other animals such as deer.

### Prevention

By routinely checking for ticks after being outdoors, you can remove ticks before they embed and have the chance to transmit Lyme disease.

1. Conduct thorough tick checks on yourself, your children and your pets after spending time outdoors. Ticks do not fly or jump onto their hosts. They wait atop grasses and other vegetation until an animal brushes against them. Then they cling to skin, fur or clothing. Remove any ticks you find as soon as possible.

2. Wear light colored clothing. This may not deter ticks, but it makes them easier to find.

3. Tuck pants into boots or socks; wear long-sleeved shirts, buttoned at the cuff.

4. Apply tick/insect repellent to pants, socks, and shoes. Products containing 30% Deet, or permethrin are almost 100% effective in repelling deer ticks. If you use these types of products, apply them only to your clothing and not to your skin.

5. Walk in the center of mowed trails to avoid brushing up against vegetation.

6. Fogging or spraying an area with insecticides are *not* effective means of tick control. Mowing grass around your home or outbuildings may make the area unattractive to ticks, thereby decreasing their numbers in the area.

### Removing Ticks

1. The mouthparts of a tick are shaped like tiny barbs. The best way to remove a tick is to grasp it with tweezers as close to the skin as possible and gently, but firmly pull it straight out. If tweezers aren't available, grasp the tick with a piece of tissue. Do not twist or jerk the tick because the head may remain embedded, which can lead to general infection at the bite site. If the head or mouthparts do break off, consult your doctor about removing them.

2. Wash the bite area and your hands with soap and water and apply an antiseptic to the bite site.

3. Adult ticks can remain on deer and other mammals through the fall and winter. If you spend a lot of time outdoors during this period, be sure to check yourself, your family and your pets daily for deer ticks. If you hunt or trap, check areas where you catch your game for ticks that may have fallen off during handling.

### In General

If you do develop the signs and symptoms of Lyme disease, contact your physician promptly. Treatment in the early stages of the disease can usually prevent complications.

For additional information about Lyme Disease, contact your local public health official.

The licensed field trial people have meaningful information to make their breeding decisions. They are a relatively small number; the hunters outnumber them a thousand-fold. The field trialer who produces great dogs cannot possibly fill the hunter's needs even if the hunter knew how to make the contact. Field trailers just don't produce the numbers of pups needed each year, and their prices are out of reach of most hunters.

But the purpose here is not selling you on what the dog writers have been saying about the need for this stake. By your show of strength, you have convinced us that you are ready. A small group has

been working hard to get things moving for you. NOW WE WANT YOU IN THE ACT!

All you hunters with retrievers (and Chesapeakes are included) who are interested in the Hunting Retriever Stake should step forward and be counted. Write your name, address, phone number (including area code) and reason for interest in the Hunting Retriever Stake on a post card and send it to: Ned Spear, 40 Grand Street, Swanton, Vermont 05488. Get your name in his computer, and thank Betty, Ned's office manager, for all the extra work she has been doing. We want to know who you are and where you are.

## A GLOSSARY FOR THE NOVICE RETRIEVER HANDLER

Those new to NAHRA Hunting Tests are exposed to a bewildering litany of unfamiliar terms. Many of these have more than one meaning. I thought it helpful to define some basic handler talk for the beginner.

**MARK:**

1. Fall of a bird visible to the dog.
2. Generic term for assorted welts, bruises abrasions and lacerations.

**BREAK:**

1. Dog's attempt to retrieve before being sent by the handler.
2. Occasional result of those same factors which caused a MARK second definition.

**CAST:**

1. Sending a dog in search of a bird.
2. Plaster orthopedic device associated with most BREAKS Second definition).

**HANDLE:**

1. To expeditiously stop, then adroitly move a retriever using hand, arm, body, voice and/or whistle signals.
2. Technique employed by an experienced Judge to soothe a novice Handler whose dog has just been dropped from competition.

Example:

H. "What do you mean, too many whistles?"

J. "Well, eleven toots during a 50 yard mark is a lot."  
H. "What the hell do I do now?"  
J. "Have a cup of coffee and talk to that nice lady over there. I think there's an opening in the Beginners' stake."

**DRYSHOT:**

1. Gunfire used to divert an incoming dog. No bird is killed on purpose. (See GUN, first definition).
2. Typical beverage ingested after the "nice lady over there" indicates she knows nothing about the Beginners' stake.

**GUN:**

1. Device which makes a loud noise and propels lead pellets behind flying birds.
2. Shooter at hunting test involved with No. 1 above.
3. Engine sound heard most often emanating from the vehicle of a dog handler entered in 3 different stakes.

**DIVERSION:**

1. Device, technique, or ploy used to seduce a dog from the task at hand. DRY SHOT (first definition), escaping pigeons, local fauna (musk-rats, turtles, skunks) or the presence of the dog's family in the gallery are most popular.

**QUARTERING:**

1. Back and forth dog movement in front of the GUN (second definition) to find fiendishly hidden birds, similar to up-land hunting.

2. Basic telephone activity involved in making numerous calls to an owner's family about their dog's progress.

**BLIND:**

1. Retrieve in which no visible fall has occurred. The dog must take a LINE (first definition) and often must be HANDLED (first definition).
2. Non-permanent structure which prevents a dog from seeing the previous test or the planting of a bird.

The above two usages are nouns. Sometimes BLIND is used as an adjective, as in: Blind luck, Blind faith, and Blind judge.
