President's Bark

Two exciting bits of information for the NAHRA membership. The first is the unanimous approval by the Board to accept and grant the Poodle full status in the NAHRA program.

Second and equally important is the inception of the title Started Retriever (SR). The new title will be awarded to all dogs that achieve four lifetime qualifications at NAHRA Licensed Hunting Retriever Field Tests. Regulations for the field testing of Started dogs shall remain the same. All dogs that earn four qualifications will be awarded the title Started Retriever, a certificate, and eligibility to

use the prefix SR in front of the dog's registered name.

New rule books are being published and will be available early in January. There are no rule changes only clarification of existing ambiguities.

It is our hope that the inclusion of the Poodle and the new Started Retriever (SR) title will dramatically increase participation by breeders and individuals and broaden the gene pool of titled hunting retrievers.

Have you ever stopped to consider that we may often underestimate the ability of our canine companions? I have seen some situations through the years that have insulted my dogs natural and trained abilities. Not only at field tests but in daily interaction with humans. My recent involvement in working with the Richard A. Wolters Foundation has been an eye opener. Basically, the Foundation supports the advancement of all breeds of working retrievers as companions for hunting, law enforcement and the handicapped as well as enhancing canine health and genetics through education, research and development. Many of us cast the purebred retriever in three distinct roles - the show dog, hunting dog and pet. The pet market makes up approximately 85% of the dogs registered each year, the show dog 10% and the field dog 5%. Actually, further examination would suggest most dogs from the show and hunting arena could certainly be classified in the pet segment as well. A microscopic overview of these three groups reveals the dogs are also utilized as service dogs for the mentally impaired and compromised, police drug dogs, seeing eye dogs and search and rescue. Therapy dogs

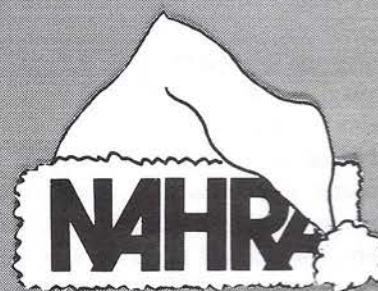
dramatically increase the mental well being of convalescent and the terminally ill through visitation programs at health care facilities. I strongly urge NAHRA clubs and individual members to seriously consider involvement with local health care facilities and convalescent homes. The animal that gives you so much pleasure and satisfaction can put a smile on someone else's face.

Veterinary Corner

ANOTHER SHOT AT "HOT" PUPPY FOODS

A short while back an expert at Cornell answered a reader's question about when to stop feeding puppy food and replace the ration with adult food. Puppy food is often tabbed "hot" food because of its higher protein content. Although opinions vary, the Cornell experts and many others recommend changing from puppy foods after four months of age.

Part of the confusion over whether or not a puppy should get puppy food may stem from the definition of such terms as "puppy chow", "growth" food, "maintenance" food, and "all purpose" food. The definition of each term is actually based on the purpose of the diet in question. One of the requirements on the label of any pet food is a statement of purpose, which makes it possible to determine the type of food simply from reading the label. Good quality puppy or growth foods are especially formulated and tested for their effectiveness in supporting proper growth and good health in growing dogs from weaning to adulthood.

Maintenance foods, by contrast, are formulated to provide adequate nutrition for mature dogs engaged in moderate activity. They do not necessarily provide the proper nutrient balance for growth. Maintenance foods should not be confused with so-called "all purpose" foods, which are intended to meet or exceed the nutrient requirements for all stages of the dog's life from weaning to old age, not just adulthood. All purpose foods can be identified by such statements as "Complete nutrition for the entire life of your dog".

Given these facts (facts of labeling, that is) one can say that in most cases a puppy should be fed puppy food until it reaches 90 percent of its expected adult weight. That will be less than a year for small breeds and up to 18 months for giant breeds. However, most puppies should also do well on an all purpose food because by definition these foods must be formulated to meet or exceed the nutritional requirements of all life stages, including puppyhood.

There are some practical considerations that can also affect an owner's decision. For instance, comparing dog foods can be a tricky business, and the lack of complete nutrition information on product labels makes the choice especially difficult. And before even comparing foods it is necessary to consider how dogs actually eat food. Dogs do not care how many pounds of food they are given as long as there is sufficient energy in the bowls to meet their needs. In effect, dogs eat calories, not cups or pounds. Consider two foods, A and B. If A has 2000 kcal per pound, and B has only 1000 kcal, a dog that requires 100 kcal per day will eat one pound of food B but only a half pound of food A. For the owner this means that in order to compare different foods, they have to be compared on the amount of food the dog will be consuming. If food A (at 2000 kcal) has 20 percent protein, but food B (100kcal) has twice that amount or 40 percent protein, a dog consuming the caloric amount of either food it requires will be getting exactly the same amount of protein in each meal.

The bottom line comes down to this: Optimal nutrition for the animal involves matching the nutrient requirements for its life stage with the nutrient balance in the diet it is fed.

There are other complicating factors as well. There appears to be a wide variation from food producer to producer on just how much protein, fat, or calcium a puppy needs. However, if the nutrient contents of foods can be compared on a "per calorie" basis, the similarities between various foods of the same type become apparent, and the differences between puppy food and maintenance

food can be more readily demonstrated. Analyzed in this fashion, it is evident that growth foods generally contain more protein, fat, calcium, and phosphorus than maintenance foods. These are the nutrients most critical for growth. Analysis of all purpose foods tends to resemble closely that of growth foods, which would explain why puppies usually do well on all purpose foods.

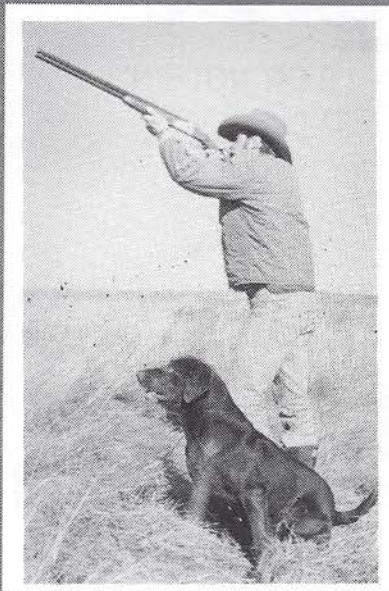
There is a possibility that a puppy would receive a less than optimally nutritional food. Say, if a company that markets an all purpose food decides to produce a puppy food but not a complete line of life-stage-related foods. Say, then, that the company decides to increase the "growth nutrients" in the new puppy food above the amounts already present in the all purpose food. Since the all purpose food already meets the nutritional requirements for growth, the new puppy food might be close to providing excessive amounts of protein or calcium. This has actually been known to happen and might have contributed to the poor performance of many litters on some puppy foods as compared to those on all purpose foods.

The bottom line comes down to this: Optimal nutrition for the animal involves matching the nutrient requirements for its life stage with the nutrient balance in the diet it is fed. When pet food companies have this attitude toward their products, it will be reflected in their product line: specific foods for specific purposes. These companies are frequently the producers of premium pet foods.

To repeat an earlier point: all purpose foods appear to be fine for most puppies. But this raises an additional issue: if the food has everything a growing puppy needs, does it have more than an adult dog needs and could this excess be harmful in the long run? If an all purpose food is in reality a puppy food in disguise, perhaps the excess of nutrients could be a source of problems. There is at present no strong evidence to support the idea that excessive nutrients in all purpose foods might be harmful, but the subject deserves thought and further research.

Training Tips

"Puppy Stuff"

Excitement and enthusiasm is what puppy training is all about!! You must make your pup's world the most interesting and exciting place possible. You can't be a stuffed shirt and be successful with your pup's training. Very little correction and lots and lots of praise. Introduce your pup to everything under the sun and be there to reassure in the event of fear. The dog has to learn to trust and believe in you. Become your dog's best friend and make his/her life fun and exciting.

The ideal time to take a pup from its brothers and sisters is at seven weeks of age. It is at this age that the dog is most likely to accept you as its new parent. If you must settle on a pup over seven weeks old, make certain that the pup has been separated from its litter mates and its mother and that the socializing has been begun by the litter owner.

A dog is like a small child except the dog never grows up. The dog will vie for dominance by challenging your authority throughout its life. Your dog must learn that you are in full control and that you are fair and trustworthy. The pup can only learn this through trial and error. You

must learn to be consistent with your praise and your discipline. All corrections must come at the time of disobedience and the discipline must be just severe enough to make your point.

Housebreaking is usually the first order of business. The key to successful housebreaking is scheduled feeding, a dog crate, and consideration. The only time pup is allowed to run free around the house is when pup can be properly supervised. Any other time, pup is to be in the crate or outside. If pup makes a mistake in the house, don't rub its face in it. The mistake is yours for not being considerate and giving the pup ample opportunity to relieve itself.

Feedings should come at least three times each day. The food should be available for no more than 30 minutes and then it's to be removed. Water should be available at each feeding. After each feeding period, pup should be taken outside so that he/she can take care of business. Use the command "High on" and stay with pup until the job is done and then lavish the praise. It won't take long for pup to get the idea.

Letting your pup out after every meal, the first thing in the morning and the last thing before you go to bed will help to eliminate any mistakes. Be considerate and let pup out often when you are around to do so. Don't feed or water pup after 7pm. This will help pup to make it through the night without making any mistakes in the crate.

The dog crate is used to confine pup while you are sleeping or when you can't be around to supervise pup's behavior. Ignore any whining or barking that pup may do to attract your attention. If it gets bad, drag pup out of the crate and swat his/her rump with a rolled up newspaper while you give the command "No noise". Repeat if necessary, but never give in to the whining and let pup out or you will be the one that is being trained instead of pup.

If pup should get his/her mouth on something that pup shouldn't have, all you can do is tell the dog "No" and take the object from pup. Pup has no ability to reason and if the object was left within reach of pup, the fault lies with you and not the dog. Keep things out of reach of pup and that will eliminate any problems.

I do not recommend working pup with another dog. I do not recommend keeping pup with any other dog. Remember, dogs

are pack animals and anytime two dogs are together, one must be dominant and we don't want to ruin pup's chances of being independent in the field. If anything, pup will pick up all of the other dog's bad habits before pup will learn any of the good traits.

Puppy training is tricking the dog into doing everything correctly without using much discipline. There is no real serious or formal side of puppy training. The use of the "No" command is about the extent of discipline and everything else is reinforcing with lots of praise. Don't be afraid to get down on your hands and knees and become a part of pup's world. Assuming this position can help to get pup to return to you if you start having problems with his/her returns.

Training begins as soon as you bring pup home. From day 49, your pup must learn to believe and trust in you. He/she must learn that what you say is gospel. You must determine what behavior is allowable and what is to be a "No". Take the time to think about this because what you decide today will be law for the rest of pup's life. As an example: you do not want your pup to chew on everything in sight as an adult, you must control his/her chewing now.

Start conditioning your pup to respond properly to the obedience commands. However, obedience training should not be a formal leash and collar affair at this time. Instead, when pup has committed himself to coming to you, call him. When pup arrives, physically put pup in the heel and sit position and hold him there for a few seconds. Praise him and then release pup to go about his business. Gradually increase the amount of time that you have pup sit and stay at heel and slowly take your hands away as pup starts to understand what you want. Use your whistle for both the come and sit commands. (One whistle blast for sit and more than one whistle blast for come.) I keep obedience separate from pup's field training until pup has gone through the "formal" obedience drills at five or six months of age.

Field training for pup must be fun and filled with excitement and enthusiasm. Introduce pup to many different areas and situations. He will learn that you are always there to protect and assure him. Never force pup into a situation but bring pup into the situation with assurance to build his confidence.

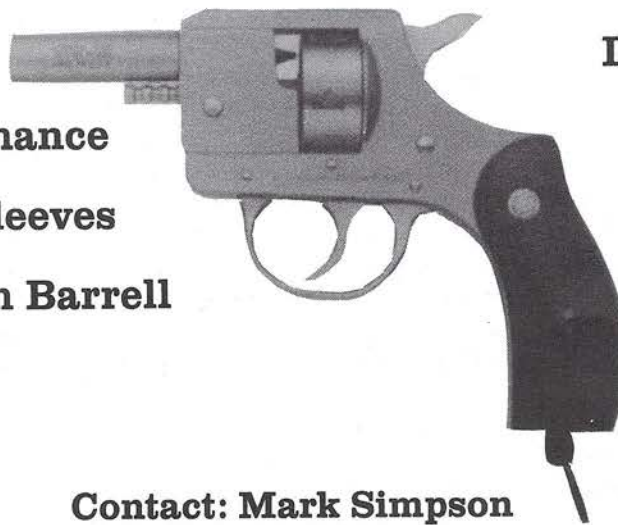

At first, your pup will stay right on your heels when you take him out for walks. This is to be expected because you are his adopted parent and pup is looking to you for protection and guidance. Don't force pup away from you. His curiosity will take over and he will be charging out in front to explore his new world when he learns he's safe. Remember to make these trips to the field a pleasurable experience for pup.

When pup feels more comfortable in the field and starts charging out in front to explore, I begin pup's upland training. Before I let pup out of his crate, I go into the field and lay five or six drag trails, (see the Chapter on Trailing), and put an additional ten or fifteen birds and bumpers in the area for pup to find. Some of the birds are dead and some are wing-clipped. (A wing-clipped bird is one that has had the outside row of feathers on one wing removed so the bird can't fly away.) All of this is done in a relatively small area so pup will stumble onto a trail or a bird/bumper often. Then, I go get pup out and work him through the area into the wind. If he winds a bird or bumper, I encourage him to retrieve it to me. Notice that I said encourage him and not command. I use the command words but always with an encouraging voice. Pup will soon learn to associate the command word with the task he is to perform.

When pup finally picks the bird up and brings it to me, I toss it out a few feet as a mark for pup to retrieve again. Guns are not to be used at this time. I try to encourage pup to keep a good hold on the bird while I put him in the heel and sit position when he returns with the retrieve. Don't be in a big hurry to take the bird or bumper out of pup's mouth. We don't want his second love (you) squelching his first love (retrieving) by ripping the object out of his mouth as soon as pup returns. Let him savor his accomplishment for a few seconds before you give the command to release. If pup is dropping the bird, it is your job to catch it before it hits the ground. Using more birds or wing-clips will help encourage pup to keep it in his mouth.

At first, I don't restrain pup from retrieving a marked bird. I let pup go for it as soon as I throw it. Keep in mind that a 20 yard mark for a puppy is like a 100 yard mark for an older dog. All we are trying to do now is to build on the desire and intensity for retrieving that pup was born with. If pup misses the mark, work him around so he is down wind of the bird and he will find it with his nose. As pup's enthusiasm for retrieving increases, I start with the steadying. Gradually increase the length of time that you are restraining pup before calling his name for the retrieve.

When pup does advance out in front of you, give him the command to "Hunt it up" in an encouraging voice. If he gets on a trail and seems interested to follow his nose, encourage him with the command "Find". It doesn't matter if pup remains hunting out in front of you or if pup picks up the trail in the beginning, middle or end. What does matter is that this field stuff is fun and exciting because birds are everywhere and pup gets his morale boosted by dad or mom.

The best advice I can give you on puppy training is to keep it short.

When pup is really showing his enthusiasm for finding and retrieving birds it is time to break pup to the gun. Remember, gun shy dogs are not born, they are man made. Be very certain that pup has a lot of enthusiasm for birds before you bring gunfire into the picture.

I start breaking pup to the gun with a 22 caliber pistol that is loaded with blanks. I toss a wing-clip out and when pup gets the bird in his mouth, I fire one shot. Watch your dog and if he shows any signs of concern, wait for a couple more days and lots of wing-clips before attempting to break him to the gun. At any sign of concern from your pup, do not fire the gun again that day.

The next step for breaking to the gun is to fire a shot as the pup is half way back to you with the bird. Then, fire a shot just before pup picks the bird up. The next step is when pup is half the way out to the

bird. Then, fire a shot when pup is within 10 feet of you on the return. Finally, shoot and then toss the bird. From the 22 I move the noise level up to a .410 then a 20 gauge and finally a 12 gauge. Use 12 gauge live ammo instead of the 12 gauge blank ammo when breaking to the gun because the "popper loads" are extremely loud. Be sure to back up to a lighter gauge gun or stop shooting if the dog is showing a great deal of concern for the noise.

Introducing pup to water requires a pair of hip boots or waders. Put them on and wade out into shallow water and call pup to you. Never drag or throw pup into the water. It may take time but you don't want pup to develop a fear of the water. Take your time and gradually walk out into deeper and deeper water. When pup is starting to show some confidence in his swimming ability, wade out with pup and toss a bumper or bird for pup to retrieve. Keep the throws short until pup builds up his confidence and then you can start moving into shore and increase the distance of the retrieves.

The best advice I can give you on puppy training is to keep it short. The quickest way to turn a pup off on retrieving is to keep throwing that bumper. Five or six retrieves of any length is more than enough. Always quit when pup still wants more. Be sure to keep the field work fun and exciting and you can start getting into the serious obedience and force training when pup is about five or six months of age, depending on pup's temperament. Right now, concentrate on building a proper training attitude. Desire, intensity, birdiness, confidence and trust in you are the main goal areas in puppy training.

Most all training books are geared for training the "average" hunting dog. There is no such thing! Every dog is totally different from the next, even when they are from the same litter.

Read everything you can about training dogs. Go to your public library or purchase your own training books from the sporting magazines or your neighborhood pet store. The more ammo you have in regards to dog training, the better prepared you will be to handle your pup when problems start to arise.

Being prepared will also save you a lot of time when problems do arise as you will already have an idea or two on how to either eliminate the problem or to prevent it from happening in the first place.

In the four years since I moved to a hobby farm, we have had two years of drought and one of flood. I lost 1,000 laboriously hand-planted trees to the drought and got my little prairie off to a very slow

start. The flooding killed 500 hand planted duck food plants. This year was a very pleasant change.

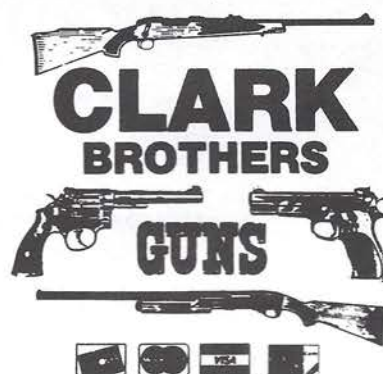
A host of waterfowl like my tiny marsh in spring. One day I had Spoonbills, Mallards, Wood Ducks, Teal, Ring Necks and Canada Geese at the same time. Maybe 50 total, but a very interesting group of visitors. Normal water levels permitted my new plantings of Duck Potato, Burr Reed, River Bullrush and Smartweed to do very well. In fact, unplanted Smartweed is doing quite well in my little hay field. Both prairie and marsh look great this fall to me, but the waterfowl disagree. Perhaps they are just saving the Duck Potatoes for Spring. In any case, the Mississippi isn't far away, so there are duck and goose dinners in the planning.

Two pairs of immature geese make pigs of themselves on my oats, but didn't nest. A pair of Mallards raised a brood on my place this summer and a Wood Duck nested in one of my boxes, though I never saw her ducklings emerge. I know I had a new family of coons. The Snapping Turtles found the marsh last year, so other hunters may also have found a meal.

I like traditional field trials (and go to a few), but I like NAHRA tests better. NAHRA tests are more like hunting and better suited to helping me prepare my own dogs for that. I believe you can still see excellence in the dog work at a NAHRA test without the competition of placements. My favorite hunting is for pheasants, so the upland work and trailing in NAHRA are especially valuable, even if they are not as difficult as water blinds. I will miss the tests and trials this Fall, but the truth is I'd rather be hunting. I've done what I can to get ready.

The dogs of EIHA are ready. I hope all of yours are too. Good hunting!

Sea Duck's Seduction:

Challenging chase tests hunter's skill, courage and endurance

An old duck hunter's aphorism holds that any duck hunt can be called successful when all those who started out return.

Nowhere is this wisdom better appreciated than in the pursuit of sea ducks; the three species of Scoter plus the Old Squaw. These formidable birds live most of their existence on large bodies of water.

Scoters arrive first, usually by mid-October. The White Wing is largest. Males sport a white eye patch and both sexes display the white speculum on its wing from which its name arises. The Surf Scoter male is sometime called "skunk head" from its forehead and neck patches of white set against a coal black head.

The swollen orange, black and white bill is quite also distinctive. The hen is dark brown and sombre.

The Black or Common Scoter male is totally black and its bill has a brilliant orange spot. Again females are drab.

The latest arriver on the Bay is the Old Squaw, smaller and swifter than the Scoters.

Although the Old Squaw, named for its plaintive call, exhibits three different plumages each year, in winter the male has white on head, back and breast. He

demonstrates a great long central tail feather. The female Old Squaw is overall brown and has a shorter tail.

Hunting sea ducks involves plying a small open boat in waters well offshore. Like most duck-hunting, the wilder the weather, the better the hunt.

Shooting from a bobbing skiff, one half a mile or more from land on the winter-wind-whipped Chesapeake challenges the above definition of success.

Yet one of the most popular Grand National Waterfowl Hunt activities is sea ducking. For the last several years, the weather has been foul, windy and rainy, for this part of the hunt.

Still, GNWH shooters speak with great enthusiasm about this experience.

Sea ducking starts well before dawn. Gear, decoys and lots of hot coffee are carefully stored in the duck boat. Attention must be paid to the most minute detail.

Once under way, anything forgotten, or broken, spells potential disaster.

The outboard motor must operate perfectly and an ample supply of gas must be at hand.

Tools, extra spark plugs, life vests and foul weather gear are as essential as shells, guns, and decoys.

The run to the hunting grounds is exhilarating. The Chesapeake in darkness is a different creature, more untamed, more ominous yet disquietingly beautiful.

The vivid colors of daytime have changed to subtle dark shades of purple and gray.

Wind and tide must be accounted for in the dead reckoning needed to reach just the right spot to set out decoys. The trip is necessarily slow to avoid hitting floating debris in the dark.

Anticipation of the coming shoot is high, yet tinged with a hint of danger when chilling bow sprays reminds that the Bay's water is desperately cold and merciless if swamping occurs.

Decoys are set with careful consideration of the forces of wind and tide. The goal is to mimic the linear array of these strong, graceful birds as they flock to feed on submerged mussel or vegetation beds.

Seemingly endless strings of sea ducks begin shortly after dawn. These flights reach a crescendo as the sun starts its mid-morning climb towards noon.

Gunning can be fast and furious, yet sometimes extraordinarily difficult.

One frustrated hunter likened the nec-

essary accuracy to William Tell trying to shoot his precious apple from the hand of a running child while riding on a bobbing merry-go-round.

The ducks are usually retrieved with a net and their sombre beauty admired.

Sea ducks have received a reputation as poor table fare. If they are correctly prepared by soaking overnight in cold, salted water then marinated for hours, they are delicious broiled.

Smoking is another favorite method. Sea ducks should not go to waste.

The pursuer of sea ducks must be both hunter and mariner. He must understand the winds of the Bay, her tides and her moods.

He must appreciate the habits of his prey and must recognize the need to take only those ducks required for personal consumption.

Finally, the seducer of sea ducks must recognize his link in a natural chain which starts in far Canadian breeding grounds, and involves a long, arduous migration. Our sea ducks are absolutely dependent on the great bounty of the Chesapeake for winter survival. Preservation of this habitat is essential.

The Arizona State Hunting Classic

It was a new experience for our dog handlers when the Valley of The Sun Hunting Retriever Club went together with Lolenda Labs and held a State Hunting Dog Classic. It was a two day event where no dogs ever go out and that made it fun for everyone.

The two categories for the event were the Novice Hunter and the Hunting Dog stake. The Novice stake was set up for the less experienced dogs including four land marks, two water marks and a quartering test.

The Hunting stake consisted of two double land marks, two double water marks, quarter and sit to flush and a land blind (there was going to be a water blind but due to lack of time, the water blind had to be eliminated).

The weather was a real treat for everyone. The Classic was held up near Flagstaff where the weather is about 20 degrees cooler than Phoenix.

A large board was posted so that as soon as each dog completed a test his/her score was posted so every handler knew

NAHRA Judges' Newsletter

Trailing

(from the Judging Guidelines, Ch. VI)

"Trailing" is perhaps the most independent function of the hunting retriever. Trailing is an area of hunting that cannot be accomplished without the use of a well trained dog. Locating cripples or providing game for the gun requires a dog that not only has a good nose but knows how to use it to follow scent and find game. A good hunting retriever is a valuable game conservation tool and should bring to the bag all downed birds. Human beings simply do not have the sensory ability to evaluate scent trails on the level of a good dog; this makes trained dogs especially valuable and presents challenges to human judges.

Dogs will usually follow a scent trail in three different manners: 1) Nose down on the trail and methodically following it to the bird. 2) Head up using a short quartering pattern across the trail until the bird is found or 3) Head high following the scent on the downwind side of the trail. (A dog can do this at quite a distance from the trail if the wind is right.) Any of the three or a combination of these methods are correct when a dog is following a scent trail and, if done with accuracy, he deserves the highest possible score.

It is important not to over scent the trail. If the trail is too heavily scented, it can confuse the dog. If the same trail is to be used for a number of dogs, it should be dragged again, but usually not more than once for every three or four dogs. Even such trails may "wear out" from over-scenting after a number of uses. (Inexperienced judges may feel that dragging a trail for every dog helps the dogs, but experience shows that this practice eliminates excellent trailing dogs in unpredictable ways.)

It is best to use a live bird or a bird killed at the beginning of the trail and then dragged off. A live wet duck dragged by the feet works well and such dragging usually doesn't injure the duck. (A dead duck can be left at the end of the drag. If conditions are dry, wet the duck before you drag it. Cold dead birds or a number of dead birds tied together are not recommended for the drag as they do not provide the best scent.)

Fresh ground should be utilized, when possible, to achieve optimum results and give dogs a fair opportunity. Every dog could thus receive its own fresh trail. However, this method requires a large amount of land with similar cover in order to set trails in non-overlapping areas. A compromise that still avoids over scented trails is to carefully mark several non-overlapping trails.

First drag one trail and run three dogs. Next drag the second trail and run three more dogs. Continue with new trails until you

run out of space and then return and re-drag the first trail for three more dogs and continue to the second, etc. The additional time between uses helps to prevent over scenting the trails.

The "drag" should be set up so that the dog does not accidentally locate the bird while just running about and not actually following the trail. The initial direction of the drag should have a long leg with the wind so that the dog cannot possibly "wind" the bird prior to reaching the end of the trail. (About 50 yards for the initial leg in "typical" conditions. It is often easier to evaluate a long trail than a short one. A dog actually working air scent off a

short initial cross wind leg may wind the bird before you determine whether or not it is really trailing, so don't start with a cross wind leg.) After the initial down

wind leg, there should be at least one cross wind leg.

Have the dragger exit away from the trail. Drag the duck in your footsteps to avoid laying two trails, a bird trail and a foot trail.

Released live bird trails for ducks and pheasants can work well, but only if the birds are good runners and you have the ample amount of ground needed to release new birds in fresh areas.

The trailing test is best run when there is moisture, (Early morning or late afternoon is the best time. Slough areas or damp grass provide the best locations. Shaded woods often works well.) Keep in mind the conditions at hand when evaluating each dog.

A trail should only be dragged in one direction, NOT OUT AND BACK! (One of the things a dog calculates, when on a trail, is the direction of the hottest scent. That is the dog's most accurate means of determining which way the bird went!) Turns should be put into the drag trail to see how the dog will recover and follow the scent. (Don't expect a dog to make the precise turns in the trail and correct itself back into the location of the scent.)

Remember, in all of our tests, marking, blinds, upland hunting or trailing, we are evaluating recovery of a dog and how it gets out of trouble rather than if he fell prey to it. Give a dog the opportunity to display his overall ability as a conservation tool.

The only time it is appropriate to use hand signals is to place the dog on the beginning of the trail, if the dog has worked its way out of the area. (Usually, the judge will instruct the handler to put the dog back on the beginning of the trail.)

Trailing is an area of hunting that cannot be accomplished without the use of a well trained dog.

First NAHRA Canadian Chesapeake Female to attain MHR



MHR-WR Chesnewton's Magnum Meggie, D.O.B. 8/9/93 completed her MHR in NAHRA on 3/26/94 at the Quail West Field Test in Parker, Arizona. She was the oldest dog of 18. Three other Chesapeakes were entered. Meg was born in Canada and has been running NAHRA trials in Manitoba, Iowa, California and Arizona. She is owned by William McNerney.

Springer Qualifies for WR and Brass Band

Dear NAHRA:

Find enclosed a copy of the registration papers and photo for our Springer Spaniel "Grouse Wings Nick of Time". Nick has qualified 5 for 5 in intermediate tests in 1994 to earn his Working Retriever Title and Brass Band. I believe he is the first Springer in Canada to achieve his WR, and second to earn a brass band after our other Springer, Jessie. Nick was trained and handled by my wife, Debbie. (I helped a little.)

I know you receive lots of letters from NAHRA members bragging about their dogs so one more won't hurt, Ha! Ha! I would like to let you know that our other Springer, Jessie (FTN 0469) has qualified at 4 NAHRA senior tests and along with her Intermediate Brass Band, has achieved the level of Master Hunting Retriever. Jessie cannot hold this title as she is not registered so I guess you will have to wait a little longer before you see the first Springer at the Invitational. Jessie is 18 inches tall and weighs 33 pounds and the last two senior events she qualified at were described by one of the judges as the most challenging tests he had seen in this region. One senior judge commented, "if she had a body to match her heart, she would be the biggest dog around". When I joined NAHRA 4 years ago, I was told by several people that trying to run Springers in NAHRA

tests was like trying to run the Kentucky Derby on a pony. I am proud to say that Nick and Jessie have proved otherwise. Debbie and I are strong supporters of NAHRA and you may note the high number of Springers running in the tests in our region. Thank you for being the kind of organization that is open minded to listen to wishes of your members and adding Springers to the list of eligible dogs that can receive NAHRA titles. We are the only hunting retriever test organization that, to the best of my knowledge, allows Springers to run in their tests. This past weekend, both Debbie and I were judging, so our 15 year old son Matthew, ran Jessie and qualified in an intermediate test (his first test). The smile on his face reminded me why I so love this hobby, and thank you to NAHRA for providing us the opportunity to pursue it.

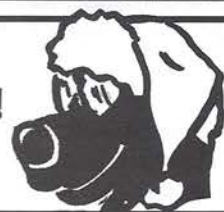

The Liar's Bench

"Lord amighty, honey," the grizzled old man said, "whyncha train Chesterpeaks? 'Em Western Shore Black dowgs iz aright for fancy trails and such, but can't stand neither tyum in cold water. And that's the smart of it!"

"Take all 'em lapradores and swump collies back to Talbot County. They never could stand real Murlin fowlin'."

His two coffee stained upper incisors dully gleamed at Cod like tiny tombstones in a field of palled pink. His eyes, though, were incredibly blue and shone with intelligence and humor.

The long retired waterman sat on the Liar's Bench outside John Spedden's general store ready to launch an opinion toward anyone who'd listen. The dogman was an easy target. Everyone knew what he did for a living and most everyone held strong views about dogs.

Cod frequently stopped at Spedden's to buy bread, sandwich meat, mayonnaise and Pepsi Cola. Sometimes he'd order a Spedden Special Submarine (Roloids extra) for lunch and hang around just for the company. The conversation was ubiquitously conservative. No, that's too mild a description. Poor, dead John Birch was a radical left winger compared to Spedden's noontime regulars. Solutions for "Murrigan political woes were easy. Nuke 'em all, Eerack, Eeran, Balmur, Nappolis and, particularly, Warshon, D.C., our nations capitol." Minorities, the source of all social evils, included everyone except you and them. And they weren't real sure about you. Minorities sucked up welfare tax dollars, had too many children, polluted the earth, and made rockfish, clams, oysters, even crabs scarce. And minorities were all criminals.

Cod tuned most of this out. The dogman was apolitical. He had enough of his own problems not to blame others, ordinarily. Cod's personal modification of the Golden Rule was Don't Do Unto Others. They'll do unto you soon enough, why draw attention.

Cod really enjoyed listening to the old timers, though. A lot of their talk was exaggerated, plain made up or some disjointed composite of actual events from very long ago. However, these patriarchs were connected to a distant time and another reality on Maryland's Eastern Shore. They remembered an era when waterfowling was easy, access to hunting unlimited and the social order revolved around seasonal outdoor activities. Hunters were respected and dogs were an integral part of everyday life. Times have changed.

Back then a hard working man could feed his family from his own garden and the Bay's bounty. A few could even make a decent living from these same sources. A hard working, fiercely loyal retriever was a necessity. That life was eroding rapidly, Cod was convinced.

Particularly intriguing to Cod were verbally recounted pedigrees of working dogs known to these men who had spent a long lifetime roaming the watery channels of the mid-Chesapeake's marshes. Cod knew that AKC "papers" had often been manipulated in years past. A six generation pedigree might not accurately

ly reflect true breeding lines for some local water dogs. In many instances there was no AKC registration at all, only remembered, almost Bardic, history of lineage. Yet Cod knew many retrievers in the area had been carefully and selectively bred from stock owned and trained by generations of watermen, trappers and market gunners. These dogs had to earn their keep by retrieving, guarding and protecting. And these were traits selected at breeding. The old timers knew the families and their dogs. Cherished tales about canine stoicism, hard work, formidable accomplishments, even heroism, were recounted many an afternoon on the shiny wooden bench at Speddens.

"Member that li'l hump backside uv James Island? Lester Griffith yewsta holt a lease 'ere. We brung home a heepa river ducks em yars!"

The old man was dredging up his youth. There was sure to be a Chesapeake dog in this story, Cod knew. The tale teller's opening challenge augured as much.

"Him 'n me and that big yellor eyed devil he alus carried went duckin' one cold Janry mornin'! Soweest wind blowin' right heavy. Cold, too, 'n spittin' snow. Damn, we knowd them 'cans would move good. Figured theyd hold up in a lee off that lump."

The tiny tidal island lay across a deep gut about one hundred yards from the tip of the the main island. The two youths had rowed their gunning skiff into the wind to get there, then tied the boat in a small indentation in the bank upwind from where they would hunt. Sedge and driftwood were arranged into a blind. A few hand made wooden decoys were set out. What a price those counterfeits would bring today! The huge brown dog with Damien eyes sat outside their hide peering into the snow squall for incoming canvasbacks.

"We kilt a pile of fowl that day, we did. Dowg fetched ever' last one! Then I seen the skiff headin' for open water. Damn fool Lester never could toy knots!"

The elderly gentleman paused for breath. Fifty years of Pall Mall regulars and wood burning stoves had taken their toll of his lung capacity. He also waited for Cod to appreciate the deep dilemma a lost boat posed for two hunters on a tide washed mound in the Chesapeake Bay in a January snow storm. The situation was vividly grim. They would probably have succumbed to hypothermia before anyone even knew they were missing.

The knarled waterman continued.

"Lester 'membered hiz old dowg tow'd chirn around in a dory sometimes. He showed the dowg 'at boat and toad 'im, fetch it! Damn dowg dint move, jest stared at 'im. Lester hullerd louder, like a scairt chile. Tereckly thet Chesterpeak entered the water and swum off. Snow come down harder. Could barley see the dowg. I figured weez gunna pass this lahf with a cold, wetass!"

"After a rahl long swim, the dowg caught up the painter commenced tuggin' on it. The bow come 'round and the dowg slowly swum back. Made piss pore headway 'gainst 'at starm!"

"Lester was up to hiz boots in wadder calling after 'at dowg like he 'uz a puppy, cloppin' his hands and sech. Took most anar

but damn if'n he finally dint came up on Lester so's he could grub the rope."

"Dowg was about stove in. Lester guv him some ginger brandy. Then he drank some hisself and I did too. Then we all had 'nother. Commenced to laugh so hard, I peed my pants. Then we rowed home. "Nuff duckin' fer one day!"

Cod asked what that dog was named. That waterman said Lester never called it anything but "dowg or summabitch". However, he added that everyone on the island knew Lester Griffith's big old dog. Cod asked if that dog had sired any pups. The waterman allowed that Lester did breed the dog on purpose a few times, if there was a right bitch. The retired waterman also implied there were a lot of curly haired yellow dogs in the South county marshes who carried some of that blood. Any deadgrass, big headed hard driving local waterman's Chesapeake might have a drop or two from the midnight stud services of Lester Griffith's old water dog.

Cod tried to pump the old man about who might now own a Chesapeake from that line. A lot of familiar last names rolled off the cracked lips; Ruark, Abbott, Snow, Hooper, Todd, more Ruarks, a whole lot of Smiths, Jones and Phillips. The dogman became totally bewildered, having grown up elsewhere than the Eastern Shore. He had no common personal knowledge which Sonny, Gibby, 'Pooh, Johnny Boy or Trip matched what surname. Still the ancient repository of marsh dog history seemed sure and confident as he listed various owners of his friend's Chessie's offspring. The old gentleman recounted personal experiences with many.

Cod looked at his watch. It was 3:30. He'd been talking for over three hours about dogs with a toothless octogenarian who never even owned a retriever and didn't think much about Cod's favorite breed, the Labrador.

"Oh my blessed, that's 'nuff 'bout wadder dowgs. Lets talk on moskeeters. Seen un near Crocheron so big hada FAA number!! Ha,ha. Saw 'nother on the Honga carried two blood ticks. Said Black and Decker on its sticker. Haw, haw!!"

Cod left, still confused about who owned which dog, but also strangely elated. Maybe some day someone would remember him, his good dogs and recount tales of their exploits.
