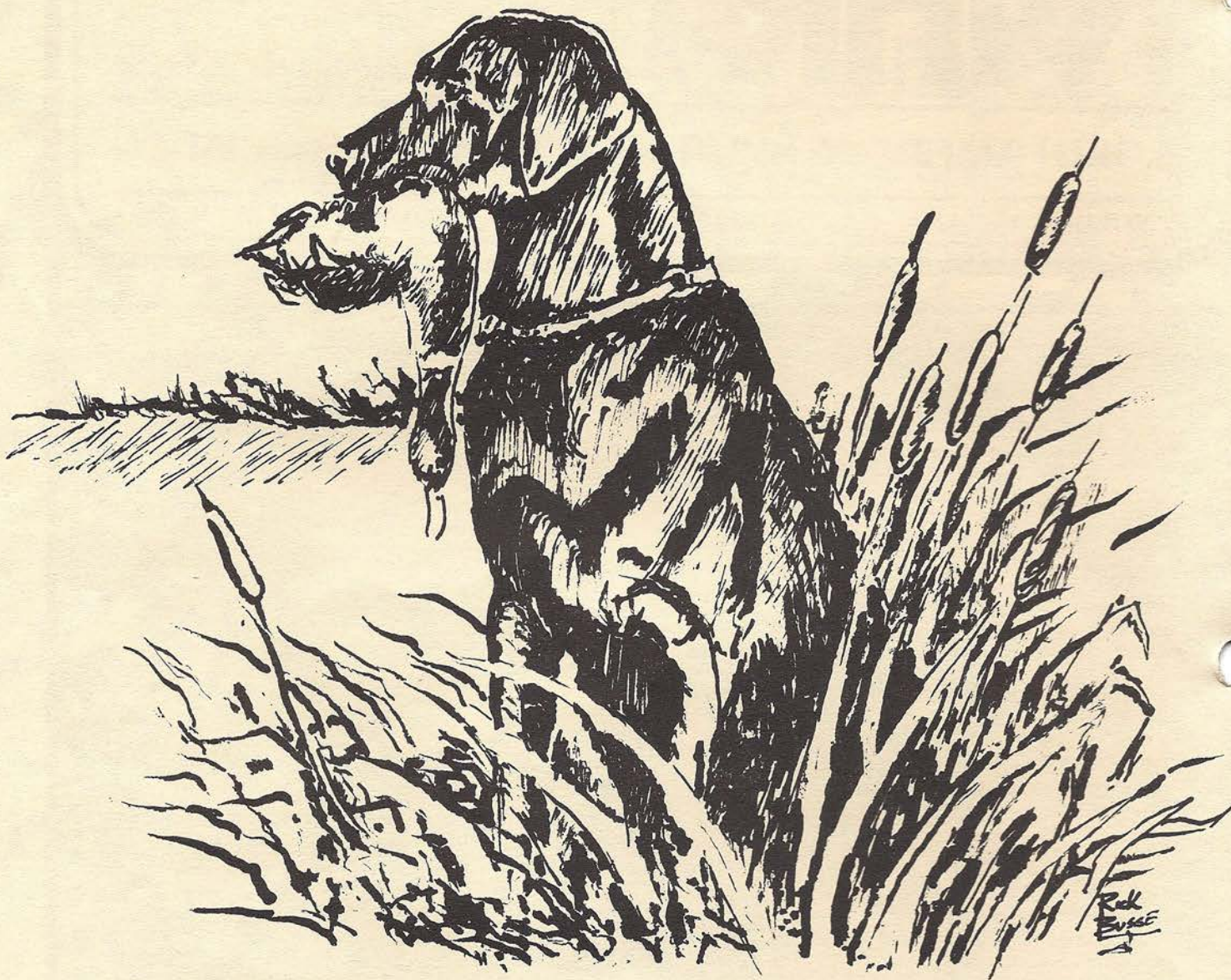

# PRESIDENT'S BARK

Those of you that have been a part of NAHRA since its beginning know the history. A spark was ignited and kindled to be a fire to be remembered. Fifty-five years of traditional Field Trial history was rocked with the new concept of testing retrievers against a standard and not against each other for placements. Today, three organizations exist that test in excess of 30,000 retrievers annually. NAHRA continues to grow at a substantial rate each year. We have 11 new clubs, 300 more members and 25 new Sponsor memberships in 1990 as well as 20 GMHR's, 60 MHR's and 80 WR's awarded titles. Since the NAHRA licensed testing program began, our records indicate that over 3,000 Started certificates have been earned. Ti-

ties have been awarded to 434 WR's, 218 MHR's and 67 GMHR's.

Host clubs and dates have been selected for Started & Intermediate Regional Events for 1991. A complete list appears on page 24. The Invitational site for 1991 and a date has yet to be determined. The field for next year's Invitational will be filled by an estimated 90 or more Senior dogs that have earned 100 or more points in 1990.

A special thanks is appropriate to all workers and participants who organized and ran the Southeastern NAHRA event in Laurel Hill, North Carolina on August 11-12, 1990 to raise money for a color membership brochure for NAHRA. The event netted over \$2,000 which is being used to fund the project. Another event is scheduled for November 30, December 1 and December 2, 1990 with a double Started, Intermediate and Senior event estimated to more than double the proceeds of the August test. I have been asked to issue a challenge to other parts of the country by the Southeast to pitch in.

Winchester - Olin continues to support NAHRA and will print the new rule book for 1991. Ammunition for the Regionals and the Invitational will be supplied by Winchester.

Three years ago I made an attempt to generate a Judge's Newsletter. I asked for input from the over 300 certified NAHRA judges to help with the project. Only three individuals responded to the request and the project was shelved. I have had many requests to make another attempt. Chuck Breslin is spearheading the new project and has been joined by Keith Stroyan, one of the three people to give response to the first attempt. Good luck, guys. I think we are in need of a direct line of communication with our NAHRA judges. Clubs can help by making an effort to host judge's clinics in 1991 to ensure greater uniformity in judging.

Canada has three MHR's this year and all are members of Manitoba Hunting Dogs. Norm Elder led the way with his female Lab MHR WR River Oak Meg. John Stiver was next with MHR WR Bruce's

Midnight Max and Brian Sparks with MHR WR Black Drake of Netley Lake, the first male MHR. Congratulations, guys!

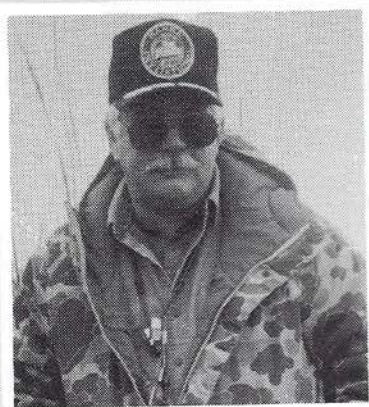

# LETTERS TO THE EDITOR

Dear Jack,

We don't have to 'compete,' it's like basketball players respecting football players.

Richard can be a little difficult, I suppose. But we all owe him thanks for finding the facts and sticking to his principles 'til he got the job done. Read the book! Our grandchildren's hunting retrievers won't know it, but if we keep doing our jobs in NAHRA, they will need to thank him, too.

## VETERINARY CORNER

### The Making Of A MHR

(continued from last issue)

Now that the puppies have been delivered and have been started on a socializing program by tube feeding them twice a day, we certainly cannot forget the mother. Take her to your Veterinarian to make certain she has had all her puppies. Many times one puppy is still in the uterus and oxytocin will expel this last one. The bitch should be put on ampicillin for seven days and oxytocin four times a day for three days to help expel any placenta and other secretions that remain in the uterus. The pups at this time should be checked for any abnormalities such as cleft palate and abnormal anal or urinary formations. At this time you can remove the dew claws, or I prefer to wait three days so the pups are a little stronger.

As soon as the bitch whelps I put her on a good puppy food, not before. A good protein food before whelping is all she needs, however, after whelping she needs all the protein, minerals and energy that comes in a good puppy food.

For the next three weeks, if you will clean the swimming pool daily as needed

and tube feed the pups twice a day, the bitch will take care of the rest.

Day 21 - take your pups to their doctor for a check up and their first deworming. As soon as you get home you need to start feeding the pups milk out of a shallow pan. My schedule is stop tubing—

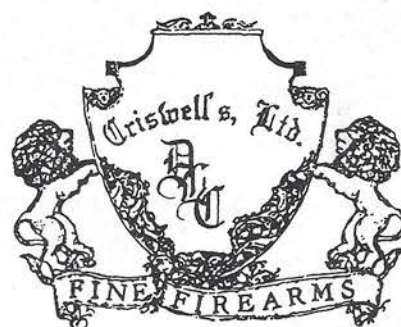
Day 22 and 23 - milk in a pie pan  
Day 24 and 25 - milk and bread in a pie pan

Day 26 and 27 - milk and softened puppy food

Day 28 - on milk and puppy food - all they will eat in 10 minutes twice a day.

By now I am having a hard time keeping them in the pool and I take them to the pen where I have a heat lamp over them when the weather is below 60 degrees. I wean the pups at 5 weeks and vaccinate and deworm them at 6 weeks.

By the seventh week I try to have all the pups homes and I usually am not sorry to see them go.

# WOLTERS SAYS...

I've been commuting to Texas and the surrounding area more than I have been going my usual commute from Ossining, New York. The next trip down will be a book signing at Legend Outfitters in Houston and they are making it a dual affair. We will sign books on Friday and Saturday and then have a Sunday seminar on training and NAHRA at some ranch in the area. I once had an English professor in college... almost fifty years ago... who said, "Never say that something is the best in the world. Say it is one of the three best. That way no bastard out there will be able to challenge you." Well, let me tell you that the Legend Outfitters sporting store is the best in the... well one of the three best... in the country. This ain't bib overalls and stuff. This is fine tweeds and tattersall shirts, which Jagoda wouldn't even know about. Their gun department could make you drool for a week. They are really interested in the NAHRA program so we are going down to spread the word.

The word down there is already being moved around. Joseph McCann out in Oklahoma started a club and now there are two... a third we think is on the way. I went down and judged their first event and was really impressed with their dogs and the club mechanics. You would have thought they were old hands at the game. Of course they did have a lot of help and went from the Texas gang, led by Don Ory, as they came over to run their dogs and help out.

The Dallas crowd had an event a week or so ago. Will Schubert was a fireball

chairman. Their event ran just as smooth as our Invitational last spring in Georgia, and those folks down there in the southland are old hands at putting on a first class act. Schubert placed a good article in the local paper and boy did it draw. The phone never stopped ringing for reservations. The paper mentioned that I was to give a seminar at a local rib house on Friday night. It was standing room only! God I looked good in my Legend Outfitter's Tattersall shirt!

Interestingly, at the seminar we had quite a few Hunting Retriever Club folks and some AKC'ers. Texas is a big area and all three retriever organizations are now running events there. We are the new kid on the block and we're stirring a lot of interest. My suggestion to all of them is that the dogs do not care what ribbon they get if they pass the test... they'll love anybody's show... so run them all. The dogs will be that much better for it and the handlers might learn something from the new kid.

I judged Started. We had forty-three dogs and we passed twenty-seven of them. They were really good. It would have been twenty eight but for an unfortunate happening. One little lightning of a black bitch was doing her last water retrieve. The bird was shot in the air and fell in the water making a big splash. The dog charged through the running water so fast that the guns, who had not fully hit their mark, could not slew lady duck sitting there as brash as could be, just waiting for that dog. As both ladies came eyeball to eyeball the hen struck first and planted her beak between the black gal's eyes. Hollering and screaming, the one with the four legs ran back "on top of the water" for land. She did not get the bird so she had to be dropped after a series of other-wise perfect work.

This is not a laughing matter, as you know. We stopped the event and worked her with a dead duck to help the pup over the fear. With a little bit of luck and a good night's sleep... next day the pup did fine. She had the guts to forget the whole thing and go about her job.

Let me tell you about one of these new, first time, handlers. I'm terribly sorry but I can not tell you his name... and you will see why.

Let's just call him Joe. Joe came into the Orvis store early this year. He had a brand new black pup. He had seen Tar and me do a demonstration at a Sportsman show in New Jersey early last winter. Somehow he knew I worked at Orvis and he just wanted to talk dogs. Most of our customers come into the shop in three piece business suits. Joe came in the store a few days before that weekend. He looked sick. This great big hulk of a guy had stooped shoulders. His tee shirt hung loose. His face sagged.

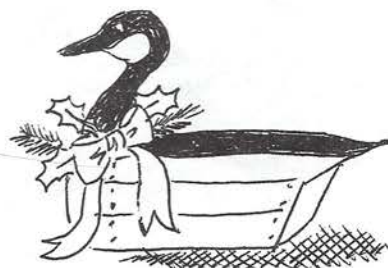
"Joe," I asked, "What is the matter?"

"Joe, what is it?"

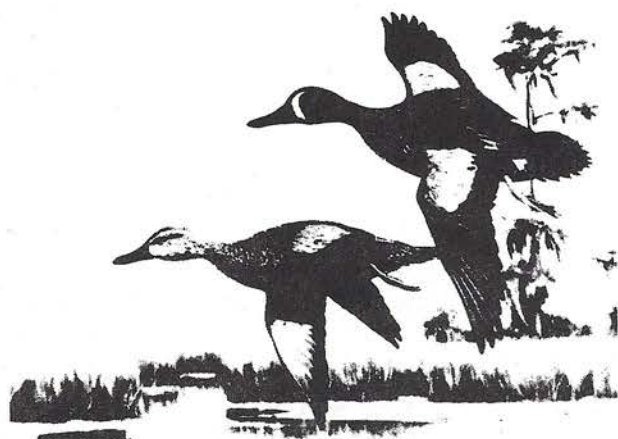

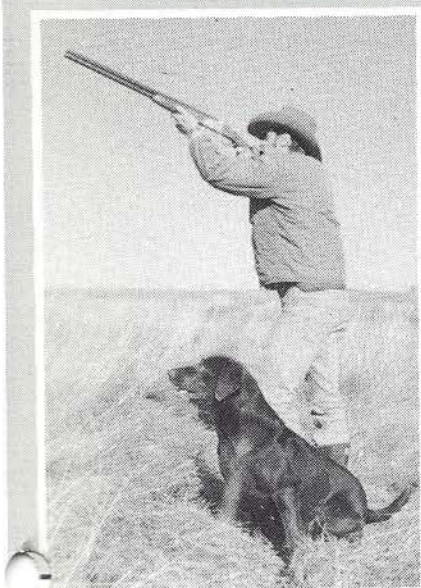

# TRAINING TIPS

Gary Erickson



I can't believe the huge jump from Started to Intermediate! It's just too much for my dog. Not only does he have to be steady and deliver to hand, he has to trail, hunt upland game and run a water blind. It will be a couple of years before my dog will ever be ready for the Intermediate!

To prevent you and your dog from falling prey to this scenario, you must train your puppy with the Senior in mind. Upland hunting, trailing, multiple marks, blind retrieves and non-slip retrieving are not required of a Beginner or Started dog in the NAHRA program, however, you as a trainer must begin introducing your dog to these concepts long before he/she becomes a Certified Started dog.

An understanding of the concepts of all of your commands ("Heel," "Sit," "Stay," "Come," "Down," "No," "Mark," "Dead Bird - Take a line - BACK," "Over" and "Back," "Find it" and "Hunt it up") and all four areas of expertise (marking, handling, trailing and upland hunting) should be taught to your dog when he/she is still quite young.

Then, you enter your dog in the Beginner, Started, Intermediate and Senior levels as your dog's response to commands and its performance in the four areas of expertise becomes more proficient and polished.

There are numerous ways of training a dog. The key isn't so much how to train but rather what to train and when.

Starting with pup at seven weeks of age, your goal is to get him to understand the concept of various "words" and with constant repetition the "words" will be associated with a particular task and they will eventually become "commands."

All puppy training should be fun and filled with excitement and encouragement. The idea is to trick the pup into doing things correctly not to force him. Take advantage of all positive responses from your pup by reinforcing that desired behavior with the correct "word" and praise pup upon completion of the task at hand. Eventually, your pup will learn the association between the "word" and his response.

The trick to conditioning a proper response is to say the "word (command)" just as the pup is responding correctly. By being consistent and only saying the "word" at the proper time, pup will learn what response is expected for a particular "word." Then, it's only a matter of time until the "word" becomes a "command."

When you start teaching your pup to retrieve, he must learn to look out in front to watch for something to fall. Give the command "Mark" as you toss the bumper and he will soon learn to associate the word "Mark" with watching for something to fall. (I release pup to retrieve marks by saying his call name.)

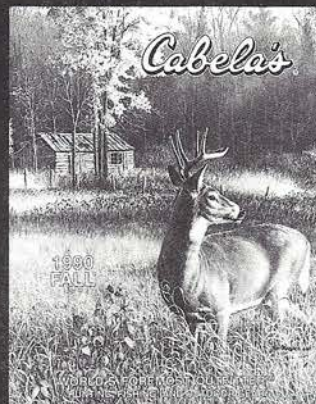
Your pup can learn simple baseball and lines to sight blinds at a very young age. Just remember to keep things extremely short and highly visible. Your yard is the best place for the initial training. All you are trying to do is to get pup to associate the words "Dead bird, take a line, BACK!", "Over" and "Back" with the proper response.

To teach lines and retrieving an object that hasn't been thrown, use a white bumper and place it so pup can easily see it from his point of origin. When pup eyeballs the bumper and wants to go, say "Dead bird, BACK" and release him for the retrieve. Through constant repetition, pup will soon learn that "Dead bird" is a preparatory command for making a retrieve that hasn't been thrown. "Back" will become the release for this type of retrieve.

Over the course of time, his obedience will improve and you will be able to restrain him longer. Eventually, you will be able to get your hand down to give him a line to the sight blind. You will also be able to have him sit and stay as you toss a bumper out behind him for the "Back" and out to either side for the proper "Over."

A puppy can be trained to associate "Find it" with using his nose to trail scent. Allow a wing clip to walk around in light cover while you get pup out of the crate. Then, encourage pup to walk around in

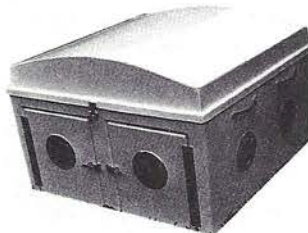

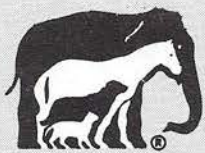

## Morris Animal Foundation

### BLOAT DEADLY TO DOGS

"Buffy was fine yesterday. This morning when I got up she was dead. The doctor said it was 'bloat.' I never even heard of bloat. How did my dog get it?" the caller said.

Several times each month Morris Animal Foundation received such calls in its Englewood, Colorado, office. Other calls detail the grueling experiences of dog owners who, more familiar with the non-specific early symptoms of bloat, have rushed their dog to the veterinarian for emergency surgery.

An estimated 60,000 dogs a year are affected with bloat. Veterinarians call it gastric dilatation/volvulus. The animal's stomach swells with gas, and may twist on itself, cutting off blood flow and leading rapidly to shock. As in Buffy's case, if the dog's owner doesn't recognize the initial symptoms—pacing, restlessness, trying to vomit—death can result within hours.

Bloat is a medical emergency. Early treatment, often including surgery to correct the twist, saves most dogs. No one knows why bloat occurs. It affects primarily large breed, deep chested dogs, and also Bassett hounds and dachshunds.

Morris Animal Foundation has made bloat a priority for study for many years, and has convened several panels on the topic. A new Bloat Panel will meet November 3 and 4, 1990, in Chicago.

Clarence Rawlings, D.V.M., Ph.D., of the University of Georgia, attributes many advances in bloat treatment to the Foundation's work. He told the Foundation's Board of Trustees that when he began surgical practice about 25 years ago, 25 to 30 per cent of dogs survived bloat surgery. Today, 85 to 90 per cent survive.

New surgical techniques and pre and post-surgical treatments have advanced dramatically. However, scientists are no closer today to answering Buffy's owner: "Why did my dog get bloat?"

Worse yet, research in this field is at a virtual standstill because of lack of funds. The Foundation gathered experts in the field of bloat three years ago to assess progress in bloat study and establish priorities for future work. They recommend an epidemiological study to determine which dogs get bloat and how they are fed, housed, trained, etc. To date, this work has not been conducted because there is not enough money for bloat study.

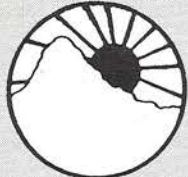

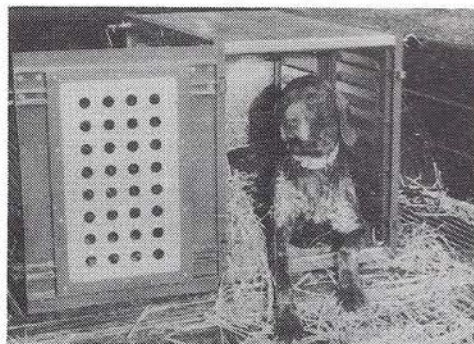

# OF HANDLERS, JUDGES & DOGS

## Lunch with Robert Sanchez

(Part 1 of 3)



Robert Sanchez

**INTRODUCTION:** His friends call him Bob and they include the rich and the famous. He is a real gentleman who commands respect because of his accomplishments, ability and knowledge. He is the hunters' hunter and has hunted all over North America, South America and Europe. He is the shotgunners' shooter and made his living for years shooting the European Flyer circuit. He was gun captain and an official gun for the Springer Nationals for nearly 20 years. His reputation as a dog trainer is legend; he has trained English Pointers, German Shorthairs, Labrador Retrievers and Springer Spaniels. He has made six Field Champions. He was director of hunting at Coto-de-Caza, one of the most outstanding hunting and shooting operations in America, for about 15 years. He has been a consultant to shooting and hunting clubs all over the world. His real love is training hunting dogs with the emphasis on HUNTING.

I first met Bob half a dozen years, ago but I knew him by his reputation for over 30 years. I went to the ranch the morning of October 5th. Bob was putting a little polish on his Springers before the weekend field trial at Pahump, Nevada. He shared his thoughts with me at lunch while we ate his famous grilled chicken cooked over orange wood coals.

We introduced sporting clays at Coto-de-Caza some 20 years ago. They were not called sporting clays when I played with

them. I got the idea from a book about an event in Chicago set up by Marshall Field. A good friend and the Shooting Editor for Field & Stream, Bob Brister, is the man who really introduced the sport to Coto-de-Caza.

The setup included a duck tower, a quail walk and a crazy quail. The duck tower provided a variety of things including incoming shots, cross shots and over the head shots. The quail walk was really the best test. The hunter would walk down the path. Launchers are tripped without your knowledge. There would be about 10 launches and they could be singles or doubles. It was a great training test for the hunter.

The quail walk with the dog at heel makes a wonderful hunting test (walk up). This is the way we hunt quail in Mexico. We keep our dog at heel and flush our own birds. The dog makes the retrieves. The path could be set up with release traps with one or two birds (pigeons, quail, chukar or pheasant). The birds would be launched and shot. This is a true hunting test for a dog that is heeling (walk up) and not hunting (quartering). It gives the gunner a good chance to shoot and the dog a good opportunity to mark the falls. It makes a good training situation. This is one thing that sporting clays has introduced to dog training.

I do a lot of quail hunting with labradors in Mexico. In fact, I've shot quail over labradors throughout most of the world. The very best way to work a labrador on quail is to walk with the dog at heel. I am not talking about hunting bob whites where a good covey is 10 or 12 birds and you need the dog to find the birds. I don't need a dog to find the quail for me in Mexico. I just hunt correctly: walk, stop, listen; walk, stop, listen. I can flush more quail this way than the dog can find. After I knock them down, I can't find them. I could knock down two or three and not find any because of the heavy cover. This is where the dog comes in.

The dog should have the ability and desire to hunt with the nose as well as with the eyes. Too many retrievers are strictly sight hunters. I think this is a terrible thing. I want a dog to use its eyes and its nose. I NEED THE DOG'S ABILITY TO SMELL BECAUSE I DO NOT HAVE THAT ABILITY.

I train a hunting dog to hunt from heel by walking the dog directly into a light

wind and toward a freshly killed bird in cover. The moment the dog makes scent, I repeat a command such as 'find it' or 'dead bird' or whatever command you want to use. The dog associates the command with the bird in his nose and his release to go hunting. It is real simple. He must associate that he can be walking at heel; and when you give your command 'find it', that means go use your nose. This comes through repetition, repetition, repetition. This is a drill that I have taught to all my gun dogs for over 30 years.

**THE VERY BEST THING A DOG CAN DO IS TO FOLLOW A CRIPPLED BIRD AND COME UP WITH IT.** That is conservation. You can go over and pick up a marked bird. That's no big deal unless the fall is in heavy cover. The asset is having a dog that can follow the cripple or find the bird in heavy cover.

**A QUAIL DOG MUST HAVE STAMINA.** You try to build the dog up through a conditioning program. A tired dog will usually turn its nose off. A dog will quit hunting when it gets tired. I freshen up my dog with a little water. I sponge his nose and mouth. A wild animal really only wants to hunt when it is hungry and they only want to hunt when it's cool. When the weather gets hot, it will want to lay down in the shade somewhere just like the game it is hunting will do. You are pushing against nature when you ask a dog to hunt. The dog must be in condition; and that isn't all. The dog must be set up correctly; that is, he must have good conformation. He must be a real athlete. He can't have hip or elbow dysplasia. He can't be overweight. I prefer the racy looking labrador rather than the cobby English style. They are supposed to be the water dogs. To me, it's not water dog; it is hunting dog.

**I WANT A COMBINATION DOG THAT CAN HUNT BOTH LAND AND WATER.** I believe the best hunting dog you can have today, not the most thrilling but the best, is the Labrador Retriever. He must be trained like a springer and a labrador. Now you have a combination that is really, really, really something. This is the dog that the guy who goes hunting occasionally or hunts all kinds of game can use better than anything else.

An English Pointer, of course, is the top of the line when it comes to hunting on horseback or even just ground hunting. It's a beautiful thing to see a dog come flashing on point with the high tail. I think it thrills me more than any other dog.

**SOME THOUGHTS ON TESTS:** Natural hunting conditions are hard to duplicate. The way we throw our marked birds is artificial. And so is the way we keep our dogs from using their noses. The trick of the dizzy bird is also a little artificial; but it is closest to a natural condition for the hunting (quartering and flushing) tests. I don't think traps should be used on

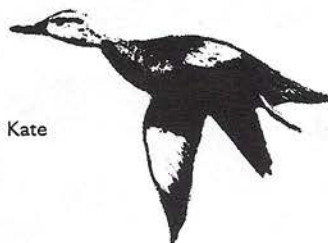

# Warden's Friend Fund Established

On June 23-24, 1990, the Blackhawk Retriever Club of La-Crosse, Wisconsin, made NAHRA history. The BRC hosted the first-ever, NAHRA "charity field test."

The project began in January when club member Mike Helgeson proposed the establishment of a relief fund for the families of Wisconsin wardens who are killed in the line of duty. The Wisconsin Conservation Wardens Association was contacted and they were very supportive of the idea. As their president, Warden David Arendt, said, "The family has *immediate* needs which are not always met by insurance policies and pension funds." So began the "Warden's Friend Fund."

The club membership voted to donate 100% of the profits from the June NAHRA event to start the fund. It was hoped that other sportsmen's organizations, corporations, and individuals from throughout the state would learn of the fund and also make contributions. In the future, once the fund reached a sufficient amount, excess monies could be used for scholarships and other worthwhile causes.

The organizing of the event then began in earnest. Mike Helgeson and Dan Kunz volunteered to co-chair the charity aspect, while Brent Helgeson and Dan would run the field tests. Letters were sent to prospective corporate sponsors. Press releases were sent to the state wire-service. A local newspaper and television station did feature stories on the project. Local businesses were asked to donate raffle and door prizes. NAHRA president, Jack Jagoda, agreed to fly in and judge. Local wardens called to lend their support.

After months of planning and working, when the dust had settled and the final tally was made, 140 dogs had run the two days of tests and the Warden's Friend Fund had an opening balance of \$2000! Handlers and workers all agreed that the field tests and the fund-raiser were a great success.

At the time of planning the activity, a Wisconsin warden had not been killed on the job in nineteen years and yet it seemed like the fund was a good idea. Unfortunately, how good an idea it was became clear in a very short time. On Tuesday, June 5, less than three weeks before the field tests, Warden Andy Krakow, age 41, was shot and killed by a thirteen-year-old boy, while assisting the Marathon County sheriff's department in answering a domestic dispute call. He left a wife and sons age 11 and 14.

Was all of the work and worry of hosting the charity event worth it? You bet! Even more than the obvious public relations benefit to the retriever club, the thought of Andy's wife and sons and others like them in the future make us glad to have played a part in starting the Warden's Friend Fund. Our thanks to NAHRA, Jack, and all of the handlers and workers who made this a truly memorable field test.

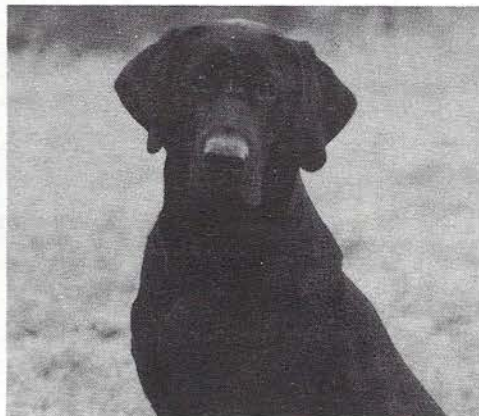

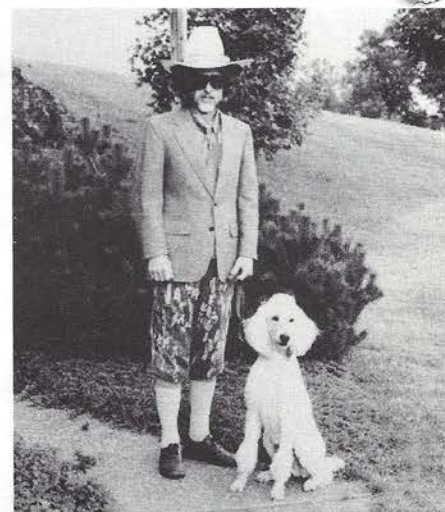

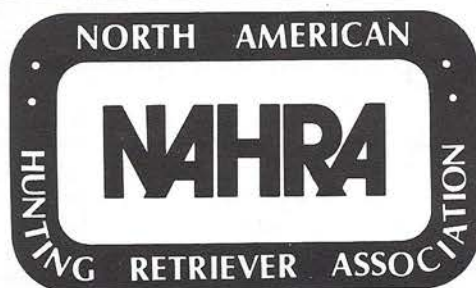

Last month I took delivery on a four month old Chesapeake Bay Retriever pup. I immediately placed her in training for field trials with me as the trainer. At this point in her young life, she is about two years ahead of most field trial prospects. She is obviously intelligent and

learned to sit, stay, and come to me in almost no time at all. She retrieves objects on land better than most older dogs, and last week I started teaching her hand signals. However, she has developed a few problems on retrieving in water.

Dear Field Trialer,

Please take your time and read this letter and the attachment. This year we have a chance to change 5C and *if we are* to continue with our sport, there is no doubt that we need some changes.

## WHERE TO IN DOG TRIALING?

I am writing this letter to you as I am worried about the direction, or, should I really say, non direction of our field trials.

I have been participating in field trials longer than any other trialer around today (I started in 1970) and have watched the ebb and flow of participants over the years. The numbers never really seem to increase. You have the "die hards" that have been participating for many years and will not pull out no matter how bad things are going, but the bulk of newcomers seem to get disheartened by really not achieving anything and leave before they have a chance to do anything. Why?

It always seems to be old hands that *win* everything. If the Tony Schuils were not winning the open then it was the McCormicks or myself. In order to achieve any recognition you had to *win*. And to try to stop the old hands *winning* the judges set up more and more complicated retrieves to try to beat the *winners*. Retrieves got longer and longer, and marked retrieves became fleeting glimpses of birds thrown in thick trees behind the dogs back. What happened? The Schuils, the McCormicks and Tait continued to win the opens, but in the novice stakes participants no longer ran novice retrieves but virtually full blown open retrieves and junior stakes became novice stakes and very few new comers were able to complete a trial. Great encouragement for new comers! !

I have waited a year since my trip to America to write this letter because I wanted to see what was happening in the Junior and Novice stakes. Comments: Junior so far - Ok, but for one trial that was virtually a novice stake, but a great amount of dissatisfaction in Novice and Open.

A couple of novice handlers up from the Cape and Natal passed a similar comment "Why should we come all this way to run in an open stake when we entered the novice stake." I agree with them. Some of the retrieves set in the novice stakes to date have been full blooded open retrieves. Are we trying to encourage a sport or are we trying to keep all new comers out and only allow the "die hards" and experienced hands to *win*? A lot of handlers do not have the benefit of experienced people to work with and have to battle on their own.

What is the point of a 200 yard blind where the highest mark is 5 and the rest either out of control or l's. What does this prove? I feel it proves nothing. It just blows all and sundry out and leaves the hardened people at the end. The few that have a chance to *win*.

How many new people in trialing get beyond the first three retrieves of most open stakes?

Roxi McCormick and I went over to America in May last year to compete, as guests of the North American Hunting Retriever Association ("NAHRA"), in their championships. 41 dogs including our dogs took part. These dogs were the cream of the top NAHRA dogs in the United States. How many competing members did they have at the time? Some 14 000. How long had NAHRA been going? Some 5 years. Why did NAHRA start? Because the hunting 'man' who has enjoyed competing in trials got sick and tired of the circus tricks being asked by the judges in the American Kennel Club Trials. A 250 yard blind where a dog that ran a few metres off line was discarded. The only people that ended up *winning* were professionals who had all day to train. The person out to enjoy himself just had no chance to compete at all.

The aforementioned is why NAHRA was formed. To save the hunting instinct of the retriever and to provide enjoyment for the participants. The professionals never gave it a chance of getting off the ground and scoffed at it - Ha! Ha! NAHRA is now growing so rapidly that most of the scoffers are now members. There were well over 70 trials a year from the southern most tip of America to Anchorage in Alaska.

What are the *two main* reason for their success.

1. *No placings are awarded.* That's right. No first (*winner*) second, third etc. What happens is that competitor and dog must beat the standard. Their trials are set up so that maximum number of points are 100.

In order to qualify your dog in a trial you need 80 points. Hence everybody that gets 60 points or more qualifies.

Now for qualifying you get X number of points, these qualification points in, *say open*, entitle you to two things.

1. (i) Those with X plus points or more at the end of the season qualify to run in the championship.
1. (ii) Those that eventually over a period (not defined) get say X plus X points are entitled to use the title M.H.R. (Master Hunting Retriever.)

You cannot believe how exciting the prize giving is and how the people root for each other. It does not matter if the guy next to you qualifies because if you qualify he can't beat you and you can't beat him. All that has happened is that you beat the standard of the trial. The standard set is high and sometimes only a few dogs qualify, but it does eliminate the people who dominate the scene. Everybody has a chance.

Does it lower the standard? *Not* if you keep the passing standard *high*.

2. *No retrieve can exceed 100 yards.*

You may say how can one set a trial then? I set a trial at Vaal Reefs this year in the open where no retrieve exceeded 115 yards and the retrieves got harder and harder as we progressed. Only 3 dogs finished! The retrieve that bombed most dogs? A double marked with both birds fully visible in the air to the dogs. A saluted duck into thick reeds and a shot pigeon into thick grass and thorn scrub. Maximum distance of each retrieve 75 metres. Dropped nine dogs for out of control, hard mouth, breaking or failing to find. Amazing

# Real Hunting Scenarios

The following situations were encountered while running dogs in licensed hunting tests (both NAHRA and AKC). They were so close to real hunting I thought to share them.

## 1. The Really Big Dove Hunt

**Scene:** You and seventy close friends, plus their dogs, are invited on a dove hunt. The total gunning area is about five acres. The folks with whom you will actually hunt don't have shotguns, only clipboards. There are a couple of other people standing in the middle of the field. They do have guns. They also have a crate of live pigeons upwind from the fall area. It is very, very hot. One of the shooters couldn't hit the ground with his hat. There are a lot of flyaways.

All seventy participants show up at 7:30 a.m., although many aren't going to get to hunt until early afternoon. Everyone stands around talking, drinking coffee and nervously eyeing each other. The dogs remain confined, some for as long as five hours. Just like real hunting, the nearest toilet is far away. Almost one third of your hunting companions are women. Attempts at discrete bodily relief liven up the wait. To spice things up even more, about every 45 minutes some "Very Important Hunter" shows up towing a bunch of dogs and muttering, "notherstake." "Notherstake" seems to be a magic word because the new

arrival gets to hunt before folks who have waited a very long time.

The actual dove shoot itself is brief, but a lot of fun. After you and your dog hang out behind a flimsy canvas fence for quite a while, the guys with the clipboards ask you over. Duck calls are sounded, and shotguns boom. What a quacking duck has to do with a dove shoot is obscure, but the dog doesn't mind. The people with the clipboard stand around while your dog hunts for the other guy's birds. After your turn, you don't get to keep any birds.

## 2. Wild Goose Chase

**Scene:** Once again you, your dog and a small army of handlers with their retrievers assemble to shoot geese in a knee-high wheat field. No decoys have been put out. Nobody wanted to tip off the geese, I guess. Even magnum decoys would have been swallowed up in the tall ground cover.

Several hunters are hidden in some trees on each edge of the field prepared to blast the big birds gliding in over 40 ft. pines. Just like real hunting.

You are cleverly seated behind a chest-high canvas screen in the middle of the field along with the clipboard folks. Your retriever sits outside wondering what's about to happen. Nobody spills coffee, nobody swears and no one stands up to go to the bathroom. The dog quickly realizes this isn't the real deal and looks at you for clues. He never sees the ducks go down.

After a lot of duck-calling back and forth, two mallards finally fly out of the woods, get shot and plop in the wheat field. This must have happened a lot because there is a big trampled-down area where the ducks land. There is also a regular path from the blind to each LZ. Even though he never saw the ducks fall, your dog's no fool; he runs the path and pins both birds. Still can't keep any though.

## 3. Double Blind Duck Find

**Scene:** You and your dog hide behind a truck as someone wounds a duck. Apparently the cripple flew 130 yards across marsh and open water to land in the crotch of a submerged tree trunk. Your dog is asked to go get that duck. A small number of decoys float near the shore, off to one side, next to a bottomless marsh. There are no blinds and no other hunters over there. They've probably drowned.

You get to start your dog way back in the marsh, rather than at the edge of the water. Your feet stay dry. So do those of your two gunless hunting companions. Maybe they tried to kill the duck with their clipboards and only minimally injured it. The neatly trussed bird, with its gay orange ribbons, is easy for you to see. Your dog's not amused; the water's cold and the still lively duck seems ticked off.

## 4. Tracking for the Feds

**Scene:** As you crouch behind a full-size conversion van in the middle of a cut corn field someone, probably a poacher, critically injures a duck. Three feathers are all that remain from this heinous act. The folks with clip boards, probably Natural Resources Police, enlist your dog's help in finding the evidence. Your retriever is now in law enforcement! Using only the three tattle tale feathers and his nose, your dog finds a very dead wet duck in the only visible cover for 12 acres.

Testing situations which mimic real hunting are the heart and soul of NAHRA's program. Judges are hunters; so are most handlers. Hopefully, every dog under judgement has, or soon will, hunt. Dogs must be able to demonstrate that they can handle real hunting situations. All dogs deserve a fair test. These statements are axiomatic. Marshalls and judges must realize that waiting five or six hours to run, waiting long minutes in a holding blind or running a course after 30 other dogs intrinsically changes a test. Inept shooters and bird boys are additional impediments. These problems need to be addressed by NAHRA.

The desire to save money by holding three stakes in one day, or processing great numbers of dogs through an event, can only result in unfairness. So does using untrained, inexperienced help. I believe these issues need to be discussed by each affiliated club, by NAHRA's leadership, by every judge and hunting retriever handler. Increasing the number of "limited" entry hunting tests, increasing fees to cover the costs of a planned two day event and formally training helpers are worthwhile to consider. Bigger isn't better. Enthusiastic volunteerism doesn't substitute for training and experience.

# TRAILING TESTS:

## Training, Testing And the Real Thing

Three memories stand out from last fall's hunting season. The start, the middle and the end; each punctuated with trail. The drought made for unusual pheasant conditions. Places that usually have plenty of birds were way down and others that usually aren't so good were up to recent record highs. Spring rains flooding nests certainly weren't a problem and I hoped the drought wouldn't be a summer problem for pheasants. The poor ducks are another matter with many of their local water holes still dried up a year later. I hunted pheasants on the dry bed of a pond that was a nice mallard home a year earlier. Apparently the drought did kill pheasants, too. It may be that the high spots were places fortunate enough to get a little rain at crucial times.

Opening day I hunted in a place away from home where I've run out of shells in the past. I missed a few quail again, but got the one pheasant I had a shot at. My youngster, Vico, proudly brought me another that afternoon. A cripple someone else had shot and left running earlier in the day. We can't say it too many times, retrievers recover birds that would suffer. Delicious noble birds that should be all the way dead or all the way alive. I love hunting, but I hate to wound a bird and loose it. Thanks to my girls, Roxie and Vico, that doesn't happen very often.

A farm close to home was my best huntspot this year. They had a late hatch of pheasants and a covey of quail. The other bonus is that it's close enough to go to after leaving work mid-week once in a while. It's a beautiful farm and I enjoy just walking around it, but I enjoy it even

more if I come home with a bird or two. The last bird I got there around mid-season ran ahead and flushed between some trees. I had only an instant for one shot and took it. He went down hard and ran just as hard. I was hunting with both dogs in heavy cover and neither one saw the fall, but all three of us were on the fall as fast as we could run over there. Vico is a fast dog and likes to try to solve problems with her speed. She took off on a line. . . (she may have gotten a glimpse of the fall or just lined on the sound.) Roxie paused long enough for me to say my trailing mantra, "dead bird, dead bird, hunt'em up." Off she went out of sight in the heavy cover, nose to the ground. I turned to call Vico in. By the time I got her back and tried to explain the finer points of obedience under excitement and the fact that there was a trail to follow, proud little Roxie came back from a very long trail with the rooster in her mouth.

Some dogs don't need to be trained to trail, but Vico and I have worked at it a lot since last hunting season. We've taught each other a lot. She's gotten quite good at trailing, too, but her style is as different from Roxie's as her color - black and white. Vico is a head up run down wind of the trailer and Roxie is a nose to the ground, hound dog style trailer. Page 40 of the rule book explains these styles briefly, but I wouldn't have understood how different effective trailing can look if I didn't own such different dogs. About all I taught Vico was to slow down a little. She's still fast enough that sometimes she's got the bird before I'm sure she's on the trail. Experienced judges are familiar with perfect 10's on trails being so different, but it was news to me when I learned HOW different they can be.

Trailing is a tough test to set up. We've had good success dragging a live duck by it's feet. Dragging by a rope tied around the wings seems to be awfully hard on the ducks they refuse to walk and end up injured. Surprisingly, dragging by the feet doesn't seem to hurt them much (we sometimes use a nylon "sock," too). When conditions are dry, we dip the duck in water before we drag the trail. This has worked pretty well in training and trials. Fresh killed opened up ducks have also worked well in trials and some judges are also experimenting with adding scent, too. I like dragging the track in my footsteps to avoid a weak foot trail that some dogs will hit and try to follow. Everything you try can also go wrong some days. The worst conditions I've ever seen were at a test and not the judges' fault at all. It was warm and damp and the first few trails went well. Then it started to rain and scenting conditions seemed to go to zero. Good judges, and some dogs got new trails and did better work. The rain stopped and a front changed - ough, the third totally different scenting conditions inside a couple of hours. I'm glad I wasn't judging. I wish I had run first. . .

NAHRA tests only simulate hunting. Giant Canada geese locking their wings overhead, being shot and drifting down aren't well simulated by a guy behind a bush throwing a pigeon, but the latter can test marking and the basic skill is the same thing we need in our hunting retrievers. Our "simulations" have to take that into account. We can't simulate everything that's important, either. Running pheasants are the toughest control problem I encounter. Test-timid Roxie can be a monster on a runner, especially if she's competing with Vico. (I don't recommend hunting two dogs together, but do it sometimes anyway when I'm short on time.) Lightning fast Vico was obeying me perfectly one day mid-season right after she had flushed and retrieved a rooster, but Roxie wanted her turn and wouldn't wait. Two beauties got away without a shot, Roxie in hot pursuit right to the flush. I don't know how to simulate wild running pheasants at a test. Trailing and quartering are new areas in retriever testing (at least since the early 1930's) and we need to share ideas, successes and failures, so we get it right. That's part of what this article is about. The other part is why we should work to break this new ground.

On the last day of the season, Roxie won me a lunch. Our club president, Mark Kluber, invited me to hunt with him and knocked down the last rooster of the year. He hit the ground hard, but ran away. One of the humans "knew" which way he went. Roxie and Mark's dog, Bo, had trouble picking up the trail, so we took the human advice and started off the wrong way, but not before I bet lunch that Roxie would have the bird before Bo. It was quite an ordeal and Roxie cooperated with the three silly humans for a long time 'til I went back to the fall and just let her do the job. She brought that bird back dead - it's amazing how far they run "dead." I got lunch, but Mark got pheasant dinner and Roxie got the biggest treat of all - doing the job she loves - hunting alone in the field unwatched by judges, a gallery or even other hunters in this case.

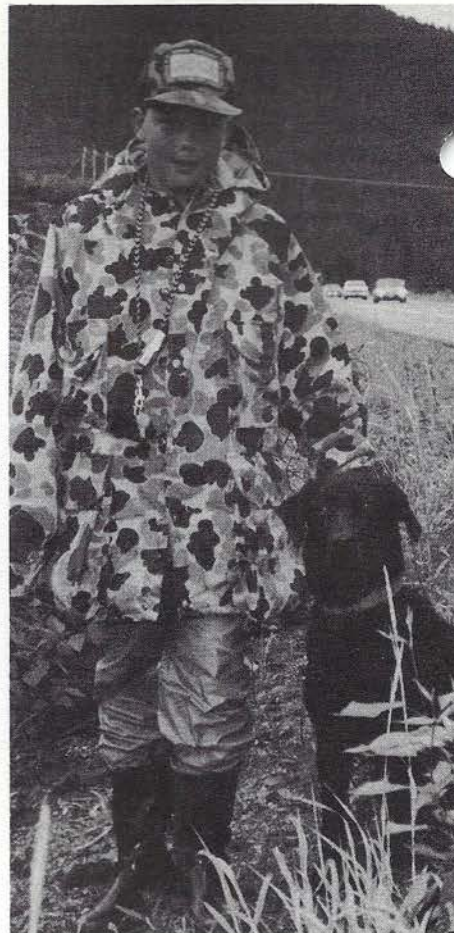


After reading Bill Medcalf's article about children's participation in the recent NAHRA NEWS, we thought we'd send in the following information.

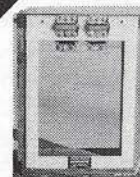

# A TRIBUTE TO THE DOG

**Senator George Graham Vest**

"Gentlemen of the Jury: The best friend a man has in this world may turn against him and become his enemy. His son or daughter that he has reared with loving care may prove ungrateful. Those who are nearest and dearest to us, those whom we trust with our happiness and our good name, may become traitors to their faith. The money that a man has, he may lose. It flies away from him, perhaps when he needs it the most. A man's reputation may be sacrificed in a moment of ill-considered action. The people who are prone to fall on their knees to do us honor when success is with us may be the first to throw the stone of malice when failure settles its cloud upon our heads. The one absolutely unselfish friend that a man can have in this selfish world, the one that never deserts him and the one that never proves ungrateful or treacherous is his dog."

"Gentlemen of the Jury, a man's dog stands by him in prosperity and in poverty, in health and in sickness. He will sleep on the cold ground, where the wintry winds blow and the snow drives fiercely if only he may be near his master's side. He will kiss the hand that has no food to offer, he will lick the wounds and sores that he encounters with the roughness of the world. He guards the sleep of his pauper master as if he were a prince. When all other friends desert, he remains. When riches take wings and reputation falls to pieces, he is as constant in love as the sun in its journey through the heavens. a hunting test (quartering) unless it is a straight shooting and marking test (walk up).

Many tests have only one purpose: To throw dogs out. Some judges are not there to see how well the dog works. An infraction that may be A MARK DOWN IN THE LAST SERIES COULD BE A DISQUALIFICATION IN THE FIRST SERIES. I do not think that's right. The first series is where they start dropping dogs because the judges do not have enough time to judge all the dogs correctly. This really isn't fair to the dogs or the handlers.

SOMETHING THAT SHOULD BE INCLUDED IN JUDGING IS CLASS AND STYLE. I do not mean craziness, just class and style. A dog that is tiring should be graded down. I realize that older dogs aren't as enthusiastic as puppies, but the dogs are used for breeding. You want conformation for staying ability. It isn't conformation for bench or show, it's conformation for staying ability that generally leads to a pretty dog. My idea of a pretty dog is one that moves without impediment, no holes in its running, no clumsiness, no hard breathing.

Here is something that should be considered in a test setup. The more the judges try to make the test the exact same test for all the dogs, the more the test changes for the dogs as the test progresses. I am talking about bird scent on the line, drag back scent trails, scent buildup at the point of fall for dead bird throws, and scent all over the place from shot flyers. What I really want to see is even scoring and unbiased judging.

A COYOTE IS A HUNTING MACHINE. Watch him. His mother shows him how to search for body scent and how to trail. He learns by trial and error. His reward for success is food and his punishment for failure is hunger. You must be your dog's mother and teach him how to use his nose with persistence. He needs your help until he gets to the point where he really knows what he is doing.

the area of the trail and every time pup crosses the trail and indicates scent, you reinforce the response to use his nose by saying "Find it."

The trick is the dog indicates he smells something first and then you say "Find it." It won't take long for pup to understand that "Find it" means to use his nose to locate the scent trail before he actually smells it. Then, "Find it" becomes a command response.

"Hunt it up" is reinforced in the same manner. Numerous birds or bumpers are placed in a small bird field. (15 to 20 birds in a field 50' x 100'.) Pup is brought into the field and worked into the wind. Every time he indicates scent and charges out to investigate the smell, encourage him by saying, "Hunt it up." Pup will soon learn what is expected of him when he hears "Hunt it up." He'll charge out to find birds before he smells them and then "Hunt it up" will also become a command.

If you are consistent with reinforcing the proper responses with the key "words," by the time pup has his first birthday, the "words" will no longer be just words but "commands." Then, it just takes time to extend and polish those responses until he becomes a Master Hunting Retriever.
