PRESIDENT'S BARK

This year commemorates the tenth anniversary of the North American Hunting Retriever Association, NAHRA. The idea of formal gun dog competition had been a dream for many clubs and individuals in isolated areas across the country. No one dared to challenge the undisputed control of the American Kennel Club who ruled the retriever game for more than fifty years until NAHRA emerged triumphant. I won't attempt to rehash those turbulent early months and years that gave birth to the hunting retriever movement. If you don't know the story, read the new chapter in Richard Wolters' book *The History of the Labrador Retriever* by Dutton publishing.

Unlike the hunt test programs of the major breed registries, NAHRA depends solely on income derived from its mem-

bership and running fees collected by clubs. The AKC and UKC live off the registration of our canine companions. Corporate sponsorship has paved the way for many projects during the past ten years. Several major pet food and related dog supply and hunter related companies have assisted NAHRA. I spent four days in mid-January at the Shot Show held in Houston, Texas. Over twelve hundred shooting and hunting sports related companies exhibited at this enormous event. NAHRA shared a booth with Game Fair Management Corporation of Norwalk, Connecticut. Game Fair is hosting seven national championships August 26-29, 1993 at Hunter Mountain, New York. The International Hunting Retriever Championships will be a part of this outdoor sporting extravaganza. I had an opportunity to speak with many marketing directors while at the Shot Show to generate advertising for the NAHRA NEWS and to seek corporate sponsorship. I ran into many old friends but one in particular played a key role in the early development of NAHRA. The original Board of Directors borrowed money to get the whole hunting retriever movement started and personally endorsed the loan. One man, Dave Meisner, the owner of Gun Dog magazine, gave NAHRA \$1,000 to get the ball rolling. Dave Meisner offered us the exposure we so desperately needed by allowing Richard Wolters to report on our progress in his gun dog column. Dave sold the publication and has been under contract not to compete. The restriction is now up and Dave Meisner is back with a slick publication called *The Pointing Dog Journal*. Dave also plans a retriever publication in the not too distant future. Trebark Camouflage was an exhibitor at the show. Jim Crumley, the creator of Trebark Camouflage was an exhibitor at the show. Jim Crumley, the creator of Trebark Camouflage, has actively sponsored and supported NAHRA for the past five years. His bark pattern revolutionized the camo industry and its perception of camouflage products. Like NAHRA, Tre-

bark is copied but never equaled. The new Trebark Universal pattern was widely displayed at the show and will most definitely have a major impact on the industry. Trebark is the official camouflage of the North American Hunting Retriever Association.

Ten years ago the early founders of NAHRA vowed to keep the program and its rules as they were originally created. For the most part we are operating by the original concept. Three years ago we clarified several areas of the rule book and made a few minor changes.

Perhaps the most specific area that was changed and most widely challenged was the section that awarded a Master Hunting Retriever title to any dog that accumulated 80 Senior points and had previously earned a Working Retriever title. This change, as well as adopting a new title for Started and a new category for Beginner was discussed at regional meetings across the country during 1992. The clubs voted to reinstate the Master Hunter title for any Working Retriever that earns 80 Senior points. This will be grandfathered to include all dogs that have qualified since the change was made. Regional club representatives voted: (1) to leave the rule book as is with no changes in any category; (2) for a two dollar increase in individual running fees; and (3) a National Raffle. New Field Test fees will become effective in 1993.

The National Raffle is perhaps the most attractive and exciting that I have ever seen. The prizes are eight hunting trips, one from each NAHRA region. They will include hunting in Mexico, Canada and Alaska. Each trip is for two people with a \$500 travel allowance, hunting licenses and all expense paid hunt for two days. Tickets will cost five dollars and will be available through your local NAHRA club or through the NAHRA office (pg. 12).

The NAHRA concept has traveled some rocky roads during the past ten years. Some of you have been there since the

Chemotherapy For Malignant Mammary Tumors In Dogs

Surgical removal of canine mammary tumors is generally successful in most dogs. Chemotherapy, on the other hand, has not been widely used nor is it considered effective. At Purdue University, however, veterinarians have reported successful treatment of two dogs, with partial remission of the cancer lasting from a year to a year and a half. The veterinary team, led by Dr. Kevin A. Hahn, cautions that because malignant mammary tumors are so diverse in nature and therefore behave so differently, predicting how an individual dog will respond to chemotherapy is extremely difficult.

Although much has been learned about canine mammary tumors, the information has not proved effective in determining the long-term survival of a dog with primary or metastatic (spreading to other parts of the body) mammary gland tumors. Meanwhile, the Purdue researchers believe that the drug doxorubicin is the most active and effective agent in nonsurgical management of canine metastatic mammary tumors.

Questions From Our Readers

Q: Why do mother dogs lick their pups?

A: As is common in many other species, mothers do a lot of licking, most often to arouse their young to eat and to stimulate urination and defecation in the newborn. But mother dogs also lick for a reason unique to the canine species. Instead of carrying their young as, for instance, a feline mother does, a bitch will lick her pups' heads

to lead them. The licking orients the pups to the mother and the pups then follow her back to the nest.

Q: Why can't you teach a new dog old or any tricks?

A: You can't just blame it on their youth. Studies have shown that there is only 10 percent of dry matter in a pup's brain at youth. In addition, myelin, the sheathing around nerve fibers, is almost completely lacking; without myelin there is little conduction of stimuli along nerves. Both dry matter and myelination increase rapidly by the end of the first month.

Q: Why do puppies sleep all in a heap?

A: Huddling together during sleep most likely is done to prevent heat loss. But this pattern changes by the third week or so, when puppies are content to sleep in a row with only side contact with littermates. Even when grown and sleeping alone, dogs will often want to lie against a wall (or you). The best way to make a newly weaned or an insecure dog content to go to sleep is to provide it with something (hot water bottle, old sweater, etc.) it can curl up against and with.

Q: Why do puppies play?

A: This is perhaps the ultimate teaser because nobody knows exactly why puppies play, even though they go at it from the age of three weeks. Learning how to get along with littermates, honing necessary skills, exercising—all are good but partial explanations. None is adequate, however, and they do not fully take into account solitary play.

As animal behaviorists say, play may just be fun and engaged in for its own sake.

Q: When they play, why do puppies often mouth one another's heads?

A: No, it's not just because puppy heads are big and handy. By three weeks of age, myelination is most complete in the head (the cranial nerves). So both the biter and the bitten get most stimulation and pleasure from this activity.

Wolters Says...

WINTER SLUMP

The worst thing a writer can do is sit and write about Thanksgiving when he knows his article will be read at Christmas. I've got no choice. I know when you read this that Spring will be around the corner. Well, that will be true here in Virginia. I can remember some of the early NAHRA events at Curles Neck Plantation near Richmond, that were held in February. We were in short sleeves. But it "ain't" so this January '93. It is a miserable week, in fact a miserable month ... rain ... rain ... rain. Nothing is happening except a glowing fire in the stove.

If I were a duck I could be outside. To think about pleasant things I have to go back to last year. Which reminds me, 1992 was a fun dog year with Duck Soup. You just might be interested, because something happened that made a major change in my dog thinking.

Duck is my pride and joy. What a year he gave me! At sixteen months of age, he became a Master Hunting Retriever and earned his bid to the Invitational. There is a good chance that he will be the youngest dog in the event and I will be the oldest handler.

At seventy-two I did not expect to spend that year running all over the country so Duck could have his fun. But from the beginning Duck showed outstanding promise. My great dog Tar had to be retired on Social Security and Workman's Compensation, and all I wanted was Duck to be trained for doing seminars and working as a "pick-up" dog at my shooting club. Mashomack has the finest tower shoots in the country, and if you want to make a pup birdie that is the place. We started going to the shoots just as soon as Duck was big enough to walk. It was not long before

he carried ducks that were as big as he was. Birdie? You can't believe how he responded. But all the dogs I trained in the last ten or twelve years were given that early training. Tar, Jet and two others took to it in the same way, but as you will see ... making Duck this birdie boomeranged on me. He learned something I had not anticipated ... something the others had not picked-up.

By the time Duck was twenty months old he had earned 200 senior points. But a major problem started developing.

Duck is something special. When he was twenty weeks old he gave his first public demonstration. Twenty weeks! I shot a dummy out and stopped him ten times to it by whistle. He learned so fast, he was amazing. I sent him for a dummy and stopped him by whistle a yard from the dummy. He sure brought down the house. I ended that demonstration by having him play baseball ... twenty weeks ... and doing a very short easy blind. As you read this you might be thinking that Wolters is "smoking" something. But all was done before a public audience and that's a fact. I tell you this because it has something to do with the problem that developed.

I think I put him in one Started event and then went directly to Intermediate, because he was steady, delivered to hand and could handle a fifty yard blind. At ten months he had his WR title.

The problem did not start to show until he was a big fellow and well into his senior work. Trish Jagoda will remember this. She was the judge. Duck almost stepped on the tough bird in the land series. I guess he was up wind and the next I knew, with his speed, he was on the horizon. This dog who listens to the whistle turned me off, and we had to stop the event to get him back. On another occasion it took Rex Bell, who Duck loves, fifteen minutes to get him back.

Then I took Duck to Nova Scotia for a double senior. We arrived on Friday night after a long drive. The club members did some last minute training and I went along with Duck to stretch his legs. I sent him on a blind and after a good line of about 100 yards I blew the stop whistle. Duck turned me off. He started hunting and was saying to me, "Ok boss, stop the whistle stuff. I'll find it myself." I lost my cool and decided I'd had enough of this stuff. I ran as best I could and got him by the collar and gave him "what for." When I half dragged him back to the line to start him over again, I was so winded that I thought I might be having a heart attack. That part of the training would be no longer in the cards for me.

Somehow Duck got the message that Friday night, and he passed both senior events that weekend. But I had to do a lot of thinking. Here I had a dog that knew his commands better than most school boys knew their ABC's. He wanted to please as much or more than any dog I

had ever had. It seemed that for no reason, all of a sudden he'd go crazy and turn me off. I put him back on the 200 yard double "T" here in Virginia. He never put his foot down wrong. I did everything possible to try to mix him up. He answered every whistle and hand signal like a veteran. I had him going wild, back, over, over the other way, come in, stop, go back and pick up a dummy. I sent him straight out to take the full 200 yard line. He went full bore. He loved it! What was going wrong?

For days this problem haunted me. There had to be a reason. I had to be smarter than the dog and at times that's not easy. I went back over every situation that I could remember where he turned me off in the field. Then it finally dawned on me. The lights lit up.

Every situation where he turned me off was in a very specific kind of cover. It was the kind of heavy cover that when you looked at it you would say, "Let's hunt this field. There have to be birds here."

I started to see the pattern. I had done perfect 250 yard blinds with him in **low cover**. He never set a foot down wrong on the double "T" ... again **low cover**. That was the answer.

When I trained Duck at the tower shoots at Mashomack starting as a pup, and through his growing up months, he learned something no other dog that I trained had learned. The tower shoots were in the exact kind of cover that was giving us the problem. Anywhere from 800 to 1,500 ducks and pheasant were released in a few hours each weekend. Duck would make a pile of birds that would feed an army. A hundred birds a day was not out of the question. There were so many birds on the ground that Duck learned that with just another few seconds of hunting he would come up with a bird. The action often got furious. As he delivered to hand, he could see another one falling, and while he was coming back with a bird he saw more birds hit the ground around him. He was stumbling over birds. What he had learned was that, in that kind of cover there was a bird everywhere. Thus came his belief, "Ok boss, stop the whistle stuff, I'll get it in a few seconds." He started hunting on his own.

Ok, now that I figured out the problem, it seemed to be easy to fix. I could not physically run out to teach him to sit on the whistle, but I could station helpers out there to do my bidding.

Big strong Rex Bell was the first to help. Now you have to realize that Rex and Duck were devoted friends. When Rex came to the house for his favorite roast lamb dinner, Duck jumped up into his arms ... up in his arms! As Rex scratched him, Duck nibbled at his face (sometimes drawing blood) and cried with joy. It was a fun scene.

Of course Rex helped with the problems. Since I could no longer run out to

make the correction, Rex hid in the high cover. I sent Duck on a blind. When he turned off my whistle Rex ran and "made the correction!" Duck was shocked. His eyes became as big as saucers and he as much as said, "Rex, my friend ... you are striking me!"

That was the end of it. Duck quit cold. He would not go for a second blind. Later, I tried it again with Lindy Hockberg, who is a swift runner. She spanked him as the sit whistle was blown. Duck quit again. Now we did have a problem!

Duck and I went off in N.Y. and Virginia to do a little duck hunting, he was good, but in the next NAHRA senior event Duck went off on his own ... whistle be damned!

In the back of my head a thought started to seep in ... the electric collar. My books, and my thinking for over thirty years has been that the collar is not needed for the hunter. The natural training system will do the job, and any time you can earn a Working Retriever title on a dog you've got a fine hunter that won't embarrass you with your cronies. But

Duck became an MHR with 200 senior points well before he was two years old. That has to say something for the natural method.

Here was my dilemma. I could no longer run out to make the correction on Duck, and it looked as though he would not deal with anyone else. He was a powerful worker with unbelievable drive and style. I could let it go at that, and still make enough points each year for the Invitational or I could put him on the collar, as my last resort, to try to make him into an outstanding animal. That would mean consistent, precision work. What did I want, and what did I owe this dog?

I have been around and seen the collar working since its inception. It started out as a vicious tool of punishment. It worked but it took its toll and left its mark. In the early days of AKC licensed field trials, where the collar was introduced, you could tell when a dog came to line if it was an electric dog or not. The way the dog moved along with its handler ... the tail down attitude ... the dog did the work like a machine but without the style and enthusiasm of a Duck. It would take many years for the better professional trainers to work out systems where the collar was used for motivation and not reprimand and punishment. Trainers learned that the collar was not a training tool. Training had to be accomplished through a natural method much as I have presented in my books. The collar was to become, in the

hands of certain professionals, a tool of reinforcement ... of perfection as needed in licensed trials ... no maybe's, no slipping, but to make sure the dog does what he knows he should do ... on command.

To do this a dog must be conditioned to the collar. And as far as I am concerned; this is not the job for the average hunter to attempt ... no "brain surgery by the book." This is hands-on learning from the right people. Buying a collar and thinking it's going to solve problems ... it "ain't." In like manner, a trainer using a collar **does not a professional make!**

Tri-tronics has spent a lot of time and money on trying to solve these problems. They hired animal behaviorists who advanced theories. As far as I could see, they and their writing just did not make the grade. Tri-tronics hired some professional trainers that made headway. What it finally took were some very smart professional trainers with a lot of hands-on experience and years of experimentation to come up with a collar training system that did not "break" the dog (in the English sense of the word) and then build him back up. Today we can have a happy worker with style, and motivated using the collar.

The problem; there is no standard to establish a professional trainer. Hang out a shingle and print up some cards and he can be in business.

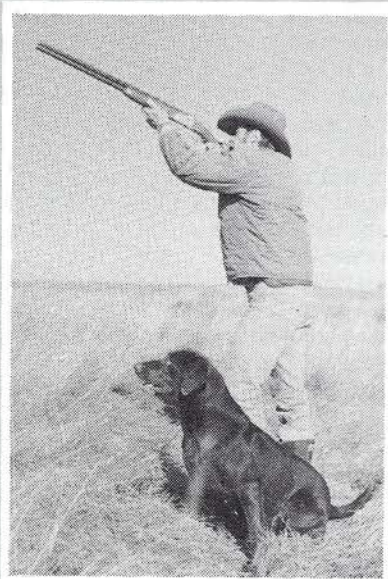

TRAINING TIPS

"COMMANDMENTS"

"YOU POINT THAT MUZZLE AT ME ONE MORE TIME AND I'M GOING TO TAKE THAT SHOTGUN AND SHOVE IT #@ #%@# &@ \$!!!" A thought that has crossed my mind all too often while judging or training with other individuals.

Many people don't stop to think how dangerous our dog training sport is. When training dogs, we are constantly using guns and ammunition. Often, we volunteer or are asked to pop or live gun when training with others or at field tests.

It makes no never mind whether it be blank or live ammo, both are extremely dangerous in the hands of the careless.

In dog training, we constantly repeat drills or specific mechanics to condition the dog to respond properly and automatically. (See Volume VI, Numbers 2 and 3.) The drills are repeated so often that the dog just performs his/her task without thinking. This is called a "conditioned response."

Humans too have "conditioned responses." And, in fact the "conditioned response" is an ingrained response to a specific situation, where we just act without thinking, there are numerous handlers out there that I wouldn't want to be within 100 yards of when they have a loaded gun in their hands.

In the Started, Intermediate and Senior categories, we are often required to carry and/or hold a shotgun in the firing posi-

tion. Even though the gun is unloaded, the "conditioned response" of participants when handling a weapon is horrifying to say the least.

For a vast majority of us, it has been many years since we had to take a hunter's safety course if ever. I would like to take the time to introduce or possibly reintroduce you to the "Ten Commandments of Firearms Safety."

1. TREAT EVERY FIREARM WITH THE RESPECT THAT IS DUE A LOADED FIREARM.

2. WATCH THE MUZZLE! BE ABLE TO CONTROL THE DIRECTION OF THE MUZZLE EVEN IF YOU SHOULD STUMBLE.

3. BE SURE THE BARREL AND ACTION ARE CLEAR OF OBSTRUCTIONS AND THAT YOU ONLY HAVE AMMUNITION OF THE PROPER SIZE FOR THE GUN YOU ARE CARRYING.

4. BE SURE OF YOUR TARGET BEFORE YOU PULL THE TRIGGER; KNOW IDENTIFYING FEATURES OF THE GAME YOU HUNT.

5. UNLOAD FIREARMS WHEN THEY ARE NOT IN USE. TAKE DOWN OR HAVE ACTIONS OPEN; FIREARMS SHOULD BE CARRIED IN CASES TO THE SHOOTING AREA. NEVER HAVE A LOADED FIREARM IN A VEHICLE, IN YOUR HOME OR IN CAMP.

6. NEVER POINT A FIREARM AT ANYTHING YOU DO NOT WANT TO SHOOT; AVOID ALL HORSEPLAY WITH A FIREARM.

7. NEVER CLIMB A FENCE OR TREE OR JUMP A DITCH WITH A LOADED FIREARM; NEVER PULL A GUN TOWARD YOU BY THE MUZZLE.

8. NEVER SHOOT A BULLET AT A FLAT, HARD SURFACE OR WATER; AT TARGET PRACTICE BE SURE YOUR BACKSTOP IS ADEQUATE.

9. STORE FIREARMS AND AMMUNITION SEPARATELY, BEYOND THE REACH OF CHILDREN OR CARELESS ADULTS.

10. AVOID ALCOHOLIC BEVERAGES BEFORE AND DURING SHOOTING.

The fact that you, as a handler, have an unloaded gun in your hand is no excuse for sloppy, ignorant and unsafe handling of a weapon. Commandment Number 1 is always in effect.

I urge you to pay close attention at all times and to religiously practice all of these commandments.

Eventually, they will become a "conditioned response" from you and we will all be safer for it.

And, since we are on the subject of Commandments, I'll give you my "Fourteen Commandments of Dog Training."

1. TRAIN INSTEAD OF TEST YOUR DOG. (Training is showing the dog what to do and testing is seeing what he can do. At the very most, test your dog once a week.)

2. KNOW WHAT YOU INTEND TO ACCOMPLISH WITH YOUR TRAINING SESSION BEFORE YOU START.

3. SET YOUR DOG UP TO SUCCEED MORE THAN FAIL.

4. AVOID ANY AND ALL DISTRACTIONS WHEN YOU ARE TRYING TO TEACH YOUR DOG SOMETHING NEW.

5. BE CONSISTENT WITH YOUR CORRECTION AND YOUR PRAISE. (Always remember to be as quick to praise proper behavior as you are to discipline improper behavior.)

6. DON'T NAG YOUR DOG. (If the dog screws up and you deem it to be a discipline situation, make your correction and be done with it!!)

7. MAKE YOUR CORRECTION JUST AS THE DOG BEGINS HIS/HER UNWANTED BEHAVIOR, not before or after it has occurred.

8. BE ONLY SEVERE ENOUGH WITH YOUR DISCIPLINE TO GET YOUR POINT ACROSS. (Nothing more and nothing less!! If you do not strictly adhere to this rule, you will create another problem.)

9. NEVER GIVE A COMMAND THAT YOU CAN NOT OR ARE NOT WILLING TO ENFORCE.

10. AVOID TRAINING IN AN AREA THAT YOU HAD TO STERNLY REPRIMAND YOUR DOG. (Stay away from that area for a couple of days before returning to train.)

11. KEEP YOUR TRAINING SESSIONS SHORT. (Always quit while your dog still wants more. It isn't so much the amount of time spent training, but rather the quality of training time spent.)

12. TRY TO END YOUR TRAINING SESSION ON A POSITIVE NOTE.

13. IF YOUR DOG HAS A HORRIBLE DAY TRAINING, HUNTING OR FIELD TESTING, DON'T CONDEMN HIM/HER. (We all have our off days.)

14. LEAVE YOUR DOG ALONE IF YOU HAVE HAD A BAD DAY. (Don't use your dog to vent your frustrations on.)

Religiously practice these Commandments and you AND your dog will be more successful in training and testing.

New Year's Resolutions

1992 was a good year for NAHRA in the midwest, and the program seems certain to get better in 1993. While it was very hectic, 1992 was also a good year for my wife, myself and Shohola Labradors. It was an immense pleasure to have Master Hunting Retrievers and a talented, energetic Started pup to choose from during the fall duck and pheasant seasons. The only drawback was my busy work schedule preventing me from hunting each one enough. After 9 years of planning, we also had our first litter; line bred on the finest living Labrador bitch line through proven producing males. We look to the future for those pups to become great hunting retrievers. NAHRA, also in its 10th year, will be an important part of their development.

The high point for the NAHRA program around here was the good work of many trained member dogs during the fall hunting seasons. People and dogs at all levels are making real progress toward becoming better hunting teams. I hunted ducks with Scott Brees' young Coal and while he isn't yet officially a WR, he is already a true working retriever and a pleasure to hunt with. Terry Nyenhuis' Boogie will be nipping at his heels in Intermediate next spring; he too has gained many days of hunting experience. Bonnie Moothart's Sunny took over the club's traveling WR trophy, while Kevin Clark's Luke and Paul Peterson's Jessie moved out of Started. Finally, at the head of the pack, Doug and

Derek Peters' MHR-WR Heidi of Chainhoist showed her masterful hunting, retrieving a crippled pheasant after a 200 yard trail in standing corn. In Iowa NAHRA is working where it counts - the field and marsh. The details vary, but the basic success is happening from the marshes of Manitoba to the prairies of Oklahoma: NAHRA is making better midwestern hunting retrievers.

The high point for NAHRA organization around here in 1992 was the emergence of a true regional program. Our past regional tests have been excellent and we have had some regionally coordinated judges clinics, but communication between clubs has been difficult. Despite attempts to share schedules, in '92, we had some test overlaps, albeit 900 miles apart. As spread out as our region is, our coordinator, Dan Kunz, was having a hard time keeping in touch with all the clubs. I don't think anyone made it to tests at all the region's clubs. Dan's "secret breakthrough" was the idea to meet by conference call. This resulted in a fruitful exchange of ideas at a level we just couldn't accomplish before.

Our Regional conference produced lots of New Year's resolutions. We agreed on a basic regional funding mechanism and discussed plans for further fund raising - both for Regional activities and for NAHRA's continental program. We will see how well

we keep our resolutions. The conference also gave us an official clearinghouse for scheduling events. I for one have been frustrated in the past sending schedule letters, but not knowing if the right club members got them. I guess another resolution is the idea that conference participants are responsible to both the club and region to coordinate these dates. Everyone has problems setting test schedules and it was helpful to compare notes.

Our regional conference also produced suggestions for the NAHRA Board to consider regarding rule changes. In a nutshell, we felt that trailing is the least uniform category in terms of evaluation. At the time of our conference, we thought that the board would be re-doing the rule book, so we sent some suggestions for their consideration. We felt that the trailing rules needed to be tightened up, but that the Board should have final say in how, since they and not we have the widespread input that the full program needs. Our region has always been generally satisfied with the Board's decisions in the past. We supported the other rumored rule changes, such as in Beginner, but learned later that most other regions did not support changes. I doubt that this

"loss" will disappoint anyone in the mid-west very much, since we were also concerned about the added complications of 4 stakes per test.

The ideas about trailing went to the Board and came back to become a draft of the NAHRA judges' newsletter. Ultimately, the quality of any field test program hinges on the quality of the judging. The judges' newsletter is probably the best place to begin in making refinements of difficult parts of the program. I didn't really want to write that issue, because the topic generates a lot of heated opinions. The regional conference generated some good ideas and we'll proof-read the drafts until it's ready to mail. In this area, our regional conference is more than a New Year's resolution - it produced well-thought-out ideas based on good and bad experiences with trailing. I resolve to write it up.

Not everything looks rosy in NAHRA's future. The success of the program depends on YOU. First and foremost, you should enjoy the program and use it to make progress with your retriever, whatever your level. Make that resolution #1. It is a rewarding program just to train for the tests. Even when you don't get the ribbons, and Roxie taught me humility at tests, so I know, it's still worth the effort come hunting season. If you like real hunting retrievers, NAHRA is your program.

Second, you should share some of the work with your club. We're all volunteers.

Finally, YOU should go out and recruit at least one more NAHRA member. NAHRA is a program for amateurs, so it "competes" with many activities. Work and family responsibilities, golf, fishing, maybe even TV. NAHRA members don't get paid, so there will always be some formerly active members who have to slack off or drop out. These people need to be replaced by new members - that's the same with every volunteer organization I know. Make a New Year's resolution for YOU to do something about bringing in new members.

NAHRA is a program for HUNTERS and their dogs. Not everybody hunts or approves of hunting. Some of those folks live and let live while others want to impose their 'religion' on the rest of us. It's a fact that many retrievers are bred and raised by folks who have never hunted. Some of those same folks are running various programs for retrievers. Those programs compete with NAHRA for dog owners' time and effort. Retrievers convert well to obedience competitors, guide dogs, drug dogs and family pets. These are fine jobs for a retriever who is unfortunate enough not to be able to hunt, but the pups who come out of my kennel will be bred first and foremost as hunting retrievers. To me that includes the people-oriented disposition that makes a good guide dog or pet and the nose that makes a good drug dog. It also includes the trainability

WHEN NAHRA FOLKS GET TOGETHER

What happens when two NAHRA folks and their dogs travel more than 3,000 miles to hunt with another NAHRA nut? The answer is, of course, a whole lot of fun.

It was my very great pleasure to host Bruce Meredith and Frances Givens for two days of waterfowling in Dorchester County, on Maryland's Eastern shore. Bruce had been the highest bidder for this hunt auctioned to benefit NAHRA at the 1992 Invitational in Portland, Oregon. Bruce had never been to the east coast so the trip was filled with lots of firsts.

As many of you know, Bruce is an enthusiastic and expert outdoorsman. His college major was wildlife biology. He has been a hunting guide and ardently pursues waterfowl all along the Columbia River. Bruce trains and campaigns hunting retrievers and is a high point NAHRA Senior judge. He really knows waterfowl, and gun dogs!

Frances is relatively new to waterfowling, but has been training and handling dogs with much success for a number of years. She can hold her own in the duck blind with anyone!

Our experience started with dinner in Cambridge then a long, dark ride to the Jenny Island Club. This 150 year old gunning lodge is located right on the Chesapeake Bay, at the mouth of the Honga River. Locals say Jenny Island is not the end of the world, but you can see it from there. Our host, Gibby Roe, had fine

liquor and warm conversation waiting to prepare us for the next morning's hunt in the middle of the Blackwater National Wildlife Refuge.

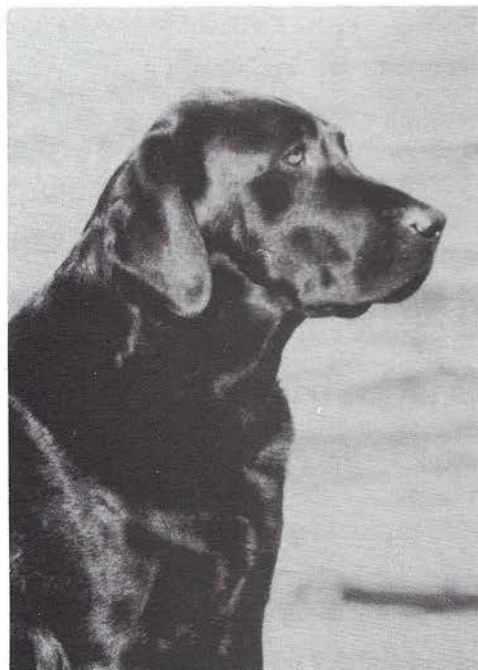
Torrential rains and extreme high tides during the previous days had changed the ducks' flight plans and thus our hunting strategy. Nevertheless, greenwing teal, mallards, black ducks, pintails and one hooded merganser were downed and retrieved. One great moment occurred when more than a hundred pintails tolled at one time to our decoys! All but 3 escaped. I guess duck fever caused us to miss!

Another highlight was the sight of GMHR Smokey Jasmine (this author's highly regarded gun dog) using Bruce's back as a ladder to get out of the blind. Long minutes of duck calling followed by multiple shot gun blasts keyed Jazz to the point of no return. So much for line manners during the real deal!

The second morning was spent at Garyview Farm near Cambridge trying to lure mallards into a small pond. Private landowners in Maryland have pioneered a duck release program which emphasizes habitat, controlled release of young birds and sufficient acreage to support hold-over and breeding populations. Bruce's dog, Buck (MHR Anya's Brassy Boss), did a super job finding downed birds. Shooting was sporty since house rules dictate that only drakes can be taken.

that makes an obedience champion. But none of these traits are primary and a long term breeding program governed by these aims dooms retriever descendants to a non-hunting role. The primary package is a bird finding maniac. And my retrievers hunt pheasants, not just ducks and geese.

I respect and admire both guide dogs for the blind and traditional field trial champions. Their training and accomplishments are both amazing. Field trials kept the hunting genes alive in retrievers for the time before NAHRA and can still contribute to the future of excellent hunting retrievers. Now NAHRA "competes" not only with the traditional trials, but also the UKC and AKC hunting retriever programs. I like traditional trials, though the ferocious competition is way above my amateur skills. I help with both NAHRA and those trials - it's not a question of exclusion for me. I don't know much about the other hunting programs, but, I'm suspicious about some of the stuff I hear. I don't know if it's inexperience or direction from non-hunters. NAHRA is governed by a Board of actual hunters and it is an all-around program, upland and waterfowl. NAHRA ideas have consistent-

ly led the hunting pack over the last decade and they will continue to do so as long as enough hunters help. That's you.

If NAHRA is small and successful, that's fine. If another program is larger and only a working certificate or specialty test, I can't see how that detracts from our success. It does compete for dog owner's time and that distraction could dilute the gene pool, but the top NAHRA dogs will still be there for the discriminating hunter. Success for NAHRA is meaningful tests for the all-around hunter's retriever; tests that improve your dog in the field and help select the breeding stock to make your next dog better. I have a job and family and can only do so much for other people's dogs. I will continue to contribute my effort where the quality is highest. For example, the working certificate tests aren't enough to serve the hunter's needs, though they may be a big accomplishment for a bench dog. If we lose our grandchildren's hunting retrievers to a big rich meaningless program run by non-hunters, we have only the hunters with retrievers to blame. That's YOU and your hunting buddies. Resolve to be sure that doesn't happen - your buddies may not even know what an excellent hunting retriever can do.

NAHRA's program looks good for '93 and its second decade. A decade of hard work and experience has given us concerned leaders, efficient organization and many

high quality judges and clubs. We've got sound tested rules that we constantly hone with things like the judges' clinics and newsletter. We've got some good dogs and a few great ones that stay on the circuit for each year's Invitational. We've got a program that serves each hunting retriever as an all-around working dog. But we'll always need new blood. Get your hunting buddies out to a NAHRA test in '93. How about even the first decade's Invitational?

Pheasant Paradise ... Well For the Hunters, Anyway

Four hundred pheasant in one day. Now that's a lot of pheasant. Whoa! Let's back up a little.

It all started when I received a call from Kent Henry, the gentleman who runs the Arizona Hunt Club. He said they were going to have another Continental Shoot and asked if we'd bring our retrievers.

What is a Continental Shoot? Well, picture yourself standing in a line with 8 or 10 other shooters each about 20 feet apart. You are facing a large hillside where every few minutes 6 to 8 pheasant come flying towards you (the smart ones turn and go the other way if they can) and shooters try to hit them as they pass over. Shooters are told never to turn around due to the fact that handlers and dogs are lined up behind them.

This particular November hunt was a little more exciting because it was going to be a 400 Pheasant shoot and the 22 shooters would include several prominent doctors in the Phoenix area plus the popular retired Senator Barry Goldwater.

The drive to the Arizona Hunt Club takes about 75 minutes from downtown Phoenix. The scenic drive through the mountainous desert area is breathtaking. After leaving I-17 and driving 7 or 8 miles of dirt road you cross a small wash, climb a sloping hillside of miles of gorgeous

landscaping and finally cross through a stone gate with pheasants engraved.

When you cross over the top and look down it is amazing. Here is a small valley with fields of maze/corn, the homestead, the stables and bunkhouse and the unique clubhouse beside a small duck pond.

The club house makes one comfortable as soon as you enter. You pass by a check-in counter and move into a spacious sitting room with flagstone flooring and a beautiful fireplace to keep you warm if the weather turns chilly.

The Shoot was scheduled to start around 10:00 AM so we slowly moved out into the fields; 22 shooters, 8 dog handlers and 9 dogs anxious to start working.

It was quite a sight watching bird after bird come flying over the hill and into gun range. At the very beginning, our young dog went crazy trying to figure out which bird to retrieve. Even though he was force fetched, at 10 months he just couldn't believe so many birds could fall so fast and so close. He looked like one of those targets you see at the Canivals running back and forth. Needless to say, once we had him corralled, we put him away and only used the seasoned dogs. What a thrill to watch those NAHRA dogs do what they were trained to do. It is definitely not a place for 'good training'! Even the most seasoned dog couldn't resist dropping a dead bird and catch a running pheasant that just landed 5 feet in front of her nose.

After 200 pheasants were released there was a short break while gunners went

back for more shells, retrievers hunted the area picking up birds and dogs were walked over to the pond and cooled down.

After the break, gunners switched positions and the next 200 birds were released. It was quite a morning watching all the doctors, friends and Senator Goldwater taking turns shooting at those 'screaming roosters'. Birds were landing in front, on the sides and behind us. Out of the 400 released, approximately 280 were brought back to the club for pictures and cleaning.

While shooters went back for a wonderful steak lunch prepared by Kent and his lovely wife, Susan, we stayed out and tried to find more of the crippled and dead birds. It was exciting to watch our young female work through the cover and come up with 19 birds all by herself. It certainly makes all that 'quartering' training worthwhile.

After lunch, the Shooters got a chance to really do some hunting. Several handlers were there with their Pointers as they went out in small groups through the desert and the maze and found many of the lost pheasants that were missed or just decided it was the 'wrong direction' for fly!

Yes, it certainly was a great day for Pheasant shooting. The weather was perfect, the people were friendly and the dog work was fantastic.

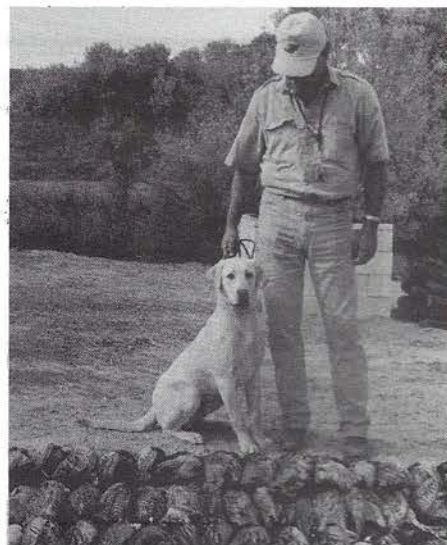

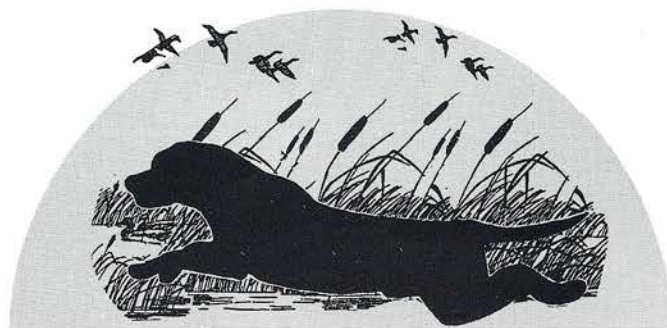

SIGNS OF THE TIMES by B. D. Colen

The majestic Canada goose is slowly disappearing from the Eastern Shore of Maryland. Lots of folks are worried. The Black Water National Wildlife refuge near Cambridge has been one of the largest goose wintering spots on the East coast. Its Canada geese population is down by 40 percent. There are plenty of theories about why geese numbers are dwindling. These include run off into the Chesapeake Bay because of aggressive farming practices, loss of protective habitat on the Delmarva peninsula, and better wintering conditions west and south of the Bay, as well as industrial and urban pollution's effects. Over-hunting has gotten blasted too. Every side has its op- and pro-ponents. Each have committees, foundations, lobbyists and fundraisers. The Bay has become very popular with a butting state and federal governments. Lots of pow-wows and get-togethers have occurred. Strategic plans have been developed and high sounding goals put forth.

My theory about the fowls decline has nothing to do with ecology. I think the prolific, ubiquitous deployment of the wild goose logo all over the Eastern Shore is to blame. Let me explain.

Long before James Mitchner wrote *Chesapeake*, folks started putting cute little stylistic goose pictures on everything. Right now almost every marina, housing development, waterfront condo, shopping center, gift shop, hotel and motel or trendy

bar from the Delaware line to Assateague Island displays either the outstretched black head with its distinctive white chin strap or the whole goose in full flight. The more signs have appeared, the less real geese are to be found. This correlation seems only logical.

I've seen it happen before.

There used to be a secret place, north of Boston, where you could always locate a partridge or two each fall. It was an overgrown apple orchard next to a lovely crystal brook. This little spring seep held native trout too. One summer a sign was nailed to a tree there which said, "Grouse Haven, Luxury Homes." There was a cartoon partridge on it. A few weeks later all the apple trees were bulldozed and the barberry burned out. The little stream became a drainage ditch. The trout died. Two months after the sign went up, all the grouse disappeared. No coincidence here!

Then there was Quail Hollow; forty-five overgrown acres of deserted Virginia farmland where six coveys of these charming birds could be found any fall afternoon by a sharp dog. The sign placed here displayed two nifty quail facing each other above the words "Country Estates." There hasn't been a Bob White there since the first foundation was dug. The little rascals can't live long on lawn grass, I guess.

I used to hunt at a place in southern Pennsylvania which was loaded with pheasants. The farmer took great pains to

leave a bit of standing corn and not cut down every bit of brush in the turn rows. One spring a sign popped up saying that "Pheasant Run" would be coming soon. A stylish rooster, in brilliant green and blue, strutted over the words, "Affordable New Homes." The development's name was pretty appropriate. In a few months all the pheasants had run off and tract houses sprouted out of the bulldozed fields. The bordering woodlot, which always provided nourishment and cover for the garishly colored Chinese chickens, had been turned into "green space" for the cluster-zoned inhabitants. Nice trade!!

The reverse to my sign theory works equally as well too. You'll never find a waterfront development called Jelly Fish Cover or Mosquito Marsh. And both these critters are found abundantly around Maryland's eastern shore. You can't swim in the Chesapeake in the summer for fear of getting stung. You'll be bled blanche in some of the swampier spots. The less signs, the more wildlife, even if they're stingers and biters.

Don't get fooled by all that business about ecology, pollution and loss of wildlife habitat when some wild creature becomes scarce. But start worrying when they put your favorite species on some corporate logo or land development sign. It's the next step to extinction.

Dear NAHRA.
I just wanted to let other dog owners know where to go for help. I needed help when I found out my dog had cancer. I was lucky and found the right place to go.

A HAPPY ENDING

My worst nightmare began on my birthday, May 17, 1992. I was getting ready to take my Golden, Bartley (A.K.A. Jackson's Bartley's Revenge C.D.S.H.W.C.X.) training when I remembered that I had forgotten to go through his coat in search of the dreaded foxtail the night before. I usually check him daily during spring, summer and fall. I was checking him and that's when I felt a small hard knot on his right front leg behind his tendon.

I immediately took him to a veterinarian and had a biopsy done. The result was terrible. Bartley had a malignant tumor, fibro-sarcoma and his condition was guarded. Bartley didn't know he had cancer. He never limped. He wasn't sick. He was the same big happy guy he always was. But I knew and I wanted to take care of it as-soon-as-possible.

I made appointments to see two surgeons. The first surgeon I saw recommended amputation or possibly a resection (Removal of half of wrist and one toe.) The chances of this cancer's recurrence with the resection is 50-60% within 6 months. The surgeon did tell me that radiation has been known to help on this type of tumor and she recommended that I call U.C. Davis. I returned home from my appointment with tears rolling down my face. Bartley was still as happy as ever, wagging his tail. But I could tell he was wondering what was wrong with his mom and why she was so sad.

A veterinarian at U.C. Davis told me he would recommend amputation and chemotherapy, which is not at all what I wanted to hear.

Bartley had one more appointment to see another surgeon. This surgeon recommended amputation and chemotherapy. He didn't recommend a resection at all. He also told me that if I didn't do anything at all that Bartley wouldn't be around in 3 months. I was devastated. Bartley was feeling just great and I, on the other hand, was a wreck.

On the way home from the visit, my husband and I stopped to let Bartley and Pee Dee, our other Golden (A.K.A. Windbreaker's Peedeeweederster) play at the beach. They both had a ball! As I sat there on the rocks watching my big beautiful boy play in the sand and surf, I thought, how can I have his front leg amputated? He weighs 100 pounds. I wondered if he could even get up and around and how it would affect his pride. Question after question ran through my mind. I knew that I had one of the biggest decisions I've ever had to make in front of me.

When we got home I gave my veterinarian a call and told him the news. I had him call the lab that did the biopsy to see what they recommended. The pathologist told him that radiation does work on this type of tumor and that there is an oncologist veterinarian in Tucson that has good success. She uses radiation and hyperthermia treatments on this type of cancer.

Mary Kay Klein, the Tucson oncologist called me right after Memorial Day and asked me if I could have Bartley in Tucson on June 5, 1992. Of course I was packed and on the road on June 4. I knew beforehand that the treatment was going to take 1 month consisting of 12 radiation treatments and 2 hyperthermia treatments. I knew I could have boarded Bartley there but I chose to stay the whole month since Bartley is my big kid. I wanted to see him through the treatments.

When we arrived in Tucson we met Mary Kay Klein and her technician, Libby. They were everything I hoped they would be. They are both such wonderful and caring people. Mary Kay initially told me that she thought we had caught the tumor soon enough for it to respond to the treatments. Bartley started his treatments on June 8 and everything that followed went great!

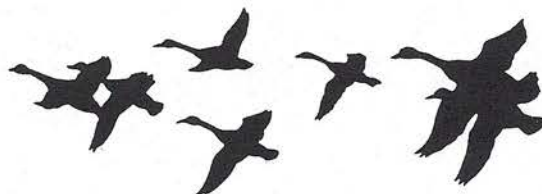
During the third week of treatment, Mary Kay told me that Bartley didn't need hyperthermia treatments because there wasn't any tumor left to heat! At that point, I knew my prayers had been answered. I just started to cry for joy. During Bartley's treatments, Mary Kay allowed me to stay with Bartley. I was there every time he woke up. The treatments usually lasted between 30 and 45 minutes. Afterwards we would go back to the motel.

Bartley never got sick during the treatments. In fact, he even got to train with some of the members of the Phoenix Retriever Club on his birthday after having gone through 6 treatments. Bartley even gained 6 pounds during the month we were in Tucson.

It has been 3 months since Bartley received his last treatment. He is doing wonderfully. We went dove hunting on opening day. I shot 2 boxes of shells and I think I was more excited than Bartley. He barked at me because of my poor shooting. He takes hunting very seriously! I am thrilled to have my big, beautiful boy still sitting with me in the field.

Bartley and I want to thank our family and all our Southern California Retriever Club friends for their good wishes, prayers and the cards we received. The manager of the motel we stayed at couldn't believe all of Bartley's mail!

I recommend that you check your dogs for knots and bumps. The earlier they are detected the greater the chance for success. Also, check all your options before you make the final decision. PROGRESSIVE RETINAL ATROPHY

A few months ago, I noticed my seven year old Labrador was having some trouble with her vision. She often did not see a ball bounce right in front of her, missed easy marks, would get off line more easily, and was relying more than usual on her nose. It became even more apparent when duck season opened. She was due for her annual check-up, so I asked the vet about it. He noticed a problem with her retinas and referred me to a veterinary ophthalmologist.

There I found out that she is suffering from progressive retinal atrophy. This is an inherited disease that causes a constriction of the blood vessels in the retina; it is similar to retinitis pigmentosa in humans. This is different from retinal dysplasia, which is a fold in the retina. As I understand it, the problem starts on the outer edges of the retina, initially causing a reduction of peripheral vision (which is often necessary for good marking ability). As it progresses, it severely limits night vision (necessary for those early dawn hunts). In its later stages, it results in severe tunnel vision, eventually leading to total blindness. The first indications typically begin around five to six years of age, and then progress over a one to two year period. There is no treatment and the condition cannot be reversed.

Since this is an inherited disease, the only way to combat it is through the diligence of breeders and potential puppy buyers. The difficulty is that it is typically not detectable until at least five years of age. This means that breeders must continually have eyes checked on their breeding stock, and also follow up on pups that may have been sold five to seven years ago. Potential buyers should not only ask for current eye exam information on the parents, but also on pups from other litters out of the same sire or dam.

I am not writing this article in an attempt to point fingers at breeders; I would just like to make more retriever owners aware of this affliction, since I had never heard of it. The frustrating part for both me and my dog is that she is otherwise very healthy; I was looking forward to two or three more years of good hunting with her. I am already working with a new Labrador pup, but it is heartbreaking to know that she will no longer be able to do the thing she loves most - retrieve birds.

NEWS FROM THE NORTH COUNTRY

Thought you folks in the "Lower 48" and Canada might be interested in just what people in the interior of Alaska do with their retrievers during the long winters. One can do only so much obedience in the house or garage, then you and the dog have to get outdoors.

First, I'd like to set the scene. Using this year as an example we've had over 10 feet of snowfall so far and that translates into about 4 feet of very dense snow on the ground. Another factor is the temperatures which vary from highs of +50F (rare occurrence) to lows of -60F or colder (not so rare). Most people won't train outdoors at -20F or colder although some of our club members push that from time to time.

Plowed Parking Lots - Everyone's got their favorite with memory blinds on the edges. We use these for stretching out distances on marks, teaching doubles, working on hand signals and teaching dogs to avoid cars (just joking!).

Snow Lines - Definition - trails made in snow with snowshoes or snowmachine. They are good for T patterns, baseball, memory blinds or marks. Running these over different types of terrain and angles is great for getting the dogs used to running straight lines (if we make the trails straight). For marks at the end of the trails we stomp down a large circle with snowshoes for the birds to land in. If you fail to do this, your bird will disappear. Then to protect us lousy throwers, we lay a bird or bumper where the thrown one is supposed to land.

I hope everyone has a good year and good luck in the dog training world.

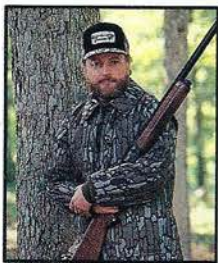
