

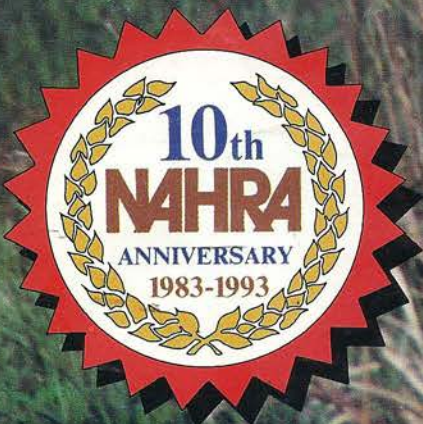

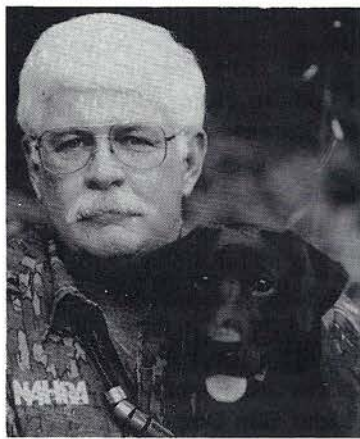

# President's Bark

It's often difficult to focus on the original purpose of the NAHRA organization and its concept amidst all the daily happenings. In the first year of formal testing in 1985, we had less than 20 clubs across the United States in contrast to the nearly 100 clubs currently active in the United States, Canada and Mexico. We had a part time employee at our first President Ned Spear's office. Of course Ned and Betty did the work behind the scene and led the list of early unsung heroes. Following in Ned's footsteps, I began assisting NAHRA in 1988 by playing host to the NAHRA office at my home. In the fall of 1991, we moved into commercial office space. We have an

office full of sophisticated machinery. We push paper like other organizations. Advertising, sponsorships and memberships are the life blood of NAHRA. Through the years, we have increased interest with incentives aimed at retaining the active participants. We have political issues and individual points of view typical of any club. The bottom line is that the dogs could care less why and how NAHRA was founded and they don't understand politics. During the past ten years NAHRA issued titles to 136 Grand Master Hunting Retrievers (GMHR), 316 Master Hunting Retrievers (MHR) and 823 Working Retrievers (WR). Over 2,800 Started Certificates have been earned by dogs of every approved breed in North America. The quality of dog work has increased dramatically. Four dogs have accumulated over 1000 NAHRA Senior points. This represents 50 Senior qualifications. Photographs and biographies on these dogs will appear in the November NAHRA News. More dogs qualify today at NAHRA Field Tests than they did in 1985. We adopted a standard not to be changed because it represents realistic goals for the hunter as created. The statement was made at our initial meeting at Mashomack 10 years ago that if 100% of the dogs that compete can qualify, we shall have achieved our goal. We have educated the hunter and his dog and provide a working gene pool of retrievers for the hunter. The program works! Look at the piece written by Jack Scanlon on page 9, "With NAHRA, Without NAHRA". I can relate and remember what it was like before NAHRA! NAHRA has had its ups and downs and growing pains as does any fledgling. During the past year we have been stable during some tough economic

times. I announced earlier that we had seven new clubs thus far in 1993. Five additional clubs are planned for the mid-west region alone. I'm going to predict that 10 new clubs will be on board before the close of this year. Our individual NAHRA memberships are up by over 600 compared to July of last year.

Started entries have increased which indicates our new members are actively campaigning their dogs. The hunter shares the common experience and love affair with his dog perhaps more aptly defined as an unavoidable affliction. The efforts of all NAHRA members makes the program possible and promotes increased conservation afield with the use of a trained retriever. It also keeps lots of tails waggin'.

Dick Weiner and the National Invitational Committee were responsible for another successful Invitational. Photos and a list of qualifying dogs appear in this issue of the NEWS. David Foulk from Kingsport, Tennessee will chair the national committee in 1994. Plans are being made and site location will be announced as it becomes available.

The drawing for the International Raffle was made in the offices of Jones and Kolb in Atlanta, Georgia July 16th. Thanks to all of you who purchased tickets and helped in this project. Winners represent a cross section from Mexico, Canada and the U.S.

The gunning season is upon us again. Ol "SixPack" will be scratchin' to go in most parts of the country by the time you receive the publication. Let's set an example for the hunter and his dog and preserve our national heritage.

### KEITH STROYAN - NAHRA'S NEW INTERNATIONAL LIAISON

Keith Stroyan will be assisting Randy  
Carlson this year in his duties as  
"National Liaison." NAHRA wants to  
rotate the position and will regularly  
train new people in the future. Rotating  
the position every few years will give the  
NAHRA Board wider access to mem-  
bers' opinions, while a training year with  
the established person will give the new  
liaison a chance to learn the job and  
make a smooth transition.

Next year Keith will take over as  
International Liaison, coordinating the  
communication between the NAHRA  
Board and Regional Liaisons in Canada,  
the U.S. and Mexico. NAHRA's Liaison  
system is the official way for members to  
communicate ideas for action by the  
NAHRA Board. It is also a direct way,  
beyond NAHRA News, for the Board to  
pose questions for official consideration

of the membership (such as the proposed  
rule changes rejected by the Regions last  
year.) NAHRA is your organization and  
the Board wants to learn about your ideas  
and problems in a coherent organized  
way.

NAHRA's International Liaison acts  
as the communication link between the  
various Regional Liaisons and  
NAHRA's Board. He sends written sum-  
maries of the Regional Liaison's semian-  
nual reports to the Board and sends  
Board concerns to the Regional Liaisons  
for the agenda of the Regional meetings.

The Regional Liaisons in turn are the  
communication link to the International  
Liaison. The Regional Liaison is also a  
coordinator for regional clubs on issues  
like choosing the host club for the  
Regional Invitational Field Test and  
resolving conflicts in the region's calen-

dar. Keith will work to help regions  
strengthen these roles, putting important  
responsibilities in local hands.

Each club has a NAHRA Representa-  
tive who acts as the primary contact per-  
son with the Regional Liaison and who  
receives information about Regional  
meetings, etc. Ideas originating with a  
few individual members can move  
through the club representative to the  
regional meeting. The Regional Liaison's  
report can distill individual ideas into a  
workable consensus plan of action that  
represents the members as a whole.

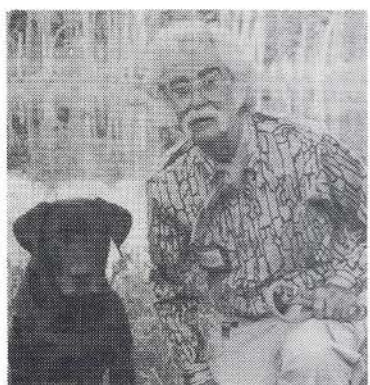

# Ready Retriever Chronicles

We've learned that his sire, GMHR, WR NAHRA's Rough'n Ready was a legend in his own time. And Ready's dam, MHR, WR, Steady Rollin' Lady, had produced several Master Hunters before she passed on. ## Guidelines to Reduce the Prevalence of Osteochondritis Dissecans in Dogs

Osteochondritis dissecans (OCD), a disease of bone formation in dogs that leads to lameness and arthritis, has been the subject of an ongoing study by Cornell and the University of Guelph, Ontario. Now those researchers in conjunction with Texas A&M University and the University of Prince Edward Island, Canada, have completed the second stage of their investigation and have issued a set of recommendations on reducing the prevalence of this skeletal disease. The guidelines are based on the belief that manageable environmental factors such as diet and exercise are related to the clinical signs of OCD. The importance of these practical preventive measures is obvious: investigators think that the prevalence of the disease in dogs has been increasing over the past decades.

The current report is based on responses to a telephone questionnaire completed by owners of dogs diagnosed with the disease. Answers revealed a definite pattern of risk factors; most important were intense exercise and diet. Dogs, especially young dogs, who played one time or more daily with other dogs were at increased risk for OCD, lending credence to the hypothesis that intense exercise, and the resulting joint trauma, are associated with the disease. The recommendation, as hard as this may be for owners of large and giant breeds to accept, is that owners limit exercise when their dogs are young and growing. It has been known for some time that breeds such as the Bernese Mountain Dog, Golden Retriever, Great Dane, Labrador Retriever, Newfoundland, Old English Sheepdog, and Rottweiler are especially prone to developing the disease. Genetic factors may be involved here, and the rapid growth exhibited in these breeds may be a more important related factor.

The study also investigated the role of diet, especially calcium, and concluded that dietary components may be risk fac-

tors in the earlier changes that precede actual development of OCD. The new findings support the previous speculation that high calcium in a dog's diet may lead to an increase in development of the disease. Administration of calcium supplements should be avoided in an effort to reduce the possibility of a young dog developing the disease. Although the feeding of specialty dry dog food was associated with decreased risk, the researchers believe that the role of dry food has to be evaluated in additional studies. It has been recognized for many years, however, that overfeeding leads to skeletal changes that may themselves predispose a dog to OCD.

In addition to these recommendations, owners of breeds at risk should be aware of early signs of the disease. The vast majority of dogs show the first signs between four and seven months of age. Dogs in this age bracket should be watched closely for the first signs of lameness and prompt veterinary attention should be given. The disease may be halted before permanent damage has been done to the joints. Lameness may develop in one foreleg or both, and stiffness may appear after exercise. Because there are many possible causes of lameness in young dogs, radiographic studies are necessary to determine if the dog has, or is in danger of developing, osteochondritis. Although the best therapy for the disease is debatable, exercise restriction and diet modification are generally accepted as first steps. Surgical intervention may be recommended in some cases.

## Advances in treating skin diseases

Without a doubt, the most important advances in veterinary dermatology have been made in allergy, cutaneous endocrinology, and bacterial skin diseases. Most work has been done in the field of allergy, since it is the most com-

mon cause of skin disease in dogs and cats. All forms of allergy (atopy, food hypersensitivity, flea bite hypersensitivity) have been studied extensively, but atopy has received most attention.

Atopy is a disorder where the sensitive animal inhales pollens, mold spores, house dust and other aeroallergens and itches its skin in response to them. In dogs, and probably in cats, atopy is a genetically programmed disorder that starts early in life and increases in severity as the animal ages. Prior to 1985, atopic animals were treated either with corticosteroid or immunotherapy (allergy shots). The latter was used infrequently because it required an intradermal skin test, which was performed by few veterinarians. Today, an atopic pet can be treated with a number of nonsteroid anti-inflammatory drugs or immunotherapy based on serologic allergy tests.

The Dermatology Service at the College of Veterinary Medicine at Cornell has been and continues to be at the forefront of the work on the efficacy of nonsteroidal medications in the control of atopic pruritus. For dogs, the Dermatology Service has studied and published the results on clinical trials of 13 nonsteroidal medications to control pruritus. Three more are currently under investigation. In cats, two drug studies have been published and two more are under way. These studies have been very fruitful. We now know that with sequential drug trials approximately 50 percent of atopic dogs and 80 percent of atopic cats can have their pruritus controlled without the use of corticosteroid. No doubt the percentages will increase as other drugs or drug combinations are evaluated.

Although serologic allergy tests were marketed to veterinarians in 1985, they did not receive wide usage until the last three or four years. Despite their wide usage now, the true value of these tests still is not known. The Dermatology

We seem to have entered a membership phase where new hunters have joined to improve their retrievers. Our Started and Intermediate entries are up and there are many enthusiastic new faces, human and canine. Some of these are experienced hunting dogs that successfully jumped right into Intermediate.

In June, I attended the second licensed test of High Plains HRA near Woodward, Oklahoma and saw one of the most solid, energetic, well-organized clubs around. The surprise is that a year-old club can put on a large superbly organized field test. The grounds were excellent, the mechanics flawless, the tests were sound and fun, the hospitality outstanding. I had more fun there than I did at the Invitational. What's the secret of their success? Experienced hunters

who work hard and harmoniously.

Entries in Started and Intermediate were also up at the Midwest Regional near Minneapolis. The increase seemed to be a similar new group who want better dogs and have learned that NAHRA can help. We need to get the word out to this kind of person across the continent. You and your club need to do it.

All the clubs mentioned above also have a big annual turnover. I was a little discouraged the first year that we lost a lot of our members. Many beginners won't train their dog past puppy work. Other advanced members have conflicts with the rest of their life and can't stay with the club. We haven't had fights to drive anyone out, but we learned some time ago that we need to work every year to attract new members. This is just a natural replacement that I suspect every club needs to do.

The surge in our club this year is partly individual effort, partly luck and partly plan. Bonnie Moothart and Bruce Mountain in their respective areas really beat the bushes for us. Several breeders have also been a key link to new members. Tim Post's Moon River Kennel is probably the best represented in our club. The Iowa DNR publicity person has also been a friend. For the last two years he has made a professionally edited video of a club test and distributed it to TV stations across the State. There's no substitute for hard working cooperative members, but there are a few things we've done that might transfer to your club and help you stay strong.

## Help Beginners Start Training

In our region we are most successful at attracting new members in the heart of winter, just after the close of the hunting season. Our winter club tests include graduated tests designed to help beginners get started at training their dog.

These tests build up gradually to an annual Sanctioned Beginner Test. We try to make that test a goal in itself; about like land tests for Started with all the bells and whistles. Some people are satisfied to stop at that point, but offer our club some support before the ice is out and golf and fishing begin. Some go on from there.

## Announce Club Meetings in Local Newspapers

We send announcements to local newspapers all around our club's large

region. These papers usually will announce the meeting free and a few print the additional information we provide at the bottom of the announcement. Such announcements usually need to have the name, address and phone of one or more club officers. These are also an important part of the information link.

## Posters

Another club member, Dick McGowan, runs a printing business and helped us design an information poster that we can hand out to interested people or post in sporting goods stores and the like. It includes a club membership application.

## Breeder-Buyer Incentives

Dick also helped us design a special "new puppy buyer" poster. This has information about our club and offers the new buyer three months free subscription to our newsletter. We offer breeders a free classified ad in our newsletter in exchange for distributing these new puppy posters. We feel that new puppy owners will be happier with their purchase if they do a little training. We know that a lot of these folks won't last long, but a few will stick with the club. They'll all make better retrievers than the ones who never joined the club.

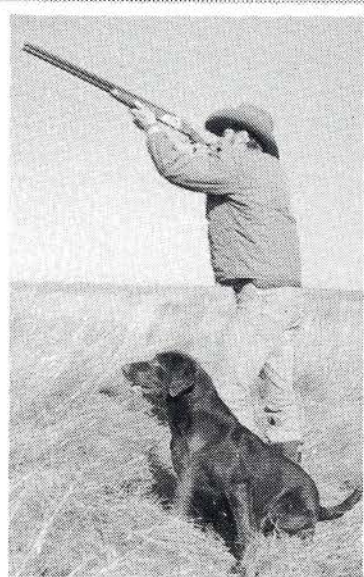

# Training Tips

by Gary Erickson



## "Marking"

Volume VIII, Number 3

One of the most important abilities of a good hunting retriever is recovering game that he sees downed without a lot of disturbance to the marsh and upland and without being handled with whistle and hand signals. This is called "marking."

I begin the marking training when "Pup" is seven weeks old and concentrate only on the Sit and Come commands. At this point in the training, "Pup" is physically restrained just long enough for me or an assistant to throw the bird.

Your six goals, in their order of importance, are: 1) Increasing your puppy's desire and intensity for retrieving by making it fun and exciting. 2) Getting him/her to scoop up the bumper and not just stand there sniffing it. 3) Encouraging him to bring the bumper right back to you as quickly as he can. 4) Encouraging him to deliver it to hand. 5) Getting him to deliver the bird to you at the heel and sit position. 6) Getting the little guy or gal to stay until he is released for the retrieve.

Get down on your knees and hold "Pup" in the heel and sit position. (If you shoot right handed, your pup should be on your left side and vice versa if you shoot left handed.) I give the preparatory command "Mark", blow a duck call and toss a bumper out in front 5 to 10 yards. (Always toss the bumper overhand when you are doing the throwing so he/she will look out to see the bumper fall instead of back at you and your hand.) I release "Pup" for the retrieve as soon as he sees the bumper and wants to go. (I always release a dog for a marked retrieve by saying his call name. In this case, "Pup".)

Just as he picks up the bumper, I call him to me by saying "Come." If he doesn't come directly to me, I get up and start running away from him and encouraging him to chase me. As he gets within reaching distance, I try and catch the bumper before it hits the ground. If your puppy is willing to continue to hold the bumper, coax him into the heel and sit position before grabbing the bumper.

I am always ready to catch the bumper before it hits the ground as "Pup" may get tired of holding it at any time. If "Pup" is willing to sit and keep

# From The North Country

I've been stepping out on my wife quite a lot lately.

Oh, it's all been perfectly innocent, but I apparently have an uncontrollable desire to be with my dog.

So I find myself, night after night, readying to slip out the door after my wife and daughter are sound asleep.

I gingerly wrap my hand around my whistle lanyard so it doesn't rattle when I lift it off it's hook. I wait until I'm outside to put the Tri- tronics collar on the

dog, and put on my hip boots. I started leaving most of my gear out in the storage shed about a month ago so I wouldn't be so noisy trying to get out the door.

Of course my black Lab, Rascal, is not nearly so sneaky as I. He knows it's time for fun and can't help but bounce just a little and pant just a little and go over to his water bowl for one last little drink. There isn't much room for such late-night exuberance in a two- room log cabin. Rascal is a cabin clod.

I'm sure my wife knows what's going on, but she is kind enough not to complain in the evening and even kinder to rattle my bones out of bed in the morning to point my bleary eyes toward the door and another day of work.

A hoard of mosquitos and bright sunlight await outside the door at 10 p.m. I smell Ultrathin repellent cream on my arms and face and give Rascal a refresher squirt of Coulston's 4- Week Tick Killer to ward off the insects.

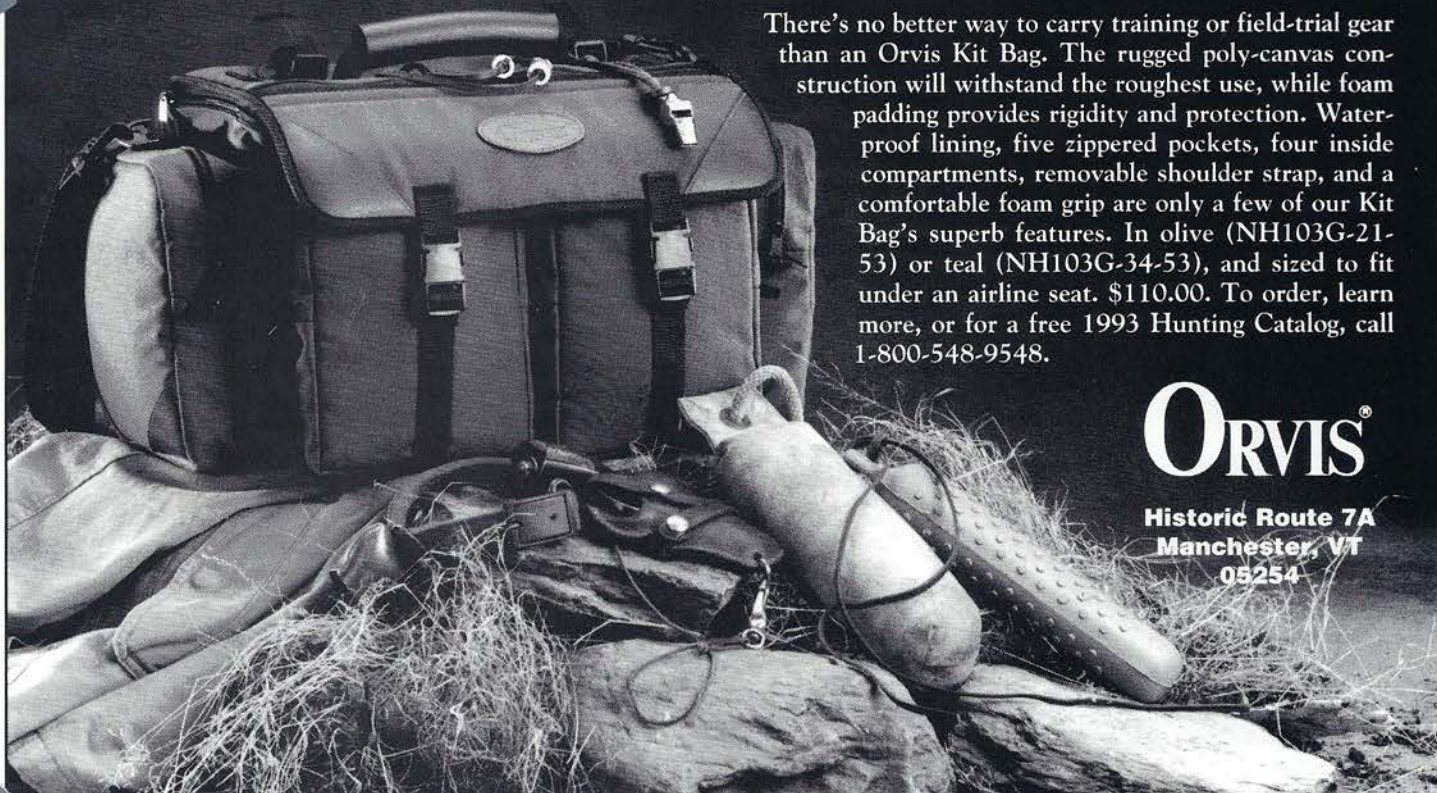

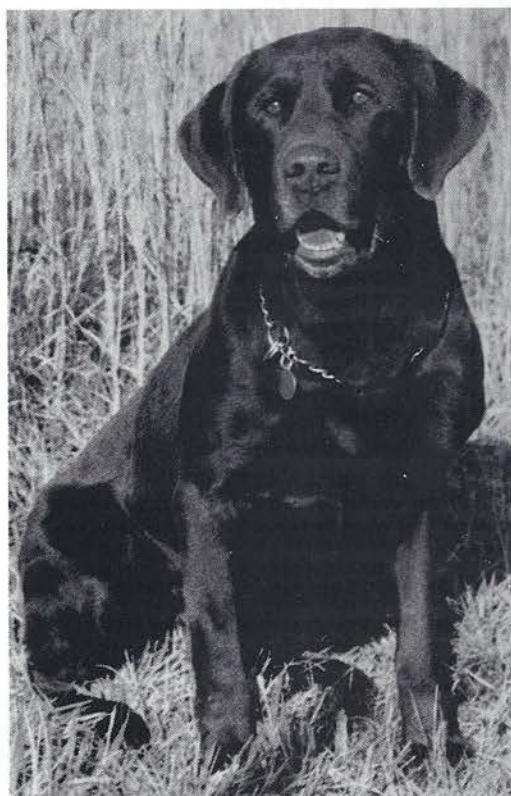

# NAHRA Invitational

## May 12- 16, 1993

The Mashomack Hunting reserve was perfect for our Invitational Test. NAHRA was born here ten years ago at lake side under the giant Linden trees. The grounds are absolutely beautiful. They are everything anyone could ask for in a test site. Geese, ducks, pheasant, turkey, grouse, dove, chukar and quail are everywhere. The game is a constant reminder that we are in a hunting paradise.

Mashomack was founded in 1964 on Shelter Island. Dan Dailey, Mashomack's present owner, reorganized the club and moved it to its present location in 1979. Last season they released forty-six thousand birds. They have two flighted bird towers. There is a sporting clays course designed by Ken Davies. Mashomack is an ideal place to test hunting dogs, hunt upland game and waterfowl, fish or shoot clay pigeons. What a wonderful place this is!

The Invitational judges and handlers began to arrive Monday, May 10. It must have been difficult for the judges to select their test sites from twenty five hundred acres of hunting paradise with many ponds.

The handlers received their orientation Tuesday morning at the Ramada Inn in Kingston. Richard Wolters gave a brief discussion of the founding of NAHRA at Mashomack. Dick Weiner introduced the judges: Jack Jagoda, Keith Stroyan and Laurie Batson. Dick also introduced Rocky Emery as the alternate judge. Since Rocky did not judge this event, he will judge the 1994 Invitational.

The judges spoke briefly. Jack Jagoda stated that the judges were looking for solid work and the dogs would be judged against the written standard. Keith Stroyan made the point that all six tests would be as close to real hunting situations as possible. Laurie also stated that the judges were equally responsible for all the tests.

Rex Bell, the Field Marshal and Gun Captain, discussed the evening banquet. He also introduced the dogs and handlers and handed out the dinner tickets, hats, programs, vests, etc. Every dog entered and received a bag of Eukanuba dog food.

The next thing on the agenda was a bitch check. Dr. Michael J. O'Neill, the Field Test Veterinarian, held the check on the training grounds at Lafayetteville State Forest. Wilber Pond was available for water training. In addition, many local owners allowed training in their fields and ponds. Everyone in upstate New York was as friendly as could be.

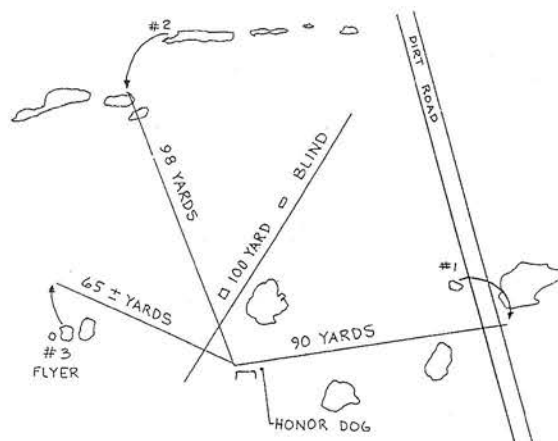
The handler recognition banquet was held at Mashomack under the tent. There were outstanding Hors d'oeuvres and a no-host bar. Dinner consisted of a wilted salad, spinach, green peas, charbroiled breast of pheasant, smoked chicken and buttered noodles with pie and ice cream for dessert.

After dinner, Dick Weiner asked Jack Jagoda to come forward. Dick handed Jack a ten thousand dollar check payable to NAHRA. The Invitational raised these funds and they are to be used for the promotion and betterment of NAHRA. Dick again introduced the judges and presented them with their judges' gifts.

The Invitational had a silent and a public auction. Woody Thurman was the auctioneer. Invitational sponsors donated

many items. There was a Tri-Tronics remote trainer, a WARN winch and a Sunnyview puppy certificate, among other things. Copies of Field & Stream were available for the handlers.

### THE TESTS



Land Marks and blind

May 12

Testing began Wednesday morning. The weather started out warm and turned hot. There was a breeze from the south (right) for much of the test. The breeze did vary from nil to strong.

The first test was the land series and consisted of a triple land mark, a land blind and an honor. Ninety eight dogs entered. Ninety two ran in numerical order starting with dog one.

The judges located their test at the base of a small hill. The gallery had an outstanding view of the test from the hillside. From this position, the gallery did not interfere with the dog work.

The judges gave the scenario at 8:00 AM. The working dog handler holds a shotgun during the entire series. Ducks are flying in from the right to feed in the field. There are two hunters with their dogs at a typical blind. The working hunter is in the blind with the dog on the left front corner. The other hunter is outside the blind on the right and is ready to leave. The honor dog is at the right front corner of the blind. They sight a flight of ducks. The working dog handler starts the test with a duck call. Every hunter starts calling the ducks. There is a pause in the calling. The right hand mark calls, throws and shoots. Ditto the center mark. There is a third duck call and a shot flyer duck. The judges release the working dog with "dog." The working handler sends the dog for the first retrieve. The judges release the honor dog and handler after the first duck is delivered to hand. After picking up the triple, the handler takes the dog inside the blind for a drink. When the handler indicates ready, a fourth duck flies in and is shot by a hunter in the field. The handler moves the dog from the blind fifteen yards to the left to the point of origin for the blind retrieve.

The judges called sixty nine dogs back.



## MAY 13

Thursday was overcast with a very light and variable wind. It appeared to be an ideal day for the trailing test. Dogs ran in numerical order starting with dog twenty four. The first dog ran at 8:15 AM. The judges released a clip wing pheasant. They placed a small amount of feathers on the ground at the point of origin. Each dog had a fresh trail unless a dog didn't retrieve a pheasant. In that event, the judges call the next dog. Some pheasants were not very cooperative.

The judges called sixty nine dogs back.

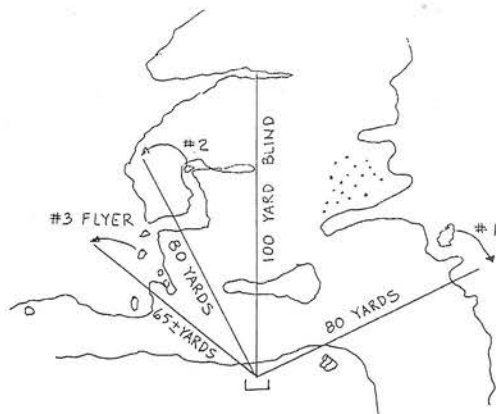
## May 14

Friday was sunny with a moderate breeze. Dogs ran the upland test in numerical order starting with dog forty eight. The scenario started at 8:30 AM. The test is held in a field bisected by a dirt road. The judges and one gun walked down the road. A handler and dog worked each side of the road. A gunner walked on the outside edge of each field. Two bird launchers are at the end of the field. Pheasant hunters with two dogs in brace drive pheasant to the end of the field where they flush. The first pheasant flushes. When it hits the ground, the second pheasant flushes. A judge releases the handlers with "dog." The handlers decide which dog retrieves which pheasant.

This was an exciting and suspense filled test because the bird launchers are frequently moved. The handlers did not know when or where the pheasant would flush. At the conclusion of the test, the judges, gunners, handlers and dogs ride back to the point of origin in pick up trucks.

The judges called sixty five dogs back. Three dogs broke on flush. One dog went out on points.

There was an excellent tailgate party Friday night under the tent at Mashomack.



## Water Triple and Blind

## May 15 Saturday

The fourth and final series was a water blind and a triple marked water retrieve. The judges started the scenario at 9:30 AM Saturday morning. Dogs ran in numerical order starting with number 73. The weather is clear with a variable and at times strong breeze blowing from the right. The hunter sets the dog on a ribbon, enters the blind and starts calling ducks. The hunter is holding a shotgun. Hunter's buddy steps forward from the blind and fires two shots. The hunter hands the shotgun to the buddy and sends the dog on a blind retrieve.

The marks are by invitation. The hunter again sets the dog on the ribbon, enters the blind and starts calling ducks. The birds fly in from the right. There is a call, throw and shot. Ditto the center mark. The third mark is a flyer duck. The hunter is

The awards ceremony was held under the tent as Mashomack. Invitational hats, programs and glasses were for sale. Richard Wolters had copies of his latest book for sale. Richard donated all the profits from the sale of his book to NAHRA.

Dick Weiner had a few words to say. He gave special thanks to all the sponsors. He thanked all the Invitational Committee for their outstanding performance.

Jack Jagoda had a few words for the qualifiers and their dogs. He stated that the judges were looking for control. Those dogs that were under control passed; those that weren't didn't.

Richard Wolters congratulated the forty nine qualifiers and gave them their awards. Richard really enjoyed this task, especially the hugs and kisses from our lovely lady handlers.

There was a special raffle for the qualifiers. Tri- Tronics donated a Model 500/LR Remote Trainer to the winner of this special raffle. Robert Meyer from Anchorage, Alaska, was the winner.

# 1993 Northeast Regional

The third NAHRA Northeast Regional was hosted by the Navesink River Hunting Retriever Club on May 1, 1993. The tests were held on the properties of the newly dedicated Wallkill River National Wildlife Refuge in Vernon, New Jersey.

Wallkill represents the first "river flood plain refuge" established in the Northeast Region. The flood plains are characterized by forest, open farmland and wet meadow habitat which support an unusually diverse number of waterfowl species.

On Saturday at 8AM handlers arrived ready to get their numbers and head for the test site. Thirteen of twenty-nine qualified Started dogs and seven of eighteen qualified Intermediate dogs participated in the Northeast Regional.

Started judges Roy and Diane Sheppard began the testing with a simulated field goose hunt followed by a duck hunt water single from a blind on the river. The second water test was a duck hunt from a canoe on the river which all dogs faired well even with the moderate current. The fourth test was a marshy duck hunting test. Some handlers had reservations before they ran the final test which consisted of the handler and dog doing a walkup through wooded cover to a small marshy area in the woods. Was it a land test or a water test? Could the dogs see the fall? Well, it was a wet land test or a dry water test and all of the

dogs could see the fall. Roy and Diane's comments after the tests were: "We were very pleased and amazed to see such fine dog work. Even as some handlers were tentative in entering the Regional so soon after a bad winter and not being able to do a lot of training. We were very impressed with the quality of the dog work."

Intermediate judges Don DeBerardino and Jim Bryson began the tests with a simulated upland pheasant hunt at the edge of the woods. The handlers hunted through a variety of cover with a hunting partner. This was followed by a quartering and trailing test. Then on to the water double also known as the "Meat & Potatoes Test". Time for some New Jersey jump shooting. The handlers did a walkup to a designated area where they left their dog and then walked another twelve feet up the shore of the river, to try and scare up some ducks. The first duck went up off to the right and was downed in the cove, this caused another duck to scare up across the river by the handlers hunting buddies and they shot the second bird and it landed near them. This was a land to water to land to water to land test for the second bird down." The last test was a blind retrieve. The swift river current pushed the dogs off their line but they recovered well" said Jim Bryson.

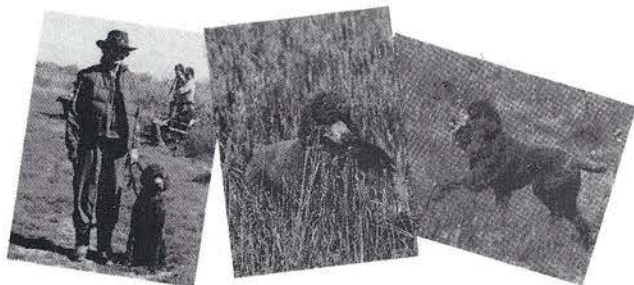

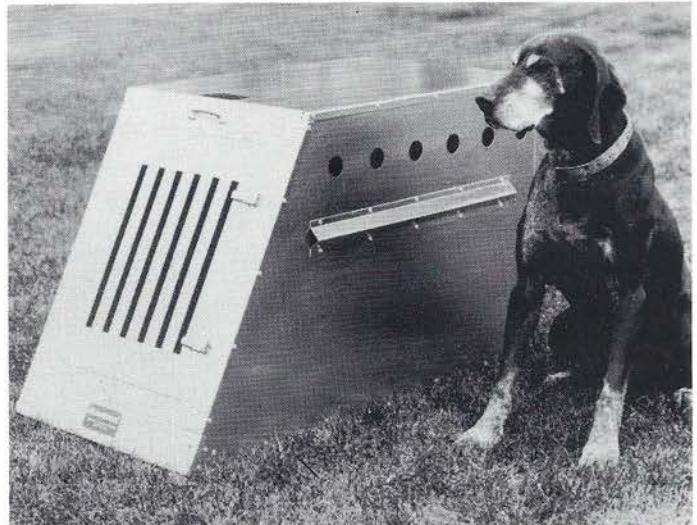

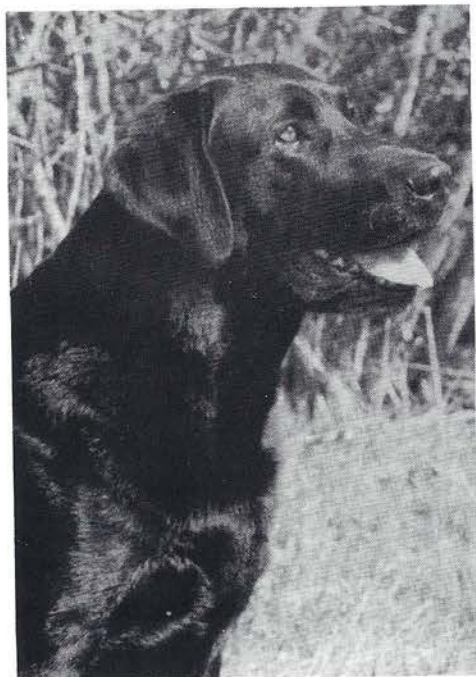

Service has completed three studies on the accuracy of serologic testing in atopic dogs and has two more under way. Our work has helped define the value of the serologic tests, but more work is needed. As of this writing, the Dermatology Service believes that intradermal skin testing is the best way to evaluate an atopic dog or cat for its allergies, but if that testing is not available to a pet owner, serologic tests are not without value.

Endocrine skin disorders, those caused by a hormone deficiency, excess, or imbalance, have accounted for about 5 percent of dermatology referrals over the last 10 years. In the early '80s, these cases had to be referred to academic institutions or specialty practitioners because the tests necessary to define the problem were not available to practitioners. Today, all of the necessary tests are available to all veterinarians through the Diagnostic Laboratory at Cornell or a number of other laboratories. These services enable the pet owner to have his/her pet's endocrine problem diagnosed and treated closer to home. This results in better treatment because the patient can be monitored more closely.

With this wide availability of testing, the nature of the cases seen by the Dermatology Service has changed. The common endocrine skin disorders, hypothyroidism and hyperadrenocorticism, are now rare in our practice, where as those associated with sex hormone abnormalities are more commonplace. The Dermatology Service has done pioneering work in this area with publications that describe most disorders. Veterinarians at the University of Tennessee documented an adrenal enzymatic defect in some Pomeranians and other dogs, which caused their sex hormone imbalance. They not only described the problem but also developed an adrenal sex hormone stimulation test to document the problem. This testing is now available to all veterinarians. With our publications and this testing, practicing veterinarians can now deal with most endocrine skin disorders.

Bacterial skin infections, called pyodermas, are very common in dogs.

Usually, the infection is secondary to some definable and treatable skin disease and can be managed fairly easily. However, there are some dogs who suffer from chronic recurrent pyodermas where no underlying cause can be identified. Years ago, these dogs were euthanized because of their life-threatening infections. Today, many of these dogs are saved if their owners are willing to persist in treatment. The most exciting avenue of treatment involves the regular injection of various bacterial products (bacterins) to stimulate the dog's immune system. In carefully selected cases, this bacterin therapy can help upward of 80 percent of the dogs. When used in less controlled situations, response rates of about 30 percent are reported. Although not uniformly successful, bacterin therapy has proven to be a useful therapeutic tool for veterinarians. When this therapy does not work for patients, chronic antibiotic administration has proven to be effective. This form of therapy was not practical in the early '80s because the available antibiotics lost efficacy with chronic usage or caused adverse or toxic reactions.

The pharmaceutical industry has helped resolve these problems. In the last 10 years, about five new antibiotics with good skin activity have been released to veterinarians and can be used safely and effectively on a chronic basis. Some of the patients of the Dermatology Service have taken some of these antibiotics on a routine basis for nearly six years with no adverse reactions except to the owner's bank account. As expected, chronic antibiotic therapy is expensive, especially in large dogs, and has the potential for development of resistant "super" bacteria. These drawbacks make this form of treatment a last resort before euthanasia.

Many other advances have been made in dermatology over the last 10 years. More than 100 "new" diseases have been recognized and the histopathology of animal skin diseases has become a recognized subspecialty. In many instances, recognition of the "new" diseases was based on advances in veterinary dermatohistopathology. These "new" diseases existed for decades, but were incompletely described. Now with the accurate diagnosis of same, specific treatment can be instituted.

The future of veterinary dermatology is both bright and bleak. In the last decade, over 50 veterinarians have

become board certified in the American College of Veterinary Dermatology and about 20 more individuals are at various points in their preparation for the certification examination. This pool of well-trained individuals, combined with a responsive pharmaceutical industry, should be able to solve virtually any problem in dermatology. The cloud over our future is the economy. Simple problems have been addressed and many of those that remain will require significant funding to investigate. Today, that funding is not available on a routine basis. If the necessary funds become available, the world of veterinary dermatology will be very different in the next decade.

holding onto the bumper, I gently pet him for a few seconds and then I take the bumper from him by using the command "Give" or "Leave it." If he is unwilling to give the bird or bumper up, you may have to press his gums into his teeth to extract the bumper as you command him to release the bird.

As "Pup" becomes more excited with this game, I restrain him for a longer period of time before releasing him for the retrieve. This is the beginning of teaching pup that he can't go for the retrieve until he hears his name to make the retrieve.

Once the dogs enthusiasm is built up to its maximum, I begin extending the distance at which "Pup" must make his retrieves. You need a helper for this part of the training, so call your hunting partner, beg your wife or bribe your kids. You will also need a half dozen bumpers for this training.

Position your thrower with all of his bumpers 150 yards out in the field. Get "Pup" out and put him on leash and walk

him at heel in a straight line towards your thrower. When your get 20 or 25 yards away, stop and put "Pup" at heel and sit. Signal for the throw and release "Pup" for the retrieve. If "Pup" makes the retrieve without any difficulty, back up 25 to 30 yards in the direction you came from and repeat the throw and retrieve.

It is critical that the bird or bumper lands in the same area each time it is thrown. We are trying to teach "Pup" to use his eyes to get to the area of the fall and then to use his nose and eyes to locate the mark without a great deal of hunting for it. It is very important that you don't drop the bumper as you will create a scent area and "Pup" will get to that spot and start hunting instead of running all of the way out to the bumper. If he is willing to come right in and deliver to hand so much the better and you should continue to encourage him to do so. However, delivery to hand isn't as important as the extension so don't be hassling "Pup" about it now. You can work on the delivery to hand in the yard on short marks at a later time.

As long as "Pup" is finding the bird and coming right back with it, continue to back up 20 to 30 yards and repeat the mark. If he has any problems at all, either rerun the mark from the same loca-

tion or move up to the last point you ran from, run the mark and quit. You may not make it all of the way back to the 150 yard point the first few times you try this exercise but keep trying each day until "Pup" does it.

Challenging single retrieves are the back bone of making a great marking dog. Remember, doubles and triples are only singles with a time delay. We will work on memory later on.

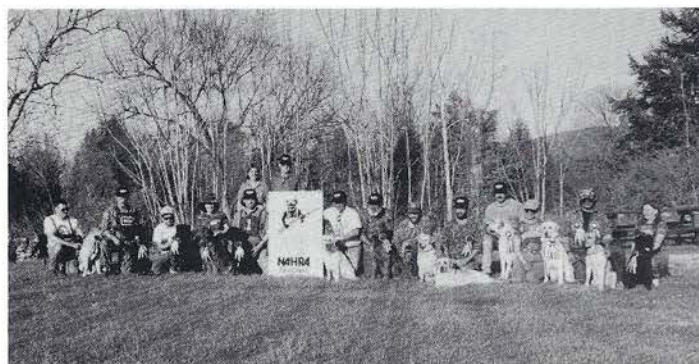

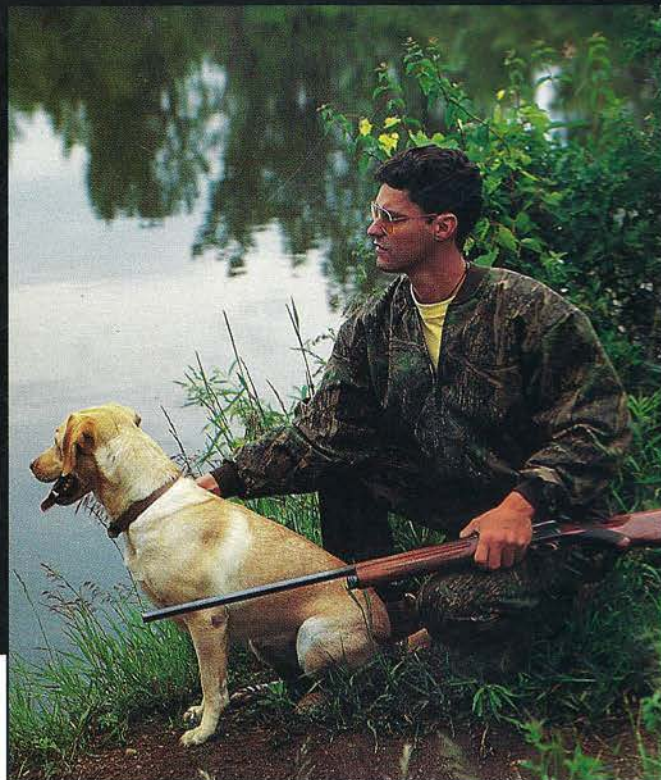
