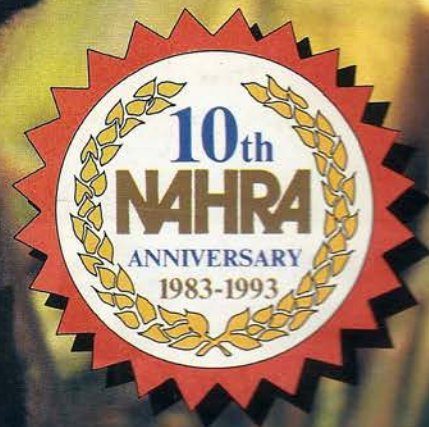

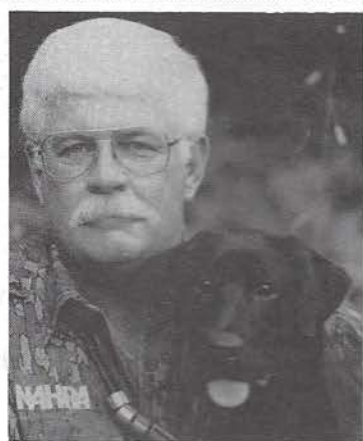

Wolters Says...

Genes or Training ... Which?

One of these days I will get organized. Twenty some years ago I had a secretary named Kathy ... I think. She was with me for many years ... I think. Back in those days I was organized ... as I kind of remember it. All I would have had to say was, "Kathy, remember those two letters about training with the collar? May I have them." Well, that is not the way it works today. Rosemary, from the NAHRA office called and said I had a deadline for my article for the NEWS in a few days. I have spent the day trying to find those two letters that I received because I thought they would make good material for the NEWS. I put them in a "special" place so I would have them when needed. Well ... they are needed now ... NOW! Kathy where are you?

So with both letters hidden in such a safe place, I remember at the time that I thought it was interesting to received two letters pretty much on the same wave length. Both came within a day or so of the other. One was from Canada and the other from our mid-west. Both writers were concerned about the use of the electric collar and its effect on the future of our retrievers.

Here was the thinking and the question of both writers: are we getting the best all

around dogs from our training programs or are we getting the dogs who can stand the pressure of training with the collar? The best dogs coming out of our collar programs are the ones that make the titles in licensed trials and hunting tests, so that when it comes to breeding, those that gain the reputations are the obvious choice. The dogs that can't stand the pressure are just lost ... they may be really great dogs.

Do you remember Ed Zern? Ed was the outdoor, humor columnist for Field and Stream magazine, and for almost half a century he wrote Exit Laughing, the last page in the magazine. How he kept the humor flowing every month for almost fifty years is hard to comprehend. Ed is retired now but they often rerun his old columns because they can't find anyone to replace him. Ed always had two or three great Labradors. He got them as drop-outs from the field trial circuit. He was a good friend of George Murnane who was big in the Long Island Retriever club and the Labrador Retriever club, back in the early days of both clubs. George had a trainer whose name I have forgotten but he made two national champions for the Murnane family, which was quite a feat. But they had dogs in their program that could not quite make the grade under the pressure of field trials, so they gave them to friends. Now those dogs had had a lot of money and training time spent on them, and they became excellent field dogs. These dogs never went on to become major breeding stock and yet I believe that our letter-writing friends thought that some great dogs were passed by, and that possibly they might have been better stock than the ones that could stand up to the rigorous training.

Now both of the writers made the electric collar the culprit. They are saying that after generations of using the collar, we will get the best collar dog but not necessarily the best breeding stock.

Well, my letter writing friends seem to not understand two facts. The first one is that the story I just told about Ed Zern and the Murnane dogs is over thirty years old ... well before the collar was even invented. If you think the early users of the collar were rough, you should have been around to see what they did before the collar. The cattle prod was standard training gear, along with the whip and the sling shot and the shotgun with number 9 bird shot. All that is why I wrote Water Dog those thirty years ago, because the average

hunter could get more than he needed from his dog without all that force. The point of all this is that training a top competitive retriever has always been a rather harsh business. Thirty years ago, most likely before my two letter writers were born, they could have written the same letter about the training tools that day ... the whip ... the prod ... the slingshot and the shotgun.

There is an exception to all this and that was Audrey Brokow and her trainer Charlie Kostrewski. He was a very gentle trainer. They were both very genteel people. They did very well as a team and produced many, many field champions. She was the first woman to handle a dog to a national championship. Today she is very old but still a great, charming lady.

So, the point this all leads up to is that from the beginning of training in this country, the dogs who could take the pressure were the ones who made the grade and became our major breeding stock.

The other "error" my letter writers seem to make is that they are still thinking of the collar as it was used only a short time ago. The collar started out as a way to give instant reprimand, the instant a problem appeared. That is just not so any more. The collar is used to have the dog do his job with an "up" attitude, an "up" tail. The collar dogs no longer walk around with their tails between their legs, scared that they will make an error.

The thing that my two young correspondents do not seem to know is that the dogs today are better than they have ever been. I just do not mean the top field trial and top hunting dogs. I mean the good average dog. I'll bet my dog's Milkbone that there are dozens and dozens of fine working retrievers in this country that could whup the pants of the British National Champion. (The British ask too little of their dogs.)

The work our top dogs did ten years ago is child's play for today's retrievers. The tests that NAHRA runs today could not have been considered when we started ten years ago. The dogs are better. I don't mean the outstanding dogs that have become Grand Master Hunting Retrievers ... I mean Joe Average's dog. We are breeding good working dogs today. We know what we are doing. We train better. We are using working stock only. We have a better product. In most cases the collar is not even an issue.

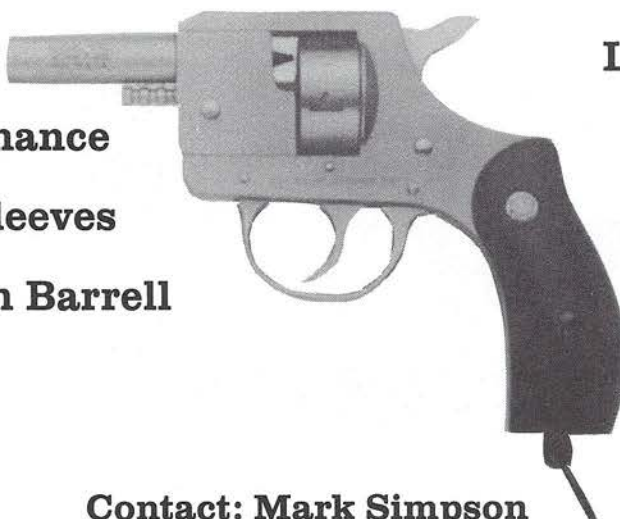

Why People Reject Their Pets

There are millions of unwanted pets, and although many of them found in shelters never had owners, a great many once did have owners and were rejected by them. Why people give up their pets has never been thoroughly studied. For years it has been thought that many pets are abandoned because of behavior problems the owner did not take the time and effort to correct. But now a lengthy investigation by psychologists at Mills College in Oakland, California, and the VA Medical Center in Martinez, California, gives some real insights into why people adopt and then reject dogs and cats. Dr. Aline H. Kidd and co-workers interviewed 120 male and 223 female adopters and determined both why the pets were acquired - that is, what expectations the adopters had of pet ownership - and why, in some instances, the anticipated human/animal bond had never materialized.

The most positive news from the study is that of the 343 people contacted 275 or 80 percent had actually retained their pets. Most of those who rejected the pets were first-time pet owners and most were significantly younger than those who kept the dogs or cats. This suggests that once having owned a pet, people have more realistic expectations and are better able to deal with the more common pet-related problems - inappropriate behavior, for example.

A significantly higher percentage of men than of women rejected their pets, as did a significantly higher percentage of parents than nonparents. If parents adopted a pet in the expectation that the animal would keep the children occupied while they went about their own household duties, they were in for a great disappointment - and the pet was bound for the shelter. The same held true if the parent expected the pet to teach the children sensitivity and nurturance.

These unreasonable expectations were simply not met, in the parents' eyes, and naturally the pets suffered. The most

reassuring news from the study is that the owners who said they expected companionship from a pet, as well as those who thought the pet would be a source of emotional support and laughter, all tended to keep the adopted animals.

Questions from Our Readers

Q: I have a Golden Retriever female that had several litters of puppies and was always a good mother. Then she had a litter of two and she just carried them around in her mouth until they died. Recently she had another litter during the night and she ate them. Why would a dog eat her puppies? Is there anything I can do to prevent this?

A: It is unusual for a bitch to be a good mother to several litters and later be a poor one and then a cannibalistic one. Usually it is primiparous (first time) bitches or those who have had caesarean deliveries that reject their puppies. The reason for poor maternal behavior after caesarean delivery is that stretching of the cervix during natural birth causes nerve impulses that cause release of the hormone oxytocin both into the blood and into the brain. In the brain oxytocin acts to "imprint" or identify the odor of the neonate as the mother's own.

Any environmental upset could have caused the bitch to carry rather than nurse her pups. The cannibalism could be due to similar causes or to a failure of some other step in the biological process of mothering. Chewing of the cord, a normal behavior, may have continued too long resulting in chewing of the pup.

To prevent problems next time, muzzle her. You will have to perform the functions served by her licking such as drying of the puppies and stimulation of elimination.

Q: What is the latest thinking about when to stop feeding puppy food and replace it with adult food?

A: The time depends on the type of puppy, desired rate of development, type of food to which the puppy will be

switched, genetics, and probably several other factors.

The incidence of developmental bone diseases such as osteochondrosis, hip dysplasia, enostosis, and hypertrophic osteodystrophy is thought by many people to be influenced by nutrition and genetics. Dogs that have a large mature size and the genetic potential for rapid growth are predisposed to these diseases when fed excessively.

Puppy foods are usually highly digestible and have a higher concentration of energy than other diets have, therefore it is usually easier to overfeed. The important question, then, is: Does the new diet meet the nutrient requirements of the puppy? If the food contains the needed nutrients, there should be no problems. Many general purpose foods have adequate concentrations of nutrients for puppies.

If you want a simple answer, Dr. Arleigh Reynolds says the Vet Clinics recommend changing from puppy foods after four months of age.

Q: Can you tell me why a 22-month-old Lab has not yet been in heat, although her sisters have been? She was the runt of a 12-dog litter but is healthy and active.

A: There are several reasons that estrus may not have occurred in a 22-month-old bitch, whereas full sisters have been observed to have had at least one estrous (heat) period. This is unusual. In some cases, a bitch may have had silent estrous periods. That is, the hormonal changes occur, but the bitch exhibits no external indications of estrus. In other cases, estrus is unobserved. That is, the bitch does have external evidence of estrus, however subtle, but the owner fails to observe them.

In both of the previous examples, the bitch is likely to be a normal female - just not average in her cycle characteristics. In other instances, the bitch may not be a normal female. For example, in this

One In a Million

Once in a thousand retriever births, a dog with really special traits is born. These special dogs go more or less to random owners and one in a thousand of these owners gives that special pup the nurture to match its nature. This article is about one in a million combinations.

In the beginning of the NAHRA program there was a special bitch, who became GMHR-WR Mississippi Molly. Molly was Rick Knuth's first dog and she and Rick were a special team in their own right. Molly often wasn't flashy, but she was almost always tuned in to Rick - working as a real team. Once Molly got to Senior, it was rare for her to fail a test. Molly did it all and was an exceptionally good handling dog.

In 1987, Molly became one of the "Magnificent Seven" qualifiers at the first NAHRA Invitational. Earlier, she produced a nice litter with a WR, an MHR-WR and FC/AFC out of Waluke Moonshine. In June of '87 she whelped an outstanding litter including MHR Molly's Hi-Bird Abracadabra, MHR-WR Hi-Birds Necanicum X-Over, MHR-WR HRCH Cedar Valley's Manhandler (Jessie) and the

subject of my story, FC/AFC GMHR-WR Cedar Valley's Hi-Bird Turk.

The sire of the litter was AFC Westwinds Pedro and it was an outstanding cross. Molly is out of a Corky-Super Chief line, while Pedro was a Honcho son crossed to a littermate of Super Powder. Pedro had a short field trial career, but produced many fine field trial dogs. Pedro's pups were often talented, but few were also as good looking as Turk - a compact 75- 80 lb. athletic build with nice head. Turk has style, brains and looks.

I still remember my first meeting with Turk, Jessie and Abby at an informal puppy stake in April 1988. They were as sparkling and enthusiastic as their justifiably proud owners Brent and Mike Helgeson and Rick Knuth. I believe Turk and Jessie were Brent and Mike's first retrievers. Story has it that Brent picked Turk using the Test in Wolter's Game Dog, but I attribute the perfect match to marvelous good luck. It was clear at 8 months that the pups were special and it has turned out that the owners lived up to their dogs. Jessie and Abby are won-

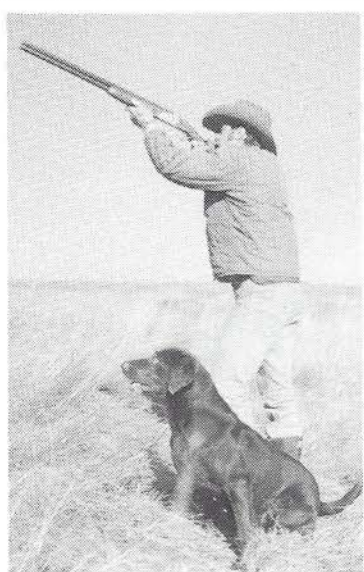

Training Tips

A finished hunting retriever takes time and know how. It takes a lot of help from others and it takes the proper equipment to train your dog successfully. I have compiled a list of the necessary equipment and its use. Some of the equipment can be made by you and the rest will have to be store bought. Get a strong wooden or plastic box to keep it all in and for hauling it along with you.

Dog Crate: This is to protect your dog while being transported. You may make one out of wood but be sure to protect any chewable portions with aluminum flashing. The plastic airline crates are probably the least expensive and the longest lasting.

Whistles: These are used to signal your dog in the field. The plastic whistles made by Roy Gonja or Acme are the best suited. The plastic whistles won't freeze to your lip when the temperatures dip below freezing. Always carry at least two whistles on your lanyard in case the pea in one freezes up.

German Pinch Collar: I prefer this collar over the standard choke chain or flat leather or nylon collars. You will get quicker results without the physical abuse

to yourself or your dog. This collar looks inhumane but all it does is pinch the skin around the dogs neck. You don't slip this collar over the dogs head like a choke chain. Instead, you remove enough of the spring loaded links until you can just get it fastened when you wrap it around the dog's neck. If the three main rings are touching each other, you must remove more links.

Leashes and Long Line: You will need a 6' leather or nylon leash for obedience training. A short 6" rope with a swivel snap on one end for holding your dog when working marks. The nylon long line should be at least 30' long and it will be used in the basic obedience as well as the field training later on. Make sure the snap on the end is a swivel type. The long line should be 3/8 inch nylon and always wear gloves when working the dog on the long line to protect your hands.

Blank Guns: Any 22 caliber pistol or rifle will suffice. The 22 caliber is far superior to the small acorn blanks. All of my shotguns for firing blanks are single shots. It will help to buy some cheap gun and then plant the wood fluorescent

Marking

by

When I was very new to the hunting retriever game, I trained one day with an extremely well-known field trailer. She had worked with some of the finest dogs in the country, including a national open champion. On this occasion there were several neophyte handlers trying to "teach" their dogs a double water mark. I watched, in dismay, as the first three handlers and their vaunted young dogs failed to negotiate the two small ponds with an intervening strip of land to reach the duck thrown on the second pond's far shore. Despite much screaming, whistle blowing and the repeated buzzing of electronic collars, not one dog did a satisfactory job. One handler went wildly out of control in frustration. Clearly I was out of my league with my young, inexperienced, hunt test dog (now GMHR-WR Scanlon's Smokey Jasmine, MH). I begged for help before coming to the line.

"How do you teach that to a dog?", I asked this doyen of all-age qualified retrievers.

Said she, "Break the mark into its individual components. Teach each in succession, then run the whole thing together."

So I did.

First Jazz fetched across the big pond. Then we moved back to run the strip of

land and the big pond. Then we ran both ponds. Jazz was the only dog to complete the task that morning.

The point is that most beginning amateur trainers don't teach marking concepts. They go out, throw some marks and expect their retriever to perform. When the dog doesn't, they try to handle (which can create popping) or just keep repeating the whole thing until man and dog fall apart. This is not teaching. Folks seem to forget the, "Teach, Train, Test, Evaluate" sequence for marks.

When teaching a mark, break down each element of difficulty. Think about terrain, obstacles, suction and wind direction. How many cover changes are there? Can cover be easily cheated? Is there a road or path across which a dog must run? Dogs love to stay on roads. Retrievers also like to run down hills and fade when going up them. Hills don't need to be very big, either. By mixing cover breaks, roads, and hills a lot of difficulty can be created.

Suction

An old fall is the classic suction used to divert dogs from the true line. This is why singles are the best way to teach marking, rather than to do multiple marks all the time. Train on sequential single marks and be aware that a dog repeatedly trained on multiple marks will suffer.

Wind

Dogs hate to run into the wind. A quartering breeze will carry scent and attract the dog. The experienced retriever usually stays down wind from where a mark lands. This can be taught. Marks should be thrown downwind most of the time. This teaches the dog not to suck to the thrower. Never underestimate the effect of moving air. Remember, too, wind may come from a different direction on the line than at the fall.

Water

Water is a major obstacle for any dog. When the true line catches the edge of a pond, crosses a ditch or, as in the opening example, leads across two pieces of water, retrieving challenges escalate. If you have trouble keeping your dog from cheating an obstacle such as water, position him at the barrier's edge and force him to run through it. Then back up. Remember another time honored rule, "The farther back a dog starts from water, the harder the situation becomes." This holds true for blinds as well as for marks.

It may take several days to adequately teach any given mark. First teach the dog

each obstacle and suction in the mark, but use a visible gun. The next day come back, throw the mark and retire the gun. When that's been done satisfactorily, teach the mark as a remote, throw a diversion, run a blind after, then before this "learned" mark.

Remember, marking is not a simple matter of vision or innate canine ability. It can be sharpened by teaching, by repetition and by training. Keep adding diversions and complexities. Marking may also be damaged by too many multiple marks or by inappropriate help. What do I mean by the latter?

When a dog does not take a straight line to a mark, handling may be useful. Having the thrower "help" by calling to the dog may not. On the other hand, over-running a mark or switching to an old fall can be corrected by having the thrower indicate the fall. In such situations, handling may precipitate problems. Exactly what to do depends on the dog, the handler and the circumstances. Be alert and know your dog.

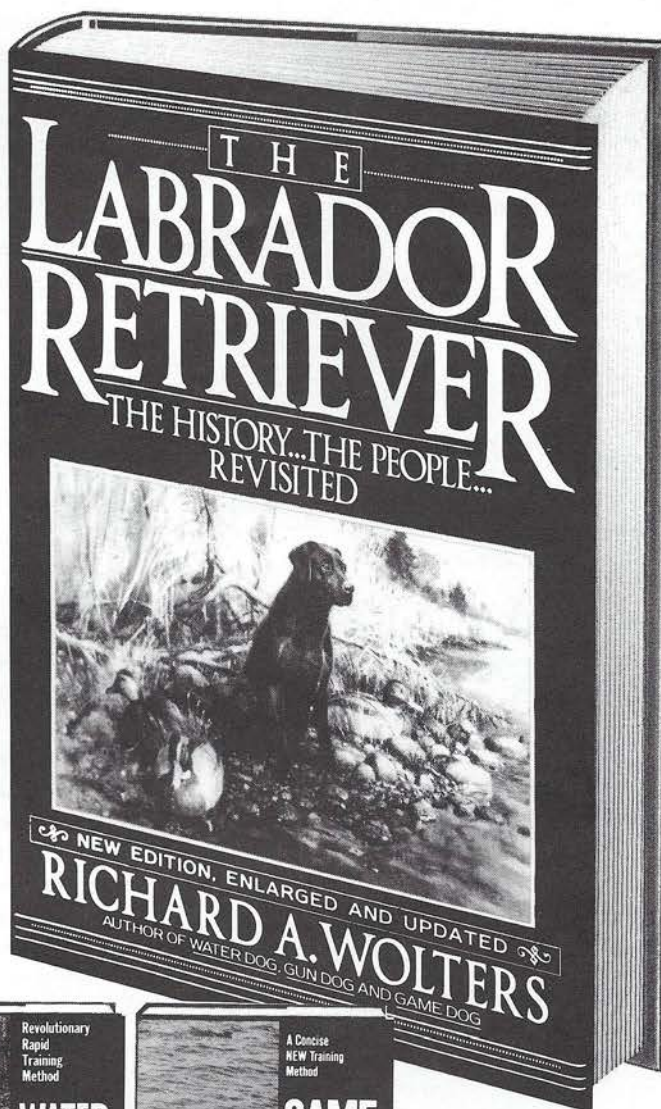
Some drills improve marking. One is called "Cheating Singles." Here a mark is thrown from the open to land behind cover or across a pond's edge. This makes it tempting for the dog to avoid the obstacle, that is, "cheat". The mark is repeated until the dog takes a correct, straight line and returns over the same route. Small bodies of water, particularly a tear drop-shaped, bermed up farm pond, are ideal for such work. A field edge or standing crop rows are the land equivalent.

Another drill is "Walking Singles." Here, the thrower moves from one location to another after the dog has satisfactorily picked up the previous mark. One advantage is that old falls act as suction, or diversion, since wind direction and/or cover change with each new throw. Moving the line, as well as the thrower, accomplishes similar goals. Walking singles also makes use of limited land facilities. With a little creativity, small bodies of water or other obstacles can be incorporated into this process. Even if there are only two or three people training, a lot can be accomplished using a small area.

One final thought. Most of us train with bumpers. After you have thoroughly taught a series of tough marks on several successive days using plastic, try doing them again with real birds. You may think your dog has never seen these marks before.

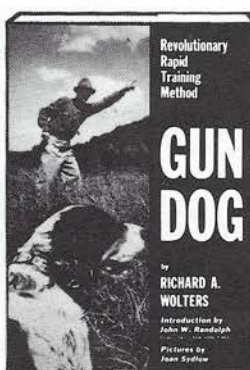

Our National Bird

Each year around Thanksgiving the thought is offered that the wild turkey, not the bald eagle, should rightfully be the symbol of the United States of America. There are probably deep psychological reasons why this occurs on this specific holiday. Surely it cannot be the sight of a totally naked, headless, gutless bird which prompts such reverence. Such a vision would fail to stir anything more than gastric juice in most Americans. And few consumers of the proposed new American symbol have ever even seen a wild turkey. The domestic turkey is a dolt. Roast eagle is not a valid comparison - carrion eaters rarely become gourmet fare. Still newspapers print editorials and the radio and T.V. are filled with commentary which argue that the turkey should be made our national avian emblem. Let's examine this phenomenon more closely.

Benjamin Franklin was reputed to have been an early and staunch supporter of the

wild turkey as America's symbol. He said the eagle, "is of bad moral character; like those among men who live by sharpening and robbing. He is generally poor and often very lousy." Franklin considered the native wild turkey more respectable as an estimable American original. Cagy old Ben was noted for wisdom and statesmanship, yet he also spouted off some pretty maverick notions. Anyone foolish enough to stand on a hill, at night, in a thunderstorm, flying a wet kite using a metal fobbed string must be a little suspect. However, Ben may have been on to something.

Surely the eagle has a noble appearance. The male bald eagle is a striking creature. Snowy white head, piercing yellow eyes and an awesome beak lend an air of strength, severity and dignity. Females and immature males are less ostentatious in plumage, but nonetheless striking. Dowdy eagle seems a contradiction in terms. In flight eagles are majestic and tireless. No

less an authority than the Bible (Proverbs 30:18-19) speaks about the wonders of the way of an eagle in the air. This bird was undoubtedly not the Bald Eagle which is the only eagle restricted to North America. Our native bird soars magnificently and can plummet with incredible speed and daring to secure prey. Still the bald eagle's diet leaves a lot to be desired.

Eagles are opportunistic consumers, although they will hunt when pressed. Their penchant for gobbling the remains of dead animals has gotten them into trouble recently. Waterfowl who have died from lead poisoning regularly become eagle meals. The national white maned buzzard has frequently been observed suffering from plumbism.

Another favorite eagle trick is to rob an osprey of hard earned fish. Eagles screech at, swoop upon or otherwise harass the poor fish hawk until its catch is dropped.

"Don't Wait Four Years To Redirect Hunting Dog's Desire"

A typical evening at home and Rascal, my 4- year old, black Labrador retriever is lying on the floor in front of the woodstove.

I patted him on the head a moment ago and his fur felt so hot it must have been only a degree or two away from combustion.

He usually saves the "woodstove sprawl" for evenings after long days afield. But this is not a typical evening for Rascal. He had a pretty tough day today. I took him to the vets' and they cut his testicles off.

It's a serious matter.

I have written before about the possibility Rascal would be neutered. He failed to

gain certification for his hips and therefore was no good as a stud dog.

Labradors and other large canines are prone to hip dysplasia, a crippling disease that is believed to be genetic.

An X- ray test is performed on dogs 2 years or older and the condition of their hips is rated. Rascal failed by only a small margin, but failed all the same.

So now he lays in front of the woodstove with a shriveled sack where his manhood used to be, a raspy throat from having an esophageal tube during surgery, and probably a ringing in his head from the anesthesia.

Meanwhile I lounge nearby with a computer in my lap, massaging my guilt pangs by writing down justifications for having maimed my faithful friend.

It will be 10 days before he is back to normal, and 45 days before he is completely sterile.

I was concerned about neutering a dog in the prime of his life. Rascal has drive, and I feared that might diminish. He is lean and muscular, and I have seen other neutered dogs quickly put on weight.

Dr. Val Stuve of Aurora Animal Clinic offered an option: vasectomy. The dog

would retain his testosterone and his appearance, but would be sterilized.

I seriously considered it. But when it came down to it, those danged "family jewels" were just a liability for poor old Rascal.

He ran away from home twice. On both occasions he disappeared through the woods in a second, ignoring my commands to come back.

He was missing less than 15 minutes each time before a search party was organized. The first time he was found within an hour. The second he was picked up by Animal Control in about five hours.

Both times it turned out he traveled upwind and was found in the company of a female or females in estrus. To the best of my knowledge he remains an innocent, however.

On only a few occasions has Rascal ever dropped a bird or retrieving dummy while working. Each time he took his mind off his work because a female in heat was nearby or had urinated nearby.

Rascal is a well- trained dog and an obedient dog, but when a female in heat walks

Twenty-five of our top NAHRA dogs competed in the championship held at Hunter Mountain, New York the end of August. Nine dogs completed the event. GMHR- WR Valhaven's Phinlin Zap was crowned the Game Fair Champion. Zapper is a Golden Retriever owned by Frank Thorngren from Lake City, Minnesota and was handled by Les Scottston. GMHR Russet's Rowdy Raja finished second and was owner handled by Tom Stasierowski of Alden, New York. Both dogs will represent America at the 1994 Game Fair in Rome next summer. The winner and runner up received Beretta shotguns plus three thousand dollars for the winner and one thousand dollars for the runner up. All finishers were awarded Barbour Game Fair jackets.

Judges for the event were Larry Calvert of Ronan, Montana and Gene Hill of Pennington, New Jersey. The tests were demanding and straight forward. Dogs ran two land triples with blinds, two water blinds and a water triple as well as upland hunting and a trail. The event sponsor was Barbour, the British clothing manufacturer. Beretta USA provided the shotguns for the top handlers.

NAHRA had a tent on the lower slope at Hunter Mountain where we conducted dog demonstrations for the public. The exposure offered us the opportunity to seek valuable corporate

sponsor relationships with several companies. NAHRA will also be included in an ESPN presentation on retrievers.

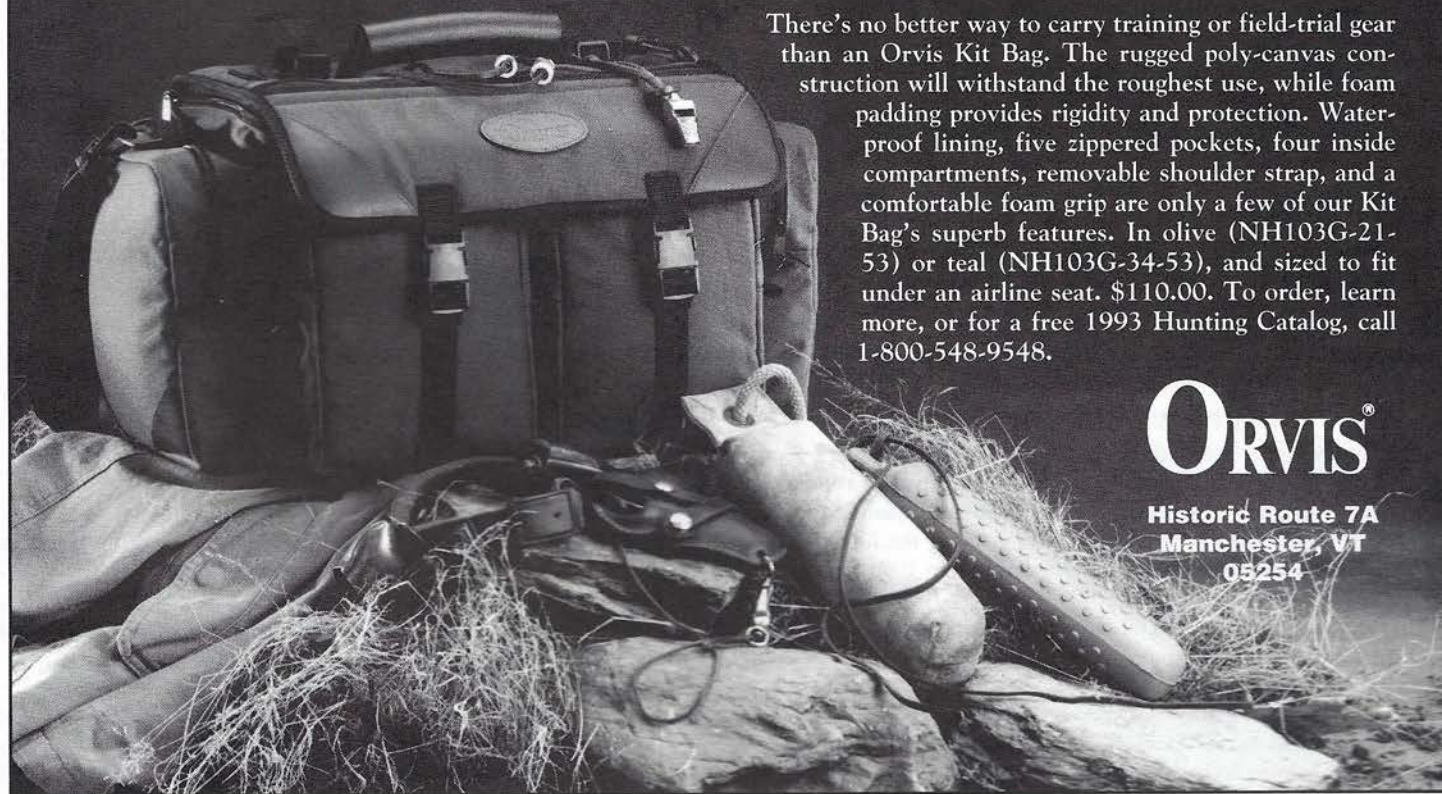

In 1983 the NAHRA concept was founded and a title created for dogs that earned one hundred points in the NAHRA program. That title was Master Hunting Retriever (MHR). Two years later, a new title was generated for Senior dogs that continued to compete in the NAHRA arena. The new title was Grand Master Hunting Retriever (GMHR) for those dogs that could accumulate 300 or more Senior points during their lifetime. During 1985 there were only twenty events held from coast to coast. For most handlers the GMHR title was only a dream. Today there are 145 Grand Master Hunting Retrievers in the NAHRA program. Since the program was founded, a select few dogs have accumulated over 1000 Senior points. It is those dogs that we recognize in the following pages and welcome into the 1000 Club.

GMHR- WR DUCK MASTER'S NOSIN AROUND, MH

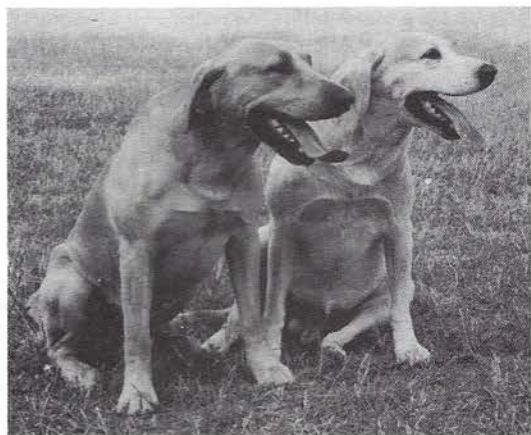

Inland Valley Retriever Club was host to the third NAHRA Southwest Regional at Raahauge's Pheasant and Duck Clubs. These are probably the finest test grounds in the Southwest with over 1000 acres of prime upland cover and 400 acres of ponds. The test opportunities are almost endless. And then came the flood. We could not get to the Pheasant Club grounds because of the mud and silt. The pond dikes were washed away. Our alternate grounds were under 10 feet of water. In spite of this, we still had a fine Regional.

IVRC made a commitment to have outstanding judges that would truly judge to the National Standard. We selected three fully pointed judges for each test. We calculated the pass/fail ratio of each judge and selected those near the middle. It was worth the effort. We had great judges and great tests.

We had a mixer Friday evening, March 19, with soft drinks, chips and dips. We introduced the judges and handlers. We gave the handlers their packets that included a quality bumper bag, the catalog, NAHRA Regional hats, IVRC hats, numbered vests, dog food and other items.

We had a thirty six page "keepsake" quality catalog with a multicolored cover, dog photos and profiles. Barbara Peets and Dianne Ouillette really did a "dog gone" good job.

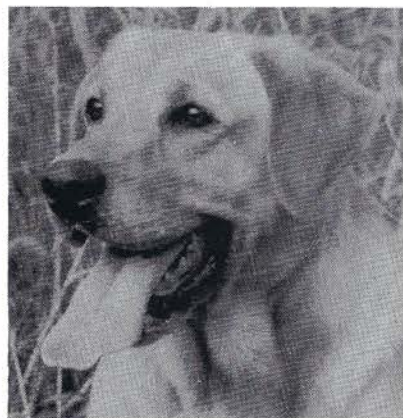

Thanks to NAHRA



It started way back when my husband, Scott, was trying to get a teal that he just shot. He was in his hip waders and using a fishing pole to retrieve it when water filled his boots and he yelled "we gotta get a dog." So not knowing about NAHRA, I bought a half breed German Short Hair Pointer/Labrador, figuring it could quarter the upland

birds and retrieve the ducks all in one.

Three months later, I learned about and joined I.A.G.D.A. (Interior Alaska Gun Dog Assoc.) and NAHRA. I had to fight the pointer instinct and push her to retrieve instead of stopping to point, but we got through it. I was hooked from the start. It was exciting to see how fast a puppy could learn and the following hunting season was much more fun. We didn't get wet except when it rained.

Even more, I loved running in the NAHRA events. After a few years of hunting and doing the NAHRA events, I got the fever of wanting that certificate of a working retriever, but I needed a purebred dog. I had never paid more than \$50.00 for a dog before, but I never needed a purebred either.

I knew right away I wanted a female yellow Lab. I looked for a year to find the right pedigree.

Not knowing about pedigrees, I asked my friend and fellow IAGDA member, Bob Dunn (AKA Bobby Frank) whose been in field trials and NAHRA forever to help me look over pedigrees. One year later, I had my puppy on order. Now the kennel owners I bought her from were very patient, they didn't mind that I was sending \$40.00 here and a hundred dollars there. Over the months, we were really enjoying the long distance conversations. Finally, the pup was born. After saving and sending money over the months, I didn't have the cash to go and pick her out myself, but I did have first pick of the litter and I trusted their judgment on picking the right puppy.

Like everyone else thinks, my puppy was the best. She braised in started and passed the regional (which she got a steak for) and has one intermediate. But the best was yet to come. Hunting over her this year was the best hunting season my husband and I ever had. We've gotten more birds in one season, but never been able to take the shots we've had this year.

For instance, while jump shooting this year, we spotted birds on a pond about 500 feet off the road. We walked down this steep embankment about 60 ft., then hunkered down, we walked another 325 feet with the dog walking and swimming next to us. We finally reached the brush to hide behind and waited. Then they flew, Scott and I both shot, we each got one. I was so excited I actually shot one (because I was missing a lot lately) that I yelled I got one, and

For those of us living in the city, finding places to safely train our dogs can be a real challenge. One of the best places I have found to do water work is the local country club golf course. It is convenient, easily accessible and glass is rarely a problem. For two and a half years, I have had good success in these ponds until last week. After completing a long memory water blind, Barney began coughing and retching uncontrollably. I figured he either swallowed some water or maybe had duck feathers or a bone in his throat. After a few minutes he seemed fine and I thought nothing more of it.

The next afternoon as I was preparing to load up for the drive to Virginia for a weekend double, he began vomiting. This continued for a few minutes and his stool was very runny. The vet said he most likely had a virus, forget the field test and let him rest a few days. Needless to say, I was frustrated at having to cancel my plans, but the worst was yet to come. Late Friday night the vomiting increased, but now it contained yellow fluid with blood in it. My normally crazy and energetic dog was in bad shape. We rushed him to the emergency after hours clinic

for fluids and hopefully a cure for the vomiting and diarrhea. After medicine to control the vomiting, blood work, rectal exams, radiographs, an endoscopy, numerous IV fluid treatments, antibiotics, cortisone for esophagus and stomach inflammation, ulcer medication, more lab work and three and a half days of misery, Barney began to come around. Can you guess the cause of all of this? Fertilizer poisoning! After talking with the course superintendent, I learned that two days before, his crew had heavily fertilized the course. After a day of rain the run off into the ponds was quite high and my dog ingested the contaminated water. My friends in NAHRA constantly tease me for being over protective of my dogs and I'm sure it's true, but I never imagined a golf course pond could be so dangerous. Many of you may think I was ignorant in training in such water, but I had never figured it to be a problem.

For those of you that aren't sure about the water you train in, please be careful. I'll never forget the look in my dog's eyes that Friday night as he began to fade away. It was much too close! Take it from someone who was careless and almost lost!

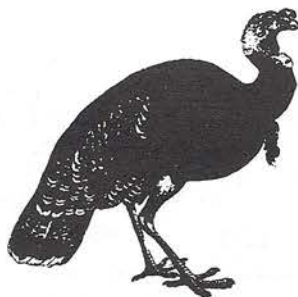

Then the eagle snatches it away. As Ben probably would put it, eagles are quite talented at "sharping and robbing." Their nests are monumental, although untidy. Eagles are reasonable parents, but not exceptional. All in all, the eagle is mostly flash, superficiality and a quick bully. Ben knew his birds alright.

Wild turkeys are native to America, just like the bald eagle. They are wily, quick and have keen eye sight. Their plumage has a somber beauty, largely appreciated only by other turkeys. The warty, bearded head and stubby neck of the male are just plain ugly. Neither their physical attributes or personal habits have ever been widely extolled by lyric poets. Turkeys can fly quite well, although they are much more fond of running from enemies. They almost never soar, hence the popular T-shirt slogan, "How can I fly like an eagle, when I'm surrounded by turkeys?" Once again the turkey gets a bad rap. They usually hang around in small crowds, have a

preternatural sense about danger and are very protective of their young and their territory. They are largely vegetarian, although insects are eagerly gobbled by gobblers.

Turkeys do have one prominent behavioral trait which sets them apart from eagles. The male turkey is incredibly horny. During Spring breeding season, the male (or jake) will attempt to seduce any object even faintly resembling a hen. He is not subtle, reticent or patient. Turkey decoys have been totalled by frustrated, aggressive, overly enthusiastic suitors. The successful turkey hunter need openly yelp like a lovesick female to attract his prize. Maybe old Ben Franklin really knew his Americans too! But can you imagine Neil Armstrong announcing to Houston Control from Tranquility Base that the Turkey has landed?

orange to help locate it if you should drop it in haste during training.

Bumpers or Dummies: You can make your own out of canvas and cork or buy them from training supply stores. Store bought are made out of canvas or plastic. The plastic dummies are fine but they can get very hot in the sun and are extremely cold on your dog's mouth in the cold of winter. The plastic bumpers come in different colors. Gray, black or white are primarily for marks and the fluorescent orange are used for blind retrieves. You will need at least a dozen bumpers when you start the formal field training. Until then, an old sock stuffed with rags will do just fine. Tie a one foot long piece of rope to the dummy so it will be easier to throw and you will be able to throw it a greater distance.

Bird Carrier: A bird crate is used to transport the birds to the field. It can be made of aluminum, wood or wire. Make sure it is large enough to carry three or four ducks or at least six pigeons. If you build one yourself, make sure there are plenty of ventilation holes.

Bird Launcher: I have never been successful just dizzying birds. I either over dizzy the bird and the dog just scoops it up when he gets to it or I don't dizzy them enough and the bird flies off before I can get the dog into the area. Therefore, I use bird launchers. Believe me, they will save you their cost and then some over the years. The electronic remote controlled launchers can be quite expensive but they are worth every penny. The bird is always right where you left it and it stays until you are ready to launch it. Kirk Burns makes the very best launcher on the market today. It will throw the bird into the air about 25' above your dog's head, giving you a very safe shot at the bird.

Duck and Goose Calls: Calls are needed for training as well as for hunting. I wouldn't recommend using an expensive call for training, however. I use the calls to direct the dog's attention towards my throwers. I have my thrower blow the call before he/she throws the bird. The dog will also become acclimated to the strange noise way before that first duck hunting trip and won't be as likely to knock the

blind down when you start calling.

Decoys: Like the calls, don't wait until the first hunt of the season to introduce your dog to decoys. I use decoys often in training. It teaches the dog not to be distracted by them and it makes the dog more comfortable working in and around them. Use them on land at first and then in the water. Make sure the anchor lines are just long enough for the anchor to hit bottom. You don't want to frighten the dog by getting him/her tangled up in anchor lines. Don't just toss out three or four token decoys but rig a real spread every once in awhile. Your dog must get used to running and swimming out through numerous decoys just like when you're hunting.

Dummy Launchers: The new Dummy-Launch or the old Retrieve-R-Trainer are great for sending bumpers out further than you can throw them. These two particular dummy launchers are single shot but Dummy Launch makes a pistol model that will fire up to nine consecutive bumpers. These launchers are advertised in many national outdoor magazines.

Waders and Hip Boots: These are a real must when you start the water training. You never know when you might have to jump in the water to correct your dog so wear them at all times when training. Make sure of the depth before you go crashing out in the water to discover the water is 1/2 inch deeper than your boots!

Birds: You wouldn't believe the number of dogs that have come in to me for training that are rock steady and retrieve bumpers until the cows come home but, when you shoot them a bird, it's a whole different ballgame. Feathers in a dog's mouth can be quite distasteful and the dog just refuses to pick the bird up.

Pigeons are the cheapest training birds around. Anyone can keep five or six live pigeons in a cage in their garage. If treated right, these birds can last quite some time. Just be sure they have food, water and grit. Birds are always more exciting for the dog than bumpers and you'll notice a big difference in the performance of your dog on birds than bumpers.

Electric Collar: Probably the greatest training device ever invented but by far the most controversial. Before the electric collar was developed, trainers controlled their dogs at great distances by shooting them with light loads from shotguns. Imagine the number of one eyed dogs back in those days. Not to mention the

critically injured and gun shy dogs. Tri-tonics is the only collar to think about using.

The "collar" is a superb tool but it is not a short cut. There is no "Instant Pudding" in dog training. The dog must still be drilled on all of the basics. Then, the dog is properly conditioned to the "collar" over a period of weeks. If the dog is properly conditioned, he/she will never associate the shock to the wearing of the "collar" or to you. Instead, the dog will associate the shock to his/her behavior.

Conditioning and timing are the keys to successful "collar" training. After the dog is conditioned to the "collar" and you start using it in the field, timing is critical. If you push that button one second too soon or too late, you will not be getting the proper correction or reinforcement.

The biggest thing against the "collar" is that it's way too easy to just push the button. If there was a needle inside the button, like those old gag gifts, then, the handler would have to endure a little pain as well. I think that would help to eliminate a few of the times a button is pushed and trainers would spend more time showing their dog what to do instead of always correcting him/her.

First Aid Kit: I carry a kit that I have put together although there are kits on the market for dogs. You never know when an emergency will arise whether you are training or hunting. I added a pair of 4" forceps, an ace bandage, a rectal thermometer and a product called "Vet-Wrap" to a regular first aid kit. I have everything for me or my dog in case of an accident.

case it appears that you have had the opportunity to observe estrus. If the bitch truly had no estrous periods, it is likely that she is not a normal female. There is a condition called the XO syndrome in which the bitch has an abnormal chromosomal constitution. Instead of having two X chromosomes, as a normal female does, she has only one X chromosome. This condition has been reported in several mammals. In humans, the condition is commonly known as Turner's syndrome. Affected humans and animals are frequently of smaller stature than their siblings and are sterile because the ovary does not develop normally. There is usually no evidence of estrous cycles. The diagnosis is usually obtained by chromosome analysis (karyotype) from a blood sample.

In this example and some other conditions where a bitch is not a normal female, she will not be fertile even if treated with hormone therapy to induce estrus. You should have a small-animal theriogenologist evaluate your dog.

upwind, it is painfully obvious which lobes of his brain they control.

Then there was that frostbite problem. It first turned up after a ptarmigan hunting trip on Murphy Dome. It was a mild day, probably 10 degrees, but the snow was deep in places. A little snowbelt in the wrong places combined with a stiff wind left Rascal with a blistered and swollen scrotum.

After that it was always prone to frostbite, so we went to Apocalypse Design, where they created a fleece jockstrap for Rascal.


They modified the garment from what they call a Belly Band, used mostly for female sled dogs after they have a litter. The band protects their teats from frostbite.

But Rascal won't have much need for his black fleece jockstrap now.

One thing lost with Rascal's neutering will be the ability to pass on his strong, but

unique bloodlines. Look at most Labradors sold in the area and you will find Snake Eyes, Super Chief or Piper bloodlines. Rascal has none of those, but his great great granddaddy is River Oaks Corky, the highest scoring field trial dog of all time.

Other big names along the line are Rascal's Medicine Man, Trieven Classic, and Lawhorn's Cadillac Mac, just to name a few.

But bad hips should not be passed on.

Rather than mourn Rascal's loss, I hope this writing serves as fair warning for those out there with strong-minded hunting dogs with even stronger reproductive instincts.

If you don't plan on breeding your dog, neuter him.

There are no guarantees Rascal will be less interested in other dogs now, but I'm betting his desire will be significantly curbed.

Distractions are something many people don't fully understand until they work hard at training a dog.

"He is perfectly behaved as long as it's just me and him working together," handlers say.

I know. I've been there.

To a male dog, a female in heat is a near-

ly insurmountable distraction. Field test judges don't even allow females in heat on test grounds.

You may think your dog will never run off or disobey but unless he is exceptionally well behaved, he will choose the female over you every time.

I've heard amazing stories about barriers overcome by male dogs trying to reach females in heat.

The first time I commanded Rascal to heel and he ran the opposite direction I was shocked. But he turned to run after a stray female dog that was walking past our house.

She ran, Rascal ran after her, and I ran after Rascal. I finally caught up to them, but not before Rascal had been hit by a van. Luckily the van only was going about 10 mph.

Getting smacked in the head with a Chevy van didn't even stop him from chasing that female.

I should have taken the hint and altered Rascal's mind way back then.

derful dogs who will work for almost any handler. Turk is a canine genius.

In 1989 as Turk turned 2 years old, Brent campaigned him for the last of the point-race Invitationals. I believe that he earned 240 Senior points and a WR that summer. And you warm- weather folks should remember that we can't get dogs in the water around here before April. As far as I know, Turk didn't fail a test that year, though I saw him break twice the next summer. He's certainly got plenty of desire. The following May 1990, Turk ran a flawless Invitational. In 1991, Turk, Abby, Jessie and another Molly son Ozzie all qualified at the LaCrosse Invitational. Quite an accomplishment and the place where many people and dogs might have rested on their laurels. Not Turk and Brent.

After the flawless Invitational in 1990, Brent's friend Lee Bilke persuaded him to let him run Turk in a licensed field trial. At Turk's first licensed Canadian trial in July 1990, Lee handled him to 2nd in Qualifying,

JAM in Amateur and finished Open. He got a Qualifying 1st and 4th that summer, too. Now he was off to the races.

Turk spent the winter of '91 vacationing down south on Andy Attar's truck. By year end, he had 3 more all- age places. In '92 Turk got to ride with the big dogs on Mike Lardy's truck and got a 1st, 2nd, 3rd, 4th and 3 JAMS in all- age competition. He qualified for the National Amateur and National Open where he ran 9 series. Turk was smoothing out as a competitor in the big leagues.

1993 has been a very good year for Turk. He has 3 Amateur wins, an Open win and just finished 12 all- age stakes in a row with 3 different handlers. He has about 41.5 all- age points, and of course, he is FC/AFC. I am hoping that before this goes to print, Turk will be NFC. We'll see.

Aside from winning the Nationals, about all there is left for Turk to do is produce more dogs like himself. Turk hasn't been bred much, but the few reports are promising. My Turk pup just turned 2, and while she was late maturing is now an excellent Intermediate dog. She is easy to handle, while very stylish and fast. She is an absolute water maniac and will swim by herself for up to 2 hours, just for fun. All her sisters had pup eye checks and were clear. Outstanding talent, great looks, sound offspring - young sires hardly can look more

promising.

It's true that Turk's latest triumphs are on the big league pro- dominated traditional trial circuit. Many of us can't afford that game because of time or money or both. However, that takes nothing away from Turk - or NAHRA. None of the kennel club's games are aimed at hunting, but traditional trials are a highly refined sport. If you can play the canine equivalent of Michael Jordan basketball, go for an AFC.

In the summer of '89 it was clear that Turk was a truly exceptional dog. Brent Helgeson, Lee Bilke, Andy Attar, Mike Lardy and countless other members of Turk's training circle have gone beyond what was already clear in early NAHRA tests. Their work proves far beyond doubt that Turk is a champion's champion, but the NAHRA program already showed it to those who cared to watch a dedicated beginning trainer build a one in a million team with a two year old dog. Turk could track, quarter, mark and handle with amazing style and precision while being almost one with Brent. With top pro- help, they went on to do it all. 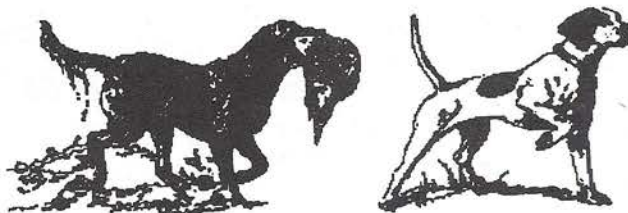

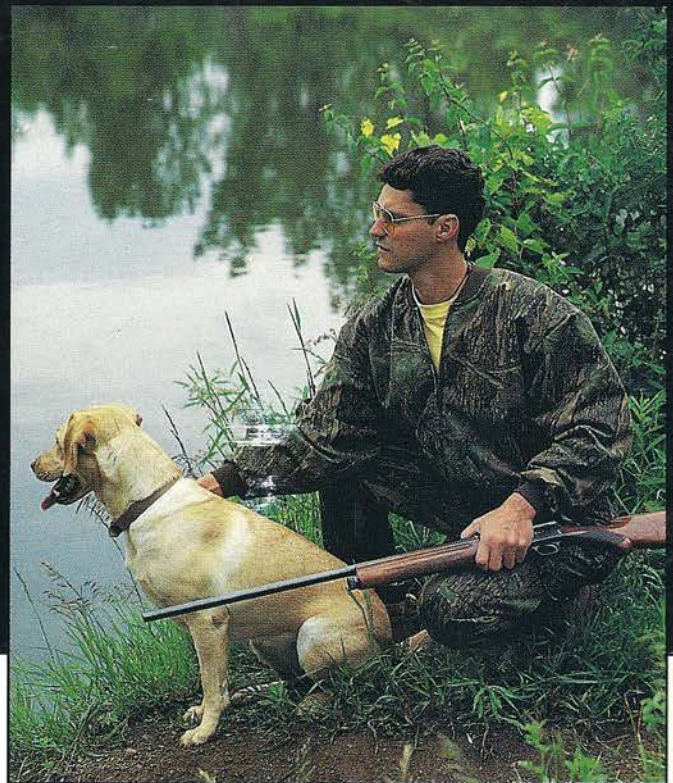
