

The Benefit is a testimonial to the continued interest and support of our NAHRA members.

We had over 140 Beginner and Started entries. It is important that we remember that novice handlers and dogs make up the majority of the NAHRA membership, and are responsible for our existence. NAHRA clubs and regions show their appreciation by hosting annual regional field tests for qualified Started and Intermediate dogs.

I had a conversation with Sue Tassey, who is the Northeast liaison, and a long time supporter of NAHRA. Sue has always gone out of her way to help and encourage new members and their dogs. She asked me to urge all the regions to reward and recognize re-

gional qualifiers as members of the All American Team.

Although we are only simulating hunting conditions, it helps prepare handlers and dogs for their first hunt and keeps experienced dogs in peak physical and mental condition.

Please look at the letter in this issue from John Chase, in Tustin, California; his experience tells it all.

I had the opportunity to hunt flooded timber, just outside Stuttgart, Arkansas last year with Dr. "Bo" Busby and his started dog "Hootie". I found out after the season, that "Hootie" retrieved over 700 birds at the Prairie Wings Hunt Club. I ran Hootie in a started test in October of this year. One of the judges commented on what a nice dog Hootie was and that he ought to make a good hunter. I just smiled and nodded my head.

Thanks to you, NAHRA continues to grow and prosper; and our little, four legged friends get the education and recognition they deserve.

## Notes from Nancy...



I enjoy being a part of NAHRA, and am beginning to understand all that is involved. Reading the rulebook (a couple of times) helps to understand a lot of the details. Assisting with the Benefit, gave me insight to the work involved in hosting a field test. There are *lots* of details, both before and after, that need attention.

With all those details to take care of, one would think it would be best to get started as early as possible, so that not too many things were left to the last minute. From this end, it seems, that getting the field test application filled out and submitted to the office, *at least* eight weeks before your event, would be to your advantage. It gets the whole process started early enough to allow time to deal with any problems that may arise. (And when aren't there problems?)

Just as there is a lot of work at your end, there is a lot of work at this end. Following are a few tips that will help the process go a little smoother:

Does your club have a current Judge list? If not, call

ahead and order one, the first copy is free, each copy thereafter is \$5.00.

Choose judges that have paid their membership dues, it is a responsibility they have accepted when becoming a judge.

Include a photocopy of your club's insurance coverage with your field test application. (Liability insurance is required).

Club membership must be current.

Field Test Committee members, are required to be NAHRA members, in good standing. Remember, Club members who are judging, cannot judge *and* be on the test committee.

Do you have all the forms you need? Do you have a field test report form? The report and all paperwork is due 15 days after your event.

Do you need labels for your premiums? (please don't forget to send one to the NAHRA office). The field test application must be approved, before sending out your premiums.

Need help? - Call! We are all in this together, and together, perhaps we can make life more fun.

Guess What? he looks at me and says, "C'mon, get dressed", tosses me a camouflage jacket, hat, and says "...and here's your gift" as he hands me a pair of CHEST-WADERS, still new in the box. He couldn't be serious. Not me! But again, with some encouragement, I finally conceded to getting dressed, and we headed out in the dark

through a field. He was several yards ahead with the dog. I was trudging on behind and then we suddenly hit the slough (marsh). I thought I'd hit quicksand!! I couldn't see where I was going, and man! it was tough slogging through the reeds, each foot sank in the mud deeper than the last. *Was I having fun yet?* We finally got to the spot where Phil said the ducks should come in. He put out his little bag of foam rubber decoys. Then he positioned Chamois on top of this inflated rubber seat...*that's what that thing is used for, it had kicked around our garage for years, and I never knew what it was.* *Lucky dog, where was my seat?* We stopped in the reeds and waited. The sun is now almost up, and even I had to admit, the whole scene was breathtaking. The ducks started arriving in small flocks and often I would not see them, but I was aware of Chamois' head turning and his whole body going erect. HE SAW THEM...I would turn to where he was looking. Sure enough there were birds in the air. Some would fly within shooting range and Phil would shoot. When a bird came down, on command, Chamois was off his platform, ploughing through the water to get the downed bird. He would return and jump back on his little seat and wait for it all to happen again. However, there were times when Phil would miss, and I'll never forget our Chamois, he would watch those ducks fly over and then look at Phil, and you could almost hear him say, "Why didn't you shoot them?"

The whole scenario was exhilarating, the marsh, the red sky, the birds in the air (at times the sky was black with them), the shooting, the action. But it was Chamois that impressed me the most. He was so focused, and

By now I'm tired, and I didn't want to counter his statement, even though I knew he was just trying to get a reponse from me. I mumbled under my breath "you shoot 'em, you pluck 'em". I used my hands to make a pillow for my head as I lay down on the ground to rest. It was now a beautiful, sunny, warm day and I soon fell asleep. Phil has this picture of me sound asleep on the ground, still in my camouflage and NEW chestwaders, completely surrounded by feathers. In retrospect, IT WAS A GREAT DAY! Needless to say, I was never able to come up with such an inovative date and so the dating game fizzled out.

I should go out again and see Lacey work. Phil says she's going to be every bit as impressive as Chamois, but I have this problem..."I STILL DON'T DO MORNINGS".

# AGGRESSION

My heart is grieving as I write this article; I have just put down my friend and hunting partner, Bailey. Many of you knew him. Bailey was the picture of health, very athletic, and a super hunter and trial dog. He qualified in two Invitationals and was eligible for the upcoming one in 1999. He loved to hunt, and had been in many different states, doing just that. He had one problem, and that was dominance aggression.

I will try to relate my story as best as I can, to be informative, and hopefully share with you a little of what I have learned over the past three years. I have consulted many veterinarians who have specialized in animal behavior, as well as trainers, both pro and amateur, on this subject. Realize, I speak from personal experience, on this subject, even though it may be somewhat limited.

Aggression - it's like a four-letter word. You avoid talking about it, especially if it is happening with your dog. It makes you feel ashamed, guilty and can even be fearful. Even so, we need to come out of the closet, and get it out in the open. You can only hide it for so long, before it will resurface.

There are three recognized types of aggression. *Protective aggression* is a type which might show when a bitch growls as you approach her newborn pups. Your dog may growl or even snap at a stranger. This is not abnormal, but in extreme can be a problem. *Fear aggression* occurs when an insecure dog perceives they will be injured and or pressured, and reacts. It may also occur when you suddenly startle a dog or awaken one that is sleeping. Although this is not abnormal, it is harder to control, as a fearful dog may react without reason. *Dominance aggression* involves the animal being 'King of the hill'. He/she has to be the best and will challenge the leader, *always*. It can be directly or happen covertly. This one by far is the worst to deal with, because we are always asking our dogs to perform, and *we* should be the boss. They must submit if you are to work together as a team; otherwise your performance in the home, field or on the circuit, will be less functional.

There are things we can do to prevent or lessen the episodes of aggression. Even so, it will occasionally rear it's ugly head and we, as handlers must be prepared to deal with it in a mature and informed way. My first piece of advise for you is, you must deal with it *right away*. Any behavior, which has been reinforced either in a positive or disciplined way will be repeated. It can be tricky, and do not be afraid to get help. You will need it. Talk to friends, trainers, animal behaviorists and vets, to get a grasp on the situation. Remember, this is your dog, be committed to getting this problem taken care of, quickly.

Bailey's problem became apparent when he was 4 months of age. I can see that now, but was not aware of it at the time. He was a pup which did not like to get on his back. He also did not like to lie down when being trained. I really had to spend a lot of time on this, more so than any other dog I have owned. This is a submissive posture for a dog, and it would allow me to win. He would not do this willingly, but finally, after much training, complied. Once during an episode in the house, he was told to get down and he snarled at me. I disciplined him for the snarl, and he came back at me with more white teeth. I quickly controlled the situation, and that was the end of it. I figured he had been taught his lesson. I could not have been more wrong.

Looking back, I now would have made sure he was comfortable on his back. I would have been slower with getting him to lie down, and reinforced him in a positive way, instead of


making him do it. Bailey was one of two males in a litter of fourteen. The other male was the dominant pup, and Bailey was tired of being picked on, and already had a fear of being on his back. I should have recognized this, but when you are in the midst of a lot of puppies, you kinda go brain dead. The breeder was not one who socialized with the puppies, and this is also an important factor to consider when selecting your next companion.

There were no other signs, that I remember, during his training which would have alerted me to a possible problem. It was not until he reached the age of 2½ years old, that I again, saw aggression with this dog. My wife and I had a French exchange student living with us for eight weeks. It was during this time, I saw Bailey growl at this student, when he approached to pet him, while Bailey was lying on a couch on our screened porch. I was surprised, but shrugged it off, as a fluke and it went away. I told the boy, who had been in our house, only a week or two, not to pet him on the couch, and everything was fine. It was not until it happened again, when Bailey was lying on his cedar bed in front of the fireplace, that I became concerned. One day, it happened with my wife, and then I started asking questions, and trying to find a solution to the problem. Bailey was trying to find his place in the real world, as he was reaching social maturity. My having people leave him alone, and allowing him to keep his place, on the couch or bed, rewarded his inappropriate behavior. Now I know better. Even though I stopped it from happening, I did not correct the situation.

Bailey was doing well in the trial circuit and was hunting great. He was a handsome dog, and I had decided earlier, I would try and breed him. He was a natural pointer, and I really wanted to see if his offspring would perform as well. I bred him thinking this would not affect him. You have to understand, his aggression was not an everyday occurrence; and, I thought I really and truly had this under control. I had talked with breeders as well as vets and handlers, and after careful consideration, felt it would be OK to go ahead with the process. Again, knowing what I know now, I would have neutered him at an earlier age, before other problems started.

We ask a great deal from our dogs, and they are super athletes. We should do all we can to make it pleasant for them with the exception of withholding proper discipline. To discipline means to teach, not necessarily to punish. There are many ways to teach, and I encourage you to find out all you can about aggression, should your dog show any signs at all. Some things I have seen since being aware of this with Bailey, and having had the opportunity to judge, include the following: dogs growling at their handler when releasing the bird; biting the handler's hand when lining the dog for a retrieve; biting the handlers leg when trying to steady the dog on the line, etc. Mind you, none of these incidents in and of themselves are necessarily a problem. Just know that your dog is telling you something, and you need to take heed. Stop it there, before it snowballs into bigger problems.

Maybe I am like a drunk turned sober - going around preaching against drinking, in this case against aggression. It is like being inoculated with a disease. Your body quickly picks up on the exposure, and alerts you to make antibodies to fight off the offending intruder. I too have been inoculated, and I see it in a few of the dogs being run in the circuit. Please take care of this problem in a mature fashion. Talk about it, train properly and please, do not continue to reinforce it. It *will* get uglier, and someone, maybe you or a family member will be injured. No dog is worth that, not even my own Bailey. "Bailey, may you rest well. You were one heck of a dog!"



## CLUB GUN DOG TEST

October 18, 1998 was a beautiful fall day in the New Jersey Pinelands when the Navesink River Hunting Club held it's club Gun Dog Test. This was the last event of the year for the club and we wanted everyone to have fun and enjoy the day. We kept the entry fee to a minimum, just enough to cover expenses,

We follow an abbreviated form of the NAHRA rules when we have our club gun dog tests. All stakes stay together and run the same marks so the club members can enjoy each others company. The Started dogs run the marks as singles, Intermediate dogs run the marks as doubles and the Senior dogs run the marks as triples. The handlers declare what stake they are running their dogs in, before they approach the point of origin. We allow the judges to also run their dogs by having at least three judges who alternate, (a judge cannot evaluate their own dog).

The day started with the land series and everyone got a shot flier for the first mark. The gunners: Tom DeFusco, Joe Eschert, Dirk Mumford and Bret Wood, did an excellent job. (Not one bird was missed or had to be sluiced all day.) The second mark was thrown from a winger. The third mark was a short, hand thrown breaking bird used only for the senior dogs. Six-month old 'Silverbrook's Princess Xena', handled by Rose Bodine, was the test dog. She ran the marks as singles. Rose ran Xena with a lead in order to catch her if she did not return. This brought on some good natured criticism from the other handlers. The lead was not necessary and the pup did fine without the lead as test dog for the water series.

It was getting warmer as the day went on, and the dogs were ready for the water series. This series consisted of a long mark thrown from a boat, a winger-thrown bird from land, on the right side of the dog, and a hand-thrown dumped bird, on the left side of the

dog. Some dogs were not called back to the water, but were allowed to run the water series for practice.


While the Intermediate and Senior dogs were doing the water blind, the Started dogs trained on more water marks in another location. Because of time, we were not able to do the Upland test or the trail. So our Gun Dog Test consisted of the land and water marks, and the water blind.

Twenty-eight dogs entered and thirteen passed. The qualifiers were: **BEGINNER:** Polly - Janice Easterbrook. **STARTED:** Cappy - Paul Chandler, Gunner and Xena - Joe Eschert, Callie - Dirk Mumford, Dillon - Megan Robinson, Indy - Renee Massey. **INTERMEDIATE:** Timmy - MaryAnn DeBalko, Toby - Romel Pineda, Smokey - Fred Bodine. **SENIOR:** Sheba - Bryan DeFusco, Maggie - Nancy Nieratko, Katie - Rose Bodine.

The club ribbons for each stake are a different color and they look nice hanging on the wall with the NAHRA camouflaged ribbons the dog has attained. The goal of our members is to try and qualify in a different stake each year in order to obtain all three colors.

It was evident everyone did have a good time. After the ribbons were given out, most members stayed and talked or ran more marks and blinds as the sun was setting behind the pines. 



## Judge's Clinic----

By Jack Jagoda

**W**hen a dog is granted a rerun, by virtue of an unfairness in the test, can he receive a perfect score?

(Section 19: A "rerun" may be granted, if in the opinion of the judges, an unfair or unforeseen circumstance occurs during the test.)

The short answer to this question is yes. A dog is granted a rerun, most commonly, on the trail, because the trail "breaks down" or is fouled by numerous dogs running the same one. In this case, a dog is not to be penalized, but goes to the new or "redragged" trail with a clean score sheet, just as if this were the first try. If the dog ran a trail, but there was no bird at the end, he would be scored on the trail he ran, and receive that score, but would be required to rerun the trail in order to pick up a bird, as returning with a bird is required by the rule book for successful completion of the trail. (Section 13.a *The dog shall be required to trail, locate a bird, and deliver it to hand.*) The rerun would only affect his score if he failed to pick up the bird at the end.

The other instances in which this can happen are as follows:

In a marking test, if one of the multiple marks has a technical problem, such as no shot being fired, a fly-away, a poor throw, etc., the series should immediately be called "No Bird" and the dog granted a rerun, again with a clean score sheet. If

the unfairness occurs while the dog is working, such as a poor throw on a diversion bird, or a dog picking up a bird from the thrower's station, or a stray dog wandering into the test, the dog should rerun the entire test, but in this instance will return with the score he had already achieved up to the point of unfairness, then have an opportunity to be scored with no penalties on the portion of the test he has not yet run.

In running a blind, the dog will again receive the score he had to the point of unfairness, then run the remainder of the blind to be scored for the balance. For example, if a dog is running a water blind, and a crippled duck swims across the line to the blind, and the judges decide to grant the dog a rerun, he will return with a score on the first part of the blind, and will then only be scored on the remainder of the blind, to receive his total score for the water blind. If he had a great initial line, and had two or three whistles and casts, to which the dog responded promptly and accurately, he could receive a perfect score if he finished the blind in as good a form. If, on the other hand, he had a poor initial line on the first run, maybe required 2 casts into the water, slipped a whistle or two, and had some cast refusals, the dog would not be able to have a perfect score, even if he ran the second blind much better.

In upland hunting, we sometimes offer a rerun if the flushed bird didn't fly well, and landed on or so close to the dog that it would be unfair to ask the dog to be steady to shot and fall. (Section 12.i A

*rerun shall be granted if, in the opinion of the judges, a poor flush or fall has caused the dog to be unfairly evaluated.*) In this case, the dog would come to the rerun with the score he had received in the first run for his quartering and upland hunt, and would have the opportunity to receive a perfect score on being steady to shot and fall if he is steady on the second go round.

In all situations the judges may use their own discretion to rerun any part or the whole series, if the judges feel there has been an unfairness to the dog. I once ran a land series where a piece of heavy machinery entered the field and started working within 50 yards of the marks. The event unsettled the young dog I was running at the time, and he just came back in to my side. The judges dismissed me, but when I inquired later, they admitted they had not even noticed the piece of equipment, so consented to a rerun for my young dog. He managed to do quite well and was called back to the next series.

One advantage of running against a standard, instead of competitively, is that any given dog need only to be judged against the standard, not compared with other dogs. So in any given test, if certain alterations occur to make the test different, you may use your judgement, to determine if the dog can be evaluated fairly. If you are not convinced that he can, the dog should ALWAYS be given the benefit of the doubt, and granted a rerun.
