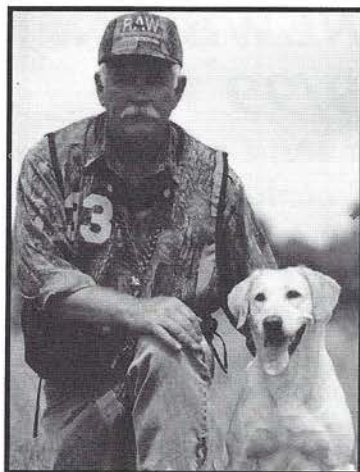

ent breeds of dogs. NAHRA is not a breed registry and survives solely on its income from running fees and memberships. Our annual income is about \$125,000. With this modest sum we employ two people, Rosemary Haynes and Nancy Rose, who provide an array of services to the NAHRA membership.

The NAHRA NEWS is another service provided to the NAHRA membership. Each quarter we attempt to locate interesting and timely articles for the NEWS. I would like to thank the NAHRA regions who contributed to this issue and urge all the regional liaisons to share their experiences with the NAHRA membership.

We have urged clubs and individuals to write articles for the NEWS in the past. Please take a moment and record your thoughts so those of us from other areas can share those things that are interesting and important to you.

Thanks to M.G. Kennedy, you will learn about two young NAHRA members in her region that train and handle their dogs at NAHRA tests. I attempted some years ago to begin what would become an ongoing section in the NEWS to report the activities of our junior handlers. M.G. has agreed to work with clubs and individuals to report the

accomplishments of our youth.

The 1999 Richard A. Wolters/NAHRA Invitational will be recorded as the thirteenth and last of the 20th century. This year's event was held at the historic and picturesque Linden Farm in Rapidan, Virginia. Photos and results of the Invitational will follow in the next NAHRA NEWS. The Pacific Northwest region will host the "R.A.W. 2000" NAHRA Invitational, in Edmonton, Alberta, Canada, next year.

I will be visiting many parts of the country this summer. I am attending the Ducks Unlimited Great Outdoors Festival in Memphis, TN, in June, and will be at The Navesink River Retriever Club picnic and judge's clinic, in July. I am judging in Edmonton, Alberta, Canada in July and at the Presque Isle Retriever Club field test in August. Hopefully I will get a chance to visit with many of our NAHRA members.

Please be active in your local club, and help us broaden our horizons, so that we may continue to be the best testing program for the hunting retriever.

Notes from Nancy...

Have you ever wondered, what goes on at the NAHRA office? I am often asked this question from folks who really have no idea of what gets accomplished here. It occurred to me that many of you might not realize the extent of work involved with this organization, and how the office functions.

On a daily basis, an average of 12 phone messages, and 22 e-mail messages are answered each morning, (Monday mornings there are twice as many with those received over the weekend). The questions and comments range from changing a field test application, updating memberships, where to get puppies or training, and asking about NAHRA clubs in a particular area, or requesting information about NAHRA. While in the office from 9:00 a.m. to 4:00 p.m. (on most days), an average of 30 phone calls, and 15 faxed messages are answered, (that's why you may get the voice mail during the day).

On a weekly basis, about of 4 judge's tests are graded. At least 6 field test applications are checked. Quite a bit of time is devoted to gathering or updating the information required, before a field test application is approved. 100 memberships (both new and renewed) are processed, as well as, orders for hats, decals and patches.

Each month, about 600 reminder cards are generated and

mailed out to let members know their memberships are coming due. Hundreds of labels are printed for clubs to send out their field test premiums to NAHRA members in their region. Upon request, packages of NAHRA information are put together and shipped to clubs for use at sportsman's shows.

Each quarter, the NAHRA NEWS is assembled for printing. It must be completely camera ready for the printer. Articles are re-typed to fit the proper format, and often, many ads require changes, because they were not received in the size they were contracted for.

Twice a year, both the list of judges and list of clubs are queried from the computer, 100 copies reproduced, hand collated, bound, and mailed to NAHRA Clubs. Packages of forms, and supplies are put together for newly formed clubs and for our current clubs as they renew their yearly NAHRA membership.

Once a year the NAHRA Benefit is hosted by NAHRA. Although there are usually helping hands from all over, all aspects are coordinated at the office, (this past year, the catalog was reproduced on the office copier and hand collated).

Additionally, there are numerous other little tasks that require attention in managing this office. NAHRA only employs two people, Rosemary Haynes and myself. Rosemary coordinates the dog records, statistics, certificates, and field test results, in addition to all of the NAHRA bookkeeping.

I truly enjoy the people, and the work. As many of you know, I am always happy to answer your questions as best as possible, or to help in any way that I can.

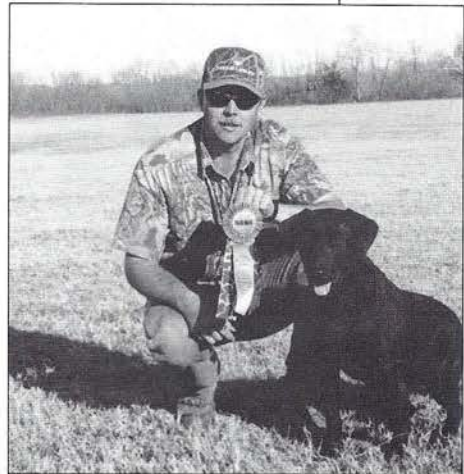
1000 POINT WINNER

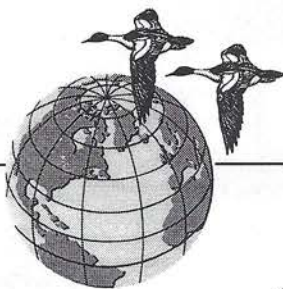

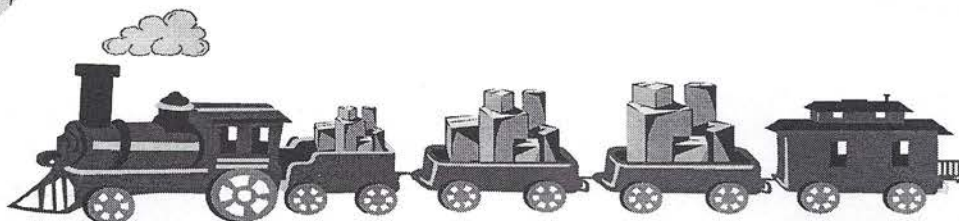

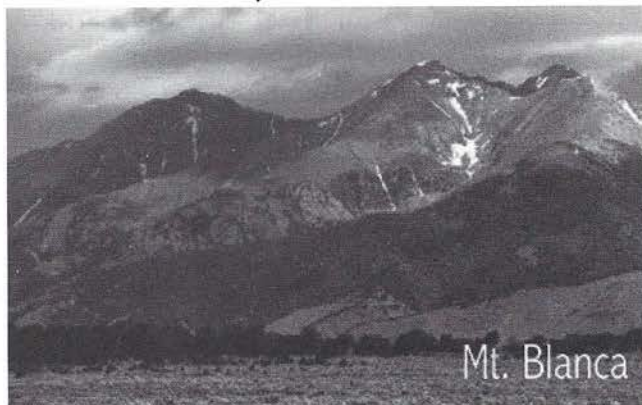

REGIONS

From the South Central Region...

The Heartland Hunting Retriever Association (HHRA), currently the only NAHRA Club in Kansas, has been sponsoring an Annual Hunter Safety Class, that has evolved into more than just classroom work. On the last day of the class, everyone is taken outside, regardless of the weather conditions, and run through various stations. The stations include: live firing of .22 rifles, shotguns, and archery; hands-on experience with rowing and handling the tiller of a jon boat; hands-on first aid; how to find deer sign, how and where to set-up stands or blinds, how to follow a wounded deer's blood trail; and when available, the Kansas Department of Wildlife and Parks provides tagged road kill for demonstration of field dress; and of course, a demonstration on conservation utilizing a trained gun dog. HHRA also provides lunch for all the instructors, participants, and parents!

By the end of the Hunter Safety Class, there are usually a number of youths (and adults) who are interested in participating in HHRA sponsored Club hunts. The Club then plans the hunt with equal number of youth and adults (for safety reasons), which allows everyone to experience the joy of being outdoors.

These classes take a lot of planning, and without the hard

working members of our small club, we would not be able to provide this service. However, I believe that everyone in the club knows the importance of establishing the ethical principles of hunting at an early age. And, to see the joy on a young person's face when they are able to put all the knowledge together and to accomplish their goal, is extremely fulfilling as an instructor.

I almost forgot to mention, this of course, also gives us an additional resource for "bird boys" for our annual Field Test! They actually enjoy doing this, and we are grateful for their time and enthusiasm. As they get older, and are ready to invest in a dog, they are already familiar with many of our members and are eager to join HHRA.

The primary reason we established the HHRA under the guidance of NAHRA, is because we believe in the ethical hunting ideals that it promotes. As well as providing potential growth for ourselves as individuals, NAHRA also allows us the companionship of persons who are all working toward the same goal - an organization dedicated to the hunting retriever!

RULES.....

Rules, rules, rules. No matter where you go, or what you do, there are rules for everything. Why? As crazy as life seems to get at times, it would be *absolute chaos*, without them. Rules provide a structure, a foundation upon which we can all rely. Every corporation and organization has their own version of rules and regulations so that the organization can function properly. We are all human, and being the creatures that we are, like to bend or break the rules to suit ourselves. We are all familiar with the old saying "*Rules are made to be broken.*" Some rules may be set up to be bent a little, to provide some flexibility, but very few are set up to be broken. Each time the rules are broken, the structure upon which the organization is built crumbles a little. If the rules were always being bent or broken, for whatever reason, eventually there would be no structure and the organization fails, falls apart because it did not require adherence to its' rules – its' structure, its' foundation.

NAHRA is no different. Each member, receives a copy of the rules and regulations book. Some of these rules are very clear and precise, while others are not quite so clear. Perhaps those are the ones set to either really make you think, or to allow for some *bending-flexibility*.

The rules which pertain to the procedure by which NAHRA affiliated Clubs may hold Approved or Licensed NAHRA Field Tests are very clear and precise, (pages 3 through 14).

On Page 3, in paragraph 2, it states: "*Unless waived by the Board of Directors, clubs **must** file official application forms for Approved or Licensed Hunting Retriever Field Tests with NAHRA **at least** eight (8) weeks **before** the date of the Field Test.*"

On page 12, in the first paragraph, the rulebook states: "*The Field Test Secretary shall, within fifteen (15) days of the end of the Field Test, forward an original typed list of qualifying dogs, which shall include all the information that appears on the official entry form (catalogs are unacceptable), together with the official entry form for each dog, initialed by the judges, the original Field Test Report form (yellow sheet) and all appropriate fees (currently \$5.00 for NAHRA members per dog run in Started, Intermediate and Senior and*

\$10.00 per dog for non-NAHRA members for each dog run in Started, Intermediate and Senior) to NAHRA headquarters."

There are several reasons for the 8-week limit in filing the Field Test Application. First, a club *cannot* host a NAHRA Field Test without this application being filed and approved. The eight weeks prior to an event allows time for the paperwork to be processed and any problems or changes to be worked out, *before* premiums are mailed out. There are three areas that seem to pose the most problems for clubs in getting their applications approved: 1) Judges who need to renew their NAHRA membership; 2) Field Test Committee members who need to renew their NAHRA membership; and 3) Submitting a certificate of current Liability Insurance. On Page 5 of the rulebook, in italics, it states: "*Clubs shall be required to carry liability insurance for the Field Test.*" Other areas of concern are: properly paired judges with enough points to officiate the stake assigned, (page 5; "*There shall be a combined total of three (3) or more points, in a specific judging category, between two principle judges, in order for the category to be approved as a point bearing event.*"); and judges assigned to a particular stake too often in the same region within a calendar year. (page 7; "*No judge shall officiate in the same category more than three times in a general geographic location within a calendar year, nor shall an individual judge the same category more than once on any given weekend.*")

With the Judges' List being published only twice a year, if you have questions, please contact the NAHRA office.

The judges listed on the premium must be the judges officiating the test unless there is an emergency substitution, and all substitutions must be approved through the NAHRA office. If the application is not approved with time enough for the premiums to be mailed, and entries to be returned for processing, the success of the Test can be significantly compromised. The expression, "it's all in the timing" certainly applies here, especially when there are so many things to prepare beforehand. Since the premiums are mailed, and we all know how reliable the postal system is, the more time allotted, the more time is available to address those problems that always arise. The result is less stress for all concerned and everyone

involved can enjoy the event. As a reminder, a premium should always be mailed or faxed to the NAHRA office, so that it can be verified with the Test Application. Some clubs have begun adding a notation of "substitution or addition of judges may occur". Substitution of judges must be approved by NAHRA in advance of the Test. If you feel a substitution may be needed, add the substitute judge to the Field Test Application, as such, so that the judges' qualifications can be verified. Even in an emergency situation, a substituting judge should never be a member of the Field Test Committee, nor a registered handler/owner of a dog running the test (pages 5 & 6).

The filing of the *Field Test Report* and results is more critical. When a Field Test Application is filed late, the success of your test is jeopardized. When the *Field Test Report* and results are filed late, it affects *everyone* else. The information from Field Test Reports are entered into the database *chronologically*. When the Report is filed late, it delays the reporting of all Field Tests that occurred afterward. Consequently, all the informa-

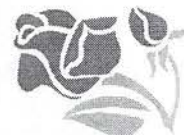
tion does not get processed for the NAHRA NEWS, nor do the certificates and titles go out in a timely manner.

Although up to this point no formal penalties have been established for the late filing of Field Test Applications, the time is close at hand when it will be necessary. It is understood that with so many things to coordinate in setting up a Field Test, some unforeseen problems may delay the entire process. Communication is the key. Contact your Regional Liaison or the NAHRA office for assistance, we are here to help.

Rulebooks are *free* to members. Read and use yours as your guide. If you need one, just ask.

Your cooperation is always truly appreciated. If we work *together*, life in general will be more pleasant for everyone.

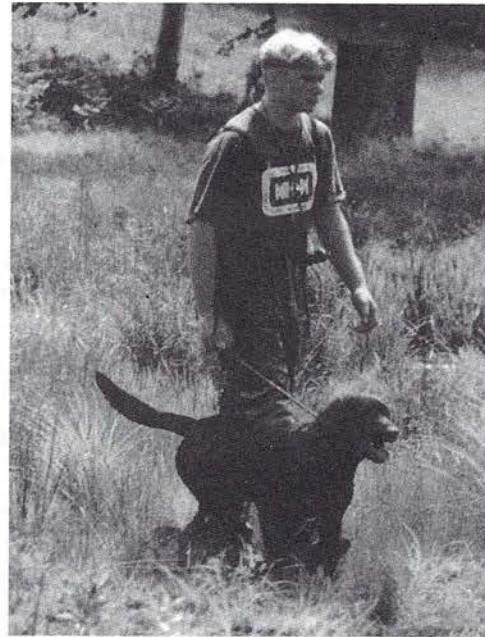

From the Southwest Region....

The Southwest Region has just wrapped up its spring rush of the field test season, which included the annual Southwest regional field test.

In the Southwest region, we have two field test seasons, spring and fall.

Our "spring" starts very early out here in the southwest. We start off the year and greet spring with a test the last weekend of January and wrap up the spring testing in mid April. During this "season", usually every club in the Southwest region hosts a test, that is seven tests. So, in ten weeks, with each club offering doubles, one has fourteen tries in each level. This keeps us busy almost every weekend and our pocket books slim! Sometime during these four months, one of our clubs will host the Southwest Regional.

What other people call "fall" with frost on the ground, a chill in the air and getting out those heavy sweaters, we think of as, "The short and T-shirt season before the really good duck hunting weather gets here." Right after the opening of dove season in early September, our "fall" field test season starts. Soon after, quail and pheasant opens. The last fall field test ends on Thanksgiving weekend. During this time four Southwest clubs host field tests. After

this field test season is over, it's time for the weather up north to get bad enough to push the northern birds down to us. Then, on to the serious duck and goose hunting season.

Now, that the last of our spring tests are over, summer starts and we look back at our first half of the Southwest Region tests and Regional.

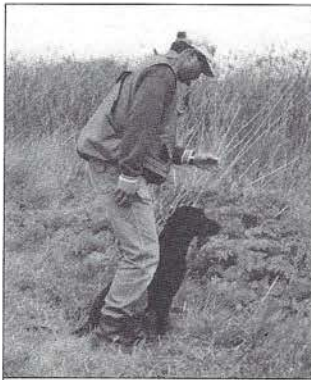

from the MIDWEST REGION

Ahhh April! the Midwest Region gets into full swing in the month of rain showers and spring flowers! It's fun to see everyone without the huge parkas and heavy earflap hats - and to see what they really look like!

The Eastern Iowa Hunting Retriever Association hosted a terrific "spring kickoff" weekend, April 17-18, at the Oakwood Hunting Ranch near Sigourney, Iowa. On Saturday, Ron Ainley (yes, the Ainley of Ainley Fabricators) of Dubuque, IA conducted a splendid handler's clinic. Ron's 30+ years in the retriever business was evident in his skillful morning presentation of highly relevant handling tips for all the levels of testing! Ron's major premise was the responsibility the handler has in helping his dog work correctly, and expertly explained and demonstrated body position when handling on blinds, and the importance of crisp, clear casts. He also stressed the importance of taking enough TIME with a dog when lining up for a blind, and said, "The less I talk to a dog the more confidence he will have. Take time, and let him settle and look."

In the afternoon, the group of 30 participants then assembled into smaller groups with special interests in specific training needs; Ron, himself, worked with folks needing assis-

tance on blinds, specifically handling on casts. Ron's friend, John Riggle (of Kentucky - an employee of Innotech as a Pro), worked with the conditioned retrieve concept and basic obedience. EIHRA President, Kirk Rice and Paul Peterson helped folks with patterns and drills. Everyone I spoke to learned something really significant, and ALL were gung-ho to continue training and testing with more confidence. Participant Bob Heise said, "Anyone who missed this clinic REALLY missed a good one!" Revonne Butler commented that she learned the importance of taking her time with her dog, and to relax and slow down. Others reported that the emphasis upon good timing when handling on a blind was well taken, and very important.

The next day, EIHRA hosted a single Started and Intermediate, licensed NAHRA test, which was also quite successful. the weather was gorgeous, ducks were plentiful and fat, and a large percentage of folks were successful in qualifying their dogs. New Titles: Scott Butler's *Lady*, became a new WR; Tony Anderson's *Missy*, Janet Mattson's *Skye*, and Kevin Schwarzhoff's *Sarah*, all earned SR's. The organizers (President - Kirk Rice, FT Chairman - Paul Peterson, Bird Steward - Ken Reed, FT Secretary - Keith Stroyan, and marshals Janet Mattson and Janine Reed) are to be

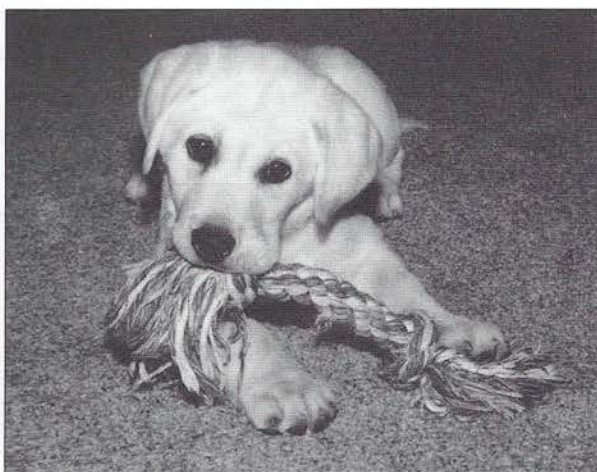
