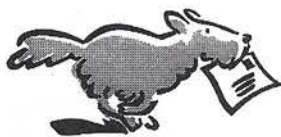
Due to changes in postal rates, regulations and our circulation, we can no longer ship the NAHRA NEWS via third class.

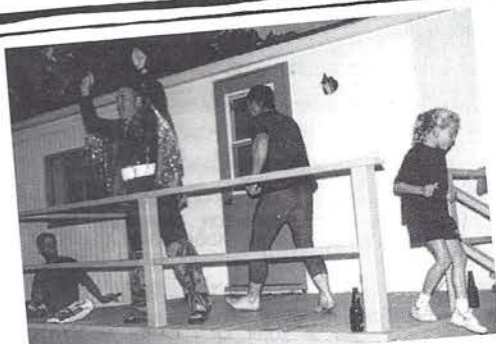

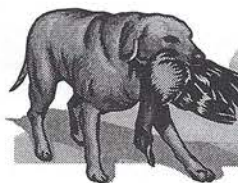

entries. In 2000 they are running a two-day test in May.

This shows that NAHRA is strong in the Northwest and numbers are increasing each year.

We don't have any clubs in Idaho or Montana to date. I have sent out some feelers but haven't heard from anyone. Maybe I haven't reached the right person. ## REFLECTIONS OF SEASONS END...

We had just set up our spread, complete with a dozen decoys, camouflage netting covering the 18' Lund Alaskan, the dog ramp hooked up on the port side aft, and a pep talk for my two buddies, admonishing them to stay down in the boat and to "listen", as the weather conditions on this day were brutal. The dialog was short lived however.

The fast moving drake Eider (*Somateria mollissima*), was hit twice with Tungsten-Iron BB as it passed from starboard to port, and came down hard, bouncing into the white capped chop of the Atlantic Ocean just north of the Isle of Shoals (six miles east off the coast of Maine).

My two buddies marked the fall cleanly and waited for their name, followed by the oft-repeated "back" command. Surveying the situation as it unfolded made me a little nervous, to say the least...the Eider came down hard, with the trajectory of a ball thrown from an outfielder to home plate, at least 75 yards away from the anchored boat, and it was crippled. A sluice shot wasn't feasible due to the distance, the 4-6 foot seas, and a 20-knot wind. To make matters worse, the cripple was making a beeline for the rocks of the Appledore Island, which was 150 yards away from my boat.

I had two choices. First, I could pull up anchor and chase down and dispatch the cripple (which is legal in Maine coastal waters), or second, I could send the most experienced dog. Handling was clearly a prerequisite for this job, especially in these conditions, and the type of birds we were gunning for. Sea Duck hunting is one of the most challenging types of hunting imaginable (for the dog and handler).

SR JH Long Ponds Ester of Westwind (Esther), was given the command, and without hesitation she made the leap into the numbing waters...with extreme prejudice, SR JH Long Ponds Hydro of Westwind (the Hydro) had the toughest honor of his young life. Esther was in an almost surreal pursuit, being picked up and carried by the current and the sea swells at a very fast pace, as she gained on the flapping cripple with each cresting swell and came within 10 yards, when the bird dove (sea ducks will occasionally dive to their death by clinging to plants and or rocks on the bottom). As she spun around looking for her mark, the cripple came up about 15 yards closer to



the rocks. The scenario was what we had practiced hundreds of times...single whistle, then an over. She got 10 yards closer and the Eider dove again. Another whistle, another over...this procedure was repeated three more times for a total of five handles. As the pea in my whistle was now beginning to freeze, the cripple was obviously growing weary of this dog coming after him and headed for the rocks with Esther in pursuit. The last thing I wanted was to see my dog get slammed into the jagged rocks of Appledore. Another single whistle, a trill to get her away from the rocks and potential danger, as I intently surveyed the shoreline, contemplating calling Esther back to the boat. Fortunately, the drake Eider is a colorful bird with a bright white and light green head, and I spotted him exiting the water and resting on a sand spit. Had this been a hen Eider, I never would have seen the bird come ashore. Finally, the last handle was an over, then a guttural "back" onto the sand spit and Esther was on the Eider, now obviously exhausted at its feeble attempt to escape a trained retriever.

Watching Esther fetch up the bird, I was hoping she would sit on that small sand spit and catch her breath for an instant, but the moment she fetched it up, she turned, and in a single movement, was back in the water headed for the boat. It was tougher getting back as she was fighting the current and the whitecaps. Up the ramp, into the boat, delivery to hand then the shake, and back to her ready position next to the Hydro (now on the verge of insanity or ecstasy... I'm not sure which, after all the excitement), waiting for the next mark. The daily bag limit of seven (7), sea ducks was had in less than three hours.

As we headed back up the Saco River to our put-in location, I couldn't help reflect on the countless hours spent in the field, on the water, and oh yes, in the truck traveling throughout New England and the Canadian Maritimes with the expectation that a day like this one would come to fruition.

Thank you NAHRA, as well as the countless friends we've met along the way, landowners, volunteers, supporters, and last but not least, the dogs...who make it all possible.

## A DUCK HUNTER'S TALE

I know we are a dog oriented organization, but most of us are waterfowlers too. The story that follows is true, and unfortunately such tragedies occur every year.

A duck hunter died this month (January). He drowned while picking up his decoys in the cold gray light of a January sunset. The air temperature was in the single digits yet the wind was calm. Darkness was quickly approaching and the lake was deserted.

I mourn for the loss, a brother of the wind swept autumn waters and frosty duck blinds, though I knew him not. He left this world at the early age of 33 years. He left a grieving wife and three children behind. He was enjoying a day in the blind with no cares and no conception that the end was near.

The story unfolds like this; he and his partner were "picking up" at sunset. They were in a 14-foot Jon boat with an outboard on the stern and a trolling motor on the bow. Inside the boat were life vest and throwing float cushions. Neither wore a life vest or a float coat, because they were uncomfortable. As the decoys were being picked up the little boat became heavier and sat lower in the water. One decoy at a time, the free board was decreasing. Then the inevitable happened. Both men reached overboard on the same side of the boat. In a split second the boat capsized tossing both of them in the frigid water.

With no life vest or cushion to keep them afloat, they tried to swim to shore and the comfort of the heater in the blind.

Completely drained of energy and in the early phases of

hypothermia, one sole made it to shore. The other could not make the swim and finally went under the cold dark water.

This is a tragic, but true story that did not need to happen. Errors compiled to the breaking point and lives are lost. If we all just think about what we are doing and take the appropriate actions, this story need not be written again. Unfortunately we are destined to do the same things in the future that we have done in the past. To minimize your chances of becoming a victim, please remember the following *Ten Commandments of Safety*:

- 1 Always wear a life preserver when on the water, especially when the water is cold and there is the potential for falling out of the boat.
- 2 Tell someone where you are going to be, and when to expect you to return.
- 3 Carry a cellular phone if you have one.
- 4 Distribute all cargo evenly in the boat and keep as low as possible in the boat.
- 5 Don't overload a small boat.
- 6 Use a pole or boat hook to retrieve decoys.
- 7 Never lean out of a small boat.
- 8 Take a water safety class.
- 9 Take care of your equipment.
- 10 Last, but not least, *use your brain*; by thinking ahead and planning, this story will not need to be written in the future.

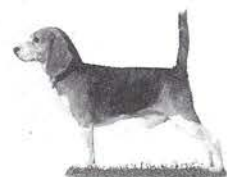

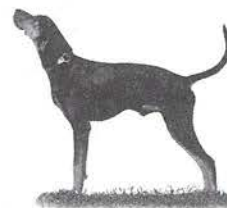

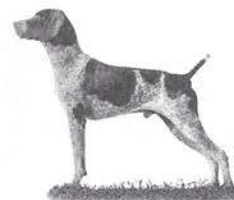
