

#### The President's Bark



The 2000 NAHRA test season has come and gone in most areas of the country. Actually a few regions are well into or at the end of their hunting season. Although hunting conditions vary greatly throughout North America, one thing is for certain, the hunter benefits greatly by the services of a well trained retriever.

People often ask me how I got started with retrievers. I tell them it's part of the normal evolution of a dog person. First, I was a hunter, and then I became a hunter in need of a dog. As the process continued, I

became a hunter with a dog, now I am a dog person who hunts.

There are two components that make up any hunting dog. natural and trained abilities. Natural ability of inherited consists traits passed on by the dogs' mother and father. Good eyes, a keen nose. desire and trainability are at the top of the list. Everything else is conditioned response to a situation or command: we call this obedience. Come, sit, heel and stay basic are obedience commands and the foundation for all advanced training. As the training continues we add commands such as hold, fetch, back, over, hunt and find it, to the dogs' vocabulary. Countless hours are spent with our dogs teaching them multiple marks, blind retrieves. and how to efficiently hunt a bird field in gun range.

The NAHRA rulebook was written to test dogs on a variety of hunting skills they might encounter in a normal


hunting situation. The use of decoys, boats, guns and calls are used to assess the dogs' suitability as a hunter. NAHRA was created for the hunter and his dog. It is the experienced hunter. trainer and handler that makes the best judge. The judges list is full of people waiting to be asked to judge. We need to make an effort to generate more competent judges. It is by the verdict of our judges that dogs earn titles. These titled dogs are the foundation for the hunting dogs tomorrow. This is a serious responsibility, one in which we should all become involved.

#### "WE FINALLY DID IT IN SOUTHERN MINNESOTA!!"

That's right! On July 15 & 16, 2000, the Southern Minnesota Hunting Retriever Association held its first licensed NAHRA Field Test near Owatonna, MN.

The road to this test has been 3 years of trial and error. SMHRA held its first meeting in December 1997, and since that point we have tried to do as much as possible for our members and their hunting retrievers.

In 1998, SMHRA became an official NAHRA club and held a couple of informal fun tests and a few training days. We were asked in May to do demonstrations at the Grand Opening of Cabela's by Joseph Middleton, the producer of the Richard A. Wolters training videos—Water Dog and Game Dog. In August we spread the NAHRA viewpoint at Game Fair '98. Our membership grew stronger.

Last year, 1999, SMHRA continued training days for its members and started planning our first field test. Unfortunately, the property that we planned on leasing fell through. Yet, we kept moving forward. On August 7, SMHRA held its first ever CERF eye clinic. Later that same month, we went back to Anoka, MN for Game Fair '99. Again our membership grew stronger. In December SMHRA held its first competition hunt for its club members, The Southern Minny Classic. It was an instant hit. Our membership grew stronger.

Here we are in the year 2000. SMHRA continued to hold training days through the late winter into spring. We have increased the number of members who are testing their retrievers. So far this year, SMHRA has 6 new Started Retrievers, 1 new Working Retriever, 3 new Master Hunting Retrievers and 1 R.A.W. 2000 Qualifier! Not bad for a club of 42 members, not bad at all.

I keep mentioning our membership. It is a group of hunters and retriever enthusiasts who are relatively new to the whole testing thing (with a few, hardy veterans mixed in). Our members are dedicated to their hunting retrievers and showed it by busting their butts at our field test. They put on a spectacular double Started and Intermediate

event. Less than a month later, SMHRA went to Game Fair 2000 more pumped up than ever about our club and our dogs. We talked NAHRA and hunting to everyone who would listen.

Well, lets get back to our first licensed NAHRA field test. We had a large entry of 114 for the weekend (80 Started and 34 Intermediate), but everything went fairly smooth. We even served 70+ people at our Saturday evening banquet. The weather was beautiful and the tests were challenging.

The weekend saw 17 Started Retriever titles and 3 Working Retriever titles completed. There were 7 breeds of hunting retrievers (Labrador, Golden, Chesapeake Bay, American Water Spaniel, Standard Poodle, and Nova Scotia Duck Tolling Retrievers.) represented, that came from Iowa, Minnesota, Ohio, and Wisconsin.

I would like to personally thank all the handlers for believing in us and attending our test. THANK YOU!!! I would also like to thank the SMHRA members who put on one heck of a test. Everyone who participated should be proud of their efforts.

I also need to thank the following sponsors: Owatonna Gun Club, Gun Dog Supply, Dale's Gun & Archery Shop, Wild Goose Sports, The Bottle Shoppe, Tech Tool & Mfg, Ten Mile Kennels, Cherry Grove Kennels, Woodhill Kennels and all the SMHRA members who donated prizes. Without their support, SMHRA would not have been able to make this event the success it was.

That about wraps it up. So I will end this with..."Training a dog to do his job with style is like creating a work of art. To paint a scene or turn a piece of stone into something others admire is a real accomplishment." - Richard A. Wolters, from his book "Game Dog".

#### NEWS FROM THE MID-ATLANTIC ...

Greetings all:

Hope the touch of fall has everyone excited for the upcoming season. I know the first touch of fall does it for my dogs and me. Thanks to the efforts of Dave Cannings, we now have realigned regions which should make the liaison process more effective. The former Southeast region has been divided into the Southeast and Mid-Atlantic regions. I am confident that the changes Dave has made will improve communications.

In the last 6 months I have received numerous letters regarding judging, tests and the result of what the writers thought were bad breaks. It's hard to know what is amiss, were the dogs not ready for tests at that level, did the judges deviate from the rule book or fail to communicate their expectations? I have also had several conversations with test organizers regarding the difficulty of getting judges for their events. It may be there is a connection between difficulty in recruiting judges and complaints from participants. Rather than dwell on tests past, I believe we are better served in working towards a solution.

NAHRA gives us a rulebook that provides both a standard and judging guidelines. As is witnessed by other retriever games standard creep is the result of poor judging rather than rule changes. Adherence to the standard is the duty of all NAHRA judges.

Part of getting good judges is to start early. Like other test preparation, & months is not too early. Clubs should not overlook taking the opportunity to ask judges to accept a club member as an apprentice. While the apprentice does not gain any judging points, the opportunity to learn is more important. Likewise asking a good seasoned judge to co-judge with a new local judge can provide them with invaluable experience. My first Senior judging experience was with Rocky Emory one of NAHRA's most experienced judges; I learned more that day about tests than in 5 years of running them.

The Mid-Atlantic Region will be having a judge's clinic this spring, I hope to see many of you there.



After Hunter attained three titles in one year, owner/ trainer Ken Klahr was interested in going to Alberta, Canada and participating in the R.A.W. Invitational. In order to attend, the dog must be awarded with five senior qualifications in a single year. After consultation with the dog and four qualifications under their belt, they packed up and headed for Beaver Dam's field test where, with little trouble, Hunter acquired two additional qualifications.



With an increased air of confidence, the trainer began to believe that senior tests were not particularly difficult. Several weeks later the Rappahannock River Retrieving Club hosted a field test. The "Hunter/Klahr" team was in attendance. These tests uncovered Hunter's weaknesses. He satisfactorily completed marks and blinds; however, sit to flush created a hurdle which kept the team from adding any qualifications to their growing list of credentials. Hunter's weakness was exacerbated by pheasants released from the traps in contrast to the traditional pigeons or chuckers. The extra auditory stimulation highlighted a skill with which Hunter struggled. After soliciting the opinion of the professional handlers in attendance, Ken took Hunter home to begin drills and practice which would ultimately correct the technical difficulties occurring during this activity.

The next outing provided a single event at Hudson Highlands. Upon arrival, Ken was greeted by a judge's wife who exuberantly informed him that they had pheasants for the "sit to flush" portion of the day's trials. A sense of nausea swept over Ken and Hunter began to feel the pressure. The test progressed nicely with water work and the team was called back for trail work and sit to flush.

With the "pheasant issue" looming over their heads, Ken's confidence about moving forward to the land series was waning. When the largest, loudest cockbird came out of the trap, trainer Ken hit the whistle and Hunter's rump hit the ground. With tears in his eyes, Ken realized that another qualification would be theirs. The trip home was joyous after Hunter aced the land series and attained their goals.

At the Northeast Regionals with the Navesink River Retrieving Club, Ken was greeted with celebratory status as Hunter was the only dog to qualify in all three classes. One woman sought him out and inquired about his marital status as he must be an amazing individual. Hunter observed from the tailgate of the truck as Ken basked in the glory. That evening Ken continued to enjoy adulations and imbibe himself on complimentary beverages as Hunter qualified in all three classes during the day's events.

With wife in tow, they embarked upon Western New York. Handler error caused Hunter to fail two water blinds and Ken returned home early with his ego in hand.

Lake Champlain provided the backdrop for the next adventure. The plan was to complete some "unfinished business" and acquire two qualifications in response to a failed attempt during the previous year's test in the Started Class. One qualification was attained and Ken's pride was evident as he was one of ten recipients of the seventy or so participating dogs.

As usual, Ken's networking skills paid off with the introduction to a Canadian, Mr. Benoit St. Amand. Benoit informed Ken of a triple held in Quebec, Canada and Hunter began planning their September vacation. Leatherstocking HRA provided a qualification of the two possible and plans became firmer with help from Benoit. Ohio Retrieving Club became a reunion with old friends and Hunter added two additional qualifications to his credit. Frank and Val (training buddies) judged one of the tests and the acquisition was sweeter with the first successful completion of a test they judged.

At the Southwestern Pennsylvania test, we renewed former contacts, picked up two qualifications, thus placing Hunter one qualification short of a Grand Master Hunter Retriever title.

The following week at Presque Isle HRA, provided two opportunities for qualifications. Ken hoped to acquire one and attend the tests in Quebec with Hunter's GMHR under his belt. Both qualifications were gained (three months short of Hunter's second birthday) and the September vacation was looking better and better. A husband and wife judging team sent Ken and Hunter a lovely congratulatory card upon receipt of his GMHR. Thanks, Char and Ted!

With the assistance of a French-speaking American, reservations and plans were made and a two-week vacation centered around training sessions and the possibility of three additional ribbons. The trip provided a much-needed vacation for Hunter, Ken and Joan enjoyed themselves also. One more ribbon was had and new friendships were forged. The banquet was wonderful and Ken and Joan danced on the table for their ribbon.

You may wonder how I got away with taking two dogs to the line today. It was just me and the young pup on the line today, but the grand old master is always there too. I can feel him tapping me on the shoulder, saying "Now remember about lining, whistles, casts, take your time and don't forget about your part of this team". I saw him looking at the young pup and quietly telling him to slow down and think before he leaps; those birds are not going anywhere. This is the gift that the "first" dog gives each and everyone of us. We need to make sure that we honor those who came first, by applying what they have taught us to all those who will follow.

What I have come to realize, is that the first dog, is the dog we will learn the most from—for they are the teachers and the trailblazers. Not that we do not learn from all the dogs we train, nor should we ever stop learning and growing in life. My "first" has opened many doors for me and given me the experience, confidence and courage to continue in this game. I might not have always been the "honor student". but he forgave me for that, and continued teaching me anyway. He has always given me his all, and for that I'm forever thankful. My goal is to honor him and his teachings.

So here's to you my dear "Travis", my "grand master", my "first". You have given me so very much. You truly are a wonderful teacher. And as our time together here is growing short, may you always be on my shoulder gently guiding me. May you always be in the wind whispering for me and the young pup to slow down, take our time and remember we are a team. May we always feel your presence and remember all the lessons you have given to us over the years. You have taught me well, my grand old master, and I hope I will take what you have given to me and make you proud. I will be forever grateful to have had you in my life. I'm so proud of you and love you so very much. Travis you will be forever in my heart—Thanks for letting me be a part of "dream team".
