





# The President's Bark



I was at the NAHRA office looking through some of the archival material that has accumulated through the years. I came across a letter written in 1983 that announced the first organizational meeting of NAHRA. The letter stated that the first priority of business was to discuss the development the running rules. remember that meeting and the sincerity of those who attended and contributed to the early structuring of NAHRA. We argued about distances and actually stepped them off to get a mental image of what we were about to create. We talked about upland hunting and how important it was and that it should be included in the testing. The only set of running rules to date was that of the AKC field trial program. Talking to the dog, blowing duck calls, firing guns, running out of boats, and flushing birds was simply unheard of. We have come a long way since that first

meeting, and the development of this comprehensive and complete set of test rules for the hunters' dog has withstood the test of time. I'm sure that most people today simply accept the running rules without any thought of how radical they were in 1984.

The concept of running against a written standard instead of dog against dog for placements was new to retriever events as well. This is the heart and soul of NAHRA. The rulebook must remain the backbone of our program, as it was the day the retriever testing concept was born. We were, and ARE, a testing program to help hunters train their dogs to be part of a conservation team! Field tests continue to be a fun day for owners and dogs, where all doas who meet the standard will qualify.

I had the pleasure of being invited to judge the NAHRA Regional Field test for the newly formed Rocky Mountain Region, held in Ft. Collins, Colorado, which is about an hour north of Denver.

Upon my arrival in Ft. Collins, I was met by Adrian Farmer, the Rocky Mountain Regional Liaison. Adrian gave me a quick tour of the grounds, we had dinner and turned in for the night. On Friday I met with co-judge Sue Smith, an old friend that I had first met 18 years ago in Alaska. As we set up our tests, one excited club member peering through the sleet and snow said "This is great, it looks"

just like hunting!"

The tests were set, and we looked anxiously toward the first dog on Saturday morning. (See the article by Adrian Farmer in this issue.) The dog work was good and certainly equal to any other region I have visited. We braved the elements for the day and watched a lot of happy faces at the awards ceremony that evening.

On Sunday morning we drove back into Denver to participate in the first judging clinic in the new region. The agenda for the Clinic was developed by Adrian Farmer and Gary Willis. The format will be used as the clinic standard for judging seminars in all regions. We had a good day and covered every topic, as time would allow.


After the judging clinic, I had the opportunity to meet with club presidents in the region and discussed a variety of topics, both on the local and national scene.

For those members that have let their dues lapse, and have been eliminated from the current edition of the judges list, they need to reapply to become a judge and take another judges test.

Greetings! I hope this finds everyone well and ready for summer. There are a few things that we, at NAHRA headquarters want to remind everyone about.

There have been several requests from our clubs to please remind everyone, that the deadline to submit entries to a field test is the deadline. The rule has always been, and will continue to be, that no late entries will be accepted. On page 10 of your rule book, the last sentence of the third paragraph states "A club holding a Licensed Hunting Retriever Field Test shall not accept any entries received after the specified closing time and date." Please, don't contact the field test secretary and try to negotiate the acceptance of a late entry. Be adult and accept the fact that you goofed up and will not be able to enter the test. We realize there are those out there who feel rules are made to be bent, but this is not one of them. The NAHRA Rules and regulations books are free to members. If you need a rule book, please contact the office.

While we are on the subject of deadlines...It continues to amaze me that everyone is always so anxious to receive their NAHRA NEWS each quarter, yet I have had quite a difficult time in obtaining articles from the various clubs and regions to print in the NEWS, by the specified deadline. If you want something to read, something has to be submitted to read. So let's get those pens, pencils and keyboards busy. Everyone loves to hear about what is going on elsewhere in NAHRA. Jot down funny, interesting or unusual incidents that occur at your tests, take photos. Was your child involved? Send in a little story and their photo with the dog. I know you all love seeing your dog's name printed in the results and title sections, how about a few words or photos on how that all came to together. The deadline for the next issue is July 6, and a full deadline schedule is always printed somewhere in the

NEWS.

When you receive a letter from Rosemary Haynes in our records department, requesting a copy of your dogs' registration certificate, she needs the certificate of registration (AKC, CKC, etc.) <u>not</u> your dogs' pedigree. A clear photocopy can be mailed to the NAHRA post office box or faxed to the records department at 540-898-5591.

Mailing labels are offered to our clubs to mail out their Field Test premiums. We charge the club just \$1.00 per page of labels (our cost of the labels), and the club receives preprinted addresses for all current NAHRA members in the areas they have requested. There are a few advantages to requesting these labels. The many new members that join NAHRA are included, (a great way to bring new folks to your club, that you may not be aware of); the field test committee will know who in their group is current with NAHRA; and who needs to pay their dues or pay the non-member entry fee. The main reason for encouraging the use of our labels, or at least a list of current members is to include the new members in the mailing of your premiums. We certainly don't want them left out!

We have received a few comments about our new decals. Most like the new look, but some folks are just not too fond of our little "Ready Retriever". Although we feel he's kind of cute, and represents the fun to be had by being involved in NAHRA, some feel he's not quite professional enough. It was suggested that we offer a decal/logo design contest. If you would like to participate in the contest, an application and rules are on page 31. Results of the contest will be printed in the 4th quarter NEWS.

# The Little Dog That Could...And Did ::::

If ten years ago, I had been asked what I would be doing now—trust me—fields test would not have made the list.

I didn't even know they existed as little as two years ago. But the past 18 months have been some of the most rewarding of my life. I have a wonderful dog, I work with an absolutely fantastic trainer, and this field test stuff is pure fun. I have met some of the greatest people and seen parts of our beautiful country that I would never have had the occasion to visit.

Let me start with the "wonderful dog". His name is Halsey. At 36 pounds and barely 18" tall, Halsey is on the small side for a male Toller. Typically, a male averages 45-50 pounds and 19-20" tall. Halsey is reddish in color with white chest and some white on his face and feet. One of the first questions people ask is "what kind of dog is that?" I give them the name: Nova Scotia Duck Tolling Retriever. At this point (if their eyes haven't glazed over) we go into the short story of "Tollers." Prized and treasured by hunters in Nova Scotia and relatively unknown elsewhere, the Toller is a medium-sized, compact retriever, bred to "toll" and retrieve waterfowl. Tolling is the act of luring waterfowl to within gunshot range. The plays, jumps and runs along the shoreline in full view of the ducks, occasionally disappearing and reappearing. It is the dog's playful action that arouses the flock's curiosity. Once ducks are in gunshot range, the dog is sent out to retrieve the dead or wounded birds. The next question is usually, "why did you pick that breed?" The short answer is that after much research, we became intrigued by the intelligence and working ability of the breed.

From the moment he arrived at our home, Halsey was a dog that wanted to work, interact, retrieve, perform, and retrieve some more. He flew through all the puppy classes, astonishing us with his quick learning and problem solving ability. Being completely new to this, we thought "roll over" and "shake" were pretty nifty, and "sit" and "down" were lofty goals. Our primary training aid was four-cheese tortellini. At this point we still were still living a relatively normal life;

family outings, skiing, Little League, etc.

Our lives were about to undergo a serious change. We had this dynamic, highly driven and incredibly smart dog and there were situations where he would not come back to us when called. We went up to the Dobbs Training Center with the sole purpose of increasing the reliability of his recall. I have a vivid memory of being asked if Halsey could retrieve. I naively answered yes, and then threw a bumper. He pounced on it, dropped it, paraded around the yard and then threw it at my feet

so I could throw it again. With great patience, Jim Dobbs explained that there might be some room for improvement. This is where it all began.

For the very first time the Nova Scotia Duck Tolling Retriever Club (USA) was having their Annual meeting in California and they were offering a series of club Working Certificates. We practiced diligently all summer long and made the weekly drive to Marysville for lessons. In September we entered and passed the club WC, which is similar to the NAHRA Started test and we were hooked.

We worked hard throughout the winter to prepare to run Started. We had the good fortune to work with a knowledgeable and patient trainer. Jim Dobbs trained me to train my dog. This was no small feat. We all still laugh about my first time on live birds; I was prepared, just before the action began, I pulled out a pair of surgical gloves and announced that I was now ready to have all the birds delivered to hand. I have come a long way—I now where a pair of nifty, black handlers gloves.

Our first foray into NAHRA was at the Kern Retriever Club's test in February 2000. We were entered in Started and were mostly clueless. Halsey passed both tests. Everyone was friendly and supportive and it was thrilling to see the dogs work. We came away from this thinking we should go another weekend and see what happens. Suddenly, we went from "having a dog" to "living a lifestyle" that centered around a dog and his field activities.

We finished Started in March 2000 and decided

to try Intermediate in the fall. Unfortunately, things don't always go as planned. Halsey had a near fatal brush with an intrusive foxtail and was laid up for almost five months. We began Intermediate seriously this February, again, down at the Kern Retriever Club's test. Intermediate was a big jump from Started. Suddenly, I was asked to perform as part of the team. In Started I could rely on Halsey's intelligence and ability. Now in Intermediate, he sometimes needed to rely on me. We needed to meld into a working team. It was both gratifying and terrifying at the same time. I worked very hard at holding up my end of the team. Drill by drill, mark by mark, we worked at an increasingly demanding level. We completed Intermediate in four straight passes and did an extra leg for good luck. One of the things I found particularly challenging about Intermediate was the transition from quartering to the more controlled marks and blinds. This transition and the level of control required were a real challenge for us as a team.

Now we questioned whether we were ready to go on to Senior right away, or should we wait until next year. We thought we would try it and see where we were. Halsey was up to the challenge and passed four straight Senior tests to get his MHR title, thereby becoming the first Nova Scotia Duck Tolling Retriever in North America to achieve this title. At the last test down in Southern California it hit me on the water series, just four more birds!!! I got really nervous and. of course, it was one of the few times in over 15 tests that I had to handle on a mark. It was a long bird over a couple of levees in heavy cover, and Halsey was hard to see. We worked together like a real team. I gave him the appropriate casts and he took them. One more bird to go, and it was the blind. Again, cast by cast, he did it. You could have heard a pin drop. There was a moment of silence, then a big cheer went up from both the gallery and the gunners in the field. Halsey had done it.

There were many times this past year that I cursed my own inexperience. I kept thinking how much better off Halsey would have been with a knowledgeable handler. That still may be true, but I am so very proud of what we accomplished together. To think that our first NAHRA test was just a little over one year ago.

In that time, I have been able to develop a relationship with my dog that transcends anything I thought possible. It is simply amazing to me that I can communicate better with my dog at 200 yards than with most people at a tenth that distance. His intelligence, courage and willingness to work are a daily

We have qualified for this year's Invitational in lowa, but unfortunately due to a previous commitment we will be unable to attend. Our goal is to qualify next year and work on our GMHR.

Thanks to everyone who has encouraged us, supported and trained us. And a special thanks to my little dog that could and did, do all I asked of him.







These dogs want to please so much, but are only able to if they are kept finely tuned. A presentation was given by Beth Barrett to the WRHRC at their General meeting in March. Beth has agreed to share this presentation with the NAHRA members who are looking for information on how to get the best from your Retriever.

## Keeping the Working Retriever, Working

A management program for any competitive working dog must include five basic components:

- I. A brief description of each of these would be:
- GENETICS --this determines the suitability of the dog for the tasks required of it (most Malamutes will have a harder time performing in Hunt tests than most Labs, and most Labs would have a hard time pulling a sled in the Arctic)
- 3. TRAINING --this determines the dog's comprehension of the tasks required of it (the most driven and highly pedigreed dog can't do a blind without proper training and handling...)
- 4. <u>NUTRITION</u> --provides the energy and physical reserves necessary to fuel the dog's performance
- HEALTH CARE --need to keep all the parts of the body in top condition in order to allow for the best performance, with as little "down time" as possible.
- 6. <u>CONDITIONING</u> --if we consider 'training' to be the mental preparation of the dog for his tasks, then 'conditioning' would be the physical preparation of the dog. This includes fitness training, but also injury prevention strategies.

The first two topics, genetics and training, are huge subjects, and we aren't going to address them here. We're going to restrict ourselves to a short introduction to the last three nutrition, health care, and conditioning. Keep in mind this is my perspective, and that I will just touch these areas - there is a ton of information out there on these topics.

#### Nutrition

- I. The first point I'd like to make about this nutrition is that most people give their dogs too much of it. It is estimated that close to 50% of working dogs are actually heavier than they should be in order to best perform.
- 2. The canine diet should be predominantly proteins and fats,

- and carbohydrates should not provide the bulk of the dog's energy producing fuel.
- 3. Your dog's dietary requirements may vary significantly depending on the time of year. During the training season, his diet should be approximately 30% protein and 20% fats. You may need to adjust both the quantity and the quality of his food to prepare him for heavy training or to keep him from becoming obese. A dietary change can take up to 6 weeks to come into effect, so you need to prepare in advance.
- 4. The ability of a dog's nose is affected by his diet. FATS have quite an influence on this, especially unsaturated fats. A study done on pointers suggested that increasing the percentage of fat in the diet had a positive impact. Before you start liberally pouring corn oil over your dog's dinner, keep in mind that excessive fat in the diet can result in diarrhea. The idea is to gradually increase the level of fat in his diet about 6-8 weeks prior to training season to around 20%.
- 5. It has also been suggested that supplementation with Vitamin E can enhance a dogs scenting ability.
- 6. If your dog is overweight, you can use what is called the pumpkin diet- replace I/3 of the volume of his regular food with canned pumpkin. (NOT pie filling, just canned pumpkin) If you normally feed 3 cups, give 2 cups and I cup pumpkin. The pumpkin provides roughage and vitamins, and fills the dog up. Most dogs quite like it.
- 7. Any athletic dog is susceptible to joint pain, whether from injury or just the wear and tear of an active life. More and more of our dogs are benefiting from the use of supplements that vets call "Chondroprotectants". Glucosamine and chondroitin are the most popular of these, and they have been shown to improve comfort in many dogs with arthritis. Some experts advocate their use in all adult working dogs, although at lower doses.
- 8. Omega 3 fatty acids are a useful supplement for most dogs. An effective source of these would be fish oil or flax oil. I use the salmon oil capsules and flaxseed oil capsules from Costco, and my dogs get one or the other most days.
- Antioxidant is one of the nutritional buzzwords these days, and indeed the research does seem to support their use. Advocates suggest vitamin C, beta-carotene, and grapeseed extracts as good choices.
- 10. Some canine nutritionists also recommend supplementing Gamma-linolenic fatty acids. Evening primrose or borage seed oil are good sources of these. Is all of this stuff necessary? One way to look at it is this: Adequate nutrition is probably all you need if what you want is adequate performance. If you demand a higher level of performance from your dog, you need to provide the best fuel you can. You can bet that there is a reason that Olympic athletes consult with nutritionists and don't eat Hostess Twinkies...



# NAHRA'S PUBLIC IMAGE

It's 8:00 am the morning of the field test. The judges and workers are busily setting up the test, and handlers are beginning to arrive at the site. At that moment, the manager of the private property on which the test is being held comes to you upset. A group of individuals just outside the property has complained to him about the disturbance that they perceive will be caused by the test. The manager is sensitive to their perceptions and, consequently, would like you to move the test to some other location. What do you do, given that committing suicide is not an option?

This scenario actually occurred at the recent Rocky Mountain Regional Field Test, on 5 May 2001. The events that lead up to this conflict could not easily have been anticipated, but the fact that I found myself in the middle of the situation got me thinking about a subject to which I had given too little thought in the past – the importance of NAHRA's public image. Here are the details.

The group was from the local chapter of the Audubon Society and they were out on a bird-watching trip, which was to begin at our test site. The site contains a wetland complex that is used by many water birds, including a nesting colony of California Gulls, one of only six such colonies in Colorado. Also, the wetland is close to a public road making for easy viewing.

Imagine the Audubon group's surprise when they arrived to find a hunt in progress — a large number of vehicles, people in camouflage clothing, dogs, and guns. Oh yes, and lots of dead ducks in buckets. Moreover, it's long after the legal hunting season and many wetland bird species are nesting in the marsh, including the California Gulls that nest on a small island about 300 yd. from shore. The site is private property, but the owners are proud of their public image as a company that promotes wetland creation and wildlife conservation.

I suggested to the land manager that, before he decided to move the test to a more hidden location, I should go talk with the Audubon group, to explain the purpose of NAHRA and field-testing. From the moment that I approached the group, I was confronted with hostile glares and body language. I introduced myself, apologized for interfering with their birding trip, and asked what I could do to minimize the conflict. I invited them to come watch the test for themselves; but in spite of my best efforts they steadfastly refused to have anything to do with it. Suddenly, one member of the group recognized my name, remembered that I was a wildlife biologist and, in fact, had made presentations at their monthly Audubon Society meetings. Tensions eased somewhat, but only

because in a previous context I was a "good guy", even though I was currently displaying poor judgment to be associating with a bunch of rednecks conducting a retriever test. Shortly thereafter, the group left to visit another site, and the test continued as planned.

I was proud of the response of NAHRA members in this situation. Once they understood the situation, the judges quickly made some changes to the test setup to minimize further conflicts with the public. On the other hand, it was the Audubon members that proved to be inflexible in this case.

But before we get too smug, let me point out that no real progress was made as a result of this confrontation. The old stereotypes persist to the detriment of both organizations. I heard various snide comments from the NAHRA gallery about the pointy-headed, tree-hugging members of the Audubon Society. And, I'm certain that the local Audubon group continues to think that we were a group of crazed rednecks whose sole aim in life is to maximize their daily kill of critters. Both stereotypes are far from the truth; I know, because I have a foot in both worlds.

In fact, both NAHRA and the Audubon Society share common goals and values, some stated and many unstated. The local Audubon chapter's mission statement is "to promote the appreciation, conservation, and restoration of ecosystems, focusing on birds and other wildlife, through education, participation, stewardship, and advocacy." There's some overlap between that and NAHRA's objectives to promote the training of dogs as valuable game conservation tools, and to educate the public in the use of purebred hunting retrievers as conservation animals. But I'm willing to bet that there is even more overlap between the core values of the average NAHRA and Audubon Society member in terms of the importance of conserving wildlife populations and the habitat on which they depend.

We as individuals and NAHRA members must look for opportunities to build on the common values we share with others to defend the things that we hold dear. This will not always be possible because philosophical differences often get in the way of cooperation. But the threats to our hunting opportunities come from many directions, including the steady loss of wetlands and quality wildlife habitat. So don't pass up that opportunity to talk to local groups, maybe even the Audubon Society, about the NAHRA retriever program. Who knows, perhaps you'll find out they're not so pointy-headed after all, and they'll begin to understand why we're so addicted to trained retrievers.

I then bought a 4 year old field trial Chesapeake bitch from a good friend of mine in Belgium. I was really eager to do these hunting things...but I found out that my Chessie was a very good worker but an even better whiner. So what could I do? I wanted a dog to work with and take part in Working Tests and Trials. My friend in Belgium helped me out another time. He knew about an American Lab that was very soft, in fact too soft for him to work with him. He offered to help me get this dog.

When the dog arrived, the vet checked him and then I could have the dog. I had never seen this dog before except in some photos. He came to me and he acted like we had been together all the time. The vet says how nice it is when dog and Master love each other so much. This day was the beginning of a great partnership between man and dog. I started to look for trainers. I started with an old friend throwing some dummies and trying to teach the dog what was needed for hunting. Two months later Banner and I went to the first working test. What a disaster... he picked up Dummies and dropped them, but worst of all he did his thing in the middle of the test field. We were the joke of the whole Retriever Club. Nevertheless we restarted training hard and in the Spring we got our first 'Good' at a working test, 3 months later an 'Excellent' and so I went on... My trainers Malu and Dani spent hours every Sunday going out with Banner and me to the training fields.


We learned a lot and worked hard under the guidance of our trainers. Malu and Dani are both international judges and have trained dogs for the last 20 years.

We passed from Test to Trial and from Novice to the Intermediate, passing the qualification for the open class.

Last year Banner passed his first Field Trial in Italy, and last October he placed 10th at the


Champions Meeting in Donaueschingen Germany. In the meantime our 2-man training group has grown to a 50 men troupe training in 5 different groups every Saturday.



twin daughters in November of 1997.



# From the Rocky Mountain Region...

You arrive early. The sky is dark and menacing, there's a 30 mph wind gusting out of the northwest, and it's spitting rain mixed with snow. Small groups of mallards and teal are flying along the shore, struggling against the wind, looking for shelter in the marsh. Your dog sits nervously by the truck as you dig into your duffle bag, searching for your warmest gloves and hat. Sounds like a great day of waterfowl hunting, doesn't it? You betcha, but it was also the 1st Regional Invitational/ Open Field Test in the Rocky Mountain Region, held on 5 May 2001.

Due to three days of snow and rain before the Saturday test, most of the roads on the property were impassable, and the tests had to be run around the edges where there was good gravel-road access. In spite of this hardship, the judges were able to visualize and setup challenging tests with the limited grounds available. Add this to the very cold, windy weather the day of the test and the judges (Jack Jagoda, Sue Smith, Kim Henton, and Chuck Liesenfeld) have to be congratulated for contributing way beyond what is normally expected in a judging assignment.

We had a great turnout too! Thirty-seven dogs (26 Started and 11 Intermediate) qualified for the Regional and of these, 21 (14 Started and 7 Intermediate) participated. An additional 22 handlers/dogs ran the "open" test, for a total of 43 dogs in both stakes. Twenty-eight dogs (18 Started and 10 Intermediate) earned ribbons for the effort. Several

participants were new to NAHRA field tests, some coming from as far away as Rifle, Colorado. I hope that the experience was positive for you and that we will see you again at future club events and field tests.

On Sunday, after the field test, the Region hosted a Judge's Clinic taught by Jack Jagoda using a new handbook developed by the NAHRA Regional Advisory Council. Twenty people attended this clinic, and I believe that all thought it was time well spent. There was some lively discussion about several judging issues, and several suggestions were made for modifications and additions to the new clinic handbook.

After the clinic, on Sunday evening, Jack had a meeting with the club presidents to discuss NAHRA affairs, and the discussions ranged from the history of how NAHRA was created to the future of the organization. Again, Jack put in very long, hard day, way beyond what could reasonably be expected of anyone. Hence, I take this opportunity to personally thank Jack for his personal sacrifice and the tremendous support he gave the Rocky Mountain Region in our first year of existence. If his efforts in Colorado are any indication, NAHRA is in good hands.

#### Health Care

- I. I said it before; I will say it again--- keep your dog lean.
- 2. Dental care do you need to brush your dog's teeth? I will tell you the truth, as a vet I have in the past advised a lot of people to do so. Most of them, including myself, didn't do it as well or as often as they needed to. What I advocate now, having tried it myself for the past 18 months, is feeding the dogs raw bones on a regular basis. Dogs are built to chew, and as long as the bones are raw, they provide a lot of benefits. Raw bones clean teeth and gums, relieve boredom and frustration (after a bad training session, you have a beer, the dog has a bone...) and produce clean, dry, relatively odor-free feces.
- 3. Ear care remember that healthy ears don't smell! The trick is to maintain a clean, dry, slightly acidic environment, which is hostile to many of the pathogens that cause otitis in the dog. After swimming, apply an ear solution and gently dry with a towel wrapped around your finger. Many commercial solutions are available which work well. For home use you can mix white vinegar or apple cider vinegar with water. Some people use alcohol, which is definitely drying, but if there is any irritation this is very painful, so I tend to avoid it.
- 4. Skin care occasional bathing with a mild shampoo is probably a good idea. If your dog is swimming in ponds and sloughs regularly in the summer, he is going to benefit from a really thorough rinse with clean water to help prevent hot spots. Providing shade will help prevent bleaching of the coat.
- 5. I, and many other vets, recommend the use of regular blood screens on your athletic dog, especially after the age of six. Having a baseline is very useful for comparison should anything go wrong, and you may pick something upon a screen before it has progressed too far.

#### Conditioning

- I. Keep dogs lean.
- 2. Check weight at neck, ribs, hips, spine.
- 3. Do canine cross training: walking, running, swimming, and retrieving
- Give dogs one day a week off no formal training physical and mental break
- 5. Don't start serious physical conditioning of any large breed dog until he is I4 months old - growth plates closed. Excessive concussion of the growth plates before closure can inhibit or damage bone growth.

#### Injury Prevention

I. Before working a dog, warm him or her up to loosen joints and muscles. This becomes even more important as the dog

ages. Never release a dog after a nearby bouncing ball - twists and turns injure dogs.

- 2. Warm up exercises:
  - a. Walk, trot on/off lead
  - b. Play ball
  - c. Curl head down between forelegs
  - d. Lateral bend left, lateral bend right
  - e. Twist/spin game
  - f. Back up
  - g. Stand up on hind legs
  - h. Stand up on hind legs with reach
  - i. Supported elbow stretch
  - j. Supported stifle stretch
  - k. "Rattle" the hocks
  - 1. Tug of war game.

Always provide fresh water to the dog before and during working. Train the dog to drink from a squirt bottle, which you can carry with you. As well as keeping the dog hydrated, this will help to keep his nasal passages moist, which is essential in effective scenting.

If you expect your dog to perform as an athlete, get used to treating him like one! The time and effort necessary to prevent injuries is worth it if you consider that one injury can end your whole season of training and competing, and may even be career ending for your dog.




