

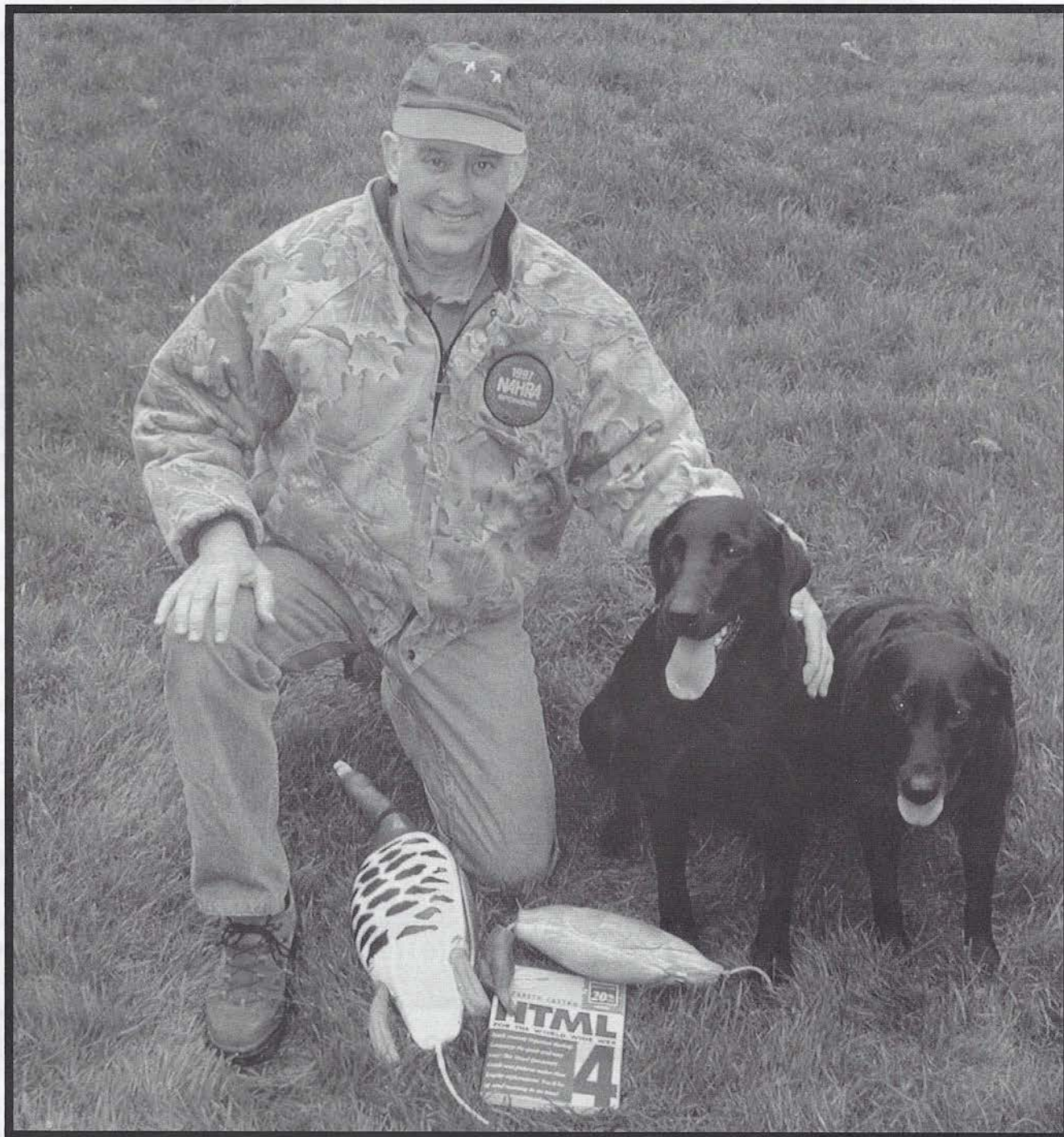

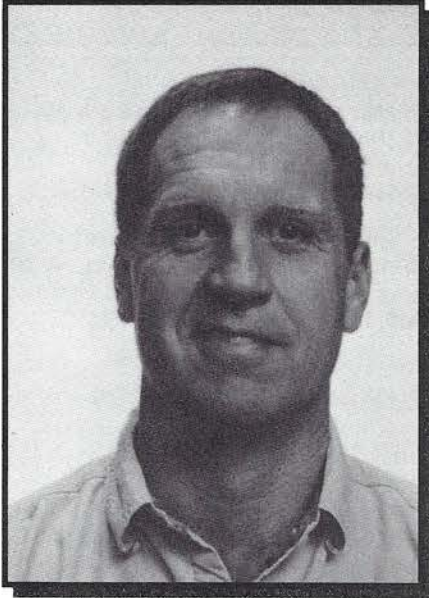

## The President's Bark



Fellow Members,

It is the training and field test season once again and I sit here working on this article awaiting anxiously for the last remnants of snow to disappear and the water to soften in this part of the world. Day to day activities are running smoothly thanks to Rosemary's efficient work ethic. With the help of a few members on selection we have purchased and installed a new computer system for the national organization. It will allow us to implement and monitor a few new processes we were unable to with the past hard drive and software. As indicated in my first President's Bark in the last NAHRA NEWS, the Board of Directors of NAHRA has established some specific priorities for which we have focused our energies. I can tell you that we are making progress on all five (5) areas.

1. **Bylaws and Articles of Association:** Two drafts have been drawn up for review. All the Board members have critiqued the documents and the process is now back in the hands of the lawyer for input as to state non-profit criteria. As soon as the Board has an official document to

present we will be posting the finished product on the NAHRA web page.

2. **Finances:** Roy Sheppard (Treasurer) has made good progress with the review of the NAHRA finances. Our mandate was to get a good solid understanding of NAHRA's financial position when the new Board took over. Upon completing this task, Roy along with Rosemary comprised a short-term cash flow statement. This was presented to the rest of the board members for comments at our last conference call meeting. It will be a standard policy to have financial updates at each Board meeting. As mentioned earlier the new software capabilities will allow us monthly statements to work with. You will also see included in this edition of the News a summary financial review. It is our mandate to present summary reviews at times throughout the year and publish a fiscal Statement at year end.

3. **Communication** is another key priority as a consensus of the Board of Directors. We are working on a monthly news bulletin that will be distributed to the members direct through email addresses. I am quite excited about this project, as it will give the members the direct link to the national organization. Ralph Luedtke, a long time member from the Northwest Region, is working with me on the layout.

4. As I am sure all or most of your regions members are aware we have implemented the national Judges Standard. This project has come along very nicely and has passed all its preliminary test cases. We have run three official sanctioned Judges

clinics and all have had great feedback. We are presently selecting candidates who will qualify as authorized NAHRA Judging presenters. This pool of authorized Judges will be drawn from for sanctioned Judges clinics within all eleven regions. I would like to congratulate and welcome Paul Young (Northeast Region), Dan Hosford (Northwest Region), Dan Collier (Southwest Region) in joining Jack Jagoda as authorized Judging presenters.

5. The NAHRA NEWS is an important part of the national organization and has been one of our communication links to the members. It is also very time consuming to manage and is without question a large cash draw on the organization. Our immediate goal was to analyze this production as to its financial and time efficiency to the national organization. We have been gathering ideas and suggestions on all aspects of the news format to see its viability on maintaining the infrastructure in-house. We have also gone outside and recently received a proposal to third party the production. We will be analyzing all options to maintain the newsletter as a viable link between the National organization and the members.

I hope everyone has a fun and successful Field test season and I look forward to meeting up with you in my travels to compete and or judge.

# WWW.NAHRA.ORG

It's been over five years since volunteering to be the NAHRA webmaster. I was running my lab through NAHRA field tests for the first time and was motivated to have an up-to-date field test schedule that was fresher than the quarterly Schedule of Events in the "News". It seemed like a worthwhile chore to work with the office manager and to publish the schedule and updates on the internet for the benefit of other members as well.

At first, NAHRA didn't have their own website; it was donated internet space courtesy of Starsouth.com. Changes and updates had to go through the owner before getting to the internet. When NAHRA later got their own site, changes could then be made faster and more space was available for expansion.

While the Field Test Schedule is the backbone of the NAHRA website, other features have been added over the years such as bulletin boards, downloadable forms, club information, RAW results, etc. Clubs can now have their downloadable premium listed along with their field test announcement (there's a postage saver). NAHRA NET (training information) and NAHRA PUP (puppy ads) bulletin boards draw a significant number of folks although both need daily monitoring. NAHRA PUP (suggested by Bonnie Moothart) seems to be a big hit. Speaking of hits, NAHRA.org gets between 200,000 - 300,000 hits a month; I finally took the counter off since it kept cycling around to 0.

Website updates to the Field Test Schedule. If you need something changed or updated on the NAHRA website, you can email "minor" changes to me at updates@nahra.org or to the NAHRA office at nahra@juno.com. (Updates are exchanged between the NAHRA office and the webmaster). "Minor" changes: changes or corrections of names, phone numbers, addresses, typos, or adding additional information (like premiums) to events that are already listed on the website. Test date changes or requests for new tests are supposed to be sent to your regional liaison for coordination and approval.

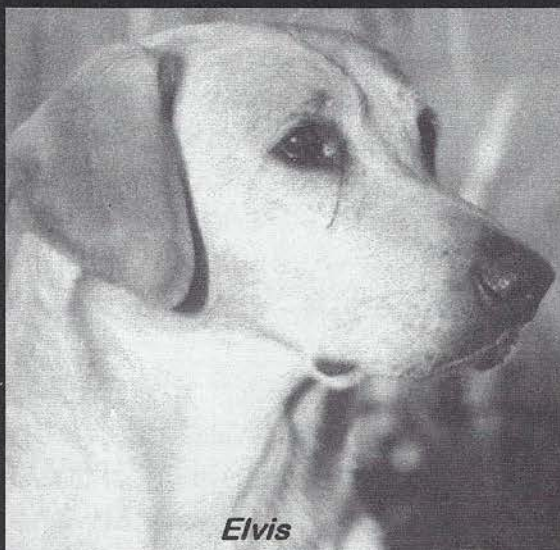
All this takes some time, but my dogs and I have benefited from NAHRA and time spent helping the program to run better seems worthwhile.

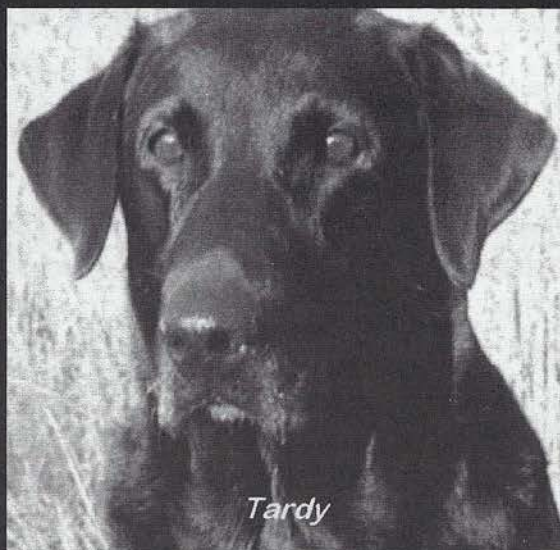

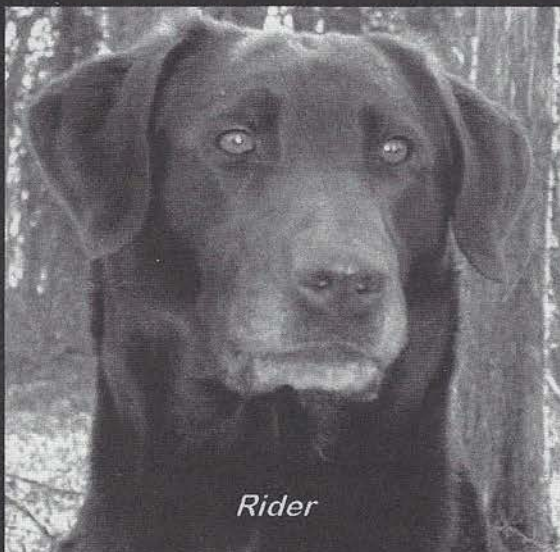

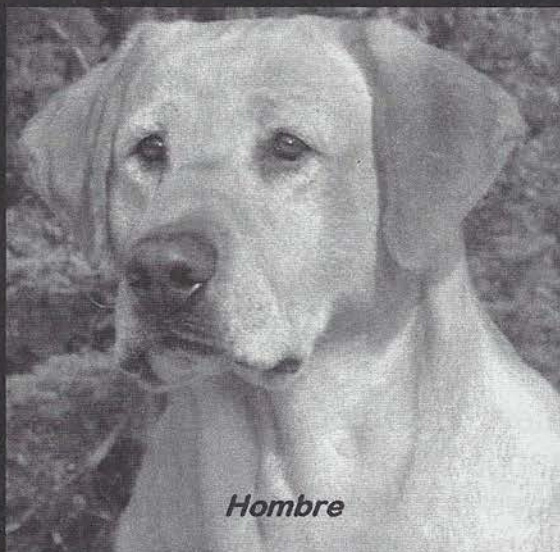

## A Note on Complaints

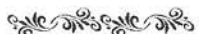
I hope this note finds everyone's dogs coming out of winter running and training their best. One of my less pleasant responsibilities is responding to complaints that have been formally submitted. I'd like to share with you the process we use to resolve these complaints.

The majority of complaints regard running rule violations. When received they are forwarded to all Board members and to the liaison for the region where the event took place. In the event that the liaison has a conflict of interest a member of the Board, typically myself, will investigate the complaint. The Liaison is tasked with investigating the complaint and forwarding all relevant information to NAHRA. Typically the judges, committee and several handlers will be asked to provide information. The Liaison will forward the information gathered to me. I provide a summary of the key issues and a recommendation for resolving the complaint to the full Board of Directors. In the event the Board concurs with the recommendation the issue is closed and the appropriate action taken. If the Board is divided or feels it needs further discussion it will be referred to the next Board meeting.

As the Board investigates these complaints it needs the full cooperation of all involved. This is particularly true in the case of our judges. It is difficult to step back from the situation that has occurred and analyze it critically to try and determine why a complaint was generated. I ask that anyone who becomes involved in these issues act promptly and objectively so we can get the issue resolved.

A related issue is how the Field Test Committee deals with issues that arise during the conduct of an event. The Field Test Committee should be the first avenue for anyone considering making a complaint. Those wishing to make a complaint should seek out a member of the committee and make them aware of their concerns. In response the member contacted should share the handlers concerns with their fellow committee members and look into the matter to see if it can be resolved locally. If the complaint has merit it can probably be resolved locally and avoid a complaint to NAHRA, which will potentially have an adverse effect on all concerned.

The make up of the field test committee is very important. All the members should have a good grounding in the NAHRA rulebook and have excellent people skills, after all the entrants are their customers.

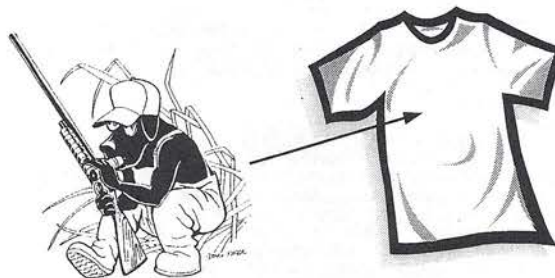

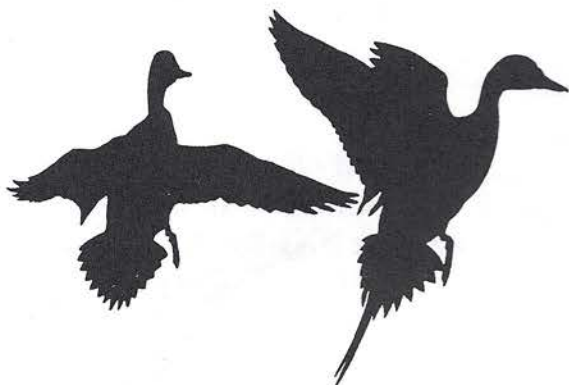

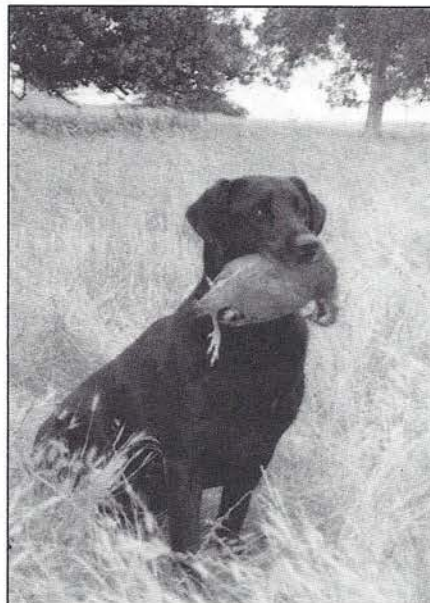

## ***NAHRA Sanctioned Judges Clinic Presenters***

As most of you are aware NAHRA is working towards establishing licensed judges clinics. Clubs and regions have been holding judges clinics in the past with varying degrees of success. In an effort to improve the quality and availability of such clinics NAHRA is developing standards for these clinics and insuring the most qualified judges are presenting them. A copy of the outline for these clinics has been sent out to all Regional Liaisons and Clubs. Many thanks to Gary, Adrian and Jack for their efforts on the outline. The next step in this process is recruiting and training a cadre of active, experienced judges. Dave Cannings has been in contact with a number of NAHRA's most seasoned judges seeking to build this group. Others have been asked to supply names of persons within their region they think highly qualified to fill this role. NAHRA will invite a small number of these individuals, potentially 6, to establish the initial group of presenters. Once the instructors have been selected a meeting of all presenters will be held in a practical central location. The goal is to have this meeting mid to late summer. This meeting will insure that all the instructors are on the same page and allow them to exchange ideas and techniques for holding their clinics. Soon thereafter cooperative scheduling by the regions can begin. Like all of us at NAHRA these presenters will be doing this for the love of our sport, so careful scheduling and effective use of the resource will be required. One of the great strengths of our program is that we have not experienced wavering of our standard. A unified group of presenters should insure that this adherence to our standards is maintained. These judges' clinics are a new chapter for NAHRA. There will undoubtedly be growth pains and missteps, but I am confident that these initial steps will lead to a judging cadre better equipped to evaluate our fine hunting companions.

## SOUTHWEST NAHRA DOGS ARE HOT AS THE REGION

**The Southwest Region may not have the money or political clout of the other regions. We may be ignored and isolated way over here out west. What we do know is that we have the best all around dogs in NAHRA. Our dogs can hunt! Our dogs can work!**

The following is an interview with the owner of one of our Southwest dogs. This dog, Huey, is what a NAHRA dog is all about. He can work hard and hunt even harder. He is his owners buddy and best friend, sleeps on his bed, lives to hunt anything with feathers and plays the NAHRA game and more.

Steve had initially learned about the NAHRA program from Dianne Ouillette, a member of Inland Valley RC and at that time the Southwest Liaison. Huey's vet had given Steve her name and number, telling him to get a hold of her, she belonged to a club that he and Huey might be interested in. Dianne, being the NAHRA supporter she was, had Steve and Huey out to Prado to train and got them to join Inland Valley Retriever Club. Taking Steve under her wing, she told him about the up coming NAHRA test, that he should enter, that Huey could do the work.

So, Steve entered his first two NAHRA tests, hosted by Delta Islands at Los Banos, CA. At the very first test, on Saturday, the judges called the handlers to do the test scenario on the trail. When Steve got to the line he asked the judge, Bethany McGahan, "I don't know what to do, what is trailing?" Bethany, took him by the arm, talked him through it, explaining what he could and could not do, what the dog was expected to do. Steve might not have known what to do, but Huey sure did as he aced the trail and passed both senior tests that weekend. All that hunting had finally paid off!

*Why run Huey in NAHRA tests?*

Lots of reasons. There is a goal to shoot for MHR, GMHR and the 1,000 point club. The people are fun to be around, the camaraderie is great. But, probably the most, is when you and your dog step to the line, there isn't a greater rush. My heart feels like it is going to come out of my chest and I think my dog also gets the same rush.

*What led you to buy a dog and why a lab when you got Huey?*

Originally I just wanted a hunting dog, a pointing or flushing breed. I talked to a vet (a lab man, I found out later) and he talked me into a black lab and since I didn't know anything about dogs, he said he would find me one. I was prepared to spend \$200 to \$300 max (Hey, I didn't know!) but the vet found one for \$500. I thought this was stupid but, said O.K.

*Why did you pick him out of all the other pups in the litter and why this litter?*

The vet found the litter and I liked Huey because he either wanted to be in my lap or carrying a bird wing around.

*What is the best thing about Huey, personality wise?*

He is calm and has intense concentration.

*What is the worst thing about Huey, personality wise?*

He is always wanting to lift his leg. Sometimes on me, sometimes on the judges' lunches, basically on anything higher than ground level.

*What is Huey's weak spot in field/hunt tests, etc.?*

Heading on shore too early if it is an angled shoreline.

*Does Huey hunt with you, and if he does, what is his favorite hunting situation and bird?*

We hunt about 50 days a year and I would have to say any upland game is of equal excitement to him. He gets a lot more flushes and retrieves on quail but, when following pheasant scent, his afterburners kick in. Last year we hunted dove and quail for almost a month in southern Arizona. He retrieved about 40 doves and 130 quail. The year before we hunted in Montana for ducks, geese and pheasants. In one day we got a limit of ducks and pheasants. Next year Huey and I are planning to hunt in the Dakotas for what ever feathered creature we can legally hunt; pheasant, duck, geese, and



sharp tails. You know, hunting all these different varieties of birds shows the real versatility of a NAHRA dog.

*What is your most memorable hunting day with Huey?*

I can't say there was just one. I would have to say his first retrieve of a wild quail. We had to go through a deep ditch with trees. I miss-marked it and thought he was way off, but I was off. He was only 5 months old. Also there was the time when we were getting 4 limits of pheasants for 2 days for me and my friends at a California wildlife refuge when a lot of people with dogs were scratching. Also his open win, it was hard to believe he had won.

*What is your most memorable NAHRA day with Huey?*

Getting his ribbon at the NAHRA Invitational in 1998, qualifying at the Invitational also got him his GMHR title.

*What is your most memorable field trial day with Huey?*

Winning the open at the PRITA trial, where he received his last points for his FC title. He won against 113 dogs, the biggest regular open ever.

*Does Huey have "kids" and how are they turning out?*

No, but he is really hoping and looking forward to meeting some nice ladies!

*What was the hardest test Huey has passed and why was it hard?*

In his open win at the water test. It was a test that you would never train for. The first bird that came down was a 350 yard retired gun, then a flyer. You picked up the flyer, came back and a short retired went off and then a medium distanced bird. You went and got the medium bird, then came back and got the short check down bird. This is where the NAHRA field tests paid off. A lot of dogs had trouble with that short check down bird. To this point about 10 minutes have gone by and he still has to pick up the first bird down. The line to the bird is only 10 yards off the back side of the gunner of the medium bird. Only 4 dogs did well on this bird.

*If Huey could talk, what would he say about you?*

Boy am I lucky to have a Dad that takes me hunting this much. Then when it is not hunting season, he still lets me retrieve ducks and pheasants. Even though they are dead and thawed out of the freezer, they are a lot better than those colored plastic things.

*What are the future plans for Huey?*

Hunt, hunt, hunt and hunt some more. Even though I know hunting messes him up a little for the field trials. Eventually we will get to the NAHRA 1,000 point club. Huey qualified to run at the National Amateur and I am looking forward to running that in June. I plan to keep running him in the amateur and open stakes to get his AFC title. I still have until the fall to try to qualify for the National Open, so we will try for that.

*Tell us about his field test experience, when did he get his MHR and GMHR titles?*

I can't remember when we got his MHR but he qualified for his GMHR at the '98 Invitational in California, just before his third birthday. He has his AKC Master Hunter. He has won two opens and has his FC.

*Tell me about any interesting stories you have about Huey.*

One of the scariest things happened to Huey and I when we became separated while hunting in Canada. I was on the edge of a field and he was in the trees although he was only 30 yards away. When I gave him the come in whistle, he became disoriented with the echo and ran towards it. I didn't find him until 4 hours later, he came back out right where I had lost him. He was a bone tired dog and I was one thankful dad.

During April, my father went into the hospital with a stroke. He loved all dogs that came into our kennel. He was our dog care person whenever we decided to get away for a while. The hospital staff allowed us to take a dog or two into his room for a visit. Even though he had great difficulty speaking to us, he seemed to perk-up and knew when a dog arrived. He touched them in that caring way as the dogs seemed to sense that he was in need of some special attention.

It continues to provide great benefit to patients, nurses, hospital staff and the dogs on each visit. Seems to me that our NAHRA testing program for dogs to reach the Master Hunter level works great for also assuring the calmness needed in a dog to work in a hospital environment. 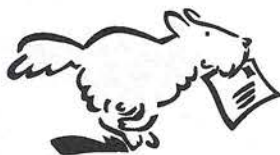

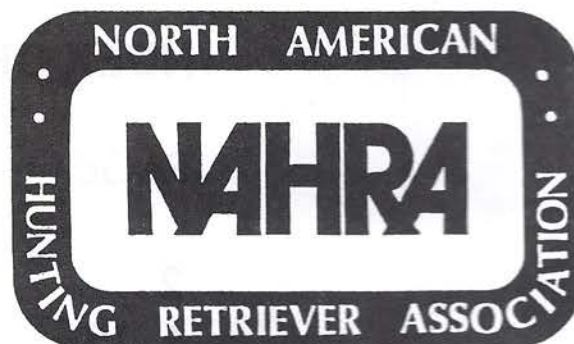

Richard told me that he and lots of his club members have discovered that there is a broad interpretation of the rules. The handlers never know what to expect. He hopes having this seminar will let both the judges and the handlers learn what the intent of the NAHRA rule book is and to tighten up the interpretation.

Kudos to Russ Stewart of San Diego HRC. He asked the California Fish & Game Commission to consider adopting a policy of 'no net loss of training grounds' for hunting dogs. The next thing he knew, he had a draft policy on the agenda for the May 9th Commission meeting, and a seat on the Taucher Committee which will meet May 17th. Thanks Russ for all your hard work.

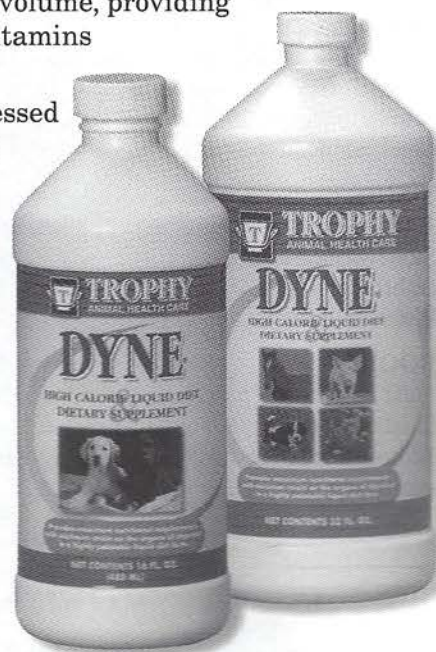
