

This issue of the NAHRA News is profiling the legacy of one Jack Jagoda. So I feel compelled to share my experiences with the man who in my opinion kept the vision of the original seven alive and protected.

It was about 12 years ago that I joined the Alberta Clipper Hunting Retriever Association. I had my four legged companion in tow and was off to a typical training session at the time held by the club. Not knowing anything about the process I was all ears and eyes. Sitting around on the tailgates after the session there was a buzz about the North American Hunting Retriever Association and our clubs ability to host a licensed field test. This was the first time I heard the name Jack Jagoda. It was suggested at the time that our club send an invitation to

Jack to have the President of the organization that we where embracing come out to Alberta and show us what this program was all about. In a very well written letter Jack denied our request. This although disappointing at the time did not hamper our enthusiasm to get hooked by the program. When I say hooked I mean hook, line and sinker. At this point I was up to three dogs two which where very active in the NAHRA process. We traveled from Edmonton throughout the Northwest region during the summer and in the winter down Nevada. Arizona and California. All the way along I kept hearing stories of the infamous leader Jack Jagoda. Not having met Jack at this point a perception was getting developed in my mind.

1998 in Mariposa California was the first time I had a chance to meet and talk with Jack. It was the Invitational Banquet night and I had the opportunity to chat with him briefly. After this encounter I still wasn't in a position to pass judgment on the man that was President of organization that was taking up a lot of my pass time. I truly got my chance to talk with Jack on flight from St Paul to Spokane. I was coming in from Houston to meet up with a friend and my dogs to run the Spokane test and Jack was coming in from Virginia to judge for Spokane for the weekend. As the dog gods would have it

we where seated side by side on this connector flight for two and half-hours. Did we ever have a talk. I came off the plane very informed on the politics of the organization and a heck of a lot more understanding of Jack Jagoda the person. This encounter was the foundation to what I consider to be a friendship we have maintained since. We have both sat at each other's kitchen tables discussing NAHRA, dogs, business and life. We have met up in both Virginia and Edmonton NAHRA events along with a hunting experience on the Chesapeake Bay. I can tell you that I have not met one person has been more dedicated to the NAHRA organization especially in protecting its philosophical foundation and rules.

Jack, I personally would like to thank you for your dedication and commitment to the Program that so many of us love to play.

On behalf of the Board of Directors of the North American Hunting Retriever Association, I would like to take this opportunity to award Jack Jagoda a lifetime sponsorship achievement award.



"One of my best recollections of Jack goes back to when we first met, but especially after the NAHRA program was "born". At that time, Jack spent many weekends at our very small cottage on the Mattaponi River. Not only were there four adults, but we had two young daughters around the ages of 11 and 14 and ONE bathroom for all to share!!! I'm sure Jack spent many uncomfortable and agonizing mornings waiting to get his turn in the "john"!! But, you know, I never heard him say a cross word to anyone about his inconvenience--he just took it in stride! Later, as the girls were growing up, whenever Jack would visit or we would stay at his house, he always treated our girls in such a unique way. Beyond the sort of "gruff" exterior, there was a softness to him that they recognized early on. And whenever he would bring them a little token gift, he would just sort of shrug it off as if he accidentally found it on the highway!! To this day, and our girls are now young, married adults with children of their own and whenever Jack's name is mentioned, they always want to know how he is, or if they happen to see him, he still treats them with the same affection as he did then. This was kind of a side that maybe some hadn't seen in the "ole goat"!!!!"



Good photographer and cook


He no longer uses his old 35mm film camera. He took to digital cameras very easily, and now owns 3 of them. Whenever he isn't handling, or talking about, a dog, he can be found taking pictures of one. He has a good eye for catching the 'right' shots, both in the look of the animal and with the background being correct. As for cooking, he does all of it. He can throw anything together and make it taste pretty good.


Obviously, this was a huge part of Jack's life for over 20 years, and still is. It was not a 40-hr / week job, but it was brought home 80 hrs / week. For a couple of years, the office was home – in a spare room, no way to get away from it. Many people with questions would call his home phone number directly, most of those after normal business hours (many well into the night). Many people, myself included, wondered why he kept at it, but it was only because he cared enough about the organization to hang on until he found someone that could manage it that he trusted. He may not have been the best business manager in the world, but NAHRA never trailed off into oblivion, either. And it's as strong today as it ever was. He did sacrifice for it, a great deal, I saw it personally. I also saw him (and Phyllis) spend a lot of their own money supporting NAHRA. They judged many events without reimbursement. They paid for office supplies and phone bills. They even paid for me to attend the Texas Invitational as a sort of payback from NAHRA for modernizing its database and office systems. I was told that NAHRA picked up the tab, but learned the truth a few years later. The last several years he and Phyllis have been promoting their business aggressively. They've included NAHRA promotional material and banners at many of their trade show booths, and in most of their speeches. They continue to encourage their clients to run their new pups in NAHRA tests. They both remain active in judging, presenting seminars, and helping to run NAHRA field tests.





News from the NAHRA Board

Clarification of Policy on Judges Points

Recently NAHRA instituted a policy which eliminated points for those judges who had not maintained their NAHRA membership. This policy is intended to reduce data overhead and to insure those that are in the NAHRA Judges Book are participating members and are potentially available to clubs seeking judges. Some confusion has arisen regarding this policy. This policy applies to judges who have allowed their membership to lapse for greater than one year. Short term lapses will not result in loss of your judges points.

Clubs are reminded to insure to the best of their ability that the judges they have chosen are current members. Field test applications listing judges who are not current members will not be approved until the judges status has changed or alternative judges are selected. This is often the cause of significant delays in getting applications approved.

Membership renewal

NAHRA currently notifies members of their upcoming need to renew on the anniversary of their membership. This requires the membership roster to be sorted monthly and the required renewal notices are mailed. NAHRA only sends out one renewal notice. Depending on the season it appears that many members don't renew at that time but rather scramble to rejoin prior to the Field Testing season in their area. Due to the heavy workload in the office at the beginning of the testing season memberships could be delayed simply due to workload as priority must be given to processing clubs field test applications. NAHRA would like to know if the

membership feels that they are adequately supported by the present method or should we investigate going to a fixed annual renewal date? Please share with your liaison and the NAHRA office your thoughts on this.

Regional Field Tests

Based on requests from the regions, qualifications for the regional field test are no longer required to be based on the calendar year. Regions may now chose their regional qualification dates based on any 12 month period. The regional field test date must be at **least** 6 weeks after the last test within the region that would qualify dogs for invitation to the regional event.

For example: The Arctic Region wishes to hold its Regional Field Test on 31 May 2003. The last date that would allow a dog to qualify for the regional would be a qualification at an event held on the weekend of April 19-20.

This change is being made to maximize participation in regionals and support the diverse climates where NAHRA events are held. The 6 weeks between dates is to allow the NAHRA office to receive and input the test results and publish the Regional qualifiers. Again six weeks is the minimum required time and where possible clubs are encouraged to allow more time.





September 1, 2002 will forever be engrained in my memory and tattooed on my body. This was opening day of waterfowl hunting in Alaska. The day that all of the long hours and effort are rewarded for. I decided to take my 6 year old Lab instead of the puppy. I don't know why I decided to take her instead of the pup but as it turns out it was supposed to be. I loaded up the float plane with my gear and my two hunting partners and off we went ot the hunting cabin. We spent two great days exploring the hunting grounds and getting our plan of attack ready for opening day!

I slept really well the night before and was ready for the first day. We got up and filled our bellies with fresh blueberry pancakes! Sometimes it just pays to camp in the middle of a berry patch. The plane was loaded with our gear, dogs and my hunting partners. This was going to be a great day. We fired up the plane and off we went not knowing that we would not reach our final destination. After about ten minutes into the flight we encountered a severe downdraft that forced the airplane to lose altitude and eventually we impacted the side of a mountain at 1300 feet. We skidded to a stop and attempted to evacuate the plane which was now upside down. The dogs had already figured out how to get out. My one friend, Bob, got us all out of the plane and settled down on the mountain. As I lay there I decided to blow my whistles to get the dogs back. I had my whistles around my neck. This was a good thing. My dog came right back. Jade realized that I was not in very good shape and immediately began to lick my face and comfort me. During the next couple of hours as the rescuers did their thing Jade sat right next to me looking me in the eyes comforting me. I have never felt so close to a dog as during those agonizing hours. I have spent tons of hours training my dog for hunt tests and hunting but never for a situation like this. I was proud of my dog when she ran the RAW and when she would make unbelievable retrieves out hunting but words cannot express how she comforted me during my time of need. Dogs have a great uncanny sense to know when things are not right. I would not have made it off the side of the mountain this day without the comfort of my friend Jade.

Now I know the real reason I own my dogs. It is not necessarily the time for hunting or training but the true companionship that they give to us. Take the time to truly enjoy your animals. They mean a lot to us. Thanks Jade!

Just to let you know I am recuperating fine from a broken next and dislocated elbow. I am looking forward to the training season next year!







Finding Trouble in the Southwest

The following is an interview with another Southwest Grand Master Hunting Retriever. The interviewees are asked to answer all the same questions. In the next issue read the story about the "Moose of the Southwest".

Why run Trouble in NAHRA tests?

Because my dog loves it. He loves running NAHRA test, especially the upland parts of the tests. I also love the people and watching the dogs work.

What led you to buy a dog and why a golden when you got Trouble?

I had to retire my other golden, Amber, and I was stubborn enough to want to keep running a golden. Almost all my NAHRA friends kept asking me when I was going to get a "real dog". So, I had to hold my ground and be wild and get a golden. Also, pulling cockle burrs out of my dog keeps me busy and out of trouble.

Why did you pick him out of all the other pups in the litter and why this litter?

I was a good friend with a fellow NAHRAite, Melanie Foster. I knew her bitch, Pony and really liked Pony's looks, work ethic, trainability and versatility. I wanted a Pony pup so bad that I gave Melanie the money for the pup before Pony was even in season.

I did not get to pick Trouble out of the litter. I had visited the pup 3 times before they were ready to go home. I had really wanted Mr. Black or Mr. Red. When I went to pick up my pup Melanie handed me Mr. Blue. Melanie still gets a kick when she thinks how disappointed I was when she handed me that pup. All I had to say was, "Oh, Okay, thanks," and not in a very happy tone. Mr. Blue was a hand full. He was always fighting and dominating all the other pups, every time I saw him. When I was in the whelping box, he was the only pup who would not stop pulling at my hair and grabbing my shirt.

What is the best thing about Trouble, personality wise?

He is very trainable and you can get on him and he bounces back really fast, a very forgiving dog.

What is the worse thing about Trouble, personality wise?

He does not want to make me upset with him, so sometimes he thinks too much.

What is Trouble's week spot in NAHRA tests?

I hate to say this, but the upland. He loves to go wild on the quarter. It took him a while to figure what trailing was all about; I started him on it late. Finally he figured out it was not a blind or mark we wanted him to do and now his golden nose is doing just fine.

Does Trouble hunt, and if he dies, what is his favorite hunting situation?

He loves to hunt. Our first hunting experience together was a fish and game heritage women's pheasant hunt. We were late and the last pair in the field. Well, we were the first back in and with a full limit. He ran around until the first bird went up and then he knew what it was all about. He went hunting for quail and dove in Arizona for a month this last fall, retrieving 30 doves and 100 plus quail.

What is your most memorable hunting day with Trouble?

The women's pheasant hunt. Probably because I was the best shot that day with the best dog. Most of the women had never hunted before and their dogs were out of control. So, it made us look really good!

Does Trouble have any "kids" and how are they turning out?

NO, not yet .We have a litter planned by his breeder for late fall. I am hoping someone has some interest in him. He has some great genes to pass on. Excellent clearances, trainability, looks and go.

What is the hardest test Trouble has passed and why was it hard?

His first AKC test, a senior test. I had entered him only because the golden retriever club sponsored the test and I had been asked to marshal. I figured he would break on the first bird and that would be that. He had only done the NAHRA started until then and was only just over a year old. Imagine my surprise when he was steady and pinned his mark and did a very good land blind. We were called to the second series and his marks were okay. But the water blind was really a hack job. We were just in the middle of water forcing and bank running in his training. The weekend before we had just been in that spot and he had been having a rough time on a channel blind. The blind was in an "S" shaped pond. You had to skim land, then get on land, then do a channel for a short while, get back on land, then back in the water and skim land again. After doing a water channel there before, he was not sure what I was asking him to do and was really worried, "What? Do you want me to get on land or channel or what?" We passed, but it was hard on both of us.

If Trouble could talk, what would he say about you?

I want my Mom to give me more marks and to play, play with me. I want Mom to let me go hunting more. I know I frustrate my Mom sometimes, but I think she knows I like to please her.

What are the future plans for Trouble?

I want him to have lots of hunting experiences. I hope to get him to the 1,000 point club. I will finish up his Master Hunter. He is all age qualified and starting to run in the amateur field trial stakes. He has made it to the last series twice out of running amateur stakes 3 times. He is ready and can do open blinds, but the open marks are over his head right now. So, w will just have to see how far he goes with that.

Tell us about his field test experience, when did he get his MHR and GMHR titles?

He got his MHR at 24 months and his GMHR when he was still 2 years old, 19 months. He is the only golden in the SW Region to get a GMHR title. We think he is the youngest golden ever to get his GMHR title. Last year he was the 4th highest pointed derby golden. NAHRA was my priority for him, so that took precedence over all other games. I don't play field trail games, never will, it is not for me. My boyfriend handles him in those. I handled him in all the NAHRA tests except for three weekends when I was judging and could not handle him. I had Steve Cote' handle him once and Dan Hosford the other two weekends. He runs easily for other people. He has only failed two tests of the 24 NAHRA tests he has entered.

Tell me about any interesting stories you have about Trouble.


He had Parvo when he was a little guy and had to be crated for almost 3 months, He could only go out to go potty on a leash and then back to the crate. He was a bundle of energy. The first time I took him out to work was at a Delta Islands training day. He was not collar conditioned yet so I was running him without a collar. A single was thrown for him, a duck in a small pond in a pasture. Well, he went right in the water, picked up the duck and took off

with it! He was running all over the place as fast as he could, all the while throwing the duck up in the air and catching it. I could not get him back for anything. We all yelled. We all threw birds and bumpers. Finally after about 15 minutes, he was tired out and came back in with his duck. Everyone was laughing so hard! Lisa DeSilva said I should have named him, "Dances with Ducks."
