## President's Bark by Jim VanderGiessen

I don't know about you but I'm ready to go hunting. It's been a long hot summer and the first few cooler days have my dogs displaying the energy they lack during the "dog" days of summer. As usual I'm behind on blind building and more behind on training.

NAHRA and the people I have met and trained with have definitely made my dogs better hunting companions. Fortunately it seems my dogs are pretty smart too because they sure get a lot of conflicting signals this time of year. Of all the hunting centered dog programs I believe ours is the most complete. That said try as we might simulating actual

hunting is a tall order particularly if you have a large field to judge.

If I had to rank my dogs skills in order of there importance to me as a hunter they would look something like this:

**Nose**, cripples in tall cover are a very frequent occurrence.

**Handling ability**, try as I might it seems the dog is always in the wrong place to get a really good look at the birds falling. Add another good shot in the blind and you have a large number of birds down some of whom are not dead and need to be picked up first. While a good mark is a beautiful thing, in my

hunting experience it's the exception rather than the rule.

**Steadiness**, I can't call and look for a dog who is going to break at the click of a safety or that first shot. I would include steadiness to wing and shot here, while I don't go west every year anymore when I do I expect steadiness. It just makes upland hunting so much more fun. I imagine based on where or how you hunt this list would look different, maybe you hunt with other dogs and honoring is critical. What matters is that the skills you train are the ones that enrich your days afield and conserve game.

# Why I Run Hunt Tests

Over the years I have had many people ask me why I run Hunt Tests. My reply is always the same “Because I get to work my dogs all summer long. And because of that, they are always primed and ready for hunting season, which is why I have a dog to begin with”. For me this is the paramount reason I play the game. However, there are so many more benefits to be harvested that it is almost impossible to name them all. Different people have different reasons, and all of them are valid. Because I work as a hunting guide in South Dakota in the fall, it is imperative that my dogs be in tip-top shape on opening day. I don’t have the luxury of being able to give them a couple days off because of sore feet or stressed muscles. Nor do I have the opportunity to refine their training or make harsh corrections when I have hunting clients in the field with me. These people are expecting to see my/our dogs in prime shape on opening day, as they will not be there next week when the dog finally recovers from his stiffness or finally begins to listen and respond properly. By running Hunt Tests during the summer, my dogs are being judged and held to a standard that the average dog owner never realizes is possible. They are put to the test in REAL-LIFE hunting scenarios. These scenarios serve as a barometer to tell me where we need to put our emphasis on training in order to be fully ready for hunting season. It could possibly be that our quartering is not up to par, or maybe our blind retrieves need some pattern field drills. Maybe we have an honoring problem, as we always have a number of dogs in the field at a time (ever had to quarter in a brace at a hunt test?) Perhaps we didn’t pick up the trail because old Sport wasn’t sure how far he was allowed to get into the field without you. Or maybe he has some blind/line

manner issues. This is especially important to me after sitting in a very small duck blind all morning with an unruly dog who the owner thought was Super Dog. All of these scenarios are indeed real life hunting situations, and by running hunt tests we can become aware of where the problems are by means of objective judging standards.

Whether you work as a hunting guide or just go out hunting with your dog on occasion, the product is still the same. You want your dog (and yourself) in tip-top shape when you go to the field. You don’t want your dog running wild flushing birds at 200 yards, nor do you want them barking and whining in the duck blind. You want them to be able to run blind retrieves for the birds they did not see fall across the creek. If you hunt with a buddy who has a dog, you don’t want to see a dog fight over a bird because neither dog will honor. I have seen friendships stressed over this very issue. Regardless of how many times you get to go hunting, there is no need for you to have to wait until you are out in the field to see what needs fixed. Just run a hunt test once and you will know exactly where your emphasis needs to be placed. You will also be in the midst of people who have been there and can give you advice on how to fix it, and maybe even go out training with you. Some of the finest quality people I know, I have met at Hunt Tests. Additionally we all have a common objective and interest, which can foster life long friendships and relationships. You might even find a new hunting partner who will introduce you to his secret spot because he would like to hunt with you and your dog. This has happened to me on several occasions.

Hunt test and field trials are a formal means of testing your dog, as well as

being rewarded for exemplary performance. I have had many people over the years tell me that they don’t want to run Field Trials with their dog. They just want a good hunting dog. This was ME, just 20 short years ago. I did not know. I was ignorant to the game. I have found this to be the case with most people in that they do not know that there is indeed a difference between a traditional Field Trial and a Hunt Test. While most of us in NAHRA have a clear understanding of the differences, many people do not know the difference between the two games. In short, a Field Trial is a test in which the dogs compete against each other, and a Hunt Test is where the dogs are judged against a standard, not each other. Traditional Field Trials have been in existence for several decades, while hunt tests have only been around for just over 20 years. Hence, more people have heard about field trials than hunt tests. Both games are played very similar, but in a traditional field trial the tests tend to be a bit more demanding in that they must choose only one dog as the winner, so the tests need to be extremely challenging to weed out the dogs not exhibiting exemplary performance that day. Almost all of the people that had previously told me that they had no desire to run hunt tests, are now hooked on the game because of that one-time exposure to our game, at my request and coercion. **Because of this, I challenge each and every one of you to make every effort possible to expose all of their friends who own working dogs to attend and possibly run in a hunt test.** They will likely be hooked, just as many of us have been.

Now on to the question of which is better; Hunt Tests or Field Trials. The answer lies within each of our own

desires and expectations. I personally don't run traditional field trials because I do not have the time or financial resources to be as competitive as that game requires. I truly wish I did. While my dogs can perform most tasks asked of a dog in a field trial, they would have to do it better than any of the other dogs entered that day to place or win. That is indeed quite an accomplishment when you consider some of the high quality dogs and trainers that we have today. Field Trials are VERY competitive, and my hat goes off to any dog that even places in a traditional field trial. I personally like to run hunt tests because I can compete against an established standard, and it is possible for my dog to have success, regardless of what any of the other dogs did or how they performed on that day.

a Field Trial, or any of the most advanced levels of a Hunt Test, regardless of the organization. These dogs have had countless hours of training and have been held to the highest standards of a working dog. They know their work, and perform it flawlessly. It is indeed a special treat to go hunting with a dog that knows his game and performs it with the style and grace of an accomplished performer. You will very likely be awestruck by what an accomplished dog can do, and the pleasure will be all yours. This will be especially true if that dog is your own. Please support all dog testing programs to the greatest extent possible. You will thoroughly enjoy yourself and it is our insurance policy on constantly increasing the quality of mans best friend.

In summary, I would always welcome the opportunity to go to the field with any dog who has achieved an FC or AFC title from

Three years ago when I went to pick up my new pup in Lebanon, Ohio, I never thought I would have a Grand Master Hunting Retriever to hunt over this Fall. # For Indian Hill Summer's Breeze 12/05/00 - 09/08/07

Breeder and initial trainer Kirk Rice received this message recently:

Kirk

You would have been very proud of how Breeze turned out. She would always squeal a yelp of elation when sending her on the first few retrieves and I've watched her do blind retrieves across 300 yard backwaters and mile-long open-water pursuits to recover a barely-crippled goose. She was featured in a Denver Post article last year and never failed to make me proud. I'm happy to say that I never took her abilities or love for granted, but my belief that she could do anything makes it harder to accept that she was still mortal.

Yesterday, 9/8/07, Breeze died.

She was bitten by a rattlesnake while dove hunting and we could not save her. She would have been seven in December.

I was on a multiple-day hunt with two of my best friends in south eastern Colorado. The trip started fabulously, had a nice dove hunt on Friday night, a great teal hunt on Saturday morning immediately followed by a short dove hunt. Toward the end of the dove hunt, around 9:40am, Breeze was bitten by a rattlesnake while looking for a downed bird in heavy cover. I was only 15' away from her when I heard the snake, I called her back, but he had already bitten her.

At first, it didn't look bad. We found fang marks in her left rear foot, but little penetration or swelling. We administered anti-histamine in the field and took her to a local vet for additional treatment. The vet thought she'd be fine with steroid/antibiotic/anti-histamine, essentially determining that no swelling = no venom, despite her behavioral symptoms.

Toward afternoon, she exhibited swelling in her chest and I took her again to a different vet which had anti-venom medication available. She was admitted, and though looking poorly, we were still optimistic since her

symptoms could be attributed to her full day of hunting followed by the dehydration of vomiting.

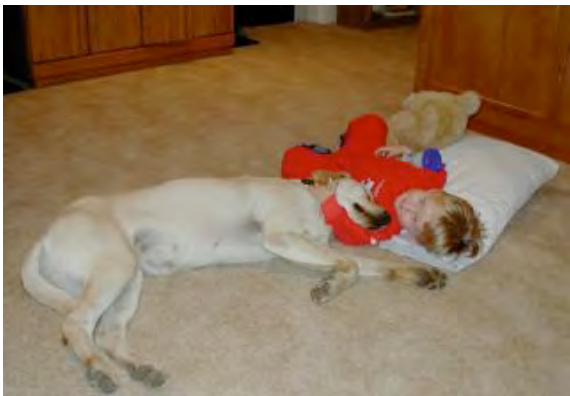
Despite IV fluid & anti-venom treatment, she did not improve and continued to decline, slipping into a coma and finally dying around 8:40 pm. Saturday evening. We now believe that the snake bit her in the lower chest with venom penetrating the chest cavity -- worse yet, it was on her left side nearest her spleen. There was no initial swelling since the edema was inside her chest cavity. The second bite on her foot would probably have been fine, but the first bite so near her organs and from a very healthy 3.5' rattlesnake sealed her fate from the beginning.

Breeze has been a constant companion for me for five and a half years -- quite literally by my side 24 hours a day. She was a great family dog and a phenomenal hunting dog. She has made several hundred retrieves in her abbreviated career -- dozens of which were legendary. The morning before she died, she had made multiple text-book retrieves and completed one exceptional open water retrieve involving a 200 yard pursuit, finally diving under water for the final recovery -- and this she made look routine.

She was at once my child, my girlfriend, my hunting buddy and my best friend and losing her is tearing me apart. Her constant companionship makes her absence much more noticeable no matter where I am. She was her true self to the end, she never yelped when she was bit, and she handled the vet visits with grace. I spent the most of the afternoon on Saturday just petting her and holding her and she would always muster a tail-wag and an affectionate return despite her incredible pain.

I'm sorry to bear such bad news. Clearly Breeze passed far before her time, but she at least died doing what she loved most.

# MHR-I Irvine's Morning Sun Madison, SH

As a six month old pup, we knew that we had taken on more than we could handle without some help.

You see, my husband and I already had a one year old black male lab that basically spoke English. Never chewed anything, house trained in less than a week... the perfect pup to say the least.

We decided we wanted a second. The search was on for a healthy, well-bred, yellow female. Our black male has some health issues so we were determined to get only the best. That's when we found Kevin and Wendy McLaren of Morning Sun Retrievers. I went and visited, fell in love with the expectant mother (Zena) and Kevin and Wendy seemed willing to put up with me! We put down a deposit and waited on the litter to be born.

On March 10, 2004, six little yellow pups were born. At almost 8 weeks, Maddy (named after James Madison as we are both JMU alums), the little orange one, came home.

At six months old, what I knew as obedience (I grew up with labs but never what I now know as a "trained retriever") seemed to be going well. Unstructured backyard time however was a completely different story, Maddy was bored. There were holes and I mean large, able to fit my 80lb black male into them, holes. We went through one whole set of deck furniture that Maddy decided tasted good and was apparently good relief for teething pain. For those of you with high-strung lab pups, I don't need to continue, you know the rest. So, I called Kevin and asked for help. He told me to come down the next weekend and meet him in the field as he would be training and he would evaluate her and give me some pointers.

That one visit was all it took. Maddy and I are now regulars at NAHRA and AKC tests in the Mid-Atlantic region. When not at a test, we travel almost every weekend to Weyers Cave for training and run drills in the yard most evenings. We made it through Started / Junior quickly,

staled a little with Intermediate / Senior but eventually moved on to Senior / Master.

Maddy received her NAHRA MHR title in April of this year. It was our last chance to qualify for the Invitational. This pass was special for us as Maddy and I passed as a team at the SVHRC test which is where we also received our first Started pass in March of 2005. Started to MHR title in almost exactly two years., not too bad for an amateur handler with no clue and an off the wall "little pocket rocket" (as she has lovingly been called by a friend in the field)!

With pride and completely shot nerves of just recently putting her MHR title on her, off to the Invitational in June we went. Maddy and I were one of the youngest teams there and definitely one of the most green having just completed her MHR title right before the deadline. All that hard work and we had made it... now, we had to pass the thing!

The Invitational went well. Maddy looked like a veteran through the land marks, land blind, quarter/sit to flush and trail. Handler nerves struck at water but as it seems more times than the reverse, Maddy pulled us through. We left the Invitational with ribbon in hand and a huge sense of accomplishment.

So, I would say this is the end of Maddy's story but as most of you probably know, with one of those high-strung lab pups as I mentioned earlier, the story is never over. We continually train, reiterate obedience and continue the power struggle in the field. I thank Kevin for taking me under his wing and not only training this pup to be a dog that I have become more proud of than words can describe but just as importantly, training me.

Next edition of the story is hopefully Maddy's AKC Master title and her GMHR.

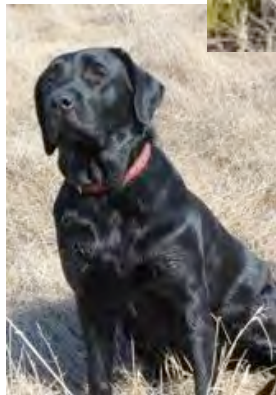
I took part in NAHRA tests this Summer for the first time and really enjoyed the tests, the organizers were great and I also enjoyed meeting the participants.

I've been out of NAHRA for a while, but have been day dreaming about the hunting seasons I'll miss this year and the NAHRA tests I missed last summer. I used to thoroughly enjoy training and testing through the year to prepare for the real thing in the fall.

Hunting, like lots of things in life, is governed by Murphy's Laws. Whatever can go wrong, will - and does sometimes in hunting. But the extremes of hunting don't make for good testing. In thinking about this contradiction - for lack of being able to do the real thing - I thought I'd send NAHRA News these thoughts.

### Upland Blockers

Sometimes when pheasants are running or cover is very high, it's a reasonable hunting strategy to post blockers and work the dogs toward them. The blocker scenario can be used in tests to save the workers walking or because workers for the next part of the test are stationed at the end of the upland field.

It makes for a bad test in either case. The dogs know they're at a test and are drawn to the workers ahead rather than putting on a good hunt.

### Into the wind marks

Typically waterfowl land into the wind and this makes for wind at the back marks. Once in a while a bird will go down into the wind in real hunting, so why not use it in tests?

Into the wind marks make bad marking tests. If a dog breaks into a hunt early on into the wind marks, it's almost impossible to know if the dog mis-marked the fall and is hunting its way to it or if it has winded the bird and is cautiously working into it. A judge simply can't tell if the dog has marked the fall or not. It turns marks into a guessing game: quartering or cautious marking??

You probably should train on into the wind marks and blinds once in a while, if for nothing more than to see for yourself what goes wrong.

### Intermediate blinds too close to marks

In real hunting blind retrieves often have to be run through areas where previous marks or blinds have been run. Judges can make up a story that since they have moved the line the old falls shouldn't interfere with the dogs. That's horrible.

Moving the line and running through the old falls is often harder than just running through the falls. Intermediate blinds are only to test a basic skill. Find a clean area.

### Re-dragged trails

The worst and most common error in setting up trailing tests is re-dragging the same trail too often. Inexperienced judges do it a lot. Sometimes the mechanics really tempts you to do it. Sometimes the trail seems to be working for 4 or 5 dogs, the not working for a dog or 2, then working again. This might be because the dogs in between couldn't trail, but more likely is because the trail was over scented and some how recovered again.

I can't think of a real hunting excuse for re-dragging trails too often even with Murphy's Law of Hunting. Crippled game isn't likely to run down the same trail...

Good hunting. I hope to re-join y'all next year.

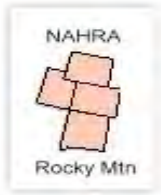

Greetings from the Northwest, though that title might not be entirely accurate. From the greater NAHRA picture, no doubt we are in the northwest corner (excluding Alaska). Interestingly, we currently have three active clubs on the east side of the Continental Divide. Additionally Spokane, being our busiest club, is located on the east edge of the Great Divide and over 300 miles from the Pacific Ocean! My stereotype thoughts of the term "Northwest" conjure up images of coastal rain forests and most households supported by logging, Boeing, or Microsoft. I suppose these images would be false for any "real world" location, but at least closer to the mark for what is labeled as the Pacific Northwest. Alaska as being somewhere on a separate planet. Now where does that leave us? Back in the Northwest corner, albeit a big corner. So the current title will have to do. Where am I going with all this?

What is the difference in handlers, hunting, and clubs between our regions? Probably not as much as many think. I see this great diversity of habitat and hunting styles right here within our region. Overall the Northwest has a few more square miles per capita, though I don't know anyone that lives in a place called "Overall". We contend with shrinking hunting opportunities and changing political correctness just like everyone has to (even the far north). Widely different hunting techniques and habits can be observed within our own region, with no need to travel to Virginia to see diversity. What I do see as important is continued efforts to expose judges and handlers to different regions. Without this cross-pollination, any one area can quickly become its own Galapagos Island. Developing strong characteristics specific to their local area. Not because specific areas need different dog skills, but left to their own devices programs will develop and progress differently. We tend to accept a certain home court advantage, but we are always preaching the development of versatile hunting dogs. Whether we realize this or

not we combat this specialization within our regions by attending and judging other events in easy driving range. Though doubtless the definition of "easy" -does change from area to area. It's a little trickier as the miles grow between Regions.

My home club in Spokane has prided itself on bringing in outside names on a regular basis, then 2007 came around with several imported judges having to cancel due to those pesky career distractions (sometimes referred to as a life outside of dogs). I say this only to deflect folks accusing me of calling the kettle black. My point is not to pound our chest, but to encourage all clubs to make active efforts to continue this practice. With travel costs up and discretionary income for entries down, I know this is doubly hard. Being unable to have as many outside judges as we wish needs to not become an excuse to never have them. Each club to their abilities and circumstances. One small additional point I always encourage is to pair these outside judges with locals. Not everyone does this, but there is a lot of visiting and discussions between judging dogs. These outside judges are a valuable resource for comparing notes. I vote for spreading around this information. Even when we don't want to hear it. Efforts along these lines might add a bit of work in the short run, but prevent splintering of our core purpose better than any policy or rule ever can.

Now that I have finished my monolog, how did the Northwest do this year? I'm a realist and hate painting an unrealistic picture. Ignoring the down sides every club, program, or any organization has to confront. Having said that, there was a lot to be pleased with. The Helena Valley Gun Dog Club sponsored their first Licensed NAHRA Test. And it didn't rain until 5:00 pm on Sunday! Naturally all tests were finished except the tail end of the one I was judging. My co-judge and I struggled through it with game handlers hanging in there. No one to blame but ourselves for that. Despite this minor

bump, the weekend was a success, and I plan on attending next years event as a handler. For all you Albertans, note this is a easier drive than any other tests in the lower 48.

Big Sky (near Kalispell) and the three Spokane tests went off without a hitch, with the Montana's club banquet being especially impressive. Spokane is a bit small of a club to be hosting three tests yearly, but we get er done. Trimming a few details like banquets and raffles. Truth is we already tax our local retailers pretty hard for other club functions. Our help and job distribution can get a bit thin (sound familiar). So Spokane's Saturday evening tailgate dinner is free, and sometimes pretty basic. As we have spread this job around to different folks a competitive spirit has gradually grown. Many have put together vittles well beyond what you expect to see in a clearing out on the test grounds. And one less necessary job to collect and keep track of payment.

2006 & 2007 have seen Calgary and Edmonton condense their two weekends each into one three day weekend each. These are run consecutively with only 3 non-test days in between. I suppose this could be considered shrinkage, but the world is changing and I see this as an effective way to keep travel costs within the reach of the largest group possible. Both tests were run efficiently with the Alberta Clippers also sponsoring our Regional Test. The festivities were fantastic with live music under their new covered area. After profits were divvied up with the host club, the event netted about \$1,000 for our Northwest Regional Fund. Great job!

It can be a treacherous path giving thanks, as many deserving names are usually left out. I'll venture out on a limb and point out Sharon Willis and Steve & Carol Fox as being tireless contributors, but there were many others. I can be a stickler for keeping everything accurate between various currencies. Notice this year I didn't need to differentiate

between US and Canadian dollars, as they are currently almost the same. No passports needed for ground travel yet, but we are expecting some changes soon.

In our region the Puget Sound Retriever Club is the originator of the three day test concept. Unfortunately theirs has become lined up next to these two Canadian weekends. Looking on a map one can see the huge distance this is to separate tests on three consecutive weekends. For the same basic market! Understandably entries were down this year. As the Regional Director I made a point to run dogs in all three, but I might be the only handler to commit to this travel. Obviously there is room for improvement in scheduling. Entries down or not, Puget Sound put on a great test and hats off to their organizational skills. Negotiations are in progress and chances are good this will be the location of 2008's Regional Test. I'll keep club representatives posted on that.

Our region finished off with Spokane's third & final test. Though not a record breaker in entries, they were solid, and the weather did not fry us. Not always a given in August. Our local professional trainer/handler Dan & Janette Hosford taking the day off from dogs to cook us a culinary extravaganza.

Incidentally, we had Rosemary look it up, and records show this is the 63rd Licensed NAHRA Test the Spokane Bird Dog Association has sponsored, almost all of them double events. That is a lot of weekends!

What did we lose this year? The Treasure Valley Retriever Club (near Boise) decided to cancel their NAHRA test this year. Frankly I understand their position. Their location is off our beaten path and many of us have not made much effort to travel down there, despite them moving tests to the beautiful area of McCall, Idaho. They are surrounded closely by several strong AKC Hunt Test clubs, which do support them well. Of note they did decide to continue to support NAHRA. This was not a change grown out of dissatisfactions with our program. Just facing the reality of who was paying the bills. A gals gotta eat. The door is still open, so we never know what the future holds.

I was finishing up this piece when I noticed Keith Stroyan's reminder to get it

done. He is a tireless worker in keeping us on track, more people should know that. He also mentioned encouragement to focus our piece on recent accomplishments.

Well I must have missed that earlier, and am too lazy to start over. So what can I include that might grab some interest?

Shopping at Sears in Spokane yesterday I happened across a new resident to the area which has run NSTRA events elsewhere. That's National Shoot To Retrieve Association, a pointing dog event. The SBDA sponsors some of these too, and we struck up a conversation as I hooked him up with some local contacts. He had read the local outdoor scribes mention of our yearly club trophies. The SBDA has awards for most qualifications for all three NAHRA categories. One for "OPEN", and another for "AMATEUR" (with some NSTRA awards as well).

Well our top NAHRA Intermediate dog last year was a German Shorthair Pointer! Carol Ramsay and Gina, or is that Gina & Carol? Everyone I know was quite happy for their accomplishment. Unfortunately the writers coverage of our Banquet seemed to end there (he has a Brittany). 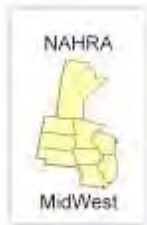

I believe our program does a great job of evaluating the full range of skills required of a great conservation animal. A NAHRA MHR can hunt anywhere and do it effectively. Still I think we can always make improvements in our field tests. For example good use of terrain can challenge a dogs abilities a lot more than a long swim. I hunt with some great guns and we don't have all that many 100 yard retrieves and when we do its pretty rare for it to be a good mark, more often than not "it's over there somewhere behind that point" I often hear folks in

the gallery make comments like "I don't know if they will be called back, they handled on a bird in both series." I hope we don't have many judges who use that formula. There is a lot more to evaluating the work than that. Conditions, quality of the throws, the inevitable distractions taking place on the grounds all need to be considered, and if you don't know what's going on you better think about calling a no bird and re-running the dog. It's all about fairness and I got to see a really good job of that in July.

This years Invitational was very well run and judged. My thanks to Frank, Scott, Val, Sonny, Dan, Ted and Diane and the many others who made the event such a success. My biggest take away from the event was how well dogs from out of the area performed and how with good judges the variables associated with dogs from all over the country can show their strengths.
